

## **NOTICE OF MEETING LEGACY MUNICIPAL MANAGEMENT DISTRICT**

Notice is hereby given that the Board of Directors of the Legacy Municipal Management District will hold a meeting of the district on **August 14, 2024, at 9:00 a.m.** at 1826 North Loop 1604 West, Suite 260, San Antonio, Texas 78248. The meeting will be open to the public, and will be held to discuss and, if appropriate, act upon the following items:

1. **Determine Quorum and Call to Order.**
2. **Public Comments:** This item is for members of the public to address the Board of Directors on issues and items of concern not on this agenda. There will be no action by the Board of Directors at this time.
3. **Public Hearing(s):**
  - a. Continuation of Public Hearing as to the advisability, general nature, estimated cost, and proposed method of assessment for the levy of assessments and the Authorized Improvements, as proposed by Petitioners. The Public Hearing may be adjourned from time to time, as may be deemed necessary and appropriate, until the Board finds by resolution as to the:
    - i. Advisability of the improvements;
    - ii. Nature of the improvements;
    - iii. Estimated cost of the improvements;
    - iv. Boundaries of the Proposed Assessed Property, and area benefitted;
    - v. Method of assessment;
    - vi. Method and time for payment of the assessment; and
    - vii. Apportionment of costs.
4. **Consent:** The following items may be acted upon in a single motion. No separate discussion or action on any of these items will be held unless pulled at the request of a member of the Board.
  - a. Consider approval of the Minutes of the following Legacy Municipal Management District Meeting:
    - i. July 29, 2024.
5. **Action/Discussion Items:**
  - a. Consider and take possible action on Resolution Authorizing General Counsel to Request Qualifications and Proposals for Professional Engineering Services Relating to Conducting a Study and Preparing a Capital Improvements Plan under TEX. LOC GOV'T CODE §§ 395.001 *et seq.*;
  - b. Consider and take possible action on Resolution Making Recommendation(s) for Board of Director Position(s), for Legacy Municipal Management District;
  - c. Consider and take possible action on Resolution to Commissioners Court of Webb County, Texas, Recommending Board of Director(s) for the District and Requesting Confirmation of Board of Director(s) in accordance with TEX. SPEC. DIST. LOC. LAWS CODE § 4008.0101, *et seq.*; and such other actions incidental thereto;
  - d. Consider and take possible action on Resolution accepting a Preliminary Service and Assessment Plan for the purpose of levying assessments under Chapter 375, TEX. LOC. GOV'T CODE;
  - e. Consider and take possible action on Resolution as to the advisability of the Authorized Improvements, nature of Authorized Improvements, estimated costs of

Authorized Improvements, boundaries of the Proposed Assessed Property and area benefitted, method of assessment, method and time for payment of the assessments, and apportionment of costs;
