The meeting will be open to the public, and will be held to discuss and, if appropriate, act upon the following items:

1. **Determine Quorum and Call to Order.**
2. **Public Comments:** This item is for members of the public to address the Board of Directors on issues and items of concern not on this agenda. There will be no action by the Board of Directors at this time.
3. **Public Hearing(s):** None.
4. **Consent:** The following items may be acted upon in a single motion. No separate discussion or action on any of these items will be held unless pulled at the request of a member of the Board.

Consider and take possible action on Landowner Petition for Inclusion of property in District Boundaries filed with the Board under Section 49.301, Texas Water Code, Authorizing and Directing Recording such Petition, If Granted by the Board, in the O.P.R. of Webb County, Texas; and such other actions related thereto;

Consider and Receive Written Petition of Landowner filed with the Board Requesting Project Improvements and Services within the District Boundaries and Requesting such Improvements and Services to be Financed by the Levying of Special Assessments In Accordance with Chapter 4008, Tex.
