Notice is hereby given that the Board of Directors of the Legacy Municipal Management District will hold a meeting of the District on **May 20, 2026, at 1:00 p.m. CST** at 1826 North Loop 1604 West, Suite 125, San Antonio, Texas 78248. The meeting will be open to the public, and will be held to discuss and, if appropriate, act upon the following items:

- 1. Determine Quorum and Call to Order.**
- 2. Public Comments:** *This item is for any member of the public who wishes to address the Board of Directors. During the Public Comments portion of the Agenda, the presiding officer will call on those persons who have signed up to speak in the order they have registered. There will be no action by the Board of Directors at this time. Public comments will be limited to three (3) minutes per person.*
- 3. Public Hearing(s):** None.
- 4. Consent Agenda Item(s):** *The Consent Agenda is considered routine and will be enacted by the Board of Directors with one (1) motion. There will be no separate discussion of these items unless they are pulled from the Consent Agenda upon the request of a Board Member.*

- 5. Action/Discussion Items:**
 - a. Consider and take possible action regarding tentative meeting dates for the District;
 - b. Consider and take possible action approving Insurance Renewal Proposal from McDonald & Wessendorff Insurance;
 - c. Consider and receive nominations for Board of Directors Position No. 4 and Director Position No. 5;
 - d. Consider and take possible action on Resolution making recommendations for appointment of Board of Directors Position No. 4 and Board of Directors Position No. 5 to the Commissioners Court of Webb County, Texas, in accordance with Chapter 4008, Texas Special District Local Laws Code, including such other matters related and incidental thereto;
 - e. Consider and take possible action approving and authorizing execution of a *Wholesale Water Supply and Services Agreement* between the District and the Legacy Water Supply Corporation;
 - f. Receive update/report from District Engineer, Kimley-Horn and Associates, Inc.;
 - g. Receive update on development within District boundaries by Developer's Representative;
 - h. Receive update on NewGen rate study and analysis by General Counsel and Developer's Representative;

 - l. New Business/Future Agenda Items.
- 6. Executive Session:** No action shall be taken in Executive Session. A closed Executive Session may be held if the discussion of any of the above agenda items concerns any one of the following items listed below:

- a. Seeking the advice of General Counsel concerning pending or contemplated litigation, settlement offers, or any matter in which the duty of General Counsel to the Board of Directors of the District under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act (TEX. GOV'T CODE § 551.071);
 - b. Deliberating the purchase, exchange, lease, or value of real property if deliberation in an open meeting would have a detrimental effect on the position of the District in negotiations with a third person (TEX. GOV'T CODE § 551.072);
 - c. Deliberating a negotiated contract for a prospective gift or donation to the District if the deliberation in an open meeting would have a detrimental effect on the position of the District in negotiations with a third person (TEX. GOV'T CODE § 551.073);
 - d. Deliberating the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee; or to hear a complaint or charge against an employee or officer unless the officer or employee who is the subject of the deliberation or hearing requests a public hearing (TEX. GOV'T CODE § 551.074);
 - e. Deliberating economic development negotiations or the offer of a financial or other incentive to a business prospect (TEX. GOV'T CODE § 551.087);
7. **Reconvene in Open Session.**
- a. Consider and take possible action on any item discussed in Executive Session.
