#### **OLD AND NEW BUSINESS**

<u>Flag Raising</u> - Although COVID 19 prevents us from having our annual Mayor for the Day ceremony, a Lithuanian flag raising is planned for Friday, July 9<sup>th</sup> at 10 am at City Hall. Our plan is to honor the former Mayors for the Day by reading the last 20 or so names. Marlene Shea will provide the electronic list to Fran Stiklus after the meeting.

<u>Club building update</u>- – Linas Balsys has not received any updates regarding the Arch Diocese providing survey results that define the back portion of the Club House boundaries. Bob Orintas noted that Waterbury's lease is up in June, and he is not sure if they are going to renew the lease; he is waiting for feedback from the attorney. He also suggested that the land extend 30 feet behind the building; Linas B will follow up with the Arch Diocese to see if he can get more information.

<u>Degree Awards Update</u> – Linas Balsys has the awards, but we need to coordinate with Fr. Aniello to get the medals blessed before being distributed. Father will be contacted to see if he is willing to officiate the mass at our September meeting and bless the medals. Bob Orintas suggested that this would be a nice symbolic gesture to kick off the new season.
