<u>Christmas Party</u> – Vita Ciullo updated the members regarding Christmas party locations and pricing. Amalfi's and Daveluy's were both contacted and without tax and tip, prices ranged from \$15 to \$25 per person. The Café on Congress agreed to provide a variety of hearty appetizers, soda, and coffee for \$12 per person (not including tax and tip). Prior to the meeting, Linas Balsys, Fran Stiklus, Marlene Warren and Vita Ciullo had a conference call to discuss the various options and agreed to support the Brooklyn neighborhood by having our Christmas party at the Café on Congress; tickets are priced at \$20. Linas Balsys will serve as the raffle MC, and several members volunteered to make desserts: Vita Ciullo, Marlene Warren, Linas Venclauskas and Marlene Shea. Fran Stiklus noted that the 50/50 raffle would be \$5 per ticket and prize raffle tickets will be \$5.00/arm's length. Members were urged to bring one raffle prize, and a canned good for the St. Vincent DePaul food bank.

<u>Club building update</u> - Linas Balsys reported that the City of Waterbury is pursuing plans to purchase the former school and convent. Father Aniello mentioned that he expects a survey to be performed to delineate the property boundaries, and Monroe Webster forwarded Linas' contact information and email to David Lepore who will be scheduling a meeting regarding the survey results.
