General Development Plan Revisions Public Information Meeting Southern High School, Tuesday, February 3, from 6:00 until 9:00 pm

Residents of Anne Arundel County are invited to learn about and help plan the future of land use in the County.

The Department of Planning and Zoning scheduled public information meetings to make the public aware of the current Development Plan and the proposed revisions that will help guide growth and public services in the county. The forum for south county will be held February 3 from 6:00 until 9:00 pm at Southern High School. Other forums will take place Monday, January 26, at Annapolis High School; Wednesday, January 28, at Old Mill H.S.; and Thursday, February 5, at Meade H.S.

Anne Arundel County's General Development Plan is a comprehensive land use plan prepared in compliance with State requirements and guidelines, a policy document formally adopted by the County Council. It establishes policies and recommendation to guide land use decisions over a ten to 20 year period. County officials use the GDP in making decisions about growth and development, land preservation, resource protection, and the provision of infrastructure and services. Current zoning is based on the last revision of the GDP. The goals of the GDP are to

- keep South County rural;
- revitalize older communities, and
- create mixed-use, transit-oriented development.

The GDP is revised every ten years; the last revision, starting in 1998, used volunteer citizen advisory groups to study 16 Small Areas and recommend plans for future growth. This was a lengthy and laborious process, after which the recommendations were finally enacted into legislation. The last of the 16 Small Area Plans took eight years to be approved and enacted. County Executive John Leopold did not want to repeat that time-consuming process for this revision.


The Draft GDP will be available for public review on the county's web site, www.aacounty.org/PlanZone/LongRange/GDP.cfm.

Funding is a major issue in revising the plan. Funding for many of the coming developments, such as the consequences of the federal Base Realignment and Closure (BRAC), is already incorporated into the General Development Plan. The influx of government employees at every level will create the need for more and better infrastructure in the form of roads, transportation, and public safety. Upper-level officials will want to move to higher priced neighborhoods throughout the county, not only in north county near Fort Meade and Odenton.

Public comments and requests for consideration of zoning changes may be submitted between January 20 and February 16th by email addressed to GDP2008@aacounty.org. Now is the time for citizens to ask for changes in current zoning classifications.



Septic system upgrade legislation fails

Bill # 84-08 would have required new home construction— in areas designated as on-site waste management problem areas and in the Critical Area and Bog Protection overlays—to include nitrogen removal technology for their septic systems. The idea was that homeowners would be eligible to receive government grants to fund the upgrades. The bill was defeated by a Council vote of five to two because of concern that public funding to reimburse homeowners for their expenses would not be available.

All around us: More commercial zoning?

In December Joan Turek wrote, “Were you aware of the up-zoning in Edgewater next to South Arundel vets to permit building of a medical building--they got a variance last [September] and now want to make the entire corner of Rt 2 and 214 commercial. An accident guaranteed to happen.”

According to the last General Development Plan, the land south of #214 is to be kept in RA zoning, except for grandfathered spots already in commercial use. The parcels in the strip between South Arundel Veterinary Hospital and the corner are held by different owners, including the State of Maryland, the Parlett family, and other individuals. The owner of the two parcels next to the vet office is Albert Stevens. The corner lot is owned by Steve Margousis of Bethesda, and has been on the market for several years, zoned RA.

Standing on Sands Road

DACA is not alone in seeking changes in the requirements for legal standing to speak on zoning change applications and new developments. Chesapeake Bay Foundation’s suit against EPA, support from the South River Federation, Magothy River Federation, CEPA, and Harwood Civic Association are just a few of the associations that claim a voice on local issues.

Local organizations that wanted information and opportunity to speak on the proposed expansion of the Riddle Sand and Gravel Mine on Sands Road were blocked because only landowners within 175 feet were notified of the application. In rural areas, neighbors as far away as a mile can be adversely affected by land use decisions. A hearing on a motion to dismiss the case for the proposed gravel pit expansion was scheduled for Thursday, January 15, 5:30 pm before the Board of Appeals.

County Executive John Leopold replied to Will Biddle’s letter “Standing on Sands Road”

“Thank you for your kind words and for your thoughts on the legal issues regarding ‘Standing’. It is my understanding that the Maryland General Assembly will address this issue again during the 2009 session. My staff will closely monitor legislation and the debate surrounding this issue.

Council member Cathleen Vitale, District 5, on the General Development Plan

Perhaps the largest project on the horizon for the County Council will be addressing the General Development Plan. Of all the legislation the Council will undertake, other than the budget, the GDP is the most important. For the first time, State legislation dictates that our plan provide a fiscal assessment of the impacts of future land use plans on area water resources, including water and wastewater supply capacities and local tributaries. There has been a push by the current State administration to focus on environmental impacts, and the county GDP will serve as one of those tools. The document, when finished, is to combine the work of the citizen small area plans and new local and state laws to create one comprehensive tool to be used by both the County and citizens for small and large development, preservation and environmental plans.

The draft General Development Plan can be found on the County's website by going to www.aacounty.org and scrolling down to the GDP Homepage. Once there, you can download any one of the many background area reports, which make up the draft plan. The document itself is some 250 pages. Reading it on line is one way to save trees and expenses.

Public input is critical to the success of the plan. As we saw with the small area plans of the last revision, citizens have an incredible grasp on the needs and

resources of their particular area. Because of citizen input, the County created commercial revitalization districts, mixed-use zoning and preservation areas. The County administration has scheduled four public forums where citizens can be briefed on the General Development Plan. [See page one].

Much has been written over the last several months about the lack of public input, inability of community activists to disseminate the plan to their community membership and the feeling that we have been left out of the process.

The plan is much more than mere zoning. The policies and strategies that the county will approve are as important as what can be built on what site. I urge each community group or community umbrella organization to hold your own forums. Learn what the County believes its vision for your area is, and if that vision is not yours, STAND UP and SPEAK OUT. As I have said in the past, your voice is the most important advocacy tool you have. I will be glad to see you attend these meetings with me and to provide input where you disagree and agree on the GDP. Call me at 410-222-1401.



PST rubble landfill emits hazardous chemicals

The County Health Department notified residents within a quarter mile of the former rubble fill on Sands Road that elevated levels of heavy metals beryllium, cadmium, and chromium were found in the water of monitoring wells drilled around the landfill site. Before the landfill was closed, PST contributed money for local community organizations. The remaining funds were allocated to the Chesapeake Environmental Protection Association to monitor the local water supply. Sprinklers in new homes

The County Council enacted legislation by a vote of six to one on January 5 to require sprinkler systems in new construction of private homes. Homes on wells with insufficient water pressure to serve the sprinkler will be exempted. Ed Woods is the Legislative Director for the State Fire Chiefs Association; he testified in favor of the legislation. He said the cost of installing a sprinkler system in a new home is about \$1.10 per square foot, or about \$3,000 in a home of 2,500-3,000 square feet.

After the fire at 1070 Governors Bridge Road two weeks ago, Don Riddle told Gail Enright that the farms

of Homestead Gardens have two ponds on Governors Bridge Road west of #424; one already has a system for fire fighters to withdraw water and they are planning one for the former Russell Rossback property. The ponds hold ground water and are sometimes fed by streams and springs. Having a pond nearby for fire fighting may reduce a homeowner's insurance premium.

Ed Woods said he has access to four hydrants provided by the Department of Natural Resources: the two at Homestead's farms, one for the pond at Homestead's site on Central Avenue, and one more to place where it will be needed. He said the fire at 1070 Governors Bridge was put out in five minutes, with damage to only part of the house. He praised County Executive Leopold for supporting increased and improved fire fighters training programs.

Anne Arundel County Farmers' Market (from the web site)

The Anne Arundel County Farmers' Market was first organized in 1981, by the County Office of Planning and Zoning. The Market was sponsored by the Anne Arundel County Farm Preservation Board, Farm Bureau, Co-operative Extension Service, and the Maryland Department of Agriculture. It opened its first season in the Board of Education parking lot on Riva Road on Saturday, June 27, 1981. It had no building and only a handful of vendors. The season was very short, with summer produce only.

The Anne Arundel County Farmers Market remained at the Board of Education site for three summers. In 1984, the first building to house the Market at the corner of Riva Road and Truman Parkway was dedicated by County Executive O. James Lighthizer. Over the years, the number of vendors grew to more than fifteen, the season lengthened, and the variety of items offered also grew.

In 1992, the second building was dedicated by Robert R. Neall and the Anne Arundel County Farmers' Market was privatized and became a nonprofit corporation.

In 1994, the Farmers' Market dedicated both buildings to the memory of Michael R. Cirino, the market's first manager. The Farmers' Market participates in the State WIC Program, to provide fresh fruits and vegetables to women, children, and infants, and the Senior SFMNP program to redeem coupons for fresh produce at the farmers' markets.

Martin Zehner of Davidsonville is president of the Farmers' Market and he has overseen the many changes over the 28 years since the first gathering of farmers. The market now has more than 60 vendors. It is open three days per week in the summer season. A huge variety of items is offered and the season runs from mid-April to the Saturday before Christmas.

The Farmers Market will hold its annual meeting in February and work out the 2009 schedule. They anticipate cuts in funding from the Tri-County Council.

A winter farmers market is open every other Sunday morning at the Nordstrom parking garage, offering food items and crafts. It is not affiliated with the Anne Arundel County Farmers Market.

Then in a flurry of splashing they shouldered aside the large water turtles to grab a mouthful. The fisher family's six-year-old daughter told us, "Don't fall in. They will eat you!"

At DACA's December meeting Bea Poulin reminded the Executive Committee that our Council representative, Ed Reilly, is serving as Council Chairman. She announced that 400 people attended the opening of the ice rink at Quiet Waters Park. She spoke of the needs for the cutbacks in the County's 2009 budget. 

pleased that a majority of the County Council recognized the will of the taxpayers to stop subsidizing new development. This legislation will help fund our school construction and road improvement needs, thereby enhancing our ability to be competitive in the regional and global economy. The impact fee is levied at the beginning of construction.

The current impact fee for a single-family detached home is \$5,096. Under the revised bill, a new house at 3,000 to 3,499 square feet will cost \$2,272 in January 2009. In January 2010, the cost will increase to \$4,546. In January 2011, it will increase to \$11,363.

The current impact fee per 1,000 square feet of retail space is \$3,140. In January 2009, the cost will decrease to \$1,405. In January 2010 it will increase to \$2,811, and \$7,027 in January 2011. The new fees take effect in January 2011 after a period in which lower fees will help preserve and create jobs.

Jerry Walker is on the Citizens Advisory Committee on Impact Fees. The CAC recommended that the full cost of impact fees be charged. Jerry reported that the amended fee structure was never mentioned to the CAC nor were they informed of the changes before it went to the Council.

Due to the current state of the economy, fewer new homes are being built, thereby decreasing environmental and infrastructure impact. For the same reason fewer zoning issues are being heard. In December 26 homes were under construction on the Mayo peninsula, three on Muddy Creek Road, and several in Severna Park—mostly large homes, not modest ones. The County is preparing for the onset of BRAC, to begin taking effect by September 2011.

The Chesapeake Bay Foundation's lawsuit against EPA is seeking to make EPA enforce its own standards for water quality in the Bay. The Chesapeake Bay Agreement is 25 years old and the Bay water quality is worse than ever. Governors of Maryland, VA, PA, and NY have agreed to do something, but it is not happening. The farther away the source of pollution from the Bay, the less the people and leaders there are inclined to change their habits that degrade the Bay – fertilizer runs off farm fields and lawns; Ohio's power plant exhausts are carried by wind straight to Anne Arundel County, which has one of the highest cancer rates in the country, degrading our air quality as well as drifting into the Bay water. Virginia is just beginning to limit the harvest of crabs and oysters.

Stephen LeGendre, after 22 years with the County and ten as Zoning Hearing Officer, is leaving Anne Arundel for a new position with Howard County.






Chesapeake Environmental Protection Association advocates responsible management of water resources

The state of the Bay continues its slow decline, in spite of small steps which are encouraging for their successes but not sufficient to alter the decline. Government leaders are unable to face the consequences of inaction. Among the best catalysts for action are informed citizens who can influence government leaders at all levels. Public education on important environmental topics constitutes the major part of CEPA's annual efforts.

At the 2008 public forum, speakers focused on groundwater resources. Dr. M. Gordon Wolman, Professor of Environmental Engineering at Johns Hopkins University, presented findings and recommendations on Management and Protection of the State's Water Resources. Dr. Robert Summers, Deputy Secretary of MD DNR, gave an overview of groundwater conditions within the state. Robert Shedlock, Hydrologist with the US Geological Survey, discussed the science of groundwater. Several areas of Maryland have experienced water shortages and the threat of further shortages continues. The general conclusion was that while some central Maryland aquifers are under stress, deeper aquifers are adequate for the present. Rapidly changing water usage, especially irrigation for agriculture on the Eastern Shore may cause danger of further shortages.

In 2008, CEPA was awarded a grant from Anne Arundel County to provide oversight of groundwater monitoring by Waste Management at the site of the former PST rubble landfill of Sands Road in Harwood. This may be the largest and last unlined landfill on the east coast (*See Villager page 5*).

CEPA is also following the construction of an additional reactor at Calvert Cliffs Nuclear Power Plant and potential construction of a high voltage power transmission line through Southern Maryland, across the Chesapeake Bay and through Delaware to New Jersey.
