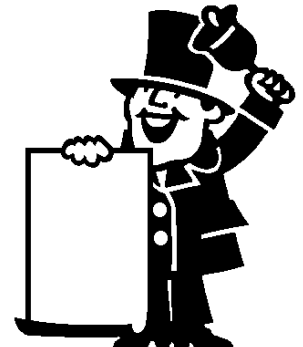

**Why does DACA sponsor Green Expo? It gets results. Ask Bowen’s Farm Supply Company**

DACA and the Green Expo have shown what private citizens can do to improve the environment. Homeowners plant trees in late March; some install rain gardens and pervious pavers in their yards. Businesses improve their properties.

After James Miller of Bowen’s Farm Supply Company saw the effect of the Green Expo in drawing attention to citizens’ efforts, he led the business to install a run-off pond behind their store on Riva Road. Shortly thereafter, local government officials dropped by the store to discuss how Bowen’s needed to manage its runoff. (“We’re from the government, we’re here to help

you,” meaning, “You’re going to do something about it.”) James told them what he had already done without any government assistance. The officials were surprised and asked to see it, so he took them out behind the store to show his business handiwork. They congratulated him on being such a conscientious businessman.

Several families have applied much of what they had learned at Green Expo 2013 to their lives. One bought an electric car, installed solar panels on their south-facing roof, and purchased a second compost bin and a rain barrel. They are very happy with these advances. Others have told of their enhancements as well—solar panels, rain barrels, and rain gardens—as the direct result of Green Expo. In one community, all households are almost religious about recycling. Their yellow bins lined up like soldiers outnumber the trash containers on Monday mornings.

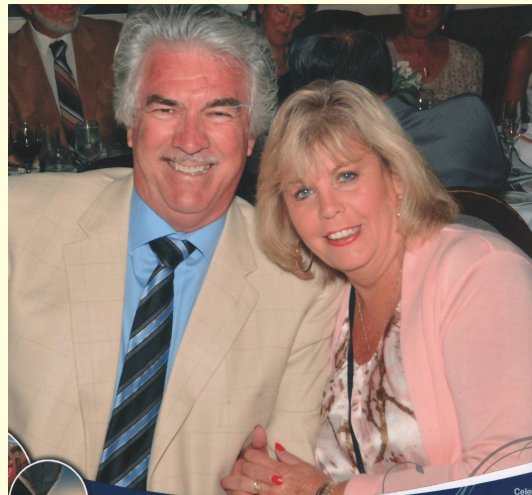

### Gerry Coffman will represent DACA at Police Community Relations Council

Police Lt. David Feerrar and Lt. Richard Alban, of the Southern District introduced themselves at DACA's February Executive Committee meeting. They invited DACA to participate in the Police Community Relations Council, organization of community and civic associations as a means to improve communications within the greater community. Lt. Feerrar stressed communication as the most effective method to reduce crime.

Gerry Coffman, a former law enforcement officer, volunteered to represent DACA at the monthly Council meetings. Any resident is welcome to join the Council. Meetings are held at the police station on Stepney's Lane. In March and April they will be held the third Wednesday of the month; after that they will return to the usual meeting time on the third Thursday. Meetings begin at 7:30 pm.

Compared to other areas of the county, Lt. Feerrar said, we have relatively little crime here, primarily thefts from unlocked autos and break-ins to cars to steal items left visible, in order to buy drugs. Heroin is a growing problem. Lesson to be learned: Don't leave anything valuable in sight on the car seats or dashboard.

Lt. Alban spoke more directly about automobile theft and the heroin problem. He also warned about "spoofing" phone calls in which you are called by someone pretending to be a child, grandchild, or friend, telling you that your child is in trouble and needs money. You should ask for the caller's phone number and offer to call them back.

**Comprehensive Zoning Lawsuit**

*Report from Chesapeake Legal Alliance Attorney Russell Stevenson*



DACA, the Harwood Civic Association, Friends of Jug Bay, the South River Federation, Lothian Civic Association, and a number of property owners are engaged in a lawsuit to oppose spot rezoning of numerous properties in South County, contrary to the existing General Development Plan as it is guided by the Small Area Plan. Russ Stevenson is serving as a pro bono attorney member of the Chesapeake Legal Alliance. On February 2 he wrote,

“Dear Clients and Supporters,

I am very happy to let you know that I have just received the opinion of the Court of Special Appeals in our challenge to the rezoning in South County, and we won on all the issues before the Court. The Court held that there were individual plaintiffs who had standing as adjoining property owners in all but one of the properties in issue. In the case of 1541 Defense Highway, the Court directed that we be allowed to amend the complaint to allege more specific ‘special harm’ from the proposed rezoning.

The Court also ruled that the Circuit Court was wrong in dismissing the case for failure to state a legally

cognizable claim. More specifically, it held that we had properly alleged claims that the zoning changes constituted spot zoning and that they were inconsistent with the General Development Plan. It directed the Circuit Court to allow us to proceed to prove those allegations. In so doing, it interpreted the applicable law in the way for which we had argued.

I wish I could say that this amounts to complete victory. The other side could still seek to appeal the case to the Court of Appeals, although they would have to convince the Court of Appeals that there are reasons it should hear the case. If the other side doesn’t try to go to the Court of Appeals, or fails to persuade it to take the case, we are back in Circuit Court, in effect starting all over, although with the applicable law clarified, very much in our favor.”

Council member Jerry Walker is the author of all the re-zoning applications on behalf of the owners of the properties in question. They had sought zoning changes that would increase residential density or permit some form of commercial use, thereby increasing the value of their land as they put it on the market. As yet, none of the owners have tried to develop the properties under the requested zoning classifications.

**Riva Park to Expand with Purchase of Carr Property in Davidsonville**

*Information from South River Source*

**R**ick Anthony, Director of the Anne Arundel County Department of Recreation and Parks, announced that the County purchased the Carr property on Riva Road in September 2013. The 36-acre parcel adjoins Riva Park and will increase the park to a total of 96 acres. The Carr property is located at the point of the triangle where Riva Road meets Beard's Point Road, just a short distance north of the main entrance to Riva Park.

Anthony said the additional land offers South County residents more open space which will not be consumed in residential or commercial development. The County is pleased to be able to protect the open space while expanding an existing park. Recreation and Parks officials are talking with consultants on how best to use the additional land. A private residence is located at the front of the acreage but the properties are adjoined at the back. The initial thought is to connect the two with a walking trail.

"We hope to have more walking trails along with baseball and multi-purpose fields," said Anthony. It will be several years before the new space is open to the public. Riva Park is located at 3629 Riva Road in Davidsonville. The current facility provides three baseball fields, three multi-purpose fields, two basketball courts, a playground and a paved trail.

**C**onstruction on the Governor's Bridge across the Patuxent River was delayed due to problems with the subcontractor. The project has since been reassigned and the county estimated that repairs would have been completed by February 28, weather permitting. ### Stormwater Management

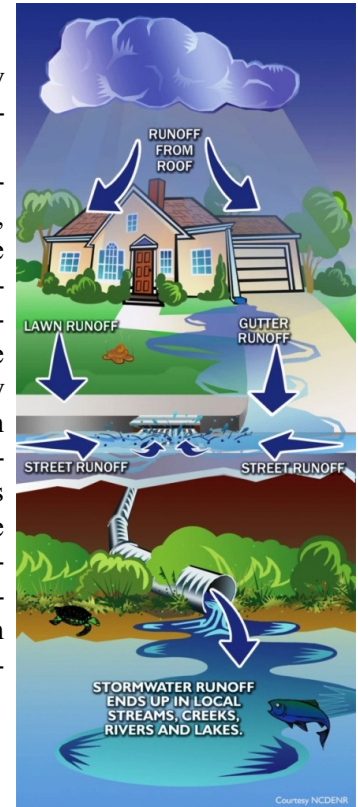
Congratulations to Erik Michelsen on his new job: heading up Anne Arundel County's stormwater management program. He began the new position on February 13 as the administrator of the Watershed Protection and Restoration Program. He has been the executive director of the South River Federation, a local watershed organization that conducts its own stormwater management projects.

To assist in the program, County Executive Laura Neuman announced on January 27 the establishment a Stormwater Fee Advisory Committee. The Committee is to study, review, and gather information to make recommendations regarding all aspects of the Stormwater Remediation Fee and the Watershed Protection and Restoration Program (WPRP).

The Stormwater Advisory Committee members will attend quarterly public meetings to gain an understanding of the extraordinary annual cost to comply with state and federal government stormwater management permit obligations and environmental goals. The Committee will also provide near- and long-term

recommendations to the County Executive regarding the Stormwater Fee and WPRP.

The Stormwater Fee Committee will consist of 15 members, with at least one representative from each of the County's watersheds and Council Districts. Advisory Committee members must be residents of Anne Arundel County and possess a strong interest in the Chesapeake Bay and its tributaries. Committee members should also be knowledgeable about stormwater issues, experienced with budgets and performance metrics, and familiar with environmental regulations. Applications closed on February 28.

The Chesapeake Environmental Protection Association (CEPA) works to restore the Chesapeake Bay by affecting environmental policy and action. CEPA provides education on Bay issues and encourages public activism and involvement in both legislation and enforcement. Our goal is sustainable growth in the region—a future where our precious natural resources are in balance with their use.

The CEPA newsletter publishes readable scholarly articles to help understand how development has affected the Bay. These articles will be printed at irregular intervals in the Villager.

#### Areas of Concern

The limits of the Chesapeake Bay's resources have already been breached by the impact of human activities that affect the watersheds. Unrestricted commercial and residential growth, fueled by permissive zoning, leads to more infrastructure for water supply, sewerage treatment, landfills, roads, county maintenance facilities, schools, and so on. All of these activities impact the Chesapeake Bay.

Citizen activists, like CEPA members, have an urgent role to play in restoring the Bay to health. Specific issues that CEPA's members are focusing on include:

- Over-nutrication from agri-business (fertilizer, manure, animal byproducts, etc.)
- Point source pollution and nutrification from sewage treatment plants and industrial and municipal facilities
- Silt and biological and chemical pollution from runoff

- Marine life sustainability issues including disease, invasive/alien species, and over harvesting
- Ground water resources (purity, depletion, and recharge)
- Shoreline erosion

CEPA is an outgrowth of a group formed when BG&E proposed a 500-foot right of way for a power transmission line from Calvert Cliffs to Odenton. This line was not designed to national standards for power lines regarding property rights, esthetic design, etc. Many of the issues were resolved by negotiating with BG&E. Since then, CEPA has been involved with many other Bay issues, such as the depletion of our aquifers, farm preservation, and ground water contamination.

### The Need Does Not Go Away

For the past five years since 2009, DACA has made donations to the eight churches in Davidsonville. DACA had received an unexpected gift of about \$6,000 in 2006 when the Friends of Rural Preservation closed its books and distributed its treasury to DACA and several other local non-profit organizations.

Friends of Rural Preservation (FRP) was a community organization formed when a development project was proposed that was not consistent with the rural nature of the Davidsonville community. They worked to enact legislation that would require public hearings and community input prior to development. At that time there was no legislation to require any community input in a proposed development. After such legislation was enacted, FRP had accomplished its goal and dissolved the organization. It shared its treasury with other like-minded organizations. DACA's primary objective was still to promote land use policies that preserve the agricultural and rural character of the Davidsonville community, protect the environment, preserve open space, and improve safety, including the safety of roads and pedestrian byways, while respecting the property rights of residents.

In 2009, when the economy made a lot of people suffer, DACA's board decided to try to help local people in need. The method of choice was to let the local churches, each of which had a distribution system in place, expand their outreach services to their Food Bank clients. From 2009 through 2012, DACA gave away \$2,000 every year, \$250 to each of the eight local churches, stipulating that the money be used to help residents of Anne Arundel County.

Shrinking DACA's treasury by \$8,000 without a commensurate income caused the board to rethink this effort in 2013. Last December DACA gave away \$1,000—\$125 to each church—and determined to invite the residents of Davidsonville to put the churches

on their support list. All these charities are tax deductible to the donor. As it may please you, send your contribution(s) to any or all of the following churches and designate on your check whether it is to be restricted to any particular outreach program.
