

Member vote at Annual Meeting to amend DACA Bylaws

everal years ago, DACA lost a lawsuit and had to pay court costs shared with three other organizations. As a result, the board and general membership approved limiting DACA's interests to "the geographical area known as Davidsonville" as described below in Article III of the Bylaws. Given DACA's decision last year to expand its area of interest to include more of South County, it is past time to strike that limitation from the Bylaws. Proposed language can be changed to "areas of concern in neighboring South County" or similar wording. The DACA Board will discuss and prepare approved language to be presented and voted on at DACA's Annual Meeting on June 6.

ARTICLE III: PURPOSES

The purposes of this association shall be

A. To consider and deal by all lawful means with common problems involved in matters pertaining to land and natural resource utilization in the geographical area known as Davidsonville and to secure cooperative action in advancing common purposes of the members of the association.

- B. To do anything necessary and proper for the accomplishment of any purposes set forth in the statement of principles adopted by the founders of this association.
- C. This association is organized and operated for the above stated purposes exclusively, and for other nonprofit purposes, and no part of any net earnings shall enure to the benefit of any private member.

Mount Airy neighbors' questions about Mount Airy Center's proposal for certification for institutional use

The Mount Airy Center, 869 Mount Airy Road, applied to the County Office of Planning and Zoning for certification for a designation as Institutional Use for Religious Purposes. Residents of Mount Airy Road, Meadowoods, and Royale Glen are concerned that Institutional Use, as described in the application, may bring unwanted change to their neighborhood. After a series of public and private meetings in November, they requested a discussion with representatives of the Mount Airy Center to answer their questions.

On December 9, DACA members Brian Stanton, Bridget and James Blake, and Malcolm Rice-Wolfe had a cordial meeting at the Center with MAC representatives Marty and Ann Sherman, George Madison, and Gerard Helminiak, where they raised the following issues:

- Preserving Davidsonville's rural and residential character
- Noise and traffic
- Landscaping
- Safety
- Transparency

After the meeting, Mr. Sherman responded with the following message on December 11:



Hi all.

I wanted to thank you for initiating the meeting on Sunday. We want to be good neighbors who are hearing your concerns about the use of the house. The following is what I took away from the meeting:

Concern about the house/property becoming a 'mega-church' - We have no plans to become a mega-church. Our meetings have always been on a small scale; no more than 10-25 people at a time. If we have larger gatherings they happen only a couple of times a year.

Concern about parking - There is no plan to expand the parking.

Concern about adding to traffic - Our traffic won't change from what it's been for the last two to three years. On a daily basis there are usually no more than 6-10 cars coming and going.

Concern about intern vetting process - we are looking into expanding our vetting process. We currently do require them to fill out an application with references and they are interviewed at least once if not more by two of our mentor team. They are usually students who've been coming to the National Student Leadership Forum over their college years so they become quite well known to us.

Start School Later, Anne Arundel County

2018 was a year of change in Anne Arundel County as we elected four members to the Board of Education for the first time. Districts 2, 3, and 6 will elect BOE representatives in 2020. The new Board members are already changing the dynamic of the Board by asking good questions and having more public discussions.

School start time was pushed back by only a few minutes last year. Better communication about transportation would ease the problems of too early school starts. SSL would encourage you to attend Board of Education meetings and send email to the board members to ask for a smartphone-based app that would allow students and families to know just when their school bus will arrive. Such an app would help reduce the back-to-school chaos caused by bus schedules, frequent road closures for accidents and other incidents, and winter weather delays. Many locations around the country, including next door in Prince George's County provide such apps. They use the GPS transmitter already installed on the buses associated with the route planning software. It is a good step towards technology integration and transparency. The cost of this item was not included in Superintendent George Arlotto's proposed budget.

The key outstanding issue is how and when to memorialize these issues so that they convey with the property in perpetuity. We explained our desire to ensure that future owners of 869 Mt. Airy Road don't take advantage of the new "institutional use" designation to undermine this understanding. They said that they were open to making these commitments part of the deed and/or giving an easement to the immediate neighbors, subject to consultation with their lawyer.

DACA Business from the December Minutes

The sign is coming, so they say! Welcome to Davidsonville sign: Jeff Potts at Signs by Tomorrow said it should be done by Christmas (or soon thereafter). Brian Riddle said Homestead Gardens is ready to install it. Installation will require trimming some of the brushy growth on the hill at the curve in Davidsonville Road.

DACA Vice President Ed Woods follows, pursues, and keeps after the issues on our roads. He reported on specifics in December. He postponed revisiting SHA about the issue of the solid red arrow left turn signal from #424 to #50 eastbound ramp until the welcome

sign was approved by SHA. Now he is back on it, in the effort to get it changed back to a blinking arrow to allow a left turn after a stop so drivers are not forced to stare at an empty roadway when it is safe to turn to the ramp.

DACA member Ray Meyer telephoned BGE and the State Highway Administration numerous times about the missing street light at #424 and Rutland Road before contacting DACA. They passed him back and forth, both disclaiming responsibility. Ed is pursuing this.

Ed tours the Davidsonville Park and Ride lot from time to time and saw that it is being used as storage for commercial vehicles, maybe abandoned; some have been there for months; he saw one with tags expired in September 2017, one with West Virginia tags.

He is trying to learn purpose of the covered up detour signs at #50 and #424 and at Rutland Road and #450. He wants to let local drivers know which roads are to be closed, when, and why.

Regarding road realignment at Cambria, Bruce Stein said BGE has finished moving the power line poles; Verizon has not begun to move its underground cables, but they may be done by July, and then road construction can begin.

AA County Immigration Screening Program

Anne Arundel County Executive Steuart Pittman held two town hall meetings to discuss his decision to end the County's 287(g) immigration screening program and to listen to residents' concerns about immigration. Police Chief Timothy Altomare and Acting Superintendent of Detention William Martin participated.

The first took place on January 14, in the Pascal Senior Activity Center in Glen Burnie; the second, at Southern High School, was on Wednesday, January 16.

The politicization of immigration policy has divided communities locally and all across America in recent months. These two meetings were an opportunity for county residents to express their concerns to the County Executive, the Chief of Police, and the Superintendent of Detention, who provided information on the role of county government in both local law enforcement and federal immigration enforcement.

A zoning win for Davidsonville residents?

he owner of 1121 Double Gate Court applied to the ▲ Office of Planning and Zoning for a variance to allow lots with greater density than allowed on property on the south side of Double Gate. She wanted to subdivide her land and create an entrance to the back lot from Green Ash Road in Meadowood. Four Meadowoods homeowners attended the hearing on December 11 and testified in opposition to the subdivision and the Green Ash Road access to the lot. Kate Fox represented DACA and spoke against the subdivision of the lot. The Meadowoods residents had a petition signed by 23 homeowners voicing their strong objections. Planning and Zoning recommended to the hearing officer that the request be denied. After testimony concluded and before the hearing adjourned, the applicant proposed that in lieu of the subdivided lot driveway apron being attached to the Green Ash Road right of way, she was willing to provide an easement for a driveway through her lot back to Double Gate Road.


On December 27, the hearing officer announced his decision against the subdivision. The owner may appeal the decision and she has until January 26 to decide. The residents of Meadowood say they will be ready if she does so.

Solar panels on Palomino Court?


The owner of 711 and 705 Palomino Court applied for a variance to allow solar energy panels on the 19.18 acre parcel at 705 Palomino Court, zoned RA, without a structure on that lot. The owner's residence is at 711 Palomino Court. The owner of the adjoining property at 805 Antietam Court plans to attend the zoning hearing on January 17 to learn more and to oppose it if it will have an adverse impact on her property. All three lots were subdivided many years ago from the original Idlewilde Farm on Davidsonville Road.

Citizen Advisory Committee (CAC) requests comments on General Development Plan background reports

Although the new County Executive has told the CAC that some changes will be made in its composition, specific details remain unknown. The CAC continues to evaluate the large amount of information on the County and the current GDP that has been assembled by County staff. Accurate and complete information of this type will be essential to preparation of the new GDP and Small Area Plans.

The Alliance for Livable Communities and Growth Action Network members of the CAC have asked that interested members of the two organizations assist them in their review of the seven GDP background reports drafted by County staff that are currently available at the County's GDP website. The most recent of the reports, "Transportation," has just become available. PowerPoint presentations for each report, which are posted on the ALC website, are also available for review and provide some supplementary information.

The CAC members asked that ALC and GAN members who review the background reports provide them with feedback in writing. ALC members who review reports and the accompanying presentations are asked to send

their feedback to Kim Brandt, who will pass it along to the CAC members.

Issues that the background reports raise, include

- poor implementation of the 2009 GDP and the lack of a structure within the county government to foster implementation and accountability for action items:
- the lack of a facility in each council district that can be used as a shelter for residents if needed;
 and
- the lack of a Planning Commission and a Historic Preservation Commission to provide greater transparency and citizen involvement.

The CAC met on December 19.

Transition Committees for the new administration are listed on page 3 of this Villager.

A number of ALC steering committee members, including Ann Fligsten, Richard Falk, and Jon Korin, are serving on the Thriving Communities and Sustainable Communities transition committees that were set up by the new administration. Each committee will formulate a list of short-term and long-term recommendations by early February.

Bird counters recorded 48 species of birds between 7:30 and 10:30 am within two miles, including 432 Canada Geese, 5 Tundra Swans, 11 Mallards, 163 American Black Ducks, 150 Northern Pintails, 1 Green-winged Teal, 2 Bufflehead ducks, 2 Pied-billed Grebes, 5 Great Blue Herons; 3 Black Vultures, 6 Turkey Vultures, 3 Northern Harriers; 1 Cooper's Hawk, 7 Bald Eagles; 2 Sora heard in the marsh repeatedly for 20 minutes; 6 clear views of Greater Yellowlegs in open marsh; 1 Bonaparte's Gull, 565 Laughing Gulls, 203 Ring-billed Gulls, 12 Herring Gulls; 2 Mourning Doves, 1 Belted Kingfisher, 1 Red-headed Woodpecker, 3 Red-bellied Woodpeckers; 1 Yellow-bellied Sapsucker, 2 Downy Woodpeckers, 1 Hairy Woodpecker, 1 Northern Flicker, 3 Blue Jays, 2 American Crows, 40 Fish Crows; 3 Carolina Chickadees, 3 Tufted Titmouses; 1 White-breasted Nuthatch; 3 Carolina Wrens, 3 Golden-crowned Kinglets; 3 Hermit Thrushes; 4 American Robins, 1 Gray Catbird, 4 Yellow-rumped Warblers, 1 Dark-eyed Junco, 20 White-throated Sparrows, 1 Song Sparrow, 1 Swamp Sparrow, 4 Eastern Towhees, 5 Northern Cardinals, 300 Red-winged Blackbirds, and 1 Rusty Blackbird..


