

# Davidsonville Area Civic Association

## Gail Enright Educational Scholarship

**Apply by June 30, 2022, 11:59 pm (ET)**

The Davidsonville Area Civic Association's Gail Enright Educational Scholarship has been created to help DACA members and their dependent children pursue educational training — academic, technical, agricultural, or professional. The scholarship was launched through a donation by Davidsonville resident Tom Angelis. The fund's growth depends on the generosity of our community.

The scholarship is available to high school seniors and graduates of any age.

### **Purpose & Limitations**

1. Scholarship funds must be used for educational training (academic, technical, agricultural, or professional) after high school.
2. The scholarship is available to high school graduates of any age for post high-school education.
3. Each award will be for \$1,000. The number of scholarships awarded by DACA in any given year will depend upon the amount of funds available.
4. Awardees may reapply annually for additional funds, although renewal of the scholarship is not guaranteed. Awardees may receive a maximum of four DACA scholarships.
5. Previous applicants who were not selected for an award may reapply.
6. Scholarship awards are made at the discretion of the DACA Board of Directors after deliberating the recommendations of the DACA Scholarship Committee.
7. Scholarship funds will be delivered directly to the educational institution the awardee will be attending. DACA's Treasurer will contact the awardee for the necessary information (e.g. payment address, student ID number, etc.)

### **Qualifications**

1. The scholarship applicant must be either a dues-paying member of DACA or their dependent who resides within the DACA geographic area, as defined by the DACA Bylaws. The applicant's legal address must be within DACA's geographic area.
2. The applicant must be a high school senior or graduate.
3. The applicant must be able to demonstrate involvement in one or more community activities, preferably within the Davidsonville area and they must be able to document that involvement (see Required Documents).

*Note: Family members of DACA Board members are permitted to apply for a scholarship. In those cases, Board members with student applicants will recuse themselves from any of the evaluations and award decisions for that year's applications.*

## Required Documents

The applicant must include the following documentation at the time of their application. Incomplete submissions will not be considered.

1. The name of the **Educational Institution** where the scholarship funds will be used.
  
- 2-a. For high school students or graduates starting a new educational program, a **Letter of Acceptance** to the educational institution for which the scholarship funds will be used. (If the applicant has not yet decided on the school or program they will attend, copies of acceptance letters from all schools or programs the applicant is considering should be provided.)
  
- 2-b. For applicants already in a post-high school educational program, a **Transcript** of their grades for the year just completed.
  
3. A list of the applicant's **Community Involvement and/or Volunteer Activities** within the past year in and beyond the Davidsonville area. Provide the organization name(s), the role(s) served, date(s) of service, and contact information for an officer or representative of the organization. If the applicant desires, they may separately list community involvement and/or volunteer activities for the previous two or three years.
  
4. A **Letter of Reference** from a responsible representative overseeing at least one of the applicant's community involvement or volunteer activities in the past year (e.g., coach, teacher, counselor, youth pastor, troop, club or group leader, mentor, supervisor, sponsor, advisor, etc.).

## Required Form & Essay

1. A brief **Application Questionnaire** is available as an online form as well as an editable PDF (downloadable at the end of the web page). If necessary, the applicant can provide the required information via a typed Word or similar document so long as the items are numbered in the same way as the official form.
  
2. The applicant must provide an answer in writing (no more than 250 words total) to one of the following **Short Answer Essay** questions:
  - a. *"What do you value about living in Davidsonville and why?"*
  
  - b. *"If you could change or improve one thing about Davidsonville, what would it be, and why?"*
  
  - c. *What field of study are you interested in pursuing, and how might it be important to your community and/or to the environment?*

## The Deadline

The application consisting of the completed questionnaire as well as required documents (detailed above) must be submitted by **Thursday, June 30, 2022, 11:59 p.m.**

Applications received after the due date by email or postmarked after the postal deadline will not be considered.

The application package may be submitted through our online submission process, via email or by traditional postal mail.

## Delivery Options

**Online:** This option is available by clicking the "Apply Here" button on the website. After answering a few brief questionnaire fields you will need to attach documents containing your longer answers and other required materials.

**Email:** Responses can be provided via an email with PDF attachments to *scholarship@daca-md.org*.

**Postal mail:** Address the package to: DACA Scholarship, PO Box 222, Davidsonville, MD 21035.

After mailing the package, notify DACA by email to *scholarship@daca-md.org* so we know to expect delivery. Receipt of an application will be acknowledged within two business days.

The applicant names and other identifying details will not be shared with the full committee or DACA board until after approval of the awardee(s).
- Applicants selected to receive a scholarship agree to allow DACA to identify them by name in The Villager, on this website and/or to media outlets.
