The carrier agrees to maintain all the proper licenses and permits to conduct business as a motor carrier in the area of intended operation. Additionally, carrier agrees to maintain liability insurance and cargo insurance at the amounts set forth by the home state of the carrier.

L.O Jackson Dispatch INC will be held harmless in the event of any and all claims. The carrier agrees to maintain an account with ( an internet load board service), in the name of the carrier, with L.O Jackson Dispatching INC as the point of contact for dispatching purposes.

The Fee for Dispatching Services will be 7% of the gross revenue of each shipment with no minimum charge.

As Loads/Freight Cargo are picked up, and amount equal to the above stated amount percentage will be payable to L.O Jackson Dispatching INC . Payments are to be conveniently paid with any Debit or Credit Card via Text or Email Invoice App Processed by square
