## OUR POLICIES - WEDDING DAY LOGISTICS

Congratulations! The team at Amour4Beaute Hair Care Essentials LLC is ecstatic and honoured to be involved. Hair We Go! On this special day our duty is ensure and provide the most memorable and stress free glam session possible. Planning to execute all services in a timely manner following a schedule. All I ask is that the Bride/ Wedding planner please communicate the importance of being on time and properly prepare all individuals receiving services with these simple instructions prior to the big day.

Everyone receiving services must arrive shampooed and ready to style. Free from excessive amounts of oils, Hairspray and product buildup.( Little to no product preferred) That's it and that's all. We are here to do the rest, Let's create beautiful memories! We look forward to making this happen! You and your wedding party are very important to us and we will make every effort to ensure your day is special.

• 2 Stylists will be guaranteed on the wedding date. Whom will be available to service those listed on page 2 including the bride. If there's any additional requests for services the day of the Wedding we will try our best to accommodate those in need. However, Additional fees will be charged. \$50.00 USD will be added to the total balance due per additional Client.

### Clients Responsibility/Preparation:

It is the Clients responsibility to provide a safe and adequate working environment. If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply. The hair stylist will not be held liable for any injuries that should arise while in a location caused by conditions within the venue.

The location must include:

- Lots of natural or lamp lighting
- Outlets
- Table for Styling Tool & Products
- Enough chairs

### Wedding Trial:

*An introductory consultation is part of the bridal hair services and is used to go over all details of the big day and the creation of a style. A hair trial run is necessary to guarantee accuracy and timing so that we have enough time set aside for your special day. Please bring any hair accessories, jewelry, veils, or other wedding-related accessories with you. Any further trials will incur a \$100 fee Per Hr.*

### Payments Schedule/Deposit:

A retainer fee/deposit of 35% is due no later than 1 week after the Wedding Trial to secure the date no later than 6 months prior to the wedding date. Or at the time of booking; this payment is non-refundable and must be paid in order to secure your event day. Last half needs to be paid a week before the Wedding Date, unless otherwise agreed upon. Regardless of internal arrangements between the bride and bridal party/others receiving services. The payment can be made using Debit, Credit, ApplePay, and Invoice Electronic Payment Link.

### Luxury Bundle Booking:

**Wedding Day Luxury:** Day of styling by appointment the morning of the wedding. Half Day, Stylist available for the full duration of wedding preparation and first look photos at the initial Styling location .

**Wedding Day Full Luxury :** Day of Styling by appointment the morning of wedding, Including Half Day, Stylist available for the full duration of wedding preparation and first look photos at the initial Styling location.

- 1 location travel (Wedding Venue / Reception Venue) Including touch ups if desired before walking down the isle or Wedding Reception Grand Entrance.

**Wedding Day Grand Luxury :** Wedding day styling by appointment morning of wedding FULL DAY RATE. Including touch ups for photos / First Looks after initial styling.

— 2 location travel (Wedding Venue and Reception Venue) Including touch ups if desired before walking down the isle and Wedding Reception Grand Entrance, In addition to style Change (Pin up/ Take down initial ceremony style, In Addition to Removal of Hair accessories ,Vail ect.

### Travel:

There will be a \$50 charge for travel over 15 miles outside of Hermosa Beach, Ca zip 90254 to the Location. In addition to this fee the bride will be responsible for parking fees the stylist must pay at the service location. ( if applicable )

### Cancellation/Liability:

Any cancellations made on the day of the ceremony will be charged in full. You will receive a refund of your initial deposit less a \$100 scheduling fee if the entire wedding party cancels within 30 days of the planned appointments. A deposit will be forfeited if less than 30 days' warning is given. In the event of unforeseen circumstances, should the stylist have a personal emergency that prevents her from performing services as agreed. All efforts will be made to ensure that a replacement stylist will be present to perform the contracted services. Should an emergency occur so last minute that no stylist can be made available, all fees will be refunded.
