### 11) Transgender Transitioning

Transgender individuals feel that they do not fit into the role that their society traditionally assigns to their physical sex. While being transgender is **not** a psychological condition, distress related to it, known as gender dysphoria, is.

Transitioning is the point in a transgender person's life when they start to express themselves in a way that they feel is true and accurate. This may involve using a name that they feel better fits them, selecting a wardrobe that does the same, gender affirmation surgery, and/or preferring to be addressed with particular personal pronouns (such as he, she, or they).

Another way an individual may seek to feel more like themselves can involve changing legal documentation to match a new name. Doing such can help one feel more like themselves, and alleviate some aspects of gender dysphoria.
