

Whitelist our emails !

To make sure you never miss important emails from us, please follow the steps below to whitelist our domains (@Republicfortheunitedstatesofamerica.org and @republicoftheunitedstates.org) in your email account. This will help ensure our messages go directly to your inbox and are not sent to spam or junk folders, or blocked entirely.

Yahoo Mail (*UPDATED*)

1. Log in to your Yahoo Mail account (ONLINE).
2. Click on the 3 dots on the left side, then Settings.
3. In the list on the left, click Filters.
4. In the second column, click "Add new filter"
5. Name the filter (e.g., "Republic 1").
6. In the From field, click "contains" and enter filter value:
@Republicfortheunitedstatesofamerica.org
7. Set the folder name to Inbox (you probably have to type it into the second field).
8. Click Save.
9. Repeat this for the other domain (@Republicoftheunitedstates.org)

Gmail (Google Mail)

1. Log in to your Gmail account.
2. Click the gear icon and select See all settings.
3. Go to the Filters and Blocked Addresses tab.
4. Click Create a new filter.
5. In the From field, enter: @RepublicfortheunitedstatesofAmerica.org
6. Click Create filter.
7. Check Never send it to Spam (and optionally "Always mark it as important").
8. Click "Create filter" again.
9. Repeat this for the other domain (@Republicoftheunitedstates.org)

Outlook.com / Hotmail / Live

1. Log in to your Outlook.com account.
2. Click the gear icon and select View all Outlook settings.
3. Go to Mail > Rules.
4. Click Add new rule.
5. Name the rule (e.g., "Allow @RepublicfortheunitedstatesofAmerica.org").
6. Under Add a condition, select From and enter:
@RepublicfortheunitedstatesofAmerica.org
7. Under Add an action, select Move to and choose Inbox.
8. Click Save.
9. Repeat this for the other domain (@Republicoftheunitedstates.org)

On iCloud.com:

1. Log in to [iCloud Mail](#).
2. Click the gear icon and select Rules.
3. Click Add a Rule.
4. Set "If a message is from" to @RepublicfortheunitedstatesofAmerica.org.
5. Set "Then" to Move to Inbox.
6. Click Done.
7. Repeat this for the other domain (@Republicoftheunitedstates.org)

On Apple Mail (Mac/iOS):

1. Open the Mail app.
2. Go to Mail > Preferences > Rules (on Mac) or Settings > Mail > Rules (on iOS).
3. Click Add Rule.
4. Set the condition to From contains
@RepublicfortheunitedstatesofAmerica.org.
5. Set the action to Move message to Inbox.
6. Click OK or Save.
7. Repeat this for the other domain (@Republicoftheunitedstates.org)

If You Find Our Emails in Spam or Junk

- Open your Spam/Junk folder.

- Find and open any email from either of the Republic domains.
- Mark it as Not Spam or Move to Inbox.

This helps your email provider recognize our emails as safe.

Maintaining Republic Parallel Status

"So, having documented above the key instances where it was necessary for the Interim Government to give Lawful notice to the *de facto* UNITED STATES corporation, and acknowledging that we continue to operate parallel to said corporation, we see no current requirement to give further notice. Let it be known that any agent (or officer of the Republic), unless authorized by the President in writing, has no Lawful authority from the Republic to serve notice on *de facto* officers on behalf of the Republic; and, if they do so, then they are acting in their own private capacity and DO NOT represent the Republic."
