The Danger of Nation-States and Lack of Lawful Standing

The concept of nation-states is a dangerous one because it comes in direct conflict with the National Constitution (1789). Since the Republic for the United States of America upholds the Constitution as the Supreme Law of the Land, anyone who advocates for nation-states in this country is in direct violation of the Constitution, plus violating any oath to the Constitution that they may have taken.

The nation-state concept comes from the Articles of Confederation (1781), which was the original agreement between the states before the National Constitution (1789). The Articles failed miserably in their attempt because of “too little federal government” due to the states acting as nations unto themselves, hence the term nation-states.

Therefore, in order to support a nation-state concept, an individual will disregard the National Constitution and revert to the faulty Articles of Confederation. As you can imagine, this individual would be totally incompatible with this Republic. In addition, by violating their oath of office (if they had taken one), they are subjecting themselves to the jurisdiction of the Insurrection Act of 1807 (codified as amended at 10 U.S.C. §§ 251–255). If a county assembly wishes to add nation-state language to their assembly documents, they will not be allowed to represent their county in this Republic. If any county assembly changes their assembly documents to include nation-state language, they will no longer be allowed to represent their county in this Republic. If the assembly documents are corrected to remove nation-state language, and the assembly guarantees a republic form of government for the people of the county, then the Republic can accept the county assembly as representing the people of that county, in accordance with the National Constitution. If the county assembly refuses to correct their documents, then they will be an island unto themselves, isolated from the rest of the counties and states that uphold the National Constitution as the Supreme Law of the Land and who represent the people within this Republic.

Our founding fathers intended the county level of government to be the highest form, which was supported by the state level, which was then supported by the federal/national level. In most cases, the state and federal/national has little to no authority to say anything about how the people govern themselves. However, the one thing that everyone at any level of government can insist upon is that all levels of government MUST uphold the entire National Constitution and all laws passed under it. This includes providing a republic form of government for the people.

Maintaining Republic Parallel Status

"So, having documented above the key instances where it was necessary for the Interim Government to give Lawful notice to the *de facto* UNITED STATES corporation, and acknowledging that we continue to operate parallel to said corporation, we see no current requirement to give further notice. Let it be known that any agent (or officer of the Republic), unless authorized by the President in writing, has no Lawful authority from the Republic to serve notice on *de facto* officers on behalf of the Republic; and, if they do so, then they are acting in their own private capacity and DO NOT represent the Republic."




