**PROCEDURE:** We request that application for use of the Minocqua Gun Club Clubhouse for rental be submitted no less than ten (10) days prior to use by the applicant.

Rental fees and security deposit must be submitted prior to the applicant's event. All payments will be deposited in the Minocqua Gun Club's account. Refunds can be held as long as thirty (30) days to fully evaluate any possible damage. In the event of any damage to the property, the replacement or damage costs will be deducted from the security deposit and the balance refunded. The renter is responsible for all damages that exceed the security deposit.

**SHOOTING:** There will be no shooting during your event unless a MGC officer is present.

**KEYS:** Keys may be obtained from the designated Minocqua Gun Club Officer one (1) day prior to use and returned in the same allotted time. A \$75 re-keying charge will apply for any lost keys.

**SMOKING:** There is NO SMOKING in the Clubhouse.

**DECORATING:** No nails, staples, tacks, or any kind of adhesive that will leave marks on surfaces can be used to attach decorations to the inside or the outside of the building. All decorations must be removed after the event.

**CLEANING:** Clean-up after the function is to be done by vacuuming, sweeping, and mopping. We expect the building and grounds to be left in the same condition in which you found it before the function. **All clean-up must be completed by 11:00 A.M. the day following the event** (unless other arrangements are made). **Failure to do so will result in a loss of deposit money.**

Alternatively, non-member and member renters can choose a cleaning service to clean up afterward. The Minocqua Gun Club can also do it at a rate of \$30 / hour. Please make sure we are notified of your choice.

**TRASH:** The renter will supply your own garbage bags and the accumulated bagged trash must be put into the dumpster behind the Clubhouse.
