There are many professional services associated with the CBH project development business. Some of the most common ones include:

A. DESIGN AND BUILD SERVICES

- 1. Urban Planning: responsible for the overall township design including theme, zoning, infrastructure, services requirements, etc.
- 2. Landscape Architects: Landscape architects help design the outdoor areas around the building, including gardens, walkways, and parking lots.
- 3. Architects: Architects are responsible for designing the overall look and functionality of a building.
- 4. Contractors: Contractors are responsible for executing the actual construction work, including hiring, and managing subcontractors.
- 5. Engineers: Engineers are responsible for ensuring the safety and stability of the building structure, as well as the systems that make it work.
- 6. Project Managers: Project Managers are responsible for overseeing the construction project from start to finish, making sure it stays on schedule and within budget.
- 7. Quantity surveyors They estimate the cost of materials, labor, and equipment required for the construction project.
- 8. Land surveyors They measure and map the land to identify boundaries and elevations, and to assist in site planning.
- 9. Environmental consultants They assess the environmental impact of the construction project and provide recommendations for mitigating any negative effects.
- 10. Surveyors: Surveyors are responsible for measuring and mapping out the land before construction begins, as well as monitoring the progress of the construction.
- 11. Lawyers: Lawyers help ensure that all contracts and legal requirements are met throughout the construction process.
- 12. Accounting Firms: Accountants help manage the finances of the construction project, including budgeting and financial reporting.

- 13. Real Estate Agents: Real estate agents help find suitable land and properties for development and assist with buying and selling properties.
- 14. Interior Designers: Interior designers help create the overall look and feel of the interior spaces within the building.
- 15. Insurance providers They provide coverage for various types of risks associated with construction projects.
