A search of his driving record revealed numerous citations for various moving violations. He doesn't appear to be active on Facebook. Looking for any other active social media account, and any helpful information about his background available online.

FINDINGS:

The following public information regarding the subject and scope of work was identified and placed into the following report. Multiple social media profiles were located belonging to the subject though most profiles appeared to have limited public content. One Facebook profile that was found belonging to the subject (Item 4) displayed that the subject is currently employed with [REDACTED]. The subject also shared images of a large semi truck, assumed to belonging to him on Item 6. There was also a post captured in the subject's Facebook Stories displaying an image taken by the subject while driving his semi truck (Item 5).

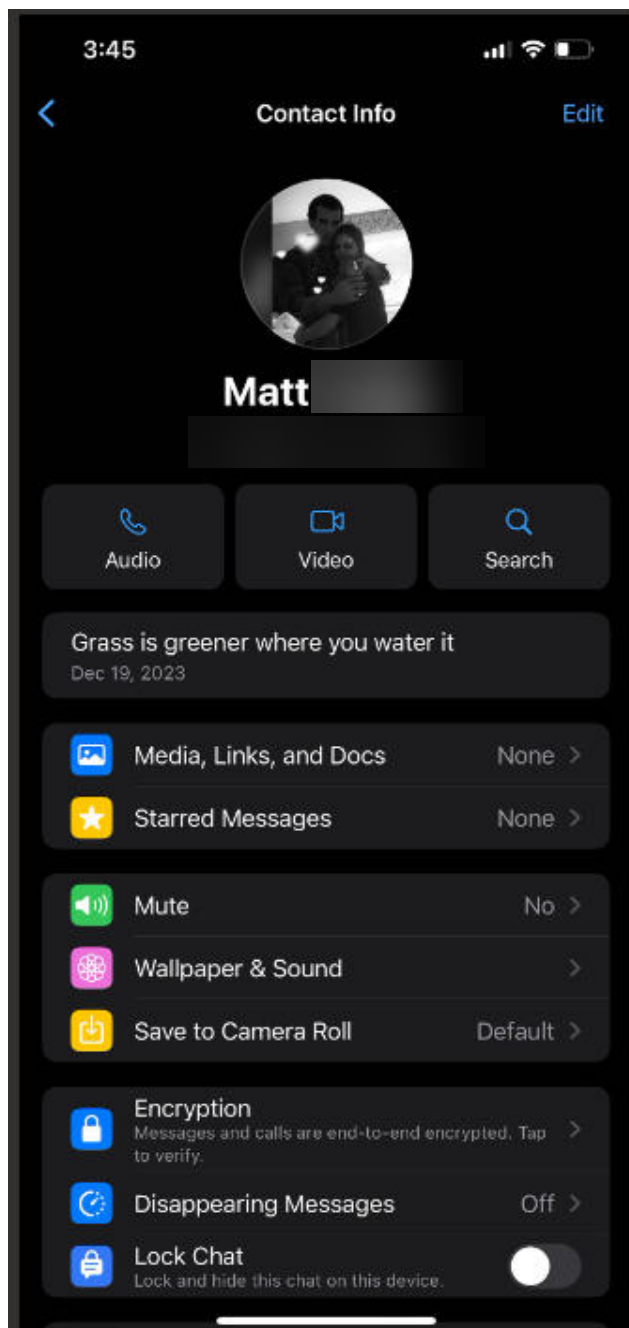
