## Entrance Gate Update - (Terry)

In the Annual Meeting Minutes I asked for feedback on the proposal to look into putting a gate at our front entrance.

I received quite a few responses to this request, the majority of which opposed the idea. The main concern was the cost, not only for building the gate but for the cost of maintaining it.

I got the message as to how our community feels about the gate. But, I was made aware of a post that was made on Facebook. This post was charged by the vehicle brake-in that took place in the Remington community (on the other side of FM 156) that was reported in the news. A Creekside homeowner shared his concern that this type of activity is happening more often and it is starting to get closer to our community. This is primarily the same message I shared in our Annual Meeting Minutes. He did go into more details as to how three gates would be needed and all the HOAs would have to figure out how to pay for the project.
