Code of Conduct

The code of conduct is in effect as soon as a participant arrives at the grounds of the facility of play and remains in effect until the participant leaves the grounds of the facility and/or at any sanctioned meeting of members of the North County Senior Softball Association, Recreational Division.

Note: "Official" means any individual acting in a capacity of an official such as, but not limited to, umpire, Player Representative, Commissioner or Manager.

No Participant shall:

- 1. At any time lay a hand upon, push, shove, strike or threaten to strike or curse an official, player or spectator.
- 2. Be guilty of a physical attack as an aggressor upon any player, official or spectator.
- 3. Endanger the safety of any player, official or spectator. i.e., collisions.
- 4. Refuse to abide by an official's decision.
- 5. Be guilty of verbally attacking and/or belittling any official, player or spectator for any decision, judgment or action.
- 6. Be guilty of using unnecessary, potentially harmful or harmful tactics in the play of the game against the body and/or person of any player, official or spectator.
- 7. Use profane, obscene or vulgar word(s) in any manner and/or language at any time.

If, in the judgment of a player's manager, or acting manager, a player violates the Code of Conduct that Manager may remove that player from the game. Violations of the above Code of Conduct are to be reported to the Commissioners by each manager of the participating teams. The violation report must be in writing and be received by a commissioner within 72 hours from the time of the incident for review and possible action. The commissioners will then take appropriate action up to and including expulsion from the league/association.

TEAM ASSIGNMENT: Your assignment to a team is not necessarily a permanent assignment. In order to attempt to maintain parity among teams it may be necessary, from time to time, to assign/move players from one team to another.

NOTE: The North County Senior Softball Association, Recreational Division **DOES NOT carry any medical insurance of any kind** that would cover players, managers, umpires, player representatives, commissioners, spectators and/or participants.

LIABILITY WAIVER, SOFTBALL

I, the undersigned, in consideration of being allowed to participate in this activity, and intending to be legally bound for myself, my heirs, executors and administrators do hereby release and discharge the City of Carlsbad, the Carlsbad Unified School District (Owner of fields and gymnasiums), the City of Vista, the City of Oceanside, the City of San Marcos, the Amateur Softball Association and The San Diego North County Senior Softball Association, Recreation Division and their respective officers, directors, commissioners, members and managers, agents, employees, umpires and contractors, jointly and severally, from any matter whatsoever arising out of or resulting from my participation in this activity; and I do expressly assume all risks of my participation in this activity, including, without limitation, the risk that I might be injured as a result of the acts or omission of the above parties or some defect in or on the property of any of them, whether caused by negligence or otherwise, except for illness and injury resulting directly and solely from gross negligence or willful misconduct on the part of the Cities or its employees and I agree to indemnify, save, hold harmless and defend each and every one of the above parties of and from any and all loss, damages, expenses, costs and attorney's fees arising out of or resulting from my participation in this activity.
