To those interested STS Marina Slips -

Ahoy! The 2021 Mariners' Marina slip prices are as follows:

- **A, B, or C Dock Slips** are **\$1,495**.
- **D, E, F, G, H or I Dock Slips** are **\$1,695**.
- **J, K, or L Dock Slips** are **\$1,895**.

As before, these prices include:

- Use of the pool for your immediate family (parents and children) and occasional guests.
- Use of the Clubhouse lower level washrooms, showers, sauna, workout room, and laundry facilities.
- Normal water usage at docks.
- Low current power at the docks (defined at 115 volts at 15 amps for items such as trickle chargers).
- Trash facilities located in each parking lot.
- Access to the marina Wi-Fi network, as available, subject to terms of service.

As in the past, the following items will also be available at an extra charge in 2021:

- *High-current shore power connections.* The 2015 thru 2020 cost was \$80 for a 30amp connection and \$120 for dual 30 amps or a single 50amp connection. This is a one-time charge for the entire season payable at the same time as your slip payment. The 2021 prices will be set by the Mariners' Marina Condominium Association (MMCA) in early 2021 (these prices are set to only cover the actual electrical costs – no mark-up or profit is added to electrical charges).
- *A pool guest pass* may be purchased for \$225 if you plan to have a frequent, repeated pool guests.

A non-refundable, \$300 deposit will hold your boat slip for the 2021 season (slip held until April 15, 2021). We will give a **\$50 discount if you pay the entire 2021 slip rental and 2021 high-current fee by March 17, 2021**. All slips without a deposit by December 1, 2020, will be available on a first-come, first-served basis. Please contact me if you would like to reserve a slip for 2021. We already have boaters waiting to see if certain slips become available so we encourage you to reserve your slip early to avoid any disappointment.
