4. The grade must be firm, stable, and unyielding. HPC is not responsible for grade prepared by others and assumes no responsibility for standing or ponding water on designed asphalt surfaces with slopes less than 1 ½ percent.
5. No retainage will be withheld. Payment in full due in 30 days.
6. Any excess material generated from any grading operation will remain onsite and disposed of by others.
7. For fine grading operations, the grade must be +/- 1/10 of a foot, firm and unyielding, uniformly shaped with enough stone in place to balance with accepted densities prior to our arrival.

8. This price is based on the NCDOT Monthly Terminal Asphalt Binder Index Price for April 2023 at 641.88 per ton. If the Asphalt Cement price fluctuates from the Index Price during the performance of our work, HPC reserves the right to adjust the stated prices with the NCDOT Asphalt Binder Index at the time of installation.
