Open Letter to the Town of Holden Beach Mayor, Commissioners, and Staff

Dear Mayor, Commissioners, and Town Staff,

As we kick off 2026 in our beloved Holden Beach – "The Family Beach" – it's time to address the ongoing concerns about our paid parking policies. Many residents, property owners, and visitors (including Brunswick County neighbors) have shared frustration on social media and in community discussions. The year-round paid parking (enforced 9am-5pm daily at \$5/hour), higher rates, and related issues are creating real angst. While I speak for myself, these suggestions echo what I'm hearing from many in our community.

Here are some thoughtful recommendations to make things better for everyone:

1. **Switch back to seasonal paid parking (April 1 - October 31)** and make off-season parking free again. Nearby beaches like Oak Island and others follow seasonal enforcement. The shift to year-round seems tied to past issues (like the sea biscuit shelling rush), but now it's deterring locals who just want to enjoy our quiet off-season beach walks.
2. **Offer a flexible multi-vehicle annual pass for Brunswick County residents and property owners.** Families with 2-3 cars shouldn't have to pay \$175+ per vehicle for separate annual passes for each vehicle – that's hundreds of dollars that feel excessive. A single household pass allowing one vehicle at a time would be fair and encourage more local support, but still limit the use of the permit to one vehicle at a time.
3. **Step up maintenance of public bathrooms and trash services.** A very common complaint is overflowing/unclean restrooms and trash cans that aren't emptied often enough – especially on busy summer days. Since parking fees fund BPART-restricted services (beach protection, access, and recreation), you should deliver top-notch cleanliness and reliability. Excellent service justifies the paid parking charges; poor service just adds to our frustration.
4. **Improve communication and engagement with the community.** The lack of response to resident complaints over the past year has felt dismissive. Complaints aren't annoyances – they're chances to improve our family-friendly beach. Revamp your public relations: more timely responses, town hall forums where commissioners and town staff actually engage with the public, and regular updates on parking feedback.
5. **Switch to a more user-friendly parking app.** SurfCast by Otto gets a lot of criticism for freezing, crashing, taking forever to set up (manually entering cards, no Apple Pay), and overall a poor experience. Switch to something proven like ParkMobile for quicker, smoother payments – it would make paying for parking much less stressful.

It's okay to adjust policies that aren't working as intended. Pivoting now would show you're listening and committed to keeping Holden Beach welcoming for residents, locals, and visitors alike.

It's time for the complaints to end and for the Town of Holden Beach to act.

For those of you that did not receive Tracey Thomas' letter of resignation email, here is an excerpt every resident and property owner should read:

During his campaign, Keith Smith promised to restore "trust, transparency, and teamwork." Unfortunately, these principles were disregarded at the outset. Revisions to the Rules of Procedure were neither shared with the public nor discussed openly before Commissioners Smith, Pate, and Dyer voted to revert to an outdated version. This outdated version is not only less transparent but also fails to account for modern laws regarding remote participation, and directly violates Ordinance 30.15 (A) [Ord. 07-04, passed 5-22-07].

Furthermore, the behavior witnessed at this meeting is a continuation of the hostile working environment fostered by Mayor Holden and Commissioners Rick Smith and Page Dyer over the past two years. This atmosphere of antagonism has consistently undermined the Board's ability to engage in civil, productive debate. It is deeply troubling to witness the very "backroom" decision-making and predetermined outcomes that were so heavily criticized now being used as primary tools of governance. By "calling the question" to prematurely end deliberation, the new majority has signaled an interest in an agenda of retaliation rather than collaboration. I have grave concerns regarding the Board's insistence on "repairing" a pier that both the Town inspector and a reputable engineering firm have deemed a total loss. Disregarding these professional evaluations to pursue a project that is not cost-effective places an undue financial burden on our taxpayers. Furthermore, based on recent public statements, it is apparent that certain members of the Board intend to prioritize the interests of non-residents over the taxpayers of Holden Beach. Any attempt to bypass the November 2025 referendum by leveraging revenue streams like parking fees or occupancy taxes would be disingenuous, unethical, and a violation of the public trust.

● Let's Talk Paid Parking at Holden Beach – Please Read Before Commenting! 🙏

As a property owner/resident, I understand frustrations with paid parking, but constant complaints can feel disrespectful to those of us who live and own homes here, and those that operate businesses here.

Paid parking helps prevent overcrowding (since all nearby beaches have paid parking too!) and funds important beach improvements. Without it, Holden Beach would face the same issue many complain about: no available spots on busy days!

I researched current policies at nearby beaches – here's a fair comparison:

Holden Beach

- Seasonal Permit: \$175/year
- Rates: \$5/hour, \$20/day, \$80/week
- Enforcement: Year-round, typically 9 AM–5 PM (free outside those hours)
- Spaces: 445 vehicle + 61 golf cart spaces
- Revenue: ~\$880,000–\$916,000 (goes to restricted BPART Fund for beach preservation, access, recreation, and tourism – not general salaries or unrelated expenses)

Ocean Isle Beach

- Seasonal Permit: \$175/year

Key Takeaway: Holden Beach and Ocean Isle have the fewest spaces, **making managed parking essential**. Holden Beach residents and property owners are proud that our revenue stays restricted to beach/tourism improvements via the BPART Fund – it directly supports a better experience for everyone, including local businesses, beach goers, and rentals.

If you love visiting Holden Beach: ✅ buy a \$175 annual pass – that's just ~\$14.58/month for unlimited parking all year! A true bargain for family beach days.

If the new commissioners wanted to make an improvement to the paid parking policies, then Holden Beach should revert to the pre-March 2024 policy of only charging for parking between April 1 to October 31. While that may have a \$100,000 to \$150,000 impact on the budget, it would be a welcome benefit for the island residents and our neighbors.

Please, let's focus on enjoying our beautiful beach together and stop with the negative comments.

Remember, if parking was free at Holden Beach, you'd be lucky to find a parking spot in the summer. Since our neighboring beaches also charge for parking, Holden Beach would be overrun in the summer and it would negatively impact the beach experience.

Relax, soak up the sun, and be thankful you live near so many beautiful beaches! 🌞

Dear Mayor Holden, Commissioners Dyer, Myers, Pate and Smith, Town Manager Chadwick and Town Clerk Finnell,

On Election Day 2025, the four Commissioner candidates agreed that no matter who won, we would hold each other accountable to our campaign promises and agreement to work together for the benefit of the Town of Holden Beach. Commissioners Pate and Smith, you looked me in the eye and shook my hand and said, "no new concrete on Block Q."

As Commissioner candidates, Keith, Chad, Sylvia and I had several productive conversations about what the Block Q area could look like, keeping the area as green as possible. Imagine my surprise when I opened the meeting packet for the January BOC meeting and saw an 80'x80' footprint for the combined pavilion and dance floor. Is that really the best you can do? I strongly urge the BOC to reconsider this design and implement a more eco-friendly building and dance floor. Has using a rental stage and dance floor ever been seriously considered? Have the economics of gutting one of the last green spaces on Holden Beach been reviewed? Please explain during the discussion of item 9 how you came up with this design and why you believe it is the best solution for our town.

Also, I look forward to hearing you explain why, on the same night that selecting an engineering firm for the Town's stormwater project is on the agenda, we want to cover more of our beautiful island in concrete. How is that going to help with our island's stormwater drainage issues? And what kind of message are you sending to the RCCP team? The Resilient Coastal Communities Program kicked off in December 2025, with the goal of having several shovel-ready projects ready to submit for grants within a year. Please, help me understand how pouring huge slabs of concrete contributes to the resiliency of Holden Beach.

On item 12, the cover sheet is woefully inadequate. Mayor Holden submitted this agenda topic on January 8th, and the only corresponding information included is the following: "Several commissioners have requested to discuss the dates paid parking is enforced within Town limits." In the interest of transparency, please inform the public which Commissioners requested this discussion and why. Do you have data and estimates of the economic impact of any changes to the paid parking plan? Will this only be a discussion, or will any action be taken?
