1006 Annual Policing Report

Sadly, this Parish saw an increase in reported crimes from five to six in 2016, this was the worst rise since 2010.

These crimes consisted of a burglary dwelling, two nonOdweliing burglaries, a theft from a motor vehicle at the same time and location as one of the non-dwelling burglaries and two public order neighbour disputes.

Other incidents in this Parish included five false/faulty burglar alarm activations, these included one being set off by a moth and a child at a different address. We also had reports of three trees across roads during high winds.

PC Reid attended the Annual Duck Race in 2016, which is always a superb event and good to meet local residents.

An excellent year again for this parish with, for the second year in succession, no reported crimes.

Other events in the parish included a damage only road traffic incident (accident), a deer road traffic incident (accident) and a suspicious car was seen where a man was asking about pigeon shooting. We also had a car registered in Essex, which was abandoned in the lay-by on B3046. PC Reid arranged for the Essex Police to call on the previous owner and as it was not moved PC Reid arranged for it to be scrapped by the Borough Council. There was also a dangerous driving allegation made and injured deer and a car on fire which was not found to be suspicious.
