3. **NO LIP-SYNCHING is allowed.**
4. Absolutely no profanity, insensitive subject matter, or dangerous stunts including but not limited to, blades, flames, and/or hazardous materials.
5. Music must be provided via thumb drive or emailed link.
6. Final performance music must be given to the DJ by **Wednesday, September 9, 2026.**
7. Groups must designate a single point of contact. Any prize money will be awarded to that individual or group name.
8. Participants under 18 years of age must have parental/guardian consent.
9. Participants must provide either their ID Card or Birth Certificate prior to event. If chosen as a winner at the show, you must fill out a W-9 for tax purposes.
10. Judges will score based on Talent/Skill Level, Creativity & Originality, Stage Presence & Confidence, Audience Engagement, and Overall Performance on a 1-10 scale.
11. Decisions of the judges are final.
12. All agreement forms must be submitted by Friday, September 4, 2026, either in person at 12 W Main Street, Williamston, SC 29697 or via email at EWBoardMembers@gmail.com.
