GOOSE HUNT AGREEMENT AND RELEASE

I, _____, in exchange for the opportunity to participate in the Controlled Goose Hunt at Brady's Run Park, do hereby remise, release and forever discharge the County of Beaver, its officials, employees and agents from any and all liabilities, claims, demands, cause of action, right, damage, costs, attorney's fees or expenses of whatever kind or nature, either in law or in equity, arising from or by reason of any bodily and/or personal injuries, known or unknown, sustained by me and/or damage to my property, or otherwise, as a result of or arising from my presence on County property and/or participation in the Controlled Goose Hunt at Brady's Run Park, I, my heirs, successors or assigns hereinafter have or may have by reason of any bodily injury or personal injury, damages to property and the consequences thereof, known or unknown, foreseen or unforeseen, arising or which may arise as a result of or in any way connected with my presence on County property and/or participation in the Controlled Goose Hunt at Brady's Run Park.

Further, in exchange for the opportunity to participate in the Controlled Goose Hunt at Brady's Run Park, I, _____, do hereby agree to defend, indemnify and hold harmless the County of Beaver, its officials, employees and agents from any and all liabilities, claims, demands, suits and losses, including all attorney's fees and costs connected therewith, and for any damages which may be asserted, claimed or recovered against or from the County of Beaver, its officials, employees or agents by reason of personal injury, including bodily injury or death and/or property damage, including loss of use thereof, which arises out of or is in any way connected or related to my presence on County property and/or my participation in the Controlled Goose Hunt at Brady's Run Road.
