

Q1 How familiar are you with semi-conductor chip manufacturing plants?






Q3 Are you concerned about ground water pollution and or excessive water use (10,000 gal/day) resulting from semi-conductor chip manufacturing?





Q6 What factors influence your opinion on the development of semi-conductor chip manufacturing plants? Select all that apply






