




15 Many Demand Reparations for African-Americans, but Damage was Global so
16 Reparations Should Unfold Globally. AARS is the Best Reparations Plan by far,
17 because it is the Most Comprehensive, and We Generate Our Own Reparations
18 Wealth from Seed Funds (SF) from (1) those Who Benefitted Tremendously from
19 Colonizing Africa and Enslaving Black People, (2) from Humble Rich Blacks Who
20 Care Deeply About Their People, and (3) from Others with Wealth and Compassion.

21
22 Black People Should be Proud, Appreciated, and Respected Globally for Great
23 Achievements, but instead they were Abused, Enslaved, and Oppressed for More
24 Than 2000 years! That was Engineered by Religious Propaganda from Sorcerers
25 Fabricating Horrible Negro Phobic Language into Scripture, to Prescribe BLACK
26 PEOPLE as SLAVES to U.S. Government and all the Other Guilty Groups!! They

28 Gained Trillions of Dollars from Wealth Transfer, while causing Acute Emotional



12 **Sista Hamer Said America was Built on the Backs
of Black Slaves So They Deserve Reparations**

1 No African-American or any black person should have to prove anything to get reparations.
2 They are victims of major crimes. Others got reparations for minor violations. The crimes
3 caused social and emotional damage and the legacy still imposes a dreadful impulse, and
4 negative impact on the entire black race! So, all Black People have earned, deserve, and are
5 entitled to reparations!! AARS has processes, programs, and services to quickly facilitate
6 justice, repairing, and satisfaction for African-Americans and all Black People, and truth and
7 reconciliation with all nations and races.
8

9 Many scholars have studied reparations for decades, then produced their reparations plans. The
10 AAIU studied it for more than 40 years, then produced their AARS reparations plan. So, it will be
11 best to compare all reparations plans to find the best one. You will find 12 Forces and 7 Power
12 Moves as reasons to endorse AARS. More plans will only cause confusion and delays, and will
13 surely be similar. Reparations for Black People are way past long overdue! So, please stop all the
14 obstruction via more ideas, groups, or studies to write more plans, we need AARS ratified ASAP!!
15

16 By knowing corruption is at an all-time high in America and globally, we know there is *corruption*
17 in the reparations arena. (Many agents, sellouts, and groups are set up in that arena, just to get
18 control of the money). Now, there is a rumor spreading around suggesting blacks will finally get
19 reparations, of approximately \$14T. Those sellouts and groups have *secret agendas*, so they will
20 not communicate with other reparations activists honestly, as they should. So, we should take the
21 reparations debate from secret agendas and meetings, into *public discussions* to identify the best
22 reparations plan. We are asking everyone 18 and older to engage in the KRP, to stop all corruption
23 in the reparations arena. We explain the KRP on the AARS Intro and Summary Docs. The KRP is
24 the 2nd Civil Rights Movement (CRM), to make a strong, collective, and constant demand for AARS.
25

26 Everyone 18 and older should engage in the KRP, to learn the advantages and benefits of AARS.
27 Then contact all African-American, Black, and Civil Groups, all Politicians, Leaders, and Pros, all
28 College Instructors and Students, and all News Networks and Social Media Outlets; to ask them
29 to engage in and promote the KRP. When many people and groups join the KRP, we formally start
30 the 2nd CRM to demand AARS via the news and social media. We inspire our government to ratify
31 AARS, as a Kwanzaa Gift for African-Americans and all Black People, and to ease racial tension.
32

33 We propose the 2nd CRM, because it is going to take collective movement, to offset the sellouts
34 and their sponsors. We should not be forced to accept another trick like H.R. 40 or integration!
35 Now, with AARS we finally do what no one else has done, and that is we stop racist police and
36 white supremacists, from killing innocent and unarmed Black People! Black People need a mental
37 transformation and certain amenities for freedom, justice and equality. Their own prime land, form
38 their own government, write their own laws, and control all entities and businesses, in their cities.
39 They finally become their own educators, employers, housing, health care, and police providers.
40 Many people say rich blacks should use their resources to help take care of their people internally.

41 They could use AARS with government agencies other guilty groups and the caring to
42 generate wealth - We gain momentum in the KRP to intensify the 2nd CRM to demand
43 AARS, ASAP!

- 4 1. Spiritual Guidance; to give African-Americans and all Black People the option to engage in
5 AAIU education and preparation to receive AARS reparations programs. We teach everyone to
6 submit to the will of God, and to learn the blessings and benefits, for using good clean and clear
7 language. They learn to absorb African cultural, traditional, and social values for a strong spiritual
8 and moral foundation. They learn and keep good spending and saving habits, to embed financial
9 stability and gain family enrichment. They learn to resolve bad stimulants and vices, to reduce and
10 soon eliminate all bad thoughts and behaviors, to self-actualize. They will strive for a National and
11 Global Black Family Reunion by studying and embracing Black Nationalism and Pan-Africanism.
12 2. Generating Wealth; we support the AARS Hedge Fund to apply AARS remedies, to repair all
13 damage, solve all problems, and facilitate genuine reconciliation with all others via economics.
14 3. Government Prime Land Grants; to recover and rebuild historical all-black towns and settle-
15 ments, and build new beautiful elite and safe, repatriated and sovereign cities at home and abroad.
16 4. The 12 Forces; to show Africa's eminence and her genius to lead in world progress, with her
17 **contributions** and **inventions** to **benefit all people**, then her unenviable **demise** and **downfall**.
18 We should list and discuss all the damage and problems, to provide reasoning to implement all the
19 AARS comprehensive, universal, and viable reparations models with its processes, programs and
20 services. That is how Black People recuperate from ages, centuries, and evil extensive eras of
21 invasions and subjugation, for a revival and reconnection back to their glorious past.
22 5. The 7 Power Moves; for African-Americans and all blacks in the U.S. to proceed to move in a
23 united, national, and simultaneous process to reject injustice, and to command swift, direct, and
24 everlasting money, power, and respect. Social fabric they lack but will soon gain with these moves.
25

27

28 It is **wrong** for the U.S. Government to form more reparations state task forces or city committees
29 to do more studies to write more reparations plans. That is corruption in the reparations arena to
30 ask or pay people to do more studies on slavery and its legacy, because we've done similar studies
31 since slavery! So, we do not need any more studies!! That utterly wastes time and deposes justice!!!
32

33 People with a strong belief in God and personal principles; a thorough knowledge of Black History,
34 Racism, Reparations, and the Civil Rights Movement; and had done the required reading, "Black
35 Theology" by Dr. James Cone, "How Europe Underdeveloped Africa" by Dr. Walter Rodney,
36 "The Destruction of Black Civilization" by Dr. Chancellor Williams, "The Pale White Horse" by
37 White Scholars, "The Secret Relationship Between Blacks and Jews" by Jewish Scholars,
38 "Blueprint for Black Power" by Dr. Amos Wilson, and "The Isis Papers" by Dr. Frances Cress
39 Welsing; to write reparations plans. The government should **only form groups** to compare plans.
40

41 Agitators and unbelievers **secretly** placed agents, sellouts, and groups in the reparations arena,
42 who are not allowed to help all blacks. Those people are paid to keep blacks controlled, confused,
43 divided, conquered, down, and away from **autonomy**. African-Americans have made great

- 1 progress under hostile conditions, so they need land for relief and self-rule. {{After all the pain and
- 2 suffering, all Black People should claim AARS for sovereignty and all forms of reparative aid}}

12 Because they were Hurt “Long Before” and “Much More” than Others

13 So Reparations are “Long Overdue” for a Black Family and Culture **Revival** - Because Africans
14 were Abused Brainwashed Displaced Deculturated and Exploited ♦

15 When Black People Discuss Racism - Colonialism and Middle Passage - Then Slavery Lynching
16 and Segregation - It is Hard to Remain Diplomatic

17 African-Americans have Debated and Fought for Freedom Since the 1500s but are Always Left
18 Behind - When Others Get Elected to Office they Uphold Laws and Lift their Race - All Black
19 Preachers Politicians and Leaders Should Uphold Laws and Demand Reparations (Respectfully

29 **FOR ENDURING SLAVERY and CRIMES AGAINST HUMANITY**

30 Let it be Known by These Statements That;

31
32 **Whereas** Africa and her Black People of African descent were **encroached** upon and **exploited** for
33 hundreds and thousands of years, by **the U.S. Government** and many **other guilty groups** for all
34 capitalist purposes, causing severe mental illness and multiple psychological disorders, while
35 withholding due and fair compensation, so it is **now resolved** that **they shall** 1) make it known

1 that **they will host dialogue on AARS**, to discuss reparations programs developed after more than
2 40 years of research, to encourage and justify the U.S. Government to ratify AARS, ASAP; and

3
4 **Whereas** we **recognize** that it shall 2) be made known that AARS is the only self-funding
5 comprehensive reparations plan, to guarantee reparations for African-Americans and all Black
6 People; but we demand \$20B from each guilty group which is great debt relief because they each
7 owe much more than \$20B, to place in separate secured placement programs to generate wealth
8 with very little risk, we ask rich blacks and those with wealth and compassion to start the process
9 from \$100M to \$5B, for a good ROI and to influence those guilty to join the process. We split end
10 profits for AARS application and U.S. Policies to facilitate **reparations** and **reconciliation**; and

11
12 **Whereas** it is also **resolved** that the U.S. Government and all the other guilty groups shall 3) agree
13 to **negotiate** and award prime land grants, so that the victims of past and present - national and
14 global racism and oppression - {{can build their own new, elite, and safe sovereign and repatriated
15 cities at home and abroad}}, and they shall 4) **recognize** that the funding placements are refundable
16 and repeatable programs, to raise funds to deed 40 mi² lots to build new high-tech cities, form their
17 own indigenous governments, and prepare to manage all businesses and emotional therapies; and

18 **Whereas** we understand AARS has three social models which are integration, repatriation, and
19 sovereignty, blacks will have an **option to choose** which model they prefer for residence, the three
20 model formula will help us to reunite and repair damage done to the entire black race; first we
21 improve integration by hosting racism dialogue and case studies to identify problems and develop
22 solutions to decrease banning and increase opportunities; second we expand repatriation by official
23 land grants abroad to go help our distant relatives build safe cities; we **recognize** there are sellouts
24 and others keeping us divided and conquered, so we must expose and overcome that problem by
25 any means necessary; and third we create sovereignty by getting our own land for autonomy; so

26 **Now Therefore We** shall 5) **recognize** that Black People have been governed and forced to live
27 under the power and control of others whose ancestors colonized and enslaved them - and that is
28 the main and on-going problem for African-Americans and all Black People - so we know it is
29 time for them to have **their own land** for **relief** from captivity, deception, and redlining in order
30 to govern themselves, and develop a will to eliminate divisions caused by inside and outside forces;
31 that will lead to a National and Global Black Family Reunion, which will provide the opportunity
32 for all Black People to use their abilities and skills to build safe cities and promote global peace.

33 ♦ African-Americans should discuss AARS in a strong project annually, seriously, and constantly.

34
35 **We Will Discuss all Docs as Requested** all Year Around Until AARS is Ratified
36 Civil Dialogue Among Good People will **Create Understanding for Liberation**

37 ♦ That strong project is called the **Kwanzaa Reparations Project (KRP)**. A **STRATEGIC**
38 **SERIOUS** and **CONSTANT DIALOGUE** on **all Docs on the Homepage**; from Kwanzaa of
39 2025 until Kwanzaa of 2026, that is a motional process designed to help victims of past and present
40 vast and vile crimes, win **AARS** in 1 year, to give hope and offer full repair. African-Americans
41 all Black People and their Allies {{THE CIVIL RIGHTS GROUP (TCRG)}} should make the KRP
42 a priority until the U.S. Government ratifies AARS *to finish the Civil Rights Movement (CRM)*.

1 Now, the U.S. Government is up to their tricks once again with a follow-up to H.R. 40. H.R. 40 is
2 an old hustler tactic bill that only leads to forming a reparations commission, to study and develop
3 reparation proposals for African-Americans. That is corruption in the reparations arena because
4 no one should pay anyone for any more studies to write any more plans, because they will surely
5 be similar, delay justice, and there are already a few good reparations plans for us to choose from.
6 H.R. 40 is an insult and setback to most reparations groups, all reparations experts, and our Global
7 Black Family because we already have AARS. A national and global plan written after more than
8 40 years of research and focused studies, **to avail we profess spiritual revival and renewal, as**
9 **we vow** to repair all damage and solve all problems for African-Americans and all Black People.

10
11 H.R. 40 and all other acts the government issues for black reparations will be limited and divisive
12 for African-Americans and all Black People, like the CA Reparations Task Force *asking for proof*,
13 the *ill reparations payouts* in Evanston IL, and seeking reparations for *victims* of the Black Wall
14 Street Massacre in OK. {{It is wrong for anyone to seek or for blacks to want reparations in one
15 area or for one tragedy, because that is divisive not redress. A good reparations plan has amenities
16 to repay and renew all blacks at home and abroad, like AARS}}. That should move TCRG to
17 engage in and uplift the KRP. The KRP is for one year from Kwanzaa '25 until Kwanzaa '26, and
18 longer if needed, to litigate national and global dialogue to expedite the inception of AARS, ASAP.

19
20 We are asking everyone 18 and older {{Mainly Blacks, Whites, and Jews}}; (THOSE INVOLVED
21 in past EUROPEAN INVASIONS, COLONIALSIM, and MIDDLE PASSAGE; then SLAVERY
22 LYNCHING, and SEGREGATION), to participate in the KRP. The KRP should occur on most if
23 not all news, social media, national and global TV and internet shows, for one year in a motion to
24 win AARS and reject wiping out DEI. DEI enables equality. It is time for the masses of blacks and
25 their allies to become proactive in reparations talks to demand AARS, instead of being in the same
26 reactive mode as subservient, to accept any *limited acts like stated above* which are not reparations.

27 We get proactive by circulating, reading, and discussing all docs on the homepage all year around,
28 until the U.S. Government ratifies AARS for Africa, African-Americans and all Black People.
29 That will lead to global reconciling with all those who harmed us in many ways, including socially,
30 emotionally, and economically, and made great but illegal land gains and wealth from hundreds
31 and thousands of years of tax-free profits. We will create a desire for the KRP on many fronts with
32 many different yet distinct churches, government agencies, and civil groups. We show a sign of
33 unity in our demands for AARS, to attain our global human and civil rights. We expose **sellouts**
34 working secretly to **keep blacks down** and **divided**, to stop an evil systemic pattern others created.

35 The U.S. Government has given billions **of our tax dollars** to help Jews in Israel and Whites in the
36 Ukraine, so they are obligated to give billions **of our tax dollars** to help Blacks in **America, Africa,**
37 **and throughout the Diaspora.** The State of the Black Union is *they vowed to re-segregate blacks*
38 *in MS, deny blacks a proper education in FL, and they changed laws to remove a black elected*
39 *official in GA.* Those *three acts of racism* should stimulate TCRG to endorse and promote one
40 reparations plan (which should be AARS), to help African-Americans and all Black People recover
41 from generations of injustice, and to learn all about and embrace programs for self-determination.

43 Brotha Pruitt 310-528-1674 *TCRG Should Examine* all Reparations Plans to Claim One - **to Cut all**
