

15 The Spiritual Flow of AARS is the Potential  
16 to Improve Race Relations for all People in America Africa and all  
17 across the World for Peace and Mutually Beneficial Relationships

1 1 To Reparations Advocates our Global Black Family and our Allies,

2 2 {{Reparations means to repair the damage done to a group of people. It took over 40 years of  
3 research to identify and outline all the damage inflicted, before producing a progressive and  
4 comprehensive reparations plan. We thank the CA Reparations Task Force, and the CA State Senate  
5 for their input to help pass 3 reparations bills. Now, that is not a win, but it does set a precedence  
6 to ratify a viable plan, based on a consensus from all-inclusive dialogue. So, we start AARS  
7 dialogue by thanking God for making Africa the cradle of civilization, blessed with good weather,  
8 prime land, and various vital assets}}. 3 {{Europe invaded Africa over 2000 years ago to capture  
9 the land, steal the resources, and colonize Black People. That is when the damage began}}.

10 4 (The slave trade made Europeans rich, so they used Willie Lynch Indoctrination and Middle  
11 Passage Transport to expand the trade. That led Europeans and other culprits of the trade to rise to  
12 become wealthy groups of people. Then more sects and corporations joined the trade, to become  
13 affluent, and to prosper). 5 ((The long overdue debt from colonialism, substances, and slavery  
14 are about \$350T. Clinical studies and global economists chart the debt from emotional abuse,  
15 psychological damage, pain and suffering, and crimes against humanity at about \$300T}}).

16 6 (All those groups are liable for damage done to Africa and all Black People). The problems  
17 include, but are not limited to spiritual deception, exploiting the land, wealth disparities, creating  
18 divisions, and acute mental disorders, 7 so they need a comprehensive solution like AARS. AARS  
19 exalts their civil origin, acceptance of God's wisdom, and mass production; exposes racism and  
20 oppression, and will repair, reconnect, revive, and transform the victims of massive crimes.  
21 8 (Now, whenever you hear a person say Europe civilized Africa, you know they are lying).  
22 9 We infer **generating wealth** to own and operate bank facilities, to amass funding to build safe  
23 cities at home and abroad, offer emergency relief, and provide cerebral therapy. There is also a  
24 great need to treat Post Traumatic Slave Syndrome (PTSS), severe rooted depression, severe  
25 emotional trauma, subdued psychological damage, and embedded transcending mental disabilities.  
26 Then we subsidize all moving and pertinent parts of AARS, to guarantee success in repairing all  
27 the damage and creating a better life for the Global Black Family via reparations and reconciliation.

28 10 {{The worst **obstacles** Black People had to endure were losing their independence to intrusions,  
29 being divided, conquered, and enslaved, and not forming ethnic unity to design and secure, a global  
30 racial hierarchy for protection; like the Jews who have the ADL, and the JDL}}. {{The worst  
31 **problem** Black People have today is they are still exploited by others all around the world. They  
32 need AARS to release them from that bondage and servitude, in order to establish sovereignty}}.

33 11 {{Black People suffer from covert activity only meant to destroy their group. That is racism!  
34 which only harms Black People}}!! 12 so they should **claim AARS** to start the process to **unite**  
35 **globally**, to slowly dissolve and to eventually eliminate, racism, oppression, and police terrorism.  
36 13 The forces of racism are so strong within integration, that Black People cannot do what is  
37 required for repair. 14 Therefore, sovereignty which is getting their own land, is mandatory to  
38 forgive past aggression, repair all damage, and to achieve collective peace with group progress.

1    15 African-Americans resisted many early social constructs like slavery, were used and abused in  
2 sharecropping, then battled experiments and segregation for more than 500 years! Those are only  
3 a few forms of racism which fuel dire suppression. 16 Whenever they agreed to leave or improve  
4 bad settings, others always hindered their efforts. \* \* \* \* 17 Many blacks have tried many times to  
5 implement **the best solution** possible for their people, which **is sovereignty**, to get their own land  
6 **to build their own safe cities, at home and abroad.** 18 African-Americans have built many  
7 historical all-black towns and settlements, only to watch all of them wither away or burned down  
8 because of racism. 19 The sad part is there are sellouts and many others who were responsible for  
9 the fall and ending of the all-black townships.

10    20 {{In light of these facts all government, independent, and other groups of people should endorse  
11 and promote AARS, which means autonomy for African-Americans, and the Global Black Family,  
12 and truth and reconciliation with all other nations and races}}. The government has a history of  
13 **deceiving** Black People. **Brotha Malcolm X said** we were **hoodwinked** and **bamboozled**, so we  
14 should get justice **by any means necessary**. Now, we should not expect the government to produce  
15 a fair and comprehensive reparations plan. They are offering blacks a few incentives in a few areas  
16 like education, housing, or health care. We should realize that is a government pattern or trick **to**  
17 **keep blacks** down, divided, conquered, submissive, and **under their control**. That includes going  
18 state by state, and city by city to do more studies, to pass more bills, which further **delays justice**.  
19 Victims of the oldest and most dangerous weapon of mass destruction called racism need aid now.

20    AARS negotiates to regain control of Africa, specifically our land and resources, to **remove** the  
21 **bondage** of others, and to gain **global autonomy**. AARS arranges for Black People to resume their  
22 **rightful place** in society as **spiritual beings**, and leaders of the AARS Global Civil Rights  
23 Movement to usher in world peace and progress. Black People should demand that their  
24 reparations plan comes from an independent group of Black People, who worked with allies, and  
25 studied the issue for at least 20 years, which is the minimum amount of time required, to recognize  
26 and assess all the damage, before producing a valid reparations plan. The 3 reparations bills passed  
27 in CA, will lead to the government forming an agency, to fund their proposal. That is a giant step  
28 towards **corruption**! The government has a history of corruption, so Black People should proceed  
29 with **caution!!** Black People should hold the government accountable for the conditions of Africa,  
30 and their dismal pattern in dealing with Great African Leaders like Patrice Lumumba. They should  
31 also hold them accountable for Ron Brown and all the other Great Black Leaders who were on that  
32 mysterious flight.

33    {{If the government gets \$14T, **most of it will be lost instantly** to taxes and tricky schemes. If they  
34 award the \$14T to the AAIU, **we will generate additional wealth** for African-Americans, all  
35 other Black People in America, the Global Black Family, and **all others** who endorse AARS, for  
36 **reparations** and **reconciliation**, **for the next four 50-year terms37 lies, or tricks, because **everything will be transparent**, which **is how reparations should unfold**.  
38 {{We will **make sure** all Black People get their own land, to form their own governments, **to own****

1 and control all affairs, businesses, entities, systems, institutions, people, and especially the police,  
2 **within their city limits**. African-Americans and all Back People need all the rights and privileges  
3 entitled to indigenous people, along with all the other reparative measures required for redress, for  
4 victims of middle passage horrors, slavery's legacy, segregation's fatalities, integration's  
5 deception, and crimes against humanity}}.

6 **21** Now that we have a plan, AARS, that will motivate all Black People to unite globally to demand  
7 reparations, and lead to a peaceful resolution for reconciliation with all others; it is time for all  
8 concerned parties to come forward, to participate in the AARS reparations dialogue.  
9 **22** People have always asked, what should Black People get for reparations for all their cultural  
0 and family losses, massive damage, social impositions, and long eras of despair. **23** The answer is  
1 spiritual guidance for unity, compensation, and land for the 3 AARS models of reparations, in order  
2 to establish self-rule and self-governing, which are the reparations goals. **24** When Black People  
3 and their allies decide to engage and uplift dialogue in the KRP to win AARS, the powers that be  
4 will quickly agree to ratify AARS, to pay their debt and facilitate new peaceful race relations.

16 **25 The Top 10 Reasons** for Everyone 18 and Older to Endorse and Promote the African-  
17 American Reparations/Sovereignty (AARS) Global Black Reparations Plan i.e. **AARS**

18 1. AARS was produced after more than **40 years** of focused research and related studies. It leads  
19 everyone 18 and older to **God** for spiritual guidance, to talk about Black History, Racism,  
20 Oppression, and Reparations openly and honestly, which is the only way to recognize what should  
21 be done to repair all the damage African-Americans have experienced over the last 500 years in  
22 America, and which Black People have experienced over the last 2000 years across the globe. It  
23 will also give African-Americans and all Black People a vision and purpose to **reunite** at home  
24 and abroad. African-Americans and all Black People need to study and embrace Black Nationalism  
25 and Pan-Africanism, to start the Restoration and Reunification Process. They are edified and  
26 inspired by learning about their true roots from Africa's advanced civilizations in ancient times,  
27 along with their truly renowned, native and identifiable names, languages, customs, and cultures.  
28 That will also form a foundation for them to **reconnect** and **uplift** their Global Black Family.

29 2. AARS offers African-Americans and all Black People in America 18 and older, a Black  
30 Plebiscite Vote (**BPV**), to claim AARS, an Injured and Indigenous Status, Sovereignty, and  
31 Certified Programs to Generate our own Reparations Wealth. The opponent's **secret agenda** is to  
32 form many new study groups (state task forces and city committees), which will delay redress,  
33 while their real agenda is to get control of the \$14T kitty. They want to spend the money rapidly,  
34 without national and global schematics in place to guarantee **liberation, safety, and autonomy**.  
35 They want Black People to spend the money fast and foolishly, to enrich Cadillac, Walmart, and  
36 other U.S. Corporations. {{They do not want blacks to have a plan **prioritizing** spiritual guidance,  
37 generating wealth, securing their own prime land, owning and operating all businesses, and  
38 **transforming** mentally into a spiritually led, united group **to demand justice** via AARS redress}}.

39 3. AARS offers programs for rich blacks and those with wealth and compassion to help poor blacks  
40 with very little risk. Their attorneys and bankers verify the **programs are legit**, before signing the

1 contracts for personal gains, and helping to fund AARS. Many people have tried this approach  
2 before, but it should be **stipulated** for AARS, because AARS will help everybody.

3 4. AARS **guarantees** that all African-Americans and all Black People get reparations benefits. All  
4 other redress plans rely on slow government, obedient sellouts, or some miracles to get reparations.  
5 No African-American or any Black person, has any guarantee for reparations, **except with AARS**.

6 5. AARS offers all Black People **safety** within **sovereignty**, which is the only way to stop corrupt  
7 police, white supremacist, and other race haters from killing innocent and unarmed Black People!

8 6. AARS gives Black People choices to remain living in integration, or to use AARS dialogue to  
9 improve integration, expand repatriation, and create sovereignty. {{AARS provides all 3 settings  
10 in a structured manner}}.

11 7. AARS **manages** all emotional, mental, and psychological services, therapies, and treatments.  
12 Black People will also learn how to build companies and corporations, to produce **quality**  
13 **products** for daily use in America, and in great demand abroad. We keep the money in the family,  
14 create great jobs, and provide complete health care **for all Black People**.


15 8. AARS facilitates genuine and lasting **reconciliation** with all nations and races via **economics**.  
16 Black People need apologies, and reparations now, to process forgiveness and new and agreeable  
17 mutual respect for the future.

18 9. AARS gives **great debt relief** to all the governments and all the other guilty groups who owe  
19 Africa and all Black People reparations, **by binding** with AARS to generate and share wealth.

20 10. AARS **guarantees reparations** for African-Americans and all Black People, with a well-  
21 planned, serious, and constant; **AARS Global Black Reparations Plan, Human and Civil Rights**  
22 **Movement via the news and media to demand AARS**, via the **KRP**). We reach out to national  
23 news networks and global social media outlets to engage, endorse, and promote AARS.

1    1. Others got reparations before African-Americans which was not fair, because Black People were  
2    subjugated first, so they should have gotten reparations first. 2 Now, it is a blessing for officials to  
3    finally admit, that Africa and all Black People deserve reparations, for reasons that are documented  
4    as crimes against humanity. 3 After more than 40-years of research we list the U.S. Government  
5    and 27 other culprits as (A) guilty groups who benefited from colonialism and slavery, and caused  
6    emotional trauma and psychological harm for over 2000 years, so they each owe \$20T up to \$50T.

7    4 We offer them AARS to atone with great debt relief, to quickly pay to repair and revive victims,  
8    and earn a small profit; by noting \$20B-\$50B cash to generate wealth, instead of paying their \$20T  
9    to \$50T debt, which they each owe. 5 AARS enlightens and inspires victims and culprits to  
10    willingly accept a refined plan for a settlement. \* \* \* \* 6 Racism has caused turmoil in the world,  
11    so reparations should be a healing and reconciling source for the world.

12    \* \* \* \* 7 AARS is a joint, comprehensive, and all-inclusive reparations plan, for victims to get  
13    restitution and satisfaction, and culprits get an incentive and a reprieve from (B) groups, rich blacks  
14    and others with wealth and compassion. 8 {They are given options to engage in wealth generating  
15    programs lined for immediate action}. 9 As people link reparations with generating wealth the U.S.  
16    Government and all the other culprits, will feel obliged and have a reason to agree to ratify AARS,  
17    ASAP, for quick relief for all Black People, a small profit, and engineering true reconciliation.

18    ↓↓↓10 Money meant for other reparations related work was embezzled, so we ask all those capable  
19    of helping, to engage in wealth generating programs. 11 Blacks need reparations at home and  
20    abroad for suffering from disconnections, social barriers, economic seizures, and institutional  
21    racism. ↓↓↓12 Government groups offer blacks redress city by city, to keep them divided and under  
22    their control, {{so blacks should make it a priority to secure their own land via AARS}}. 13 They  
23    are excluded from rights and privileges others enjoy, because of their forced labor and invaluable  
24    contributions. \* \* \* \* 14 So, we all know Black People deserve, have earned, and are entitled to  
25    have their own land, so ratify AARS now for blacks to get safety and autonomy to last forever.

26    15 It takes \$150T x (2 or 3) for global relief and funding (7) top reparative zones; to rebuild Africa  
27    and repair all Black People back to their peaceful and progressive status they inhabited; prior to  
28    European invasions; which were (1) spiritual guidance to improve self and attain global unity, (2)  
29    Certified Firms (CF) to generate wealth from seed funds (SF), (3) governments grant prime land  
30    to build AARS redress cities at home and abroad, (4) classes and programs to learn how to form,  
31    own, operate, and manage all businesses (5) remedies to start emotional therapies and repairing  
32    vast damage, (6) educational tools to learn all about the 3 AARS models of reparations; which are  
33    integration, repatriation, and sovereignty, then (7) to seek reconciliation with all nations and races.

34    16 SF are noted or blocked in clients accounts for programs duration, so clients cannot lose their  
35    SF. The guilty (A) groups note \$20B-\$50B cash as SF, utilizing the AARS Hedge Fund and  
36    operating U.S. Black Banks. That ensures a reparations money trail, and real redress banking  
37    power. 17 Then one person becomes a client by blocking \$5B cash from the SF, in a new account  
38    at a major bank, then submits a compliance form to one firm. 17 Then clients get contracts for  
39    their lawyers to verify firms and programs are legal, and profits do accrue. 18 The (B) groups open  
40    a new \$100M-\$5B cash account a major corporation, or block the cash in their account at a major

1 bank. Then clients engage on a first come first serve basis. \* \* \* \* \* 19 We also offer AARS to  
2 those at war as a civil solution, because we generate and share generational wealth to end conflicts.

3 **20** We are **fortunate** to have identified Associate, Certified, and Top Law Firms to generate wealth  
4 for humanitarian aid, college and traditional and historical all-black towns, and city infrastructures.

5 **21** The firms rebuilt Germany with these programs after WW II, so Black People should inspect  
6 them for reparations. **22** The programs protocols are for rich blacks and others with wealth and  
7 compassion to engage first, to show the programs are still legit, that will motivate the guilty groups  
8 to engage. Thank you for your consideration and help, as we look forward to talking to you soon.

9 **23 JUSTIFYING THE \$150T REPARATIONS DEMAND:** People who know about the Global  
10 Economy, Money Market Variations, and U.S. Finances know there are only about \$350T on  
11 Record. Therefore, we justify the \$150T demand by shouting, we Generate Our Own Reparations  
12 Wealth with AARS, so there is no limit. We may generate \$150T 2, 3, or 4 times, until all African-  
13 Americans and all Black People get relief and live happy in new, elite, and safe ecofriendly cities.

14 **24** Now, to clarify the issue most scholars agree there is not enough money in the world, to pay  
15 the \$650T reparations debt, that is owed to Africa and all Black People. Nor, are there ample words  
16 in any language, to offer an adequate, appropriate, or worthy apology for crimes and damages like  
17 cruelty, brutality, and life in fear of the police. {{But America's power and the world's economy  
18 come from Black Slavery, so Black People could claim half for debt, relief, damage, disconnection,  
19 emotions, labor, losses, contributions, criminal taxes, lynchings, police killings, and injustice}}.

20 **25** The masses of Black People are **dominated** globally and are forced to live mad, and below the  
21 poverty line. **26** So, AARS **prioritizes building** enough elite and safe cities, with nice homes for  
22 all Black People. **27** AARS **relocates** all blacks who live badly in 3<sup>rd</sup> world countries, poor inner-  
23 cities, and redlined areas, into prime land for immediate action, relief, and a revival. **28** AARS will  
24 repair, uplift, and teach self-determination processes and programs for all Black People to learn.

25 **29** Note, the AAIU proves the \$150T debt from a relative theory, where the punishment should fit  
26 the crime, so **the demand** should fit the **5 evil deeds**, and dissolve all racial barriers. **30** The deeds  
27 range from the 407 BC European plot to invade and capture Africa and enslave Black People,  
28 extending massive pains and capital gains for more than 2000 years! **31** then factor the 5 deplorable  
29 deeds as; 1 Spiritual Decline 2 Wealth Disparities 3 Stolen Land and Resources 4 Stifling Social,  
30 Emotional, Family and Group Socialization and Stability and 5 Perpetrating Deaths and Divisions  
31 for more than 2000 years! **32** Plus, all penalties for more than 2000 years to easily justify \$150T.

32 **33** The AAIU prepares African-Americans and all Black People to regroup and transform mentally  
33 into **a globally united group**, with principles of rules for **sovereignty**, to become a truly **liberated**  
34 and **independent** people. {{They need their own land to get relief from and away from racism and  
35 oppression, so we assess all the malicious, vicious, and extensive crimes to easily justify \$150T}}.

36 **34** The AAIU easily justifies \$150T in another way for spiritual guidance programs, rites of  
37 passage programs, and joining and forming unions to build safe cities. We will secure local and  
38 global sites and staffs for classes, therapies, and services in all areas of people activity. So, \$150T  
39 is required to complete physical and mental restoration, of building cities and renewing minds.

1 \*\*\*\*\***35** Scripture says People Owing a Debt may have to Pay 7x as much, or all  
2 the substance of their house, if they are found guilty of deceit, captivity, and/or usury.  
3 It is relevant because many say the reparations debt is \$150T up to \$650T, which provokes many  
4 new groups to try many ways to get control of those funds. They may have 100 to 1000 **highly**  
5 **credentialed people**, to make it seem as though they *assembled* the best scholars and groups, to  
6 produce the best reparations plan. Yet, it will only be **symbolic** just like all the other meetings with  
7 all the same people. It will not be of any **significance**, unless they all agree on 1 plan to endorse  
8 and promote (AARS), as the 1 plan to repair and revive Africa and all Black People.  
9


10 **36** We should compare all reparations plans instead of having more groups, meetings, or programs  
11 to produce another plan. No Equity Restorative Justice (**ERJ**) for U.S. Blacks to settle for less. We  
12 raised our \$50T ERJ settlement, up to a \$150T payment, to Demand Full Redress (**DFR**) for Africa  
13 and all Black People, since we can generate our own wealth now. ↓↓↓↓ **37** AARS also stops police  
14 terrorist and white supremacist from killing innocent and unarmed Black People! **38** We call on  
15 the masses of blacks, their allies, and all new groups and people *assembled* to endorse and promote  
16 AARS, so the U.S. Government and all the other culprits will agree to ratify AARS, ASAP.  
17 **39** That is truly what we need to redirect funds for wars overseas into AARS to help at home first.

18 ↓↓↓↓ **40** It is crunch time, so we must beware of the boule, sambos, sellouts, and uncle toms in  
19 the reparations arena. They keep blacks down, divided, confused, delayed from justice, far from  
20 full recovery and redress plans, docile, and under the enslavers control! **41** Some say culprits set  
21 \$14T aside for national reparations, which is limited and divisive. So, people are in the reparations  
22 arena with an evil agenda, led by those who want control of that \$14T. **42** Black People should  
23 stay focused and scream and shout they are still victims of racism, oppression, and police terrorism  
24 in integration, **43** so they need alternatives like repatriation and sovereignty for integration.

25 \* \* \* \* \* **44** Black People should **seriously assess and examine the 3 Models of AARS**, to learn  
26 all about programs to improve integration, expand repatriation, and create sovereignty. Then make  
27 a **strong collective demand** via the **KRP** for the U.S. Government to ratify AARS, ASAP. We  
28 will establish all 3 models immediately and simultaneously, for swift justice from an accurate,  
29 complete, fair, full, comprehensive, and viable reparations plan.

1 1 Discussing reparations is a very serious matter. Others got reparations before Black People, but  
2 that was not fair, because blacks were hurt first, and much worse and much longer. 2 So, we discuss  
3 AARS without disruption or retaliation, to learn about the truth from the beginning, to show crimes  
4 and damages posing problems, to form a plan like AARS we validated with universal solutions.  
5 3 We know reparations are way past long overdue, so everyone should confidently, constantly, and  
6 demonstratively, demand AARS Global Black Reparations in all venues, until AARS is ratified.  
7

8 4 God made Africa the birthplace of all of humanity, with very dark Black People as the original  
9 people. 5 He also set resources in Africa to benefit all nations, and intelligence in Africans to lead  
10 all peoples to prosper. 6 {{Learning the true history of different races will show contributions, from  
11 various cultures around the world. Now, observe the great ancient African cultures to learn about  
12 their efficient methods in math and technology, which led to forming and maintaining superior  
13 African infrastructures we admire. Then try to learn the brilliant manner in which they governed  
14 their affairs, and the significance of their impact on the advancement of their civilization, and most  
15 other cultures around the world. Many studies do prove that Africa is the Cradle of Civilization}}.  
16

17 7 Considering those facts and upon early European exploration they learned Africa had much better  
18 weather, bathing and soothing oils, tasty spices, vast resources, and was a strong strategic place to  
19 relocate. 8 They also learned, the great ancient African civilizations consisted of knowledge and  
20 wisdom that was so powerful, that it provided diagrams for most of the wonders of the world, and  
21 for the foundations for society as we know it today. 9 That led Europeans to invade, divide, and  
22 conquer Africa; steal her resources; chain and enslave Black People; and diminish Africa's legacy.  
23

24 10 {{The truth is that the Pope noticed that ► 7 European nations were fighting over African land,  
25 her valuable substances, and billions of blacks to colonize; while in that process they murdered  
26 hundreds of millions of Black People. So, he tried to stop the ► in fighting by suggesting to  
27 partition Africa into 7 territories where resources flourished, so each nation could continue  
28 benefiting from stealing her in ground assets, deviant sex all across the continent, and forced slave  
29 labor}}. 11 {{They actually plotted Africa's demise for the beneficiaries of cruel and brutal crimes  
30 of colonialism and slavery, including profiting from capturing human cargo, capitalizing African  
31 properties and resources, and dominating, indoctrinating, and terrorizing Black People. That  
32 ensued in Africa, all around the Diaspora, and all up and down the Trans-Atlantic-Slave-Trade  
33 Route. These criminal acts still exist and are spreading in America and globally}}, 12 so, AARS  
34 reparations will work to bestow justice and autonomy for blacks, and reconciliation with all others.  
35

36 13 {{Therefore, when analyzing Black Reparations, we have to go all the way back to the  
37 beginning, of the European Invasions in 332 BC. That is how we learn the main problem blacks  
38 have today, is they lost their sovereignty, way back when the invasions began. When blacks were  
39 sovereign, they had control of their own land and natural resources, governing their groups and  
40 tribes of people, and local and national trade}}. 14 Now, a good reparations plan will be national  
41 and global, like AARS, to restore all that has been taken and stolen out of Africa, and from Black  
42 People. It will include mental therapy programs for ages and centuries of oppression, which planted

1 emotional trauma and psychological disorders. 15 So, AARS terms can impart modes for spiritual  
2 guidance as part of a plan to regain sovereignty and procure cerebral recovery, as a prerequisite for  
3 unity; monetary relief for loss of lives and resources; and land grants in America, Africa, and  
4 globally, to return or settle blacks back to land that was stolen from them, to amend the intrusions.  
5

6 **16** The Kwanzaa Reparations Project (**KRP**) is a reading task to start and elevate a peaceful  
7 political process for a public project to expedite all blacks winning AARS, and others accepting  
8 and binding with AARS. **17** KRP is a vision to get all blacks and everyone else 18 and older to read  
9 and discuss all docs on their homepage. The process should produce a transforming procedure in  
10 the minds for all non-blacks, to stop thinking about and treating Black People so bad and cruel. **18**

11 **17** This is critical for blacks, because vestiges and beneficiaries of slavery, do cause others to  
12 mistreat blacks. The oppressors created a crash caste system to show and spread degrading images,  
13 malicious propaganda, and primitive stereotypes of Black People. That enabled them to enslave  
14 Black People, and it also influenced most others to abuse, deceive, and exploit Black People;  
15 extending massive damage. **18** Blacks need to and should promote the KRP all around the world,  
16 to get all others to start thinking about and treating all Black People fair and just. ♦

17 Perhaps we should specifically summarize AARS for clarification, to confirm AARS offers Global  
18 Black Reparations, and Worldwide Racial Reconciliation, to benefit all African-Americans, all  
19 Black People, and everyone else in America and on earth ♦.

20  
21 **19** Now, AARS offers redress for all 50 million blacks in America, and all 1.5 billion blacks  
22 globally. This is done with programs for a spiritual renewal for unity, generating wealth from seed  
23 funds (SF) for emergency relief, and by getting prime land for all three models of AARS  
24 reparations. **20** Model one, is to improve integration via racism dialogue and case studies. Model  
25 two, is to expand repatriation so they reconnect with their extended Global Black Family, learn  
26 their native names, languages, customs, and cultures; and draft a resolution for Black Nationalism,  
27 Global Black Unity, and Universal Racial Reconciliation. Model three, is the most important model  
28 to create sovereignty, for African-Americans and all Black People to demand their own land for  
29 liberation and independence. **21** Then most governments should grant blacks their own land, that  
30 can never be confiscated for eminent domain, or any other excuse that they ever devise. **All Black**  
31 People need their own land after enduring extensive and fatal atrocities to forgive and live in peace.

32  
33 **22** Three beautiful services of AARS are giving Black People time to recover and regroup  
34 personally and collectively, and seeking to grow spiritually. Blacks must learn to love and trust one  
35 another, to prosper in sovereignty, as they get control of their own land, cities, institutions, and  
36 lives. **23** So, all governments, and all others who benefitted and gained unjust enrichment, while  
37 causing severe psychological damage and acute emotional trauma, from colonialism, the middle  
38 passage, and slavery; **24** should agree to atone by offering a sincere apology, and binding with  
39 AARS to generate wealth for all Black People, to raise the Global Black Economic Foundation  
40 (the AARS Hedge Fund), and to initiate mutual respect and benefits for descendants of slaves, who  
41 are also the offspring of the most noble leaders and spiritual deities. **25** The KRP will also help to  
42 form better images of Africa and Black People, and improve race relations now and forever.

1    26 We know reparations means one group claiming redress, engaging a political process, or filing  
2 lawsuits for crimes inflicted by others, to get justice. 27 The U.S. Government was liable for minor  
3 damage done to others, so they were right to give them formal reparations, but they were wrong to  
4 give others reparations before Black People. 28 The U.S. Government and all the other guilty  
5 groups, are liable for major damage done to Africa and all Black People first, so blacks should  
6 have gotten reparations first. 29↓ Now, coping with Black People being denied reparations is an  
7 insult to their entire race, and it triggers Post Traumatic Slave Syndrome (PTSS), because blacks  
8 needed and should have received reparations right after slavery. 30 Since AARS was not ratified  
9 for June 19<sup>th</sup> of 2024, we should lift calls and demands for AARS in all venues until it is ratified!!

10    31 There are some pivotal reparations plans with good ideas to offer, but they all rely on lawsuits,  
11 reluctant sources, or some miracles to get reparations. That is highly unlikely and may never  
12 happen. \* \* \* 32 {{So, AARS is the only reparations plan that **will enable Black People to**  
13 **generate their own reparations wealth**, from seed funds (SF) for the next four or five 50-year  
14 terms, to raise \$150T to fund what they have earned, deserve, and are entitled to, which is AARS}}.  
15    33 {{AARS also offers processes, programs, and services to regain control of their home and  
16 motherland Africa; or at least to get most of the wealth from her resources; reconnect with their  
17 Beautiful Culture and Global Black Family; repair all damages and injuries; solve all problems;  
18 recover most losses; and transform mentalities to attain and secure global unity, for collective  
19 safety, peace, and progress. 34 Then we provide services for all Black People to make a choice to  
20 take advantage of the opportunity to get on the right path, to heal and self-actualize personally, and  
21 to uplift relations among their people at home and abroad, then with all other nations and races.

22    \* \* 35 No other plan even comes close to offering all these amenities, concessions, and  
23 requirements. So, we are calling on the Global Black Family and their allies, to engage in the KRP  
24 peaceful and political reading process on their free time, planned reserved times, and also to honor  
25 Kwanzaa at home and abroad. We circulate, read, and discuss all docs on the homepage, to learn  
26 all about AARS, before making our serious and constant national and global demands for AARS.  
27 That should inspire most reparations advocates, then the masses of Black People and their allies,  
28 to faithfully endorse and promote AARS, until it is ratified. 36 The KRP is a peaceful and political  
29 process which include a Black Plebiscite Vote (BPV) for all U.S. Blacks 18 and older in 2025-6,  
30 outlined in the next 3 paragraphs as another **power move**, like generating their own wealth.

31  
32    37 The BPV indicates Black People are indigenous to this land called America, as distinct relatives  
33 of the Great Ancient Black African Olmecs, who were here first building civilizations, not Native  
34 Americans or Mesopotamian Mexicans. 38 So, everything Indians and Mexicans ever got for any  
35 kind of aid or help, especially in the name of sovereignty before Black People, should be turned  
36 over to the rightful recipients, Black People. 39 {{Thus, all blacks deserve the rights and privileges  
37 of indigenous people, like land and emergency cash relief which will eventually come with AARS.  
38 We have not won AARS yet because we have not utilized the KRP. With KRP participation and  
39 momentum, we gain land, other reparative measures, and the last part of AARS; which is a national

1 and international declaration and treaty, from all governments, militaries, and lobbying groups with  
2 power, of non-repetition of slavery, and for safety and equality for all Black People}}.

3 **40** The BPV also gives U.S. Blacks a chance to finish the Civil Rights Movement (CRM), because  
4 they were forced to integrate. That is when blacks should have been awarded 40 acres and a mule  
5 they were promised, but never received right after slavery. **41** Since they were maliciously denied  
6 freedom, justice, equality, safety, and fair wages, before the CRM, and now they suffer from more  
7 covert operations sustaining oppression after the CRM via AIDS, Drugs, and Infiltrating Black  
8 Churches, that blacks should have demanded and gotten options to examine the three models of  
9 AARS reparations, right after the CRM. **42** The three models are (1) to improve integration, (2) to  
10 expand repatriation, and (3) to create sovereignty; then they use the PV to claim 1 of the 3 models  
11 for residence. **43** It was too early for Black People to integrate after the CRM; because the country  
12 was still in chaos from avid civil disobedient movements in bussing, freedom rides, protests, and  
13 sit-inns; then she erupted after Dr. King's assassination, which caused the CRM to end abruptly.

14 **44** So, when U.S. Blacks 18 and older take their BPV, they will claim an injured and indigenous  
15 status by name, (Indigenous African-American, or Indigenous Black-American). We will officially  
16 seal a group status, to get emergency relief land grants of 40 areas of 40 square miles (40 mi<sup>2</sup>), of  
17 prime land; to build new, elite, and safe cities for calmness and comfort. **45** Now we propose Black  
18 People will use the BPV to officially claim a status, to officially claim AARS, and to officially  
19 choose 1 of the 3 AARS reparations models for residence. **46** {{Next, we explain the 3 reparations  
20 models as another **power move** like the PV. Blacks should learn they do not have keep living in  
21 integration, with violence, crime, corruption, and police terrorism; becoming common, wreaking  
22 havoc, and escalating out of control! So, they should make learning about the 3 models a priority}}.

23  
24 **47** (1) Improving Integration: The AAIU and their allies will form the AARS Congress as a Power  
25 Base to implement the AARS Global Black Reparations Plan. The AARS Congress will consist of  
26 leaders, residents, and conscious people **with a track record of helping Black People**; those who  
27 are knowledgeable of reparations; those with reparations ideas and plans; those from other  
28 reparations groups; those protesting social inequality, injustice, and police terrorism/killings; those  
29 giving input on AARS; and those who are clear, confident, and savvy on understanding and  
30 collaborating in advanced methods of spirituality, education, diplomacy, law, politics, and reform.  
31 **48** The AARS Congress will host a 5-Year National Dialogue on racism, corruption, and police  
32 terrorism/killings; and host 5-Year Case Studies on various businesses, entities, institutions, and  
33 systems in America; to improve their performance for, and interaction with Black People. Both  
34 programs will improve integration, and police and race relations much more than imaginable. {{So,  
35 AARS starts and sustains, justice and racial healing, for the U.S. to become a civil society}}.

36 \* \* \* **49** {{All U.S. residents 18 and older should endorse AARS as reparations for blacks, and  
37 AARS racism dialogue and case studies to produce positive changes in all areas in society, because  
38 it will **benefit all Black People, and everyone else in America}}** **50** AARS also provides financial  
39 services for blacks to use reparations most wisely, and not to squander them by themselves or with  
40 others. \*\* **51** That is key because **Black People should celebrate after AARS is ratified**, but limit

1    their partying and rejoicing. Blacks provided many vital contributions, while enduring racial  
2    suppression and profiling others have avoided because of their race, **so blacks need reparations**  
3    **ASAP.** \*\*\* **52** So, we ask all churches and everyone else to shout long and loud for AARS.

4    **53** (2) Expanding Repatriation: Repatriation is going **back to Africa, down south, or any other**  
5    **place on earth** where Black People were colonized, enslaved, and/or exploited. We will get  
6    leaders from a few worldwide groups like (Marcus Garvey's, Randall Robinson's, and the African  
7    Women Leaders Network), on the AARS Congress to direct repatriation. They will get permission  
8    from leaders in the places down south or overseas, where blacks choose to go to visit, or to live.  
9    With AARS we exalt and simplify the repatriation process at home and abroad.

10    **54** Blacks should learn the customs of their people in the places where they choose to go, to make  
11    sure they do not offend their distant relatives on arrival, and to go with a sense of belonging and  
12    gratitude. AARS offers **Global Black Family** Healing, Recovering, Reuniting, and **Transforming**  
13    of the **Mentality Process**. They will also go with ample resources to build new, beautiful, elite, and  
14    safe repatriated cities. By learning their native names, languages, customs, and culture; they  
15    prepare for their **Global Black Family** and Culture **Restoration Process**. We emphasize AARS  
16    will also provide services for all Black People to get **dual citizenship**, to enhance both processes.

17    **55** (3) Creating Sovereignty: The most important model of reparations, because we ask African-  
18    Americans and all Black People to develop a new line of thinking. To nurture the desire to leave  
19    the restraints of others, to seek their own land at home and abroad for self-governing and self-  
20    control. They will look out for their own best interest, by declaring and pursuing their own political  
21    and ideological agenda and destiny. So, most then all blacks should leave the **shackles** of  
22    integration, to get **control** over their lives in repatriation and sovereignty. Granting absolute power  
23    and authority of a consenting people, to form their own governments, and to manage all activities,  
24    businesses, entities, people, resources, and systems within their city limits. **56** Black People are  
25    held down and controlled by others in integration, and that is their main problem. **57** So, blacks  
26    need their own land to leave multiple problems and foul police in integration, and to provide basic  
27    life needs like quality jobs, homes, and foods for their people themselves.

28    \*\*\* **58** Blacks should also learn **sovereignty** is their **salvation** at home and abroad. It requires all  
29    people to know that it is **their inherent right** to have their own land, **to govern themselves**. The  
30    U.S. Government should grant U.S. blacks 40 areas, of 40 mi<sup>2</sup> of prime land, near traditional black  
31    cities, symbolic to 40 acres and a mule, to build their own new, elite, and safe, repatriated and  
32    sovereign cities, with the latest technology. \*\*\* **59** AARS city planners designed facilities from  
33    artistic views, for public and private places, in appreciative and flawless styles, to honor their  
34    Amazing Classical African Civilizations, noted Freedom Fighters, and brave Political Prisoners.

35    \*\*\* **60** AARS city plans also poses **building beautiful** infrastructures and homes, including  
36    shopping malls, parks, schools, highways, roads; and successful associations, businesses,  
37    companies, and global multinational conglomerate corporations; with excellent communication,  
38    protection, traveling, and nutritional services. AARS city citizens will also produce products used

1 daily in America for local and national commerce, and produce products in great demand abroad,  
2 for global trade and commerce. \* \* \* 61 Many blacks have good and great ideas for businesses,  
3 products, and projects. By claiming AARS they use the SEEG to generate wealth, to fund all  
4 proposals Black People vision in their own cities, no more acquiescing, or begging. 62 So Black  
5 People will **rise** like proud **producers** - Instead of Continuing to **Fall** like Injured **Consumers**

6  
7 \* \* \* 63 **Generating Reparations Wealth:** This should be **the deciding factor** to get everyone 18  
8 and older to endorse and promote AARS. Since AARS is a thorough, comprehensive, and complete  
9 plan to repair, recover, heal, transform; and set black folks on the right path to good health, peace,  
10 protection, and prosperity; it is a real blessing for them to be able to generate their own reparations  
11 wealth via SF, to guarantee AARS reparations benefits for African-Americans and all Black  
12 People, and to implement AARS without interference. 64 We ask everyone 18 and older to engage  
13 in AARS Dialogue via the KRP, to stop conspiracies and corruption in reparations arena, and to  
14 discuss and demand AARS. 65 Most Black People live in poor social conditions, so they need  
15 monetary help first, then HBCUs, and Black Institutions to benefit the masses of Black People.

16 66 In America the AAIU sources identified the U.S. Government, the other 27 guilty groups, all  
17 rich blacks, and all others rich with compassion for blacks, as potential clients to engage SEEG  
18 programs to generate wealth upon notice. 67 Now all the guilty governments and groups each owe  
19 much more than \$20T, and more like \$30T up to \$50T each. So, another great benefit of AARS is  
20 providing great debt relief for governments, and all the other guilty groups, by asking them to **note**  
21 \$20B-\$50B cash as SF, to utilize the AARS Hedge Fund, and operating U.S. Black Banks, instead  
22 of **paying** their \$30T-\$50T debt, which they each owe. \* \* 68 The greatest benefit of the wealth  
23 generating programs is SF are blocked in clients accounts for the programs duration; from 10 days  
24 to one year to maximize profits; then SF are unblocked afterwards, so, clients cannot lose their SF.  
25 These programs are safe with multiple daily transactions, for big profit in little time with little risk.

26 69 We go to all potential clients with programs to generate wealth for AARS, 70 instead of settling  
27 for less, crying or forgetting about the past, or filing difficult lawsuits to win with U.S. courts  
28 declining justice due to Standing, Statute of Limitations, and Sovereign Immunity. 71 Please shout  
29 generating wealth expedites the process for all Black People to get immediate benefits at home  
30 and abroad. 72 It is politically incorrect and socially unacceptable to continue to deny blacks  
31 reparations, especially since they can generate their own reparations wealth now, and others got  
32 restitution before them, which was totally wrong!! ↓ ↓ ↓ 73 {{We list harmful and major damages  
33 of losing their home and mother land called Africa; their wealth; culture and family; and 600  
34 million Black People killed due to racism; to demand all black folks get AARS, ASAP}}.

35 74 We ask all rich blacks, and all others who are rich with compassion for blacks, to block \$100M-  
36 \$5B, or block the cash in a new account at a major bank, then complete a compliance form to enter.  
37 Rich blacks and the compassionate should work with their attorneys and bankers to verify these  
38 programs are legit. Then they start the process to negotiate bank endorsed contracts, to aid AARS  
39 earn a high profit in little time with little risk, and to sway and inspire all guilty groups to engage.

1    75 The AAIU and their Allies Now and Forever KRP Task has 4 Points; (1) To Ask all Black People  
2 and their Allies to Endorse and Promote AARS; (2) To Ask Many Potential Clients to Provide SF;  
3 (3) To Ask the U.S. Government to Ratify AARS, ASAP, or by Kwanzaa '25, so all the other guilty  
4 groups will agree to engage and sustain; (4) to award **all Black People AARS aid** at home and  
5 abroad, ***as a Gift to the Global Black Family***. Since AARS was not ratified for 6-19-24, we must  
6 make it a point **to increase and intensify** many **more calls and demands for AARS**, until the  
7 U.S. Government, and all the other perpetrators, culprits, and guilty groups agree to ratify AARS.

## 8    76 GUIDELINES FOR PRODUCING A REPARATIONS PLAN

9    77 {{To clarify the reparations position we attest it is wrong for the AB 3121 group, or any group  
10 to declare Black People **should prove** lineage, their DNA, region, tribe, or **anything else** to qualify  
11 for reparations}}. 78 AARS serves rapid action with an ID process on page 16 of their Closing  
12 Summary; to guarantee African-Americans and all Black People receive reparations benefits.  
13 79 Africa and all Black People have endured Aggression and Repression, and Pain and Suffering  
14 for more than 2000 years globally, and more than 500 years nationally. The result of the long eras  
15 of Mistreatment and Exploitation forced Africa and all Black People to become victims of harmful  
16 Spiritual Decline, large Wealth Disparities, and Dire Ethnic Social Barriers. 80 So, by assessing  
17 those 8 reasons, Africa, African-Americans, and all Black People need reparations to forgive and  
18 get quick relief, to repair all damages, recover most losses, recuperate, reconnect, and transform.

19 81 It is also wrong for the AB 3121 group, or any other group to have public meetings, prior to  
20 releasing findings to produce a reparations plan. They will not get scholarly input, they will only  
21 get emotional testimony, and that is only good for venting frustration regarding injuries of the past,  
22 which are concurrent with problems which must be solved today. 82 So, they will not receive  
23 specific info to produce a very good, strong, and structured reparations plan like AARS. 83 They  
24 obstruct justice and impose stress, just by asking blacks for proof, because all blacks require  
25 redress to make them whole, after experiencing acute anxiety, deep depression, and social barriers,  
26 from the 8 reasons stated in the prior paragraph. They caused a deadly impact to Africa and all  
27 Black People as victims of anger, aggression, slaughter, genocide, and crimes against humanity.

28 84 It is critical for most blacks to become **proactive** in the reparations movement **to contest** the  
29 current tone, because they are about to get played like a group of instruments with no intelligence.  
\* \* \* \* \* 85 The AAIU combined more than 40-years of in-depth research in order to produce  
31 AARS, so all blacks and everyone else 18 and older should want to read and discuss all docs on  
32 the homepage. AARS was written to get justice for blacks, and facilitate global reconciliation.

33 86 Upon reading the docs people will find many strong reasons to endorse AARS. Like gauging  
34 economic setbacks across entire continents and hemispheres, along with African wealth transfer  
35 for more than 2000 years, to make other nations and peoples rich and prosper, to determine a fair  
36 settlement is \$2M via 20 \$100K payments for **emergency relief** for all African-Americans and  
37 Black People in the U.S. who are 18 and older, and all Black Families abroad, **for the next 20**  
38 **years**; because land, cities, and safety should be a top priority and met within the next 20 years.  
\* \* \* \* \* 87 {{The top goal for the victims should be to get spiritual guidance, an emergency

1 monetary settlement, and sovereign land via utilizing the KRP to demand AARS. In the process  
2 all blacks and their allies should make bold and constant calls to congress to demand AARS}}.

3 **88** Therefore, Reparations Advocates should host AARS Dialogue to **expedite** the process for all  
4 Black People to get reparations, to **examine** the 3 AARS models of reparations, and to **prepare** all  
5 Black People to use reparations wisely. \* \* \* \* **89** {{AARS is the best reparations plan by far  
6 because it has **3 models** to start immediate and simultaneous action for justice, to (1) improve  
7 integration, (2) expand repatriation, and (3) create sovereignty. Now another priority and a  
8 significant fact is they will generate their own reparations wealth from SF. Profits are negotiated,  
9 ideally 25% to clients, 65% for AARS, and 10% for fees. That should encourage the U.S.  
10 Government and all the other guilty groups to engage quickly, from caring incentives such as  
11 atonement, great debt relief, and sharing profits for reconciliation}}.

12 **90** It is a blessing to know **money** was given to help, but it was **embezzled**, so everyone who wants  
13 to help should engage in the wealth generating programs, for a safe profit and reconciling. If the  
14 U.S. Government and the Vatican secretly slated \$14T for reparations, that is not nearly enough,  
15 but it is okay because we can easily generate \$150T a few times from those and other SF, to fund  
16 AARS. **91** Wealth generating programs are secured by system banks, credit facilities, and officers,  
17 so SF yield rapid, high, and safe profits with very little risk. AARS will serve relief, redress, justice,  
18 and satisfaction for all Black People; and all other nations and races who endorse AARS.

19 \* \* \* **92** With AARS Black People learn to **transform their thinking** to improve self, to strive for  
20 global unity, and to know they are **inherently entitled** to their own land, to govern themselves and  
21 to build their own new, elite, and safe cities. **93** They demand to stop being owned and controlled  
22 by others, haters, puppets, and old laws; \* \* \* \* **93** in order to attain what they truly need most;  
23 a new spiritually led mindset, land, and wealth; for self-rule and self-governing. They will finally  
24 become their own educators, employers, and providers for housing, health care, and military police  
25 to keep their cities and citizens safe. \* \* \* \* **94** AARS will solve a myriad of lethal and lingering  
26 problems to establish group safety and autonomy to last forever. **95** Blacks have resisted  
27 encroachment and violence for ages, and they are still victims of transgression, so they need a  
28 break from hostilities, which are rising in integration. **96** So, AARS prioritizes restoring and  
29 renovating traditional and historical all-black towns and settlements. and locating and engineering  
30 prime fertile land in clean environments to build new, beautiful, elite, and safe repatriated and  
31 sovereign cities, at home and abroad. That should occur in all places where Black People were  
32 abused, colonized, enslaved, exploited, or victimized; by racist intrusions, policies, and practices.

33 **97** Racism and oppression have wrecked the balance of a level playing field in society for image,  
34 status, and in the arrangement of human relations and expectations for all Black People. They are  
35 said to have a strike against them just by being born black. **98** So, all blacks should stop teaching  
36 their children that life is fair in America, and teach them the truth. Their parents should teach their  
37 children that if they get a higher education, it will give them a better chance to get a higher paying  
38 job, to offset racism and live good. **99** So, let us admit we live in *cycles of fear and anxiety* at  
39 home and abroad, because racism is the dominant force in all societies around the world. Therefore,  
40 Black People should learn all about racism and oppression. Dr. Frances Cress Welsing defines and

1 explains racism/white supremacy in her book called the Isis Papers. It should be required to read  
2 before writing a reparations plan. A few others are How Europe Underdeveloped Africa by Walter  
3 Rodney, the Destruction of Black Civilization by Chancellor Williams, the Pale White Horse by  
4 White scholars, and the Secret Relationship between Blacks and Jews by Jewish scholars; and the  
5 17 set VHS series called “Eyes on the Prize” to see why blacks need sovereignty and independence.  
6 **END OF GUIDELINES**

7 Dr. Welsing said, “Black People were brought here for **slavery**, and now they are just here for **wars, labor, taxes, and entertainment**”. I say, “**they are misused and do not get any justice** and **definitely not in the courts**. 100 They suffered severely and extensively as a group, 101 so they should get  
8 reparations abundantly and fully as a group. 102 Anyone trying to limit or deny any black person  
9 reparations aid is leading criminal activity, and must be **prosecuted** to the fullest extent of the law.

10 103 Black People suffer from major problems, which had and have a wide range of fatalities on  
11 their entire race, like the Red Summer, FBI’s Cointelpro, and the U.S. Draft. They are noted in a  
12 list of 30 reasons for blacks to claim reparations in the U.S. on our AARS Closing Summary.

13 \* \* \* 104 Everyone 18 and older should read those 30 reasons, then decide if they will endorse  
14 and promote AARS. 105 {{The U.S. was in an uproar before, during, and after the Civil Rights  
15 Movement (CRM). So, President Lyndon B. Johnson called for the Kerner Commission Report,  
16 after Dr. King’s assassination; to study why blacks lived in such poor conditions; what could be  
17 done to improve those living conditions; and how blacks embraced unity and organized to propel  
18 the CRM, but the government concealed the report}}. ↓↓↓↓ 106 Then they **infiltrated** Black  
19 Churches to stop Black Preachers and Black People from calling for more CRM, to demand justice.

20 107 The report offered proposals which would have provided national sweeping reforms, to have  
21 a positive impact, and improve those living conditions for African-Americans and all Black People  
22 in the U.S. Now a good reparations plan should be national and global like AARS, with programs  
23 for spiritual guidance to improve self and formulate national and global unity, and programs for  
24 safety and progress; along with land, cash, and social mobility via repatriation and sovereignty as  
25 stated herein. ↓↓↓↓ 108 {{Regrettably, agent provocateurs, the boule, sambos, sellouts, and uncle  
26 toms are taught and paid to prevent Black People from attaining full recovery plans, and sadly they  
27 are in the reparations arena. They also try to discredit and discourage other reparations activists}}.

28 109 All government groups work from the H.R. 40 position, which is limited to otiose studies and  
29 creating restricted proposals, instead of just comparing and choosing one reparations plan, which  
30 should be the limit and range of government involvement. 110 AARS is a complete and viable  
31 reparations plan that provides clarity, and reduces conflict confusion and dissension in the ranks.

32 111 It also stops preconceived notions for collaborated corruption to pay for more otiose studies.

33 112 AARS sanctions programs for spiritual guidance, generating wealth, acquiring land, owning  
34 and managing all businesses, and facilitating worldwide reconciliation. Please engage in the KRP.





1    1 How Governments / Guilty Groups / Sympathetic Groups Repair Africa and all  
2    Black People via **AARS** 2 We Generate Wealth and Secure Prime Land Grants  
3    to Build New Elite and Safe Repatriated and Sovereign Cities  
4

5    3 We ask Everyone 18 and Older to Assess the 3 Videos and 7 Docs  
6    on this Homepage to Compare AARS to all other Reparations Plans  
7    to Learn AARS is the Most Suitable Viable and Comprehensive Reparations Plan  
8

9    4 The long and evil eras of European Invasions caused Africa's Destruction and Downfall, caused  
10   social and emotional damage, caused global racial oppression, and the legacy still imposes a  
11   disruptive impulse and negative impact on the entire black race! 5 So, Africa and all Black People  
12   deserve, and are entitled to reparations. 6 We issue a strong order to cease and desist all new ideas,  
13   groups, and programs for reparations, because we already have some reparations plans to assess  
14   including AARS. 7 AARS has ideas from our great scholars of the past and present, and issues full  
15   recovery. AARS exalts spirituality, unity, generating wealth, solving all problems, and reconciling.  
16

7    8 Many scholars studied reparations for many decades then produced their reparations plans. Now,  
18   it is best to compare all reparations plans, to find many advantages and strong reasons to demand  
19   AARS. 9 More plans will cause confusion, dissention, and delays, and they surely will be similar;  
20   but will not gain any land, power, or respect. 10 Reparations for Africa and Black People are way  
21   past long overdue, so stop all activity from new groups **11 because AARS should be ratified ASAP.**  
22

23   12 More plans could diminish or cancel what Black People should get for reparations. 13 We  
24   alleviate that problem with SEEG safe programs to generate wealth. We can generate the \$150T  
25   required to fund AARS in the next four 50-year terms ourselves. Reparations funds should go to  
26   safe programs to generate more and on-going wealth for AARS. We guarantee transparency and  
27   reparations payments for all U.S. Blacks 18 and older, and for all Black Families abroad, ASAP.  
28

29   14 Good communication in the KRP will get most TV and social media to get most Reparations  
30   Advocates, most Black People 18 and older, and their Allies in the church, politics, education,  
31   movies, business, law, and sports; to demand the U.S. Government and all the other guilty groups,  
32   who benefitted from awful crimes during long eras of colonialism and slavery, and caused deep  
33   emotional and psychological trauma for more than 2000 years, to agree to ratify AARS, ASAP.  
34

35   15 The annual KRP reading cycle is also a peaceful political process, and humanitarian project for  
36   Black People and their allies to get a good education and preparation for reparations, and for Black  
37   People to promise to use reparations wisely. 16 Black People have been victims of racism/white  
38   supremacy, and police terrorism since they came to America. 17 It is time to use AARS to promote,  
39   attain, and maintain national and global unity; to achieve collective love, peace, and progress.  
40   18 I have been talking to many clients with means and integrity regarding generating wealth, as a  
41   **corporate service**, before they ratify AARS. The SEEG found a few companies managing

1 programs to generate wealth to fund humanitarian projects. The funding programs range from  
2 \$100M-\$5B, and can yield high rapid returns with very little risk, so the programs are safe and  
3 good for reparations. The SEEG negotiated with these companies to use for AARS. **19** I entrusted  
4 my main client to ask some high profiled and wealthy people, to do due diligence on the programs  
5 with our team. We will confirm validity in two days. Then my clients and the others may choose  
6 to engage the max \$5B contracts, for a minimum profit of 15%-25% per week. Then they ask their  
7 friends and sponsors to join at their comfort level from \$5B-\$25B, to help fund AARS.  
8

9 **20** I have a few \$5B-\$25B clients now so it is a priority to get validity, to raise the \$150T to fund  
10 AARS. We will engage many more clients to secure funding for AARS. **(21)** The AAIU is asking  
11 the Congressional Black Caucus (CBC) to ask our government for \$50B from our tax dollars, for  
12 a \$1T profit deferred over 40-years; to recoup war costs overseas, relieve the U.S. national debt  
13 and boost her economy, and to help all Black People at home and abroad. **22** Note: they help others  
14 abroad before they help Black People at home first. **23** So, Black People need a National and  
15 Global Civil Rights Movement via the KRP and social media, to demand and win AARS, ASAP!  
16

17 **24** Then the AAIU will ask the other 27 guilty groups who were found liable for damage, to engage  
18 at a structured level with their \$20B up to \$50B. {{The protocol and preference are for rich blacks  
19 and others with wealth and compassion, to engage first from \$100M-\$5B}}. **25** When the rich  
20 blacks and others start the process, it will inspire the guilty groups to engage. This AARS economic  
21 piece facilitates genuine and lasting reconciliation, because the guilty groups can atone with great  
22 debt relief, while victims get long overdue emergency relief for generations of suffering.  
23

24 **26** I am asking strong **God-fearing** reparations activists, grass roots leaders, and civic oriented  
25 people; along with top athletes, attorneys, doctors, educators, entertainers, police overseers,  
26 politicians, preachers, psychologist, scientist, therapist; and experts from all races, in all private  
27 and social services, sectors, systems, and institutions; to serve on the AARS Congress with me.  
28 **27** We will form solutions and provide services in all fields, and lead in implementing AARS. We  
29 ask everyone 18 and older, mainly college students, networks, and the social media, to use their  
30 means, to endorse and promote the KRP to help us win AARS, and support the AARS Congress.  
31

32 **28** We invite clients who are ready, willing, and able to engage in the wealth generating programs.  
33 I have asked my clients to ask other philanthropist, and to ask Bill Gates to ask all wealthy groups  
34 to engage. **29** Rule: if a person or group is suspicious of activity that led to abusing, colonizing,  
35 deceiving, depopulating, enslaving, exploiting, insulting, or relocating Black People, they should  
36 apologize to atone, and help to repair the damage they inflicted by engaging in the safe programs.  
37 That is not letting them off the hook, that is holding them accountable by asking them to engage.  
38

39 **30** We know many of them have the wealth, combined with deep compassion for the less fortunate  
40 victims. Now, we offer potential clients a few incentives; the 15%-25% min. return per week on  
41 their SF; receiving agent fees for recruiting other clients; the option to serve on the AARS Congress

1 with people who have knowledge and experience in spiritual renewal, generating wealth, acquiring  
2 land, political influence, city reform, and people transform; **31** then endorsing AARS for Global  
3 Black Reparations, and Universal Racial Reconciliation.

## 5 **32** The Demand and Need for AARS at Home and Abroad

7 **33** we know there are many reasons for Black People to claim reparations in America, which calls  
8 for a plan with viable solutions, but the plan should be national and global, because Black People  
9 were damaged at home and abroad. **34** So, let us disclose our list of 30 reasons for blacks to claim  
10 reparations in America, even though there are many more we will discuss later, but we reiterate  
11 the plan should help all blacks. **35** We ask everyone 18 and older to assess the 30 reasons, then  
12 decide if they will help us to get more endorsements and promotions for AARS. **36** The reasons  
13 set a \$5T claim for each violation. “That is one way we justify the \$150T Demand to fund AARS”.

15 **1. Racism/White Supremacy (R/W):** because it caused Africa and all Black People to experience  
16 long-term invasions, colonialism, slavery, and fatalities for hundreds and thousands of years!

17 **2. The African Holocaust/MAAFA:** caused by long eras and high rates of casualties and  
18 devastations on Slave Ports, Slave Ships, the Middle Passage, and Life in Bondage and Misery!

19 **3. Psychological Damage:** caused by enduring wrongful repulsive acts, lies, and deceit, going  
20 back as far as the Nicaean Conference, plotting European Invasions in 407 BC, and includes the  
21 whitewashing of biblical writings!

22 **4. The Pope and the Church, the Rothschilds and the Jews:** for their role in (planning, starting,  
23 and not speaking out against slavery), and in (accruing hidden wealth in the hundreds of trillions)!

24 **5. Faith Based Initiatives and 501(c3) Programs:** keeping Black Churches, Organizations, and  
25 Leaders from the struggle, and limiting or excluding their participation in collective movement!

26 **6. Slavery in 3 Terms:** 1<sup>st</sup> in economics withholding their wages and wealth, from their labor and  
27 inventions, 2<sup>nd</sup> by passing slave laws, codes, and restrictive covenants to keep them subjugated,  
28 and 3<sup>rd</sup> for emotional abuse and psychological trauma!

29 **7. Failures of Reconstruction, Share Cropping, and Integration:** after slavery blacks were  
30 given false promises to achieve equality, but they failed in all 3 of those life-threatening models!

31 **8. Jim Crow Segregation:** forcing blacks to live in overcrowded, insect infested, underserved  
32 ghetto areas. Now, they are still victims of a system operating with separate but not equal policies!

33 **9. Attacks, Bombings, and Massacres:** of all Black Towns, Churches, Institutions and Homes,  
34 from Fannie Lou Hamer's and Dr. King's, to the Alabama Church killing 4 young black girls!!!!

35 **10. KKK and Police Terrorism, and Racist Groups Like the White Citizens Council:** in a list  
36 of hate groups who killed blacks, crushed their plans for equality, and prevent peace and progress!

37 **11. Freedmen's Bureau Murders and Bank Thefts:** when thousands of blacks were killed as  
38 Freedom Fighters, and millions of dollars and acres of land were stolen way back in the 1800's!

39 **12. Stolen Legacy:** seizure of black inventions and family and tribal land and assets; being left  
40 out of history; never receiving credit or compensation for their origins, contributions, or genius;  
41 and causing gross ethnic poverty, dire racial oppression, and low self-esteem on a global scale!

1   **13. The Red Summer:** In the summer of 1919 the country went up in smoke, as white mobs  
2   burned all Black Towns, and killed African-Americans all across this nation!

3   **14. Institutional Racism:** using their learning, social, and legal institutions, to systematically  
4   deny Black People equal access to a quality education, employment, housing, and healthcare!

5   **15. Discrimination:** denying blacks equal access, using white preferential treatment to separate  
6   the races, and a hidden agenda to preserve the status quo, and maintain black oppression!

7   **16. Genocide:** creating and allowing drugs and viruses to spread, while concealing the cure; and  
8   population control subtly imposes death and destruction via Abortion, AIDS, and Experiments!

9   **17. Corruption and Divisions:** Corruption is costing the U.S. to lose billions every year, which  
10   should be for reparations and domestic issues; and Africa and Black People divided by outsiders!

11   **18. Assassination and Silencing of Black Leaders:** like Martin, Malcolm, Marcus, Medgar, and  
12   Ron Brown. Hurting all blacks especially mothers, and harming leaders to weaken struggle!

13   **19. Cointelpro and Operation Fruhmension:** and other government-funded programs operating  
14   out of government agencies, formed to destroy Black Leaders and our struggle for liberation!

15   **20. The Black Matrix:** exposing secret military tactics after the Civil Rights Movement, to cause  
16   subliminal effects meant for blacks to reject struggle and accept domination and living in fear!

17   **21. Civil Rights Violations:** like both Bush terms, Jena 6 injustice, Hurricanes Katrina aftermath;  
18   emotional distress over personal attacks like Author McDuffie, Lavena Johnson, Breonna Taylor,  
19   George Floyd, and Roger Fortson; and unsolved murders in dark swamps, remote areas, city  
20   walks, and jails; and promising black high school students killed, like the Atlanta child murders!

21   **22. Mis-Appropriation of Taxes:** where billions of dollars are spent annually on the military,  
22   NASA, and international affairs particularly Israel, in addition to excessive allocations for police  
23   agencies, evil experiments, and old research programs suppressing millions of Black People!

24   **23. Gentrification:** deceiving Black People to steal their property and assets, which was their  
25   inheritance; for white folks in the name of eminent domain, and renovation all across America!

26   **24. Bogus U.S. Emergency Relief and Disaster Aid Agencies:** not complying with their mission  
27   statements, to help those in need after tragedies! Misusing and stealing billions of dollars in aid,  
28   and donations that were meant to help African-Americans after manmade and natural disasters!!

29   **25. Presidential Damage:** Andrew Jackson vetoed 40 acres and a mule, Nixon further divided  
30   and devastated black families, Reagan reversed civil rights gains, Clinton gave higher prison  
31   sentences, Bush Sr. & Jr. flooded our communities with drugs and diseases, raised oil prices for  
32   billions in gas profits, and Trump guilty of lying, 34 criminal counts, and war mongering!

33   **26. Making Sell Outs:** using lying and sneaky blacks like Clarence Thomas and Ward Connerly  
34   against affirmative-action, and ego inflated self-righteous submissive blacks like Roland Martin,  
35   and Barak Obama against reparations, and now funding Larry Elder the HNIC of all sell outs!

36   **27. Negative and Harmful Images, Propaganda, and Stereo Types:** portrayed as uncivilized  
37   and illiterate in music, photos, books, movies, and society; causing mistreatment of Black People!

38   **28. Lack of Power:** never able to protect themselves from racist attacks, or ensure accountability  
39   from the perpetrators, or ever permitted to have their own land for safety, like 40 acres and a mule!

40   **29. \* Listing Others who Received Reparations:** who were not hurt or damaged nearly as bad,

1 or nearly as long as Black People, which is not fair; and also causes anxiety, and mental illness!!  
2 **30. \* \* Because the U.S. Government** has not Enforced Proposals, Constitutional Amendments  
3 (13, 14, or 15), nor Laws, Policies, or Reports for Progress or Protection, which would have led  
4 African-Americans into Equality; that is compounded by the government refusing to update or  
5 remove laws enacted since slavery, intentionally designed to disenfranchise Black People, oppress  
6 their entire race, and prevent them from reaching any form of equality; We Should Demand AARS.

7  
8 **37** Please go to <https://www.nairaland.com/2971359/shocking-pictures-slavery-never-seen> to  
9 see what caused severe, in-depth transcending emotional trauma, proving reparations are way past  
10 long overdue! Those images require Black People to claim AARS to demand \$150T for redress.  
11 You can visualize, imagine, and feel the actual crimes and intentions of the culprits for more than  
12 2000 years! and the awful abuse and mistreatment the victims were forced to endure, for more than  
13 2000 years! to justify the reparations redress claim and demand for \$150T.

14 **38 Assess the Overdue Reparations Debt for over 2000 Years of Crimes and Damages!**  
15 (1) Racism/White Supremacy and the Murder of 600M Black People \$10T (2) Invading and  
16 Capturing Africa \$10T (3) Stealing Assets \$10T (4) The Inhumane Neck and Leg Chains  
17 Colonization Middle Passage Slave Breaking Colonies Slavery Reconstruction Segregation and  
18 Integration \$10T (5) Stolen Land Inventions and Ideas \$10T (6) Forced Slave Labor and Evil  
19 Emotional Trauma \$5T (7) Slave Production and Crops \$5T (8) Lynchings Beatings Whippings

25 along with Post Traumatic Slave Syndrome (PTSS), for the last 2000 years globally \$15T.  
26 Therefore, the Debt is Classified and Figured at \$150T!  
27  
28

29 **39** The monetary calculation at \$2M for all Black People 18 and older in the U.S., is 50M People  
30 x \$2M = \$100T; “That is another way we justify \$100T of the \$150T”; There may be *an excess*  
31 of funds, so we will use ***that excess*** for unexpected and emergency costs, to reclaim Africa, secure  
32 sovereignty in America, rebuild both infrastructures, and transform the mindset into global care.  
33  
34

35 **40** We provide relief by using all three AARS models of reparations for all 50M blacks in the U.S.,  
36 with an emergency settlement, and a priority on poor Blacks, HBCU's, and Black Institutions}}. The 3 models of AARS reparations are (1) Improving Integration, (2) Expanding Repatriation, and  
37 (3) Creating Sovereignty. We need **\$30 Trillion** for programs to improve, expand, and create each  
38 model, with **\$100 Trillion** for individual relief, plus **\$20 Trillion** for reserves and repetitive costs,  
39 **(that is \$150 Trillion, as a DFR settlement)**. **41** We prepare for sovereignty with many service  
40 programs. Yes, blacks still get relief if they deny sovereignty, and many options to engage various

1 cultural and social programs to transform, or to remain stable, for healing purposes, and for healthy  
2 and productive living. We will implement programs to establish all three models of AARS  
3 immediately and simultaneously.

4 Now, for all Black Families Abroad it is 1.5B Families x \$2M = A quantitative amount that may  
5 require generating \$150T 2, 3, or 4 times. Do not let that equation or evaluation fool you into  
6 thinking reparations are not doable, because we will generate our own reparations wealth with  
7 AARS, so there is no limit. Therefore, we will generate \$10 Trillion at a time, to silence all  
8 doubters, to make sure that all Black People and their families are given emergency relief, and a  
9 nice home in a safe healthy eco-friendly area}}. 41 {{You must consider capturing, killing, and  
10 raping men, women, and children; plundering, pillaging, and stealing from an entire continent and  
11 people; then consider crushing their hopes and dreams for freedom, justice, and equality. Then  
12 consider they used mobile, social, and hostile barriers to exploit and prevent progress, during those  
13 long eras of experiencing crimes against humanity; **for more than 2000 years}}**; 42 to understand  
14 the required and repeated \$150T reparations demand. So, there can be no limit to generating wealth  
15 for AARS, because all Black People need redress with spiritual guidance, emergency cash relief,  
16 and land to build new, elite, and safe cities at home and abroad, with clinical psychological therapy.

### 17 **43 The {{7 Power Moves}} are Very Effective When Done Nationally and Simultaneously**

18 **44** The AAIU will form the AARS Congress as a Power Base to Implement AARS, and follow  
19 steps {1} through {7} the next time a black person is unjustly killed by the police, and/or to speed  
20 up calls for more endorsements and promotions for a Global Civil Rights Movement via the news  
21 and social media, to Demand AARS. The AARS Congress will {1} start a 5-year-national protest  
22 against police killings, and for reparations; {2} a 5-year-national-dialogue on racism, corruption,  
23 and police terrorism; {3} a 5-year-case-study to identify institutional and systematic biases, so we  
24 can produce solutions for all institutions, systems, and society; {4} a 5-year-case-study to improve  
25 interaction with and performance of all companies, institutions, and systems, that blacks depend  
26 on for learning, progressing, and surviving; {5} start 5-year-national-boycotts **against** companies  
27 disrespecting blacks; {6} start 5-year-**buying-campaigns** from companies who respect blacks; and  
28 {7} transferring 75% of our assets into our operating U.S. Black Banks. (These 7 power moves  
29 will get our governments and the top U.S. Corporations attention very quickly, and get Black  
30 People money, power and respect very quickly). African-Americans and all Black People have  
31 endured and are suffering from racism, oppression, and exclusion in the U.S. at the hands of those  
32 in power, so they should agree to make moves, with their allies to strengthen the AAIU to carry  
33 out these 7 power moves, to get swift justice for blacks and truth and reconciliation with all others.

### 34 **45 THE AARS GLOBAL BLACK REPARATIONS BLOG and DIALOGUE**

35 **46** We will use various programs and platforms, to discuss the need for **most** African-Americans  
36 and most Black People in the U.S. to **leave** the suppression of racism, police terrorism, and  
37 corruption in integration; to become a **truly free, liberated, and independent people in new,**

1   elite, and safe repatriated and sovereign cities. **47** Black People have waited too long for justice  
2   in integration, and they are still witnessing a rise in violence, crime, and racism. **48** So, AARS is  
3   a national and global vehicle for all Black People to live happy in new, beautiful, elite, and safe  
4   cities.

5   **49** The AAIU is **positioning the military** to encourage and train young crips and bloods, young  
6   tough brothas and sistas, and our young tough brothas and sistas coming home from jail; to build,  
7   maintain, and become the military police force, for our newly established repatriated and  
8   sovereign cities. The pay scale is \$4000 a month for blacks 18-34, and \$8000 a month for blacks  
9   35-55. **50** With AARS **all blacks in the U.S. 18 and older** should start getting paid 20 payments  
10   of (\$100k), for a total of \$2M later this year, or ASAP. AARS also requires the U.S. Government  
11   to grant Black People 40 areas, of 40 square miles (40mi<sup>2</sup>) of prime land; (symbolic to 40 acres  
12   and a mule); for 40 million blacks in the U.S. We know Manhattan is 33.77mi<sup>2</sup> with 1.63 million  
13   people and considered one of the world's leading commercial, financial, and cultural centers.

14   **51** So, 40 areas of 40mi<sup>2</sup> are good for 40M U.S. Blacks for Repatriated and Sovereign Land Areas.  
15   We know 10M blacks will want to remain in integration with programs to improve the conditions.  
16   Our first two cities will be formed as official repatriated and sovereign cities, for the African-  
17   American and the **Global Black Family Reunion, for their repairing and recovery process**.  
18   They will be designed and function similar to Manhattan. The repatriated city is for Black  
19   Nationalist for independence. The sovereign city is for blacks who do not cuss, live good calm  
20   clean lives, and are deeply into spirituality. AARS enables us to build four cities at a time to  
21   promptly help more groups of African-Americans, until we help and link all Black People at home  
22   and abroad.

23   **52** The military will have a strong presence via small bases in each AARS city. These small bases  
24   will be top flight with top flight soldiers, and we will pay them an **extra stipend** with their  
25   benefits. **53** **Black People being unjustly harassed, beaten, and killed** is a **matter of national**  
26   **security!** **54** So, the military should leave some of their strong soldiers behind to **patrol** with our  
27   strong soldiers they train, **to keep AARS cities and citizens safe**. **55** The AAIU will issue AARS  
28   to all police terrorist and white supremacist, so they stop killing innocent and unarmed Black  
29   People!! **56** **We will provide opportunities for blacks who were wrongfully terminated, or**  
30   **got stressed out at work.**

31   **56 African-Americans are not safe** living in integration as sacrificial lambs, who are victims of  
32   racism and police terrorism, of which both are secretly growing. Black People are **descendants of**  
33   slaves, who were victims of **extreme** abuse and violence, for ages and generations. **So**, you know  
34   it should not continue but it does, and you know that is a dog gone shame. **57** Especially in  
35   knowing all the contributions, sacrifices, pain and suffering African-Americans embody.

36   **58** The victims suffered and still do from the world's worst crimes ever for capitalism, while they  
37   were trapped in chains and bondage, during colonialism and slavery, causing Epic Black Anguish.

1 That created spiteful divisions, then a spiritual decline. **59** So, they need AARS for repair, to  
2 reunite, and transform, back to revive spirituality and solidarity, prior to colonialism and slavery;  
3 then seek racial healing with all other nations and races. AARS serves to uplift world politics, for  
4 all nations and races to get mutual respect and benefits. AARS is a complete plan with programs  
5 for spiritual guidance, generating wealth, and acquiring land. {{All plans with those 3 factors puts  
6 them in a top category, so we offer 3 main reasons for everyone to endorse and promote AARS}}.  
7 {{Generating their own reparations wealth will **restore** black pride and unity, getting inner peace,  
8 abolishes begging, and is the key to liberation. So, generating wealth should be a high priority}}.

9 ↓↓↓ **60** African-Americans have been fractured by recent affairs including the governor of Florida  
10 stating slavery was good for Black People, because they were afforded the opportunity to learn a  
11 trade, disregarding all divisions, fatalities, social injustice, wealth transfers, and mental disorders,  
12 caused by slavery. **61** Another high-ranking lady working in government, refused to acknowledge  
13 the legacy of slavery has a negative impact on African-Americans and all Black People, putting  
14 herself in hot water, and contradicting the following apology for slavery.

15 \* \* \* **62** An apology from Georgetown and the Society of Jesus Maryland Province, for their role  
16 in the 1838 sale of more than 270 enslaved individuals for the university's benefit, took place today  
17 in the company of more than 100 slave descendants. "Today the Society of Jesus, who helped to  
18 establish Georgetown University and whose leaders enslaved and mercilessly sold your ancestors,  
19 stands before you to say that we have greatly sinned," said Rev. Timothy Kesicki, S.J., president  
20 of the Jesuit Conference of Canada and the United States; during a morning Liturgy of  
21 Remembrance, Contrition, and Hope. **63** {{We hope and pray with you because we have greatly  
22 sinned, and because we are profoundly sorry. We thank them for the prerequisite for reparations}}.

23 **64** Racism and hatred are resurfacing in the worst ways and language, of wanting to put blacks  
24 back into segregation in Mississippi, wanting to deny blacks a proper education in Florida and  
25 other states, and republicans admitted they changed laws **to remove a black elected official in**  
26 **Georgia**, to save Trump. All these acts of racism should inspire all blacks and their allies to endorse  
27 and promote one reparations plan, (which should be AARS).

28 **65** New groups in the reparations arena think very highly of themselves. They do not consider the  
29 work of our great heroes and sheroes of the past like Dr. John Henrik Clark, Booker T., Frederick  
30 Douglass, Marcus Garvey, A. Philip Randolph; Dr. Frances Cress Welsing, Queen Mother Moore,  
31 Sista Callie House, Wangari Maathai, or Sojourner Truth. **66** Our big advantage is finishing what  
32 our great leaders of the past started. That is AARS's intent, and one of the main reasons why AARS  
33 was produced and is so valuable. AARS has infused the work of all those great leaders, and will  
34 lead African-Americans and the Global Black Family, to winning reparations and reconciliation.  
35 **67** It is a shame to know Black People do not have more honor and respect for their elders, great  
36 leaders of the past, and their Global Black Family today. That is another reason why we wrote the

1 AARS Global Black Reparations Plan. **68** Black People should study and embrace their amazing  
2 ancient African cultures, heritage, values and traditions, to secure global unity and group respect.  
3 **69** We refute government tricks going state by state and city-by-city to waste more time for more  
4 studies. That breeds corruption. We should stop that moot pattern of forming more groups to write  
5 more plans. They want to keep blacks under their control, so they reject all plans calling for our  
6 own land. Our reply should be the KRP to elevate and extend Global Dialogue to demand AARS.

7 **70** We share info in the next paragraph to show inclinations for sovereignty. The undeniable  
8 history of Africa's preeminence, their incredible leaders, Europeans disbelief in their anointed  
9 wisdom, God gave them, to become leaders in education and administration to lead all peoples to  
10 prosper. **71** Then they tried to usurp Africa's heritage, then they tried to declare Egypt, as a place  
11 of European origin, but failed. **72** So, now we reiterate we want to delegate justice, to a people for  
12 damages and problems documented as crimes against humanity. So, we endorse and promote the  
13 vision to rebuild Africa, and repair African-Americans and the Global Black Family, via AARS.

4 **73** According to Dr. Leaky, the European paleontologist who discovered Lucy, the oldest human  
5 bones ever found, Africa is the birthplace of all human beings. According to Mendel, the European  
6 scientist who proved dark genes are dominant and light genes are recessive, Africans are the  
7 original people, and the parents of all human beings. According to the Honorable Elijah  
8 Muhammad, the African prophet who brought a sense of self-worth to millions of Black-  
9 Americans, Black People are the original people, and they have been here for trillions of years. He  
10 taught everybody the original people were created in God's image, and as Gods chosen people, he  
11 gave them knowledge and wisdom to create and advance all of the arts and sciences, including  
12 concepts of theory, time, language, travel, structures, and trade. Those original people were very,  
13 very dark and beautiful Black People. They called the land where they lived the home of the burnt  
14 and dark-skinned people. A land known as Kemet among African Griots and Black Scholars.

25 \* \* \* \* **74** These great African civilizations produced many great African Kings such as  
26 Akhenaton, the world's greatest social reformer. He was a wizard at administration, and he loved  
27 life so much that he outlawed warfare. The African peoples shared his spirituality, so they were  
28 blessed by God and encouraged to build the pyramids, the sphinx, and a variety of great temples,  
29 with invaluable ancient artifacts within. **75** The Europeans were amazed at those structures, and  
30 the calculations required to construct those glowing architectural phenomena, way back in ancient  
31 times, and they still cannot figure out how the Africans built those great structures back in those  
32 times. **76** The Europeans gave up trying to understand Gods knowledge, along with the advanced  
33 intelligence of the African civilizations, and began feeble attempts to make the structures appear  
34 as though they would reflect European heritage. They even went as far as chipping away at the  
35 sphinx's nose, and they initiated portraying Africans as uncivilized and uneducated undesirables.

37 **77** Cheikh Anta Diop, the great Senegalese Historian, Egyptologist, and Paleontologist insisted on  
38 proving to the Europeans, that Egypt was surely of black ancestry, **78** so Europeans should stop  
39 chipping away at the great African wonders of the world, and accept the fact that Africa and Black  
40 People are the home and originators of spirituality, the races, and higher learning. **79** Europeans

1 reserved a place for Aristotle, Plato, and Socrates as their great thinkers, but all three received their  
2 education in Africa. **80** In 1974 Diop also told them he could prove beyond a shadow of a doubt,  
3 that Egypt was in Africa, and that Egyptians were Black People. When Diop told them he could  
4 prove it by obtaining pigment from the mummies, Europeans had to agree that Egypt, and all the  
5 other great ancient civilizations along the Nile were in Africa, and populated by Black People,  
6 until the bastardization of the African continent began with European invasions in 332 BC.

7 \* \* \* \* **81** A few of the glorious ancient African civilizations that flourished in Africa were Ghana,  
8 Mali, and Songhai. Ghana is a West African country that is known for its abundance of wealth in  
9 gold. Though she is rich in wealth and has priceless traditions, **82** {{Ghana took a turn for  
10 the worst when the invasions began. Ghana and most African nations exist today as nations in  
11 turmoil, plagued by persistent poverty, neglect, mounting debt, political instability, and unbearable  
12 problems like famine, disease, distrust, and divisions; which came as a result of racism,  
13 subjugation, imperialism, and colonialism}}. **83** The awesome ASANTE Empire controlled the  
14 territory until the British came prompting good spirits, but had bad intentions. The ASANTE rich  
15 traditions had communal land holdings by lineages or clans, inheriting their people's loyalty. The  
16 AKAN people were matrilineal, while the GA, EWE, and most northern groups were patrilineal.

17 **84** Black People should be proud, appreciated, and respected globally for great achievements,  
18 **85** but instead they were abused, enslaved, and oppressed for ages! That was caused by religious  
19 propaganda, which was imposed by others writing negro phobic language into scripture, which  
20 prescribed blacks as slaves! The Pope apologized for having 7 European Nations, and all the other  
21 guilty groups agree to suppress developing Africa, while overtly dominating and subjugating Black  
22 People! There were also 17 U.S. Corporations who gained unjust enrichment from the slave trade.

### 23 **86 AARS Executive Order: \$50B from U.S. Government and all Guilty Groups**

24 **87** The U.S. Government, the Pope and the Church, 7 European nations, (Britain, Denmark,  
25 France, Italy, the Netherlands, Portugal, and Spain), the Willie Lynch Letter and the Jews, and the  
26 17 corporations listed below, are all guilty of grand land theft, ruining traditional family and  
27 culture, and multiplied mass murders; in Africa; the Diaspora; and in America. **88** So, black folks  
28 need AARS right now, to get emergency monetary relief, land, and programs to repair, rebuild,  
29 and recover all their losses and damages. AARS services all these areas and much more, so we are  
30 calling on **President Donald Trump** to issue an **Executive Order** to ratify AARS for Kwanzaa  
31 of 2025 or ASAP; as an apology and a gift to African-Americans and the Global Black Family.

32 **89** The **Executive Order** should be \$50B from the U.S. Government and all the other 27 guilty  
33 groups, ASAP, evenly to the AARS Hedge Fund and operating U.S. Black Banks. The Executive  
34 Order Notifies all 28 guilty groups to engage with AARS to atone, make amends, and earn a  
35 reconciliatory profit; so blacks can get emergency reparations relief, their own land, and police  
36 accountability. When America accepts AARS, they agree to emergency relief, 40 areas of 40 mi<sup>2</sup>  
37 of prime land grants, and ensure the safety for all African-Americans and Black People in the U.S.

5 This compilation comprises materials on landmark class action lawsuits brought on behalf of 3.5  
6 million descendants of enslaved Africans for slavery reparations. The plaintiffs in six different  
7 states (New York, New Jersey, Illinois, California, Louisiana, and Texas), filed the actions against  
8 17 defendant corporations, who have profited for hundreds and thousands of years from  
9 colonialism, slavery, and the transatlantic slave trade. The cases have been consolidated in the  
10 U.S. District Court, Northern District of Illinois, Eastern Division before Judge Charles R. Norgle.




## \*\*\*\*\* 91 The Pope Apologized for Their Role in the Slave Trade

We sincerely **thank the Pope** for having the courage to admit that the Church is faithfully apologizing for their role in the Slave Trade. Hopefully other perpetrators will have leaders with the same guts to admit their transgressions, because they are all liable for damages. **92** AARS has applicable processes, programs, and services to provide refined relief for perpetrators and victims. **93** We also thank the World Council of Churches (WCC) for telling Europeans, Americans, Arabs, Jews, and all other culprits to pay reparations to Africa, parts of the Diaspora where blacks were abused, colonized, and exploited, and all other places where blacks were causalities of war!

**94** We honor Mr. Peoples, a late Compton Community Activist who brought attention to the Black-American Slave Trade Holocaust, by driving the model of a slave ship all around the greater L.A. County for nearly 40 years. He filed a lawsuit against the Catholic Church for their role in the Slave Trade, which was dismissed but should not have been, without a proper judicial process in a sworn court of jurisprudence. **95** The Pope asks Africans to Forgive Christians for their Role in the Trans-Atlantic Slave Trade. We forgive you as **apologies** are **prerequisites** for reparations.

Pope John Paul II recently journeyed along the same route that hundreds of thousands of Africans passed through on a voyage to the New World as slaves. The Pontiff begged for forgiveness for Christians involved in the Slave Trade.” How can one forget the enormous suffering inflicted, ignoring the most elementary rights of man, on the people deported from the African continent?” he asked.” From this African Sanctuary of Black Pain, we begged the Pardon from Up Above.” The Pope made the comments during a visit to Goree Island, which is a 20-minute boat ride from a French naval base in the capital of Dakar in West African Senegal.

Calling the Passage, a “Door of No Return,” the Pontiff toured cells of the “House of Slaves” where at least 600,000 Africans passed through, during an extended period ending in the early 19<sup>th</sup> century. **He likened the house or slave ports all around Africa**, where Africans were chained, awaiting slave ships, to this century’s concentration camps, the “**Maison des Enclaves**,” which has been **restored as a museum to document the horrors**. In a meeting with Muslim leaders, he appealed for an end to modern-day slavery, citing organized prostitution, and stressed the need for cooperation and equality for Christian minorities, who he said are discriminated against in many Muslim countries. The Pope’s week-long pilgrimage was aimed at strengthening the role of the Catholic Church in the heavily populated Muslim countries of Senegal, Gambia, and Guinea.

1                   **96 AARS Emergency Individual and Family Monetary Payments for all Blacks**

2  
3       The SEEG identified three top rated companies to generate wealth for humanitarian projects which  
4       we can use for reparations individual and family relief payments (PMs). Many Black People have  
5       bank issues or have lost bank accounts. AARS gives them a new bank account as a **1<sup>st</sup> reparations**  
6       **award**, with dual services, to learn and keep good spending and saving habits, and to stop all bad  
7       habits. All 30-50M blacks in the U.S. 18 and older will get a **red, black, and green, Reparations**  
8       **ID Card (RID)**; by last name A-Z; state; DOB; AGE; SSN; income; photo, fingerprints, and **birth**  
9       **certificate**; for accurate PMs. All Black People will be notified of becoming a member, of one of  
10      the twenty-one operating U.S. Black Banks for PM. All blacks will get a bank card, from their  
11      RID, from their appointed Black Bank, for PMs. All reparations PMs go to their bank cards. Black  
12      settlement for PMs is birth by 5-1-2008, because that was the first day African-Americans and all  
13      Black People, received an official apology from one of the culprits for colonialism and slavery.

14  
15       **97** We will take these funds and give all blacks 18 and older in America 100k ASAP, as an initial  
16      PM. We will give those blacks 20 - 100k PM every 30-90 days, pending how long it takes for them  
17      to receive their PMs. Then we resume PMs until we reach the \$2M goal for those Black People.  
18      This path aids and inspires all Black People to use reparations most effectively, and not to squander  
19      them selfishly, or with others. It also gives black folks time to pursue policies to attain top mental  
20      and physical health, by engaging in AARS preparation to receive reparations programs, which  
21      enforces learning to produce and sell products for daily use in the U.S. and in great demand abroad.

22  
23       **98** AARS delegates the same ID process for all Black Families outside America, to provide \$2M  
24      per family, since the cost of living is much lower, and the number of blacks are much higher.  
25      Blacks must be 18 to get PMs. We teach those blacks to be smart with their money, to take care of  
26      the younger people in their families by investing. Blacks will not pay taxes on any reparations  
27      PMs. It should also be agreed that no government, or group will harass any black person for any  
28      debt, since AARS calls for Black People to be released from all debt, as a **2<sup>nd</sup> reparations award**.

29  
30       **99** Blacks should take the rest of this and next year to design and fortify a global racial hierarchy,  
31      their AARS Congress, and studying all moving parts of AARS. That will position them to adopt  
32      and produce healing, repairing, recovering, and transforming programs. **100** We are blessed and  
33      fortunate to have found sources to generate wealth for projects. We should move like experienced  
34      clients and savvy business people to engage. \* \* \* **101** We should also apply pressure via planning  
35      for national action, including (1) planning for the 2<sup>nd</sup> National Black Political Convention, (2) the  
36      2<sup>nd</sup> Million Man March, and (3) the 2<sup>nd</sup> Civil Rights Movement to demand AARS, ASAP!

37  
38       **102** Black People should use their BPV during 2025-6 to claim AARS, an Injured and Indigenous  
39      Status, and 1 of the 3 AARS Reparations Models for residence. **103** We will keep you informed  
40      on directions and when to take the BPV.

1    104 AARS takes us on a journey to a long overdue spiritual awakening and a brand-new beginning,  
2    for African-Americans and the Global Black Family. That is exactly what the AAIU postulated  
3    after more than 40 years of research, and exactly what African-Americans and all Black People  
4    need, have earned, deserve, and are entitled to receive. 105 **AARS is a Global Black Reparations**  
5    **Insurance Policy.** The act starts and revolves when rich blacks, guilty groups, and others who are  
6    wealthy and care for blacks, begin to use the SEEG to generate wealth. The U.S. Government will  
7    quickly join the act to cover their current war debt, avoid bad publicity, and the 7 Power Moves.  
8

9    105 African-Americans are fortunate to know hundreds of communities and organizations across  
10   the country, are considering providing reparations to Black People in America for generations of  
11   abuse, oppression, racism, slavery, and segregation. Places like CA, MA, Rhode Island, North  
12   Carolina, Iowa City Iowa, and Evanston Illinois; along with religious denominations like the  
13   Episcopal Church; prominent colleges like Georgetown University in Washington DC.; and most  
14   importantly don't forget there are a number of financial institutions who have committed to  
15   economic development for underserved areas, so let's make them keep their word via AARS.

16   106 We have an issue on the reparations plan that was posed for a few blacks on housing issues in  
17   Evanston. The civic group that posed the plan that landed in 2019, said pro reparations groups  
18   offered pro-bono legal aid, if the plan is challenged. All blacks and everybody else should  
19   challenge the plan, because it is not a reparations plan, it is only a housing redress program. Only  
20   a few blacks will qualify, out of many in need. 107 The dissenting voter stated the effort was  
21   paternalistic, and assumes Black People cannot (a) generate or (b) control their own wealth.  
22   African-Americans should claim AARS for both reasons, and unity liberation and independence.  
23

24   108 Reparations are meant to repair damage done to all Black People, not a few who qualify in a  
25   local area, or for a specific massacre. 109 We have some blacks being misled who are trying to get  
26   reparations for a few blacks, which is wrong. We should demand AARS to identify national and  
27   global damage, using and creating strong programs to repair that damage, and listing issues and  
28   lingering problems we should solve now. 110 They fought the Civil Rights Movement (CRM), to  
29   gain rights which would have led blacks to equality. 111 But they were fooled by others, so they  
30   need a 2<sup>nd</sup> CRM to win those rights, and slowly dissolve racism and police terrorism. The 2<sup>nd</sup> CRM  
31   will be the Reparations Movement, to win our rights in a peaceful and political process, the KRP.  
32

33   112 Blacks are divided, deceived, and in danger, so they should unite around AARS, to ask the  
34   U.S. Government to ratify AARS, ASAP. 113 Then they will build their own new, elite, beautiful,  
35   and safe repatriated and sovereign cities. 114 Many people wonder and ask what is fair, full, and  
36   suitable compensation; for all the hostile and volatile eras of abusing, capturing, colonizing, and  
37   displacing Black People. They endured atrocities; lost their homeland, family and culture; resisted  
38   colonialism and cruelty and brutality; middle passage horrors; slavery slaughters; and segregation  
39   disasters. It requires at least 20 years of research, to understand the effects of those long-periods,  
40   of deep-suffering and shocking-oppression, in order to submit a good, valid, and complete answer.  
41

1      ↓↓↓ 115 You must understand the reasons for Europeans plotting those invasions, understand  
2 why it led to Africa's demise and the destruction of Black Civilization, the adverse psychological  
3 effects of the 30 reasons coupled with the emotional trauma; after being branded, chained by the  
4 neck and legs, forced into slavery, then forcibly raped. 116 Then they turned the tables and divided  
5 Black People, so that they could indoctrinate blacks to hate, envy, revile, and distrust one another.  
6 \* \* \* \* 117 {{So, the accurate answer is to ratify a plan for spiritual guidance, PMs, land, safety,  
7 autonomy, and ethnic relief and progress. The only way to reach those goals are with principles  
8 and rules for sovereignty}}. Their Internal BPV during 2025-6, is for U.S. Blacks only 18 and older  
9 to claim AARS, an injured indigenous status, and sovereignty. Their BPV organizes evidence to  
10 unite blacks to win reparations, and to slowly reduce and finally end racism and police terrorism.  
11

12     118 AARS emphasizes leaving corruption in integration, for peace and prosperity in repatriation  
13 and sovereignty. It includes youth programs to decrease foul language and activities for racial  
14 improvement, and adult programs to nurture a desire to self-actualize, set goals, and teach our  
15 children good habits and values. This is a spiritual call to bring the Black Family back to order. A  
16 priority that is to acknowledge and reclaim our true home and motherland, culture, and heritage.

17     119 First, there are advantages with (1) sovereignty as an alternative to (2) integration. Primarily  
18 with problems which stem from slavery, which created deep divisions among blacks, which they  
19 must solve among themselves. Basically, they start labeling sellouts, identifying limited plans  
20 called reparations, and embracing unity, even though many of them will remain integrated. Second,  
21 they remove themselves from harm in integration, while getting options to learn to utilize their  
22 abilities, networks, and skills to build their own new, elite and safe repatriated and sovereign cities.

23     120 Black People should live in all three models or settings, because they walked and struggled  
24 with Whites and Jews to achieve equality in integration. 121 However, their position also  
25 emphasizes (3) expanding repatriation, since they lack basic civil and human rights, because of the  
26 color of their skin, so they are mistreated. 122 They should protest for 5 years to demand justice,  
27 and work to mend and uplift their family relations at home and abroad. 123 They should build their  
28 close and distant relatives, new, beautiful, elite, and safe cities on prime land. The AARS Congress  
29 will uphold and exalt repatriation to elevate Global Black Family Reunion and Reconciliation.

30     124 The AAIU data base identifies 17 corporations who surely owe blacks reparations. We also  
31 hope and pray that the U.S. Government, the Roman Catholic Church, and the Bush's and  
32 Rothschild's will cooperate, because AAIU data has proof of them profiting from slavery, and/or  
33 exploiting Black People. 125 We will ask the 28 guilty groups, then all the others with wealth and  
34 compassion, particularly the large financial institutions that committed to economic development  
35 for underserved areas, to consider using SEEG programs to help generate wealth for reparations.

36     126 Implementing these AARS amenities in quality and quantity are paramount, and requires four  
37 50 years terms for Black People to heal, be repaired, and build safe cities. 127 They should replace  
38 negative fixtures, which have become normal in their daily interaction, (like offensive language,

1 harsh vulgar music, and hostile lewd behavior), which come from bad experiences with racism and  
2 oppression; **with their classical**, identifiable, and noble names, languages, customs, and culture.

3 \* \* \* \* 127 {{All races of people get along good at musical, political, and sporting events, so  
4 reparations should unfold via annual, constant, and serious dialogue. That will pave the way for  
5 the races and especially the police, to keep that same level of appreciation and respect for one  
6 another, in our daily lives}}. 128 When African-Americans get their own land, others will give  
7 them respect, so they can build their own new, beautiful, elite, and safe cities. ↓↓↓ 129 {{African-  
8 Americans and Black People have done way too much in the U.S. to keep being denied reparations.

9 Race relations have been very bad and are getting much worse}}. 130 {{A brief parting will help  
10 the races learn to respect one another, just like a divorce. After people divorce, they reconcile after  
11 forming a sincere mutual respect. Then they realize they needed that mutual respect from the start,  
12 to keep good relations to last forever. The AAIU offers sovereignty as that parting, as an American  
13 social service through the AARS Congress, for genuine and lasting racial reconciliation}}.

14 **131 Brotha Pruitt's Experience:** In Carson CA our parents taught us good family values, and we  
15 had strong support systems. That background gave me visions to nurture to help others. I developed  
16 good habits and a desire to read for long stretches in elementary school, with the Head Start  
17 Program. I went on to Jr. High and participated in campus activities related to communications. I  
18 enjoyed watching music, sports, and promo campaigns bring people together, creating the most  
19 fun, festive, and memorable occasions. I grew 10" the summer before High School, so I learned  
20 the fundamentals of basketball, and became a Legend at Verbum Dei High in Watts in 1979.

21 I was a gifted 6'8" point guard, trained hard, and became an All American who won a scholarship  
22 to UCLA. 132 I transferred to UAB because coach Larry Brown lied; after saying I'd play the  
23 point. After I left UAB I found out coach Gene Bartow was in cahoots with Larry, so he deceived  
24 me on playing the point too. Gene let me play the point for the whole year I sat out. Then when I  
25 became eligible, he switched my position. I tried to appeal but they black balled me after lying to  
26 me, and telling lies on me! That was cold blooded and it still hurts!! I was a victim of racism in  
27 sports by owners, associations, managers, and coaches abusing their power, as were many athletes  
28 like Muhammad Ali, Curt Flood, Raymond Lewis, Craig Hodges, Michael Vick and Colin  
29 Kaepernick. We should **investigate racism in sports** to get equal opportunities for more blacks to  
30 own, manage, and become coaches and recruiters for colleges and the pros.

31 133 This AARS Plan is fair, complete, and has comprehensive amenities. It has ideas and  
32 suggestions from our great black and other scholars of the **past and present**. It includes processes,  
33 programs, and services to get spiritual guidance; emergency monetary relief; prime land grants;  
34 repair massive damage; solve lingering, lethal, and mounting problems; and **will create a new line**  
35 **of thinking in all Black People**. So, they learn and realize they have earned, deserve, and are  
36 entitled to their own land, right here in America, as indigenous people with indigenous rights.

1 **134** That will enable blacks to build their own new, beautiful, elite, and safe repatriated and  
2 sovereign cities; form their own indigenous governments; write their own sovereign laws; and  
3 control all affairs, companies, institutions, and systems in their city limits. **135** We work to  
4 diminish all sell outs, then we unite genuine reparations activists, with our entire Global Black  
5 Family, and all of our allies. **136** We will use AARS as the base reparations plan, then add all other  
6 good ideas from all other good people and plans, as amends to repair all damages and injuries, and  
7 recover most losses, to help repair African-Americans and all Black People at home and abroad.

## 137 20 AARS Bullet Points

- \* 1. Giving Honor to God, and praying for special help to unite African-Americans with all Black People on a global scale, then we have KRP dialogue to win AARS in one year.
- \* 2. Reveal programs to slowly get the 7 Old European Colonial groups and the New Colonizer China out of Africa, or to at least start sharing the resources they seize equally, with the natives.
- \* 3. Reveal programs to limit or stop the enormous influx of immigration, because it is choking the American education, health care, employment, housing, political, legal, and social conditions.
- \* 4. AARS is strong with 3 main parts; spiritual guidance, full repair and recovery, and generating wealth from SFs, from governments, all other guilty groups, rich blacks, and others who care.
- \* 5. Therefore, AARS is the best reparations plan by far. All the other reparations plans require waiting for the oppressors to approve, begging, or filing lawsuits that are nearly impossible win.
- 6. AARS provides great debt relief for the governments, and all the other guilty groups who owe trillions in reparations. They are all guilty of vile and vast crimes against humanity.

3 cities; and (3) Creating Sovereignty, **for blacks to develop a new line of thinking**; to learn they  
4 deserve, have earned, and are entitled to their own sovereign land, here in America.

5 **14. The AAIU Black Plebiscite Vote (BPV):** serves to let everyone know that Black People are  
6 indigenous to this land, as distinct relatives of the Great Ancient Black African Olmecs, who were  
7 here first, building and moving civilizations, not Native Americans or Mesopotamian Mexicans. .

8 15. The governments should stipulate that their new government granted repatriated and sovereign  
9 land, can never be taken away from Black People; for eminent domain, any necessity, or any other  
10 reason that they ever conceive.

11 16. On the KRP, which we are engaging in now, which is circulating, reading, and discussing all  
12 docs on the homepage, with everyone 18 and older, until AARS is ratified by the U.S. Government,  
13 including agreements and terms to influence all the other guilty groups to bind with AARS.

14 17. AARS prevents reparations opponents and their sell outs, from trying to set criteria for blacks  
15 to receive reparations. Its irrational, all African-Americans identified as black on their birth  
16 certificate, and all Africans identified or who we know are black abroad will get AARS benefits.

17 18. Reparations opponents and their sell outs, have the nerve to say blacks can only claim  
18 reparations for the last 400 years. Its irrational, Africa was invaded over 2000 years ago, and blacks  
19 suffered over 500 years here in the U.S.

20 19. Reparations opponents and their sell outs are even saying blacks have to prove they are a  
21 descendant of slaves to qualify for reparations. Its irrational, all African-Americans and Black  
22 People should get reparations from colonialism, middle passage, slavery, racism, and oppression.


23 20. Opponents and their sell outs continue to say blacks sold each other into slavery, repeating  
24 myths and propaganda, while ignoring the facts! Blacks very rarely sold other blacks into slavery,  
25 but blacks were often beaten, sold, transported, and enslaved by others both nationally and globally.

26 21. When discussing reparations most people are only concerned about the money. AARS provides  
27 that in emergency monetary relief, along with programs and services to heal, repair, recover, and  
28 transform back to their peaceful status, prior to colonialism and slavery, then seek reconciliation.

29 22. We expose true Black History to prove Africa is the home of humanity, and blacks are the  
30 original people; so, that all people, and especially the corrupt police and white supremacists, can  
31 start to give them their due respect, or at least tolerate them as human beings. They should also  
32 stop all the unnecessary harassment, and unjust killings of African-Americans and Black People.

33 Since the California Senate recently passed three reparations bills, that should lead **African-**  
34 **Americans and all Black People**, to receive reparations (AARS) benefits. Since a government  
35 group made this progress, they should work with the AAIU, to help get AARS ratified and  
36 implemented. We will reveal its capabilities and power, in our AARS Global Black Reparations






12 It was an eerie moment in April 1991 when 300 African-Americans arrived in Abidjan, capital of  
13 the West African country of Cote d’Ivore for the first African / African-American Summit. Long  
14 estranged brothers and sisters were meeting once again, five hundred plus years after their  
15 separation, reweaving the fabric of common memory and shattered heritage. One African-  
16 American woman walked straight to the first African Ivorian woman she saw and clasped her in  
17 an emotional embrace. “You’re my sister, you’re my sister”, she said to the Ivorian woman. The  
18 Ivorian woman understood little English but the message was not lost yet amazingly clear to her.  
19 Both women held on to each other as if frozen, then dissolved into happy-painful-loving tears.

20 There was poetry and potential power in that moment as in the Summit itself, which began on  
21 April 15 and ended on April 19. The whole constellation of Africa’s past was present in Abidjan.  
22 Then the real challenge of the summit was about the present state of Africa, and the failure of  
23 African-American relations. That concern was exemplified in the congress apart relatives, in the  
24 affirmation by both parties; that blood is thicker than the pains of history, that memory outlast  
25 physical separation; but most importantly, is the shared faith that the fate of Africa - the new  
26 frontier, in **Reverend Leon Sullivan’s apt words** – is the business of all people of African descent.

27 The situation in Africa has become serious in several respects. Not only are Africans condemned  
28 in the present to poverty and misery, but unborn generations are sentenced to an existence of pain  
29 and suffering. African-Americans should find joy in learning about and claiming their roots, which  
30 is a climax of great societies that culminated in the classic civilization of Kemet, which is the  
31 standard for all modern governments and societies.

32 African-Americans should want to learn about and claim their roots, which is a climax of great  
33 societies that culminated in the classic civilization of Kemet, which is the standard for all modern  
34 societies. So, Europeans should stop calling themselves African. Colonizing Africa for thousands  
35 of years does not make you African. Africa is a Black continent and Africans are Black People.

4      A Racial Hierarchy and Empire for Negroes - The Negro's Creed must be Confidence in Self -

7      Negros should stop their hero worship and adoration of others, and rush to create positive images  
8      of themselves. We must canonize our own saints, and elevate them to positions of fame, so we can  
9      honor our great black men and women, who have made their distinct contributions to the world  
10     and our racial history. Sojourner Truth is worthy of the place of sainthood alongside Joan of Arc;  
11     Crispus Attucks and George William Gordon. They are all entitled to the halo of martyrdom, with  
12     no less glory than that, of any of the martyrs of any other race. Africa has produced countless  
13     numbers of men and women, in times of war and peace, whose luster and bravery would outshine  
14     that of any other people. So, we should see the good and perfection in ourselves. We are entitled  
15     to our own opinions with Gods guidance, and not colligated to or bound by the opinions of others.

#### 16      A Peep at the Past

17      Others have no more right to dishonor, disrespect, and disregard your feelings and manhood, than  
18      you have in doing to them. Their arrogance is only skin deep, and has an assumption of superiority  
19      that has no foundation in morals or law. They come from the same family tree as we do, but their  
20      history is much more primitive and uncivil. Their ancestors ran wild and naked, lived in caves, and  
21      they made human sacrifices. When we were embracing and excelling in the arts and sciences on  
22      the banks of the Nile, their ancestors were still drinking human blood and eating out of the skulls  
23      of their conquered dead; so why did they give us a reputation they deserve of being savages and  
24      immoral people? Their self-made image is that of a pure and sacred people, when our civilization  
25      had reached high progress, they still ate unseasoned and raw food, and believed the world was flat.

#### 26      Allegiance to Our Race

27      Let no voice but your own speak to you from the depths of the Negro's journey. Let no influence  
28      but your own rouse you in times of war or peace. {{Your allegiance shall be to God, then to your  
29      race, family, and homeland}}. Remember always that the Jew in their political and economic ways  
30      are always Jews first; the white man is always a white man first under all circumstances, and you  
31      should be no less than a Negro first, because every other race does the same. Let no one inoculate  
32      you ever again with evil doctrines to suit their own conveniences, as they succeeded with the Willie  
33      Lynch Letter, to our demise. Be true to yourselves and beware of others deceiving you.

1 Elaborating on Sovereignty: A Remedy for All Blacks for Colonialism and Slavery

2 When Black People start feeding, educating, employing, policing, and providing housing and  
3 health care for their people, they will solve their problems themselves. That cannot be done in  
4 integration. That is why most African-Americans should become a sovereign people in America.  
5 Initially we expect 20-25 million Black People (40%) may prefer sovereignty. We will know after  
6 the BPV. However, we believe 90% of all blacks will prefer sovereignty, after they see we have  
7 no racism, live in solemn peace, and are making group progress in our elite and safe cities. The  
8 10% who may want to remain integrated as they should, are the 5% who are rich or satisfied, while  
9 the other 5% are haters and sell outs. The masses should want a new start with God, and a plan.

10 When African-Americans get their own land to build their own cities; they can establish their own  
11 books, customs, and holidays to observe to help repair damage; celebrate black awards, triumphs,  
12 and contributions; honor our old and new heroes and sheroes; and to give guidance and stability.

13 Black People have to learn that they deserve, have earned, are entitled to their own land. They  
14 must learn and should start thinking and knowing that they can live in peace, in their own sovereign  
15 and repatriated cities, right here in America. They should claim an injured and indigenous status  
16 with the BPV, on the land of which their ancestors built the foundation with their blood, sweat,  
17 forced slave labor, and tears. Now is a good time to learn AARS presents positive alternatives for  
18 Black People to living in integration, which are repatriation and sovereignty, so let us reunite to  
19 relentlessly pursue reparations with this AARS plan. We prepare for national class action lawsuits  
20 and movements by strengthening the AAIU to perform the 7 power moves of AARS.

21 Slowly dissolving racism and improving police and race relations are the “changes” that will make  
22 America a much better place. The KRP strategy was written with visions to start a peaceful and  
23 political reading project, to win AARS in one year, or ASAP, and achieve “the 3 goals”. The KRP  
24 is for everyone 18 and older at home and abroad, as part of an AAIU program to seek pride and  
25 unity among blacks, and harmony with all other nations and races, so that we can live in a civil  
26 society in America, and globally. We recognize reparations are owed for “crimes against  
27 humanity”, “in memory of our ancestors” to reunite, repair, restore, and uplift our people back to  
28 the safe, spiritual, peaceful, and progressive status we were in, prior to colonialism and slavery.  
29 With AARS we provide 5 up to 50-year terms, programs, and services to bring this to fruition.

### 30 Prioritizing Spiritual Guidance

31 African-Americans worry about penalties for debating racism and oppression openly and honestly.  
32 An imposition we must overcome with God to list and discuss all the problems in society without  
33 fear of retaliation. There are way too many passive blacks in top positions in politics, the church,  
34 supposedly civil rights and pro black groups, and in the reparations arena, which is hindering and  
35 delaying justice. Please stand up to show your allegiance is to your people, to make a difference.  
36 We need our people to be strong soldiers like Senator Cory Booker of NJ, Attorney Hakim Jeffires  
37 of NY, Former News Anchor and Analyst Joy Ann Reid, and Attorney Jasmine Crocket of TX.
