Now in conclusion if the descendants of perpetrators and victims of colonialism, slavery, and other cruel crimes; considers participating in the T&R Process to dialogue to identify serious problems, which need solutions in integration; until we find AARS is the best reparations plan for African-Americans and all Black people, that is very much appreciated, and well deserving for the Black Family. If the EE decides to give partial reparations to a small group of Blacks in America, that is unfair to other Blacks, and deliberately divisive. That will cause divisions to expand among Blacks.

Reparations is the one lawsuit that must be filed on behalf of all African-Americans and all Black people, because they all have endured vast damage, and suffered severe emotional trauma from a racist system and practices. If a small group of Blacks gets any recourse that is very good, but its' not reparations. That is simply makes up for discrimination or crimes against those Blacks. We do not need a study like H.R. 40 to confirm slavery caused extensive damage to all Blacks in America. We should use the T&R Process to solve problems now, and to identify mounting problems preventing Blacks from having freedom, justice, equality, and safety in Integration. Then we create repair programs in all areas of life. Now most importantly we prepare Blacks for sovereignty.

We are in some trying times now, so we can see and feel racism and police terrorism on the rise. The relationship between Blacks and the Whites in power started off terrible, and has gotten much worse, like a bad marriage. Therefore, Blacks should take Whites to court and demand reparations to the tune of half of what they own in this country, and around the world. That is familiar to many Black men, who had to give up half when they went through divorce with their wives. They lost their dignity and nearly everything they had. When we file our reparations lawsuit it must come from those of us who experience filing reparations lawsuits, so we can get what we deserve.

It is time out for all grudges and divisions among Blacks. We need each other now more than ever before. Racism, police terrorism, and extremely poor social conditions are way too serious for us to remain divided. We must put our differences on the back burner, and began to move collectively to pursue and win reparations, to get emergency relief, solve problems, and build safe cities.

I am so serious about this that I will walk from LA to NY to bring the Black Family back together. We have been hated on way too long as a race, so now we need to show each other some real love. If you are Black, you should know that Brotha Cliff Pruitt Loves you. Now, let us observe millions of Blacks who lost their jobs due to smoking weed, and now you can buy weed at stores and its legal. We need reparations for all Blacks who were fired because of weed, lost their jobs because of the immigration influx, and forced into a life of crime to survive. So, the AAIU, SEEG, and their allies will form the AARS Congress as a group we need all Blacks to support for safety and survival. The AARS Congress will apply pressure on the government and guilty groups via dialogue and the T & R Process, until we see improvement in integration, and a stipulation to build safe repatriated and sovereign cities, right here in America, in Africa, and throughout the Diaspora.
