

::: THE AAIU DECLARATION (THE UD PLAN)

To Advance America's Dialogue on Racism for Social Justice
Teaching Blacks to Study and Embrace Repatriation and Sovereignty
and Preparing for the 2nd Civil Rights Movement (CRM) called the KRP

RACISM

Willie Lynch Indoctrination was used to divide, conquer and control African Slaves. Now Blacks are divided in a web that seems impossible to untangle, because they are divided into different religious, political, and social groups with a little influence, who ideally believe their group is better, or more valid than other black groups, and their race. If and when all these groups merge it will create a real power base for African-Americans, (The AARS Congress). Then the police and white supremacists will not be so quick to kill Black People! Dialogue will help undo that web of deceit by proving African-Americans and All Black People were intentionally divided for colonial and slavery purposes. Placing them in bondage, stealing their land and resources, rescinding their heritage, then denying liability. They can overcome divisions and succeed in their mission of strengthening the union by uniting based on their experience as victims of oppression. A remedy for regaining compassion, trust, and solidarity, is uplifting their race with collective cultural, social, and economic practices. Know obedience, unity, and sovereignty will induce the healing process.

REPENTANCE

When people feel like they want to apologize and make amends for crimes in the past they are in transition with the power of the Holy Spirit. This manifestation can help African-Americans and others commit to reconciliation. I am praying to take the Black Family into a covenant to clean themselves up spiritually, prior to deferring the process over to others. This formula can help Blacks defeat adverse effects of Willie Lynch Indoctrination. The effects caused immoral conditioning coercing Blacks to talk bad about each other, treat one another like strangers, and kill each other like enemies. They should implant ideologies to reverse conditioning and recognize repentance as the spiritual source that can help all people willingly engage self-assessment. Stressing spiritual growth and group tolerance will take people into a new era of peaceful race relations. It should not take civil unrest or another act of God, for people to discuss measures for social and economic justice. Greed, hate, and maintaining the status quo prevents people from reaching equality. We will change that by forming both groups to implement spiritual and special programs to repair the Black Family, and for healing the entire human race.

and REPARATIONS

This education project will go into a law that stipulates victims of gross human rights violations, forced displacement, slavery, torture, terror, rape, and murder have a right to reparations for these crimes, including restitution, compensation, land, and rehabilitation. We will debate this law with congress in the AAIU United States of America Truth and Reconciliation Process.

1 The African-American Independent Union (AAIU) “The All-Inclusive Union”

2
3 MISSION: To host racism educational dialogue to discuss social barriers preventing equality,
4 advantages of sovereignty over integration, and major contributions noting Africa and Black
5 People as leaders. To uplift their conditioned consciousness focusing on resolving their differences
6 and reuniting, to form a power base, to work collectively and effectively to solve problems, and
7 resume their struggle for equality in the 2nd CRM.
8

9 PURPOSE: To encourage Blacks to take an honest look at their race, their families, and personal
10 problems they perpetuate. This should motivate them to learn about repentance to admit their
11 faults, and atonement to make amends for their trespasses. This will help change their pattern of
12 using foul language and destructive actions that fuel self-hatred and black on black crime, into
13 using language and actions that produce self-respect and racial bonding. This will work to help
14 reduce and eventually eliminate envy, hating, and jealousy among their people. Making a strong
15 call to their people to commit to self-actualizing and upholding racial solidarity, as advocating
16 their need for reparations, and social tolerance with others.
17

18 PROBLEMS: There are historical and current problems posing grave danger to African-
19 Americans. We have to declare racism has been the root of their problems for centuries. Now the
20 problems facing their teens and young adults are having a negative impact on an entire generation.
21 It should be a priority for them to form the union to examine self and society, to expose and solve
22 all of their problems, from both internal and external conflicts, to help improve their living
23 conditions, and find peace among themselves.
24

25 African-Americans cared about one another and were together during the Civil Rights Movement
26 (CRM). They were very serious about their struggle to gain Freedom, Justice and Equality (FJE).
27 They were on one accord expressing a will to stop the cruelty, as others joined them because they
28 witnessed excessive police brutality. They need a 2nd CRM because the police are still killing
29 Blacks, and not being held accountable, and they have not reached equality!
30

31 As they engaged in the CRM struggle, *evil forces* like avid Segregationist, the John Birch Society,
32 Cointelpro, and all the other Racist Groups, were working undercover to undermine their efforts
33 to gain FJE, destroy their Civil Rights and Pro Black Groups, and incriminate or even assassinate
34 their beloved Black Leaders.
35

36 Those evil forces caused more damage and divisions among their people by turning Blacks in
37 positions of leadership into agent provocateurs, snitches, sell-outs, and race traitors. All of those
38 *disloyal Blacks* sold their soul by *taking bribes* for personal gains, and starting passive groups to
39 prevent collective action. We will stop that *divisive madness* by forming the union, and proceeding
40 to neutralize that *demonic activity*. The Black Family suffered substantial damage after the CRM

1 when sellouts declined to organize to finish the struggle. Now, African-Americans are still victims
2 of *evil forces* that *continue* to work *undercover* to *divide* and *oppress* their people. They should
3 respond by forming the union to revive the masses creating the power structure to offset evil forces.
4 They should also accept their individual duty of confessing to apologize, and atonement for
5 reconciliation, so they can have forgiveness among themselves and with others. • Then good
6 people can help us finish the struggle from Slavery, the CRM, and up to now, to help African-
7 Americans win FJE.

8
9 After centuries of struggling, we still find overwhelming evidence bearing cycles of corruption
10 preventing Blacks from gaining FJE. Statistics proving Blacks are still facing unjust elections and
11 laws, and systematic discrimination against prescribed education, employment, housing, health
12 care, and loans. These problems compound with the explosion of Drugs, the epidemic of AIDS,
13 and unfairness in the Criminal Justice System. Now we must also mention the mistreatment of
14 Black People in the saga of the great floods of the Mississippi in '22, and Hurricanes Katrina and
15 Rita. They should have formed a union after slavery. That would have been the best way to prevent
16 severe long-term suffrage, after devastation from tragedies at home and abroad.

17
18 GOAL: To form the union to offer help, guidance, services, and protection for Blacks and poor
19 people, just like the ADL and JDL does for Jews. People should realize forming the union indicates
20 a need to organize on a national level to implement proactive strategies for change. • The union
21 will work with Black Churches, Spiritual Black Groups, and Compassionate White and Jewish
22 Groups; to dialogue on the AAIU UD, the Five Phase Plan, and the Reparations Proclamation, to
23 win African-American Reparations, and facilitate new race relations of **peace** with all people.

24
25 FUNDING: Resources are required for any union to operate according to their mission statement
26 to be effective. That is why the AAIU will emphasize initial donations, monthly membership dues,
27 engaging big business ventures, and benevolent and philanthropic donations, to institute an
28 economic plan to solve problems now, and build new and beautiful safe sovereign cities.

29 30 The Reparations Union Lobbying Association (RULA) "The Power Base"

31
32 First; they request most people in America, to join most African-Americans in donating \$100 to
33 help form and register the AAIU. Black People have become readily accustomed to donating to
34 causes to help others. Now it is time for Blacks and others to donate to a cause to help African-
35 Americans recover from 500 years of racial oppression. We have many incentives for the \$100
36 donations, so contributors know they are donating to a worthy humanitarian cause, and they will
37 receive educational materials exceeding \$100. Like (1) the educational products which include the
38 (AAIU (Book/CD) and DVD), and Pro Reparations Docs. They teach True Black History, Promote
39 Black Unity, **Profess Peace for & with all People**, and Show Sovereignty is the Cure for Racism.

1 The AAIU products represent 40 years of research to disclose buried, yet positive and powerful
2 information for everyone in America, and alert to learn. (2) The info will inspire everyone to
3 repent, atone and forgive, so all of us can learn to appreciate all racial and ethnic groups, in order
4 to elevate multi-culturalism, and request black reparations. (3) The info shows the profound impact
5 of using the AAIU for economic boycotting, and selective buying on a national level, as a power
6 move to demand reparations! (4) The information shows reparations as a debt owed by
7 beneficiaries of slavery and exploitation because they caused extensive damage including; (A)
8 spiritual decay; (B) wealth transfer; from theft of land, resources, inventions, ideas, slave labor,
9 and crop production; and (C) social, educational, and employment discrimination and exclusion;
10 and (D) from eminent domain to racial misery, so (5) The 1st million Blacks will get a nice home.

11
12 There is a great need for Blacks to have a union that will be prepared to come to their rescue when
13 discrimination, racial attacks, and police terrorism accelerates. There is also a great need for them
14 to have a union to deal with institutional racism and obstacles which prevent them from living in
15 peaceful and clean cities, having a quality education, good paying jobs, much better housing, and
16 complete health care. The greatest need is for the masses to have a union that is ready to work with
17 an all-inclusive, totally dedicated and constant passion, directed towards winning African-
18 American Reparations. Replacing wealth, they lost due to colonialism and slavery to form a
19 Reparations Fund. It's not fair to have given others reparations when they were not damaged nearly
20 as bad or long, as Blacks were and still are, due to racism/white supremacy; thru slavery, KKK
21 bombs and massacres, reconstruction, segregation, and prematurely forced integration.

22
23 Second; we will ask 200 million people for a \$100 donation to help form the union, and get the
24 products on 2-1-2021, then \$10 a month. Since no one has solved the most dangerous problem in
25 America called racism, the AAIU solution is to use this funding plan to form the union and build
26 a safe sovereign city. The 1st 1 million Blacks who donate will get the option to live there free of
27 racism, in a peaceful, green, spacious, high-tech environment; with a good job, in a prime, fertile,
28 and neutral region. Success of the city will move the rest of the Black Family to have a Plebiscite
29 Vote to choose whether they prefer to live in integrated or sovereign cities in America. All
30 indications lead to building more sovereign cities upon Blacks learning sovereignty is one of the
31 three models of reparations, which represents independence. **The three models of reparations**
32 **are (1) Improving Integration, (2) Expanding Repatriation, and (3) Creating Sovereignty.**
33 Fortunately, a better funding plan is available to form and register both AAIU and SEEG for free.

34
35 Third; this funding plan will also be used to join and acquire business to generate billions of dollars.
36 This will increase union resources and their ability to take care of themselves, including taking
37 diverse action if necessary. This empowers them to command respect and sustain independence. It
38 is mandatory for them to amass union resources to conduct the AAIU United States of America
39 Truth and Reconciliation Process (T&R process), a legal and public procedure showing facts about
40 Blacks suffering severe and extended periods of damages, which requires reparations to repair.

1 Fourth; they will accept large and small tax-deductible contributions and charitable donations with
2 no strings attached to solve problems, boost union activities, businesses, products and services,
3 and build their safe sovereign cities.
4

5 Fifth; Most new businesses, companies, and groups have a funding plan of this nature to achieve
6 their goals. Fortunately, the SEEG identified programs that generate wealth. They recommend we
7 use these programs to generate wealth for African-American and Black Reparations, so we are not
8 going to use the briefly described small funding method above. We are going to use the SEEG
9 programs to generate our own reparations wealth, from billions in seed funds (SF), to the hundreds
10 of trillions that Blacks need, (\$200T for U.S. Blacks, and \$450T for Africa and Blacks abroad, for
11 full reparations. We will also use these programs to register, form, and fund the AARS Congress
12 to initiate and carry out action described in this RULA section, instead of the AAIU and the SEEG.
13

14 They need resources for their congress to remain effective. As disparities multiply, they can focus
15 on forming the congress to produce solutions for many issues, which have caused major damage.

16 • They should form the congress to resume and finish the STRUGGLE, because Black, White,
17 and Jewish Freedom Fighters, sacrificed their lives in the CRM, for African-Americans to reach
18 full equality, and to stop being harassed and brutally killed by the police, and white supremacists!
19

20 People for Spiritual Growth Civil Rights & Reparations (PSGCRR) the AAIU Advisory Board
21

22 I have read the bible many times over the last five years, which has given me a strong spiritual
23 foundation and a good relationship with the Lord. I have accumulated 40 years of painful and
24 costly research to find a solution for racism. Now I am devoted to motivating African-Americans
25 to conceptualize independent thinking and sovereign living as the solution for Racism. This will
26 also facilitate racial healing between the remnants of those enslaved and the enslavers. Now all
27 people should learn the process of repentance, atonement, forgiveness, and recompence; to admit
28 faults, apologize, grow spiritually, and make amends. • We can learn people are human beings
29 with race variations under God's grace, who should strive for universal peace and prosperity.
30

31 Repentance will help all people get closer to God, and transform out of personal vices and
32 addictions, while helping Blacks to improve relations within the Black Family and with others,
33 and cultivate their minds containing innate love, peace, and compromise. The Reparations Fund
34 will be a part of the Reparations Package to provide resources Blacks need to design programs to
35 recuperate from Post Traumatic Slave Syndrome (PTSS), Suppressed Psychological Anxiety
36 (SPA), and all other emotional and psychological damage they incurred over the past 500 years,
37 due to experiencing direct hate from all out vicious racial attacks, and anti-black stereotypes.
38

39 Dialogue will enable us to discuss set backs on race relations, and why protests and riots are set
40 off by racial assaults against victims like Arthur McDuffie, and racist remarks from people like
41 Donald Sterling. These situations confirm there are strong undercurrents of unaddressed racism in

1 America. If racism is allowed to remain unaddressed it will be the downfall of America. I have
2 been hosting and appearing on racism and reparations radio programs and conferences; at churches,
3 colleges, and social functions, for the past 20 years. Racism works simultaneously to benefit whites
4 while oppressing Blacks. It exists subliminally as a crafty deadly disease, curable within the T&R
5 process. People have to face the truth if they want to atone for their part in slavery. America should
6 allow Blacks to learn their true history in school, and time to heal slowly.

7
8 Truth is African-Americans are descendants of people who gave the world (1) the concept for the
9 theology of monotheism, which is the knowledge of one true and omnipotent God, (2) social
10 models to govern nations and cities, which are preferred systems to ensure order and sustenance,
11 and (3) many wonders of the world, which includes equations to build the sphinx and pyramids.
12 Thus, they should be treated like people who provided great achievements and contributions to
13 advance all civilizations. They should not continue to be treated like offspring of slaves incapable
14 of independence. {{I truly thought the Holy Spirit had led me on this research journey to help Black
15 People. But now I know the spirit is telling me it is in my best interest, to ask most people in
16 America to help me, help Blacks and poor people}}.

17 This can be done by preparing for, scheduling, and monitoring AAIU Dialogue on Racism to solve
18 problems in integration, and explore developing sovereignty. I will have authors and educators
19 discuss proposals to diminish racism. I will have spiritual leaders discuss prerequisites and
20 necessities for repentance. Then I will be the 2nd half moderator to discuss pros and cons of 1st half
21 statements; and AAIU plans to build the first safe sovereign city for 1 million Blacks, and to win
22 reparations, as we coopt administration among likeminded community activists. The Dialogue, the
23 T&R Process, this declaration, and our Plebiscite are meant to bring the Black Family back
24 together, after being torn apart and distorted by others with criminal, colonial, and slavery
25 intentions; to assert our claim and right to reparations, for all forms of losses and damages, and
26 reclaim our culture and rightful place in society as spiritual, peaceful, and intelligent people.

27
28 The AAIU will create teams of attorneys, investigators, scientists, engineers, and specialized
29 trained security. This will enable the union to protect Blacks and poor people, create a powerful
30 voting bloc to defeat laws and politicians that cause them harm, and build Blacks safe sovereign
31 cities. Blacks should select a group from their talented tenth to designate a group of Blacks, Whites,
32 Jews, and others who are rich and influential, and concerned about the spiritual growth and
33 wellness of all people, to serve as their union advisory board. To submit various revelations, think
34 tank ideas, and suggestions for Blacks to get immediate relief from racism, utilizing board aptitude
35 to offer viable solutions. They should also ask their board to help with funding by helping to form
36 many sub-groups with the SEEG to raise 5B each for collective economics. They will generate
37 wealth with no risk of losing their money. That provides resources to solve problems and build
38 safe cities, utilizing the Five Phase Plan, the Black Manifesto and plans from Caucasians United
39 for Reparations and Emancipation (CURE). They contain solutions like a Swift Agreement with
40 Policemen to Discontinue Daily Harassment, and Unjustly Killing Blacks, and Long-Term

1 Recovery Plans; for Blacks who are suffering from the legacy of slavery, which is racism deeply
2 rooted in the minds, institutions, and systems all across America! Therefore, the Solution to
3 Racism, Police Terrorism, Corruption, Hypocrisy, and Injustice against Blacks is “Sovereignty”

4 Most African-Americans are spiritual and caring people who want independence and prefer to live
5 in peace and harmony. Yet, the result of experiencing extended periods of extreme racism and
6 sudden unjustifiable police killings, is a cycle of internal distress causing SPA. This untreated
7 illness is forcing most Blacks to subdue anger impairing their emotions. They have a long list of
8 stress related ailments and unsolved problems, causing intense pain and suffering and getting
9 worse. They need immediate action to address these issues, lingering effects of slavery and
10 lynching, social and institutional discrimination and exclusion, and immigration which slowly
11 begot encroachment on traditional black cities. Now during these cultural and social impositions
12 African-Americans provided many valuable contributions, supplied free slave labor, and
13 demonstrated heroic patriotism, to help build, feed, and protect America. They should be awarded
14 reparations to repair damages, and as gratitude for their sacrifices and services! They should not
15 have problems which reappear in cycles, which leads to riots and protests!!

16 The best way for Blacks to solve their problems, and prevent harmful racial attacks is to form the
17 union and prepare for the 2nd CRM. {{{Visualize the union as a vehicle to forecast and prepare
18 action for Police Brutality, Dr. King’s Birthday, Black History Month, and Lasting Forever. Rich
19 Blacks and others can use SEEG plans to make big money, and help less fortunate Blacks. Blacks
20 are not doing anything collectively to help themselves, but they have become experts at gaming
21 on, lying to, and hurting one another. They can change this pattern of self-destruction, into a
22 massive effort of union formation, to build a strong black nation}}}. This is a giant step towards
23 reestablishing racial pride and unity, which will make others give them respect. • Most Whites
24 and Jews admit Blacks are victims of racial domination and abuse of power. That is why most of
25 them will support the union. They have a history of helping Blacks during our most difficult times
26 of struggle, through the Underground Railroad, Abolitionist, Quaker, and Civil Rights Movements.
27 The union’s 1st priority will be to let people know attacking African-Americans is no longer
28 acceptable because you will be held accountable for your actions. Since crooked cops and many
29 others in America have the supremacist attitude of knowing they will get away with attacking and
30 killing Blacks; the attacks will continue. That is why it is **THEE PRIORITY**, and of the utmost
31 importance to support the AAIU and claim AARS!!!

32 The union will serve as an official group for accountability, permit allies to offer support, put those
33 on notice with the supremacist attitude, and give Blacks and poor people many advantages in their
34 quest for liberation and justice.

35 Union responsibilities to its members outlined in RULA guidelines for prevention, peace and
36 progress will come into effect immediately. The 2nd priority will be to solve problems; pressure
37 the government into engaging in ongoing deliberations on Black Reparations, in the T&R process
38 with Black, White and Jewish Scholars, who have studied the issue for at least 20 years, and have
39 plans for repairing damages; and to build safe cities. They must not have been compromised in any

1 way because reparations are much more than money. This will help Blacks and poor people get
2 the respect they deserve, and prepare the next generation of black leaders to serve honestly, and
3 resist temptation; instead of waiting on others to appoint Uncle Tom or selfish leaders. This will
4 help them improve their lives and relations with the police and others.

5 AAIU Resolution

6
7 To recognize the AAIU Racism Dialogue as the best mechanism that will enable African-
8 Americans to identify all of their problems, with the intent of developing solutions. Now hosting
9 the T&R process will produce results by notifying knowledgeable descendants of perpetrators and
10 victims of slavery, to participate in the T&R process. Both groups should work openly and honestly
11 in the T&R process, in order to produce a fair African-American Reparations Package. {{Blacks
12 should envision developing and keeping, a common philosophy or line of thought among their
13 people, for their survival now and in the future. Working a threefold belief system honoring;
14 God 1st, Race 2nd and Sovereignty 3rd, with their own land, governing bodies & infrastructure}}.

15 AAIU Summary

16
17
18 Upon examining aspects of forming the union it is best to promote this as a people saving and fund-
19 raising campaign for most people in America, mainly to help Blacks, and to help make **positive**
20 **changes** for all human beings.

21
22 The AAIU will organize African-Americans and their resources to address racism, corruption, and
23 police terrorism by implementing three sub-union groups. First; the RULA power base will create
24 special teams for action, encourage politicians to review plans that were designed to give aid to
25 newly freed slaves, the reasoning behind 40 acres and a mule, and coordinate activities for national
26 economic boycotting and selective buying. Second; the AAIU board will offer suggestions to help
27 mandate laws for civil and human rights, expose and revise broken promises for equality through
28 integration, and have discussions on the Kerner Commission Report, written in response to the
29 national rebellion after Dr. King was assassinated. Third; the Student Union Action Committee
30 (SUAC), to discuss affirmative action and welfare programs that were supposed to be implemented
31 to make up for losses, from past exclusion and discrimination, in education and employment; other
32 programs they gained from social and civil rights protests, that were cut or underfunded; and most
33 importantly to seek justice and racial healing via the dialogue and T&R process.

34
35 Please contact me if you are interested in helping us form the union. We are forming and registering
36 this union to help poor people, mainly African-Americans because they were wrongfully taken
37 against their will, and forced to endure chattel slavery; forced to clear swamp land, produce various
38 cash crops, see family abused, beaten, raped, and sold off; withstand diseases, withstand racial
39 misery, and get killed for 246 years! Then exploitation lasted for another 100 years under diabolical
40 reconstruction and satanic segregation. This entitles Blacks to reparations and it will become

1 obvious in the T&R process!! We will reveal terms for claims; by showing the damage racism
2 caused, from being captured, chained, and put in dungeons; then experiencing chains in the Middle
3 Passage, Slave Breaking Colonies, and Cruel and Unusual Punishment in Slavery!!!
4

5 Since then and in current times African-Americans are forced to endure severe chronic emotional
6 injuries and debilitating heart breaks. That is why they unexpectedly experience effects of racism
7 so badly today, therefore they should have a sincere desire to rid themselves of that evil disease.
8

9 As victims of Slavery and other race-based crimes like the Tuskegee Experiment, Blacks never
10 received an adequate apology and/or restitution; therefore, they encountered further damage in the
11 form of population control, genetics, and medical malpractices. Dr. Nathan and Julia Hare exposed
12 that in their book called "The Endangered Black Family". Then the enemies of equality used lies,
13 sell outs, and a secret mental war Franklin Jones exposed in his book called the "The Black
14 Matrix"; to keep Blacks divided and confused, and from organizing to pursue any legal/political
15 recourse. The union will create and fortify programs including head start, rites of passage, and
16 reform systems to **focus on repairing** the Black Family, along with all their celebrations!!!
17

18 AAIU Overview

19
20 My life and studies revolve around asking African-Americans to prioritize forming the union to
21 start the 2nd Civil Rights Movement, because I have always noticed Black People are victims of
22 social injustice. All Blacks should want to form the union quickly via the donations because racism,
23 corruption, and police terrorism should be exposed and abolished. All advisors, contributors, and
24 those willing to help Blacks can become union members, to help them (1) form a pool of potential
25 local leaders, (2) join qualified Blacks in AAIU Racism Dialogue to solve racial problems, (3)
26 organize for national action, (4) realize the 1st one million Blacks who donate will get the option
27 to live in their first Safe Sovereign City, (5) let all Blacks and poor people know they will have the
28 union behind them to address racism, and all other injustice they encounter in society, (6) we fund
29 raise by selling AAIU products as part of our Black History Month Project, which is reading,
30 circulating and discussing AAIU docs in class; info at <https://aaiuendracism.org> from Oct-1-2020
31 / Jan-21-2021. (7) prepare for the T&R Process, and (8) to ultimately facilitate racial healing.
32

33 People feel uncomfortable when talking about racism, corruption and police terrorism, but they are
34 completely out of control. We should have racism dialogue, and work together as courageous
35 people in the T&R Process to stop this out-of-control madness! It is our constitutional right to
36 challenge and change repressive collaborations!!
37

38 Everybody in America should read the Book/CD, and watch the DVD very carefully. They expose
39 many problems which specify a sign of captive endangerment for the Black Family. Affirming a
40 complete understanding of why there is a great need for people to help them form the union, to

1 focus on solving their problems, and helping African-Americans reach a well deserved destiny of
2 living in peaceful cities.

3
4 The Black Family is in dire need of restoration and reimbursement for cultural and economic losses
5 from aftershock of slavery, share cropping crimes, and disillusioned integration. Many African-
6 Americans also need psychological rehabilitation from mental disorders, due to harsh treatment
7 over 500 years. And America is in great need of the dialogue and the process for social change.
8 People of different races can learn to understand and tolerate their differences, and we can teach,
9 and expand on racial sensitivity in our schools. These lessons must be nurtured and amplified for
10 Blacks and poor folks to live in peace and make group progress. They must stop letting minor
11 problems and major offenses get swept under the rug. They need accountability to punish
12 criminals, recover what was lost or stolen, and deter action causing needless death and destruction.

13
14 The union has a data base for advisors, members, associates, and friends to relay information
15 providing details on problems they need to solve immediately, and problems to solve in the slow
16 and methodical T&R Process. The union will request contact information on all people and groups
17 who are genuinely working towards making America a better, more humane, and civil society, for
18 all her citizens and residents. The union will gladly reach out and work with these people in their
19 pursuit of BLACK LIBERATION.
