8 To Reparations Advocates, all Black People, and Everybody 18 and Older, **September 1, 2022**  
9

10 No person or group should write a plan saying Black people should prove lineage for reparations.  
11 **No black person** should have to prove anything to get reparations; because the generations and  
12 centuries in suffrage created social and emotional damage, causing **global racial oppression**, and  
13 **the legacy** still imposes a disruptive impulse, and negative impact **on the entire black race!** So,  
14 **all Black people deserve, and are entitled to reparations!** {So, please stop all new ideas, plans,  
15 and studies, because it is not possible to produce a better reparations plan than AARS}. AARS has  
16 processes, programs, and services, **to quickly provide** due relief, justice, and satisfaction for all  
17 African-Americans and all Black people, and **truth and reconciliation** with all nations and races.  
18

19 Many scholars have studied reparations for decades, then produced a reparations plan. **The AAIU**  
20 **studied the issue for more than 40 years**, then produced their AARS reparations plan. So, it may  
21 be best to compare reparations plans written as of now, then you will find **many advantages**, and  
22 **12 strong reasons to endorse AARS.** **More plans** will only cause **confusion and delays**, and  
23 **will certainly be replicas.** Now, **reparations for black folks are way past long overdue!** So, we  
24 do not need any more **obstruction** via more ideas, plans, or studies, we need AARS ratified ASAP!  
25

26 More plans could diminish or cancel what Black people should get for reparations. We alleviate  
27 that problem with SEEG safe programs to generate wealth from **refundable seed funds (SF)**. So,  
28 we can generate the \$650T required to fund AARS, for Global Black Reparations ourselves, over  
29 the next four 50-year terms. All reparations funds should go to the safe programs to generate  
30 wealth for reparations, to **guarantee transparency** in using reparations SF, and **to guarantee**  
31 **reparations payments** to all U.S. Blacks 18 and older, and to all Black Families abroad, ASAP!  
32

33 The AAIU is **hosting and promoting the annual KRP reading project from Black History**  
34 **Month, to Juneteenth**, then to **Kwanzaa** for everyone 18 and over, in America and the world to  
35 evaluate AARS. We use KRP to read, discuss, claim, endorse, and promote AARS globally. KRP  
36 will replace corruption in the reparations arena, with public dialogue, **which is how reparations**  
37 **should unfold.** The KRP will expedite blacks getting redress, and lead to **AARS reformation and**  
38 **reconciliation.** Good communication can get Reparations Advocates, the Congressional Black  
39 Caucus, and most blacks and their allies, to demand the U.S. Government to ratify AARS, ASAP!  
40

41 We encourage everyone 18 and older to engage in the KRP, to learn that Black people needed and  
42 should have been awarded reparations, (40 acres and a mule), right after slavery, for many  
43 centuries of crimes against humanity. African-Americans, and the Global Black Family,  
44 are victims who endured massive and extensive damage, for more than 2000 years globally, and

1 more than 500 years nationally! {Our government should use AARS as the solution, because  
2 AARS was written with programs to benefit all blacks and everybody else in the world! {KRP  
3 reading is also a **peaceful political process**, and **humanitarian project** for blacks to get a good  
4 education on, and prepare to receive reparations. Another **great benefit of AARS** is the agenda  
5 for **racism dialogue** and **case studies** to improve integration; and police and race relations; expand  
6 repatriation; and create sovereignty in America. We enact **both processes** to produce solutions for  
7 problems, to **assure** personal safety, and living in a civil society for all people in America! Black  
8 people have been victims of **racism/white supremacy**, and **police terrorism** for generations! Now  
9 it's **time** for them to use **AARS for Global Black Family Unity**, and **Ethnic Peace and Progress**.

10  
11 I have been talking to many clients of integrity regarding generating wealth, as a **corporate**  
12 **service**, before they ratify AARS. The SEEG found three companies operating, utilizing unit  
13 algorithms, with high end bank notes, in an arbitrage of predetermined budgets, to fund  
14 humanitarian projects. The SEEG negotiated with these companies to use them for reparations. I  
15 entrusted my main client to ask Mr. Warren Buffet to do due diligence on the companies, with my  
16 team. We will confirm validity in two days. Then my clients and Mr. Buffet engage \$5B contracts,  
17 for a minimum profit of 50% per week. Then they ask friends and sponsors to join at their comfort  
18 level from \$5B-\$25B. I have **1** \$25B and **6** \$20B clients now, so, it is a priority to get validity, to  
19 raise the \$650T to fund AARS. We will engage many more **clients** to secure global reparations. I  
20 am asking the CBC to ask our government for \$500B, for \$4T back deferred over 20-years; to  
21 **raise AARS's share, recoup Ukraine war cost, relieve national debt, and boost the economy**.

22  
23 Then ask the other 28 groups found liable for damage, on page six line four, to engage at a  
24 structured level with their \$500B. {{They also allow **rich blacks and people with compassion for**  
25 **blacks** to engage from \$100M-\$5B}}. This AARS economic piece facilitates **genuine and lasting**  
26 **reconciliation**, because the guilty groups get great debt relief from owing trillions, and the victims  
27 get **long overdue emergency relief**, for generations of suffering, then renew programs in 1 - 2 yrs.

28  
29 I am asking strong **God-fearing** grass roots leaders, civic oriented folks, and reparations activists;  
30 top athletes, attorneys, doctors, educators, entertainers, police overseers, politicians, preachers,  
31 psychologist, scientist, therapist, and experts from all races in private and social services, systems,  
32 and institutions, to serve on the AARS Congress with me, to form solutions and provide services  
33 in their professions, and to help the AAIU to implement AARS. I'm asking business clients and all  
34 **college students, news networks, and social media outlets**, if they have the time to use their  
35 platforms to **engage** in, and **promote** the KRP; to win AARS, and **support** the AARS Congress.

36  
37 AARS **processes** and **expedites** securing reparations benefits for all African-Americans, and all  
38 Black people to get **emergency relief**, and **land to build safe cities**. We invite clients ready,  
39 willing, and able. I have asked my clients to ask other philanthropists, and to ask Bill Gates to ask  
40 wealthy groups to engage. Note: if a person or group is suspicious of activity that led to abusing,  
41 colonizing, deceiving, depopulating, enslaving, exploiting, insulting, or relocating Black people,  
42 they should apologize to atone, and help to repair the damage by engaging in the safe programs,  
43 to generate wealth, if they have the means. This is not letting them off the hook, it is **holding them**  
44 **accountable**, by asking them to engage in safe programs to make amends, and to seek forgiveness.

1 We know many of them have the wealth, combined with **deep compassion** for the less fortunate.  
2 **Clients' Incentives**; the 50% minimum return per week on their \$100M-\$5B, receiving agent fees  
3 for recruiting other clients, the option to serve on the AARS Congress, and **endorsing AARS** for  
4 **Global Black Reparations, and Universal Racial Reconciliation.**

17 ***WE HOPE & PRAY for ALL BLACKS, WHITES & JEWS 18 & up to ENGAGE IN the KRP***

18 **The Reparations Debt:** for Racism/White Supremacy, and the Murder of 600M Black People \$2Z  
19 Invading & Capturing Africa \$1Z - Stealing Resources \$1Z - Animal Leg & Neck Chains,  
20 Colonization, Middle Passage, Slavery & Segregation \$1Z - Stolen Ideas, Inventions & Land \$1Z  
21 - Slave Labor \$500T - Slave Crops \$500T - Lynching/Tormenting \$500T - Red Summer/Bombing  
22 Blk Towns \$500T; Spiritual Decline & Propaganda/Stereo Types; Loss of Culture, Legacy, Social  
23 Status, Economics, Education, Families, Names, and Languages; Enduring Cruelty, Brutality,  
24 Misery, Restrictive Covenants & Slave Codes/Slave Laws in America for the last 500 years, and  
25 Global Racial Subjugation & Post Traumatic Slave Syndrome (PTSS) for the last 2000 years \$2Z  
26 **Yes, the Reparations Debt, that is Way Past Long Overdue is Categorically \$10Z!!**

27 The KRP should also be a transforming period in the minds for all non-blacks 18 and older. For  
28 all other people to stop thinking about and treating blacks so bad. This is critical for blacks, because  
29 the beneficiaries of slavery, their cohorts, and everyone else displays a bad attitude and behavior  
30 towards blacks, because the oppressors created an imperial system to show and spread degrading  
31 images, malicious propaganda, and primitive stereo types of blacks, which enabled them to enslave  
32 blacks, and influenced others to abuse, deceive, and exploit blacks. Black folks need to and should  
33 promote the KRP around the world, to get all others to start thinking about and treating all Black  
34 people fair and just. AARS offers **Global Black Reparations, and Universal Racial Reconciliation,**  
35 **to benefit all African-Americans, all black folks, and everyone else in America, and on earth.**  
36

37 **Page 8 of this AARS Global Reparations Plan has a Reparations ID Card Payment Process, (*that***  
38 ***may take 2 months, for accuracy*)), for all Blacks in the U.S. 18 & Older & all Black Families Abroad.**

39 **PLEASE PRINT and CIRCULATE the AARS PROMO PAGE the NEXT PAGE; THEN**  
40 **demand NATIONAL AARS REPARATIONS DIALOGUE with BROTHA PRUITT; To**  
41 **START a GLOBAL CIVIL RIGHTS MOVEMENT to DEMAND AARS REPARATIONS**  
42 **AS A CERTIFIED GIFT FROM our GOVERNMENT to THE GLOBAL BLACK FAMILY.**

1 The U.S. Government and the 28 other guilty groups are liable for **major problems** and **vast**  
2 **damage** from their invading and capturing Africa, stealing her resources, and enslaving Black  
3 people. The damage stems from **racism**, colonialism, slavery, **lynching**, and segregation, and **casts**  
4 **emotional trauma**. **So, all U.S. Blacks 18 and older** should start getting **emergency payments**,  
5 **(\$100k on 6-19-23)**, **then all Black Families abroad soon thereafter, if not we should increase**  
6 **and intensify worldwide calls and demands for AARS in all mediums, platforms, and venues!**

7 Black people should be **proud, appreciated, and respected globally** for **great achievements**, but  
8 **instead** they have been abused, enslaved, and oppressed for over 2000 years! That was engineered  
9 by **religious propaganda**, fabricating awful anti-black, and evil negro phobic passages in scripture  
10 to **prescribe** blacks as slaves to the U.S. Government, and the guilty groups! **The Pope apologized**  
11 for having 7 European Nations, and the government to **silently** suppress developing Africa, while  
12 **obviously** subjugating and dominating Black people! There were also 17 U.S. corporations which  
13 gained **unjust enrichment**, like hundreds of trillions, from the slave trade, transport, and policies!

14 **{{AARS is for blacks at home and abroad; with programs to learn about and reconnect** with  
15 **their homeland, culture, family and customs; to regain** control of African resources, and **to build**  
16 **safe sovereign cities in America, Africa, and globally}}**. **Blacks are victims** of the world's worst  
17 crimes ever, **for capitalism** in chains and bondage, causing **Epic Black Suffrage!** It begot **spiteful**  
18 **divisions**, then a **spiritual decline**. So, they need AARS to reunite, repair, and **transform minds**,  
19 back to **revive solidarity and spirituality**, prior to slavery, then seek racial healing with all others.  
20 AARS serves to **elevate world politics**, for all nations and races to get **mutual** respect and benefits.

21 AARS is a **complete plan**, with safe programs to **generate wealth** from seed funds (SF). **{{A plan**  
22 **with both elements** makes it **the best reparations plan by far**, so everyone should **endorse and**  
23 **promote AARS}}**. SF are even **refundable**, so **all powers and guilty groups get great debt relief**  
24 via **loaning** \$500B in SF, instead of **paying** the \$30T up to \$50T, that they each owe! **Blacks get**  
25 **great suffrage relief** via **cash, building** safe cities, and **repairing** all damage! **{{Generating their**  
26 **own wealth** restores **black pride and unity, getting inner peace, abolishes begging, and is key to**  
27 **liberation}}**. So, **generating wealth should be the priority. 12 strong reasons to endorse AARS!**

28 **First**, guilty groups note \$50B-\$500B cash as SF utilizing the AARS Hedge Fund and operating  
29 U.S. Black Banks. That gives us a **money trail**, and black banks real **banking power**. Rich blacks  
30 and the compassionate, should start engaging now at \$100M-\$5B. **Second**, one person becomes a  
31 client by submitting a long doc for compliance. **Realize**; nobody around foul activity can engage.  
32 **Third**, clients get contracts for diligence. {SF programs require clients to **block** a contract amount  
33 in their accounts for programs duration, timing, and operations. **So, clients cannot lose their SF in**  
34 **these programs**}. System banks and their banking officers manage the programs, so they are secured, and  
35 yield rapid high returns. "A **proper line of communication** will get most **Reparations Advocates**, most  
36 of the **Congressional Black Caucus**, and **most blacks** to agree to endorse AARS". Then our **government**  
37 **will be justified in ratifying AARS, ASAP**, so their \$14T and all SF can generate \$650T to fund AARS".  
38 **Incentives to Move Fast: (1) programs open and close quick! (2) victims need emergency relief ASAP!**  
39 **(3) clients get 50% weekly payouts at \$100M & above! & (4) SF unblocked** after programs profit & close!

1        **AARS Executive Order: \$500B from the U.S. Government & all 29 Guilty**  
2        **Groups to Generate Wealth for Emergency Funding & Securing Reparations**  
3        **Resources to UTILIZE the AARS HEDGE FUND & OPERATING U.S. BLACK BANKS**

4        The U.S. Government, the Pope and the Church, 7 European nations, (Britain, Denmark, France,  
5        Italy, the Netherlands, Portugal, and Spain), the Willie Lynch Letter and the Jews, the KKK, and  
6        the 17 corps. listed below, are all guilty of land theft, ruining families and culture, and mass  
7        murders; in Africa, around the Diaspora, then in America. So, all blacks need AARS for emergency  
8        monetary relief, land, and programs to recover, repair, and rebuild their emotional and social status.  
9

10       The African-American Reparations/Sovereignty (AARS) Plan services all these areas, and much  
11       more, so we are calling on **President Joe Biden** to issue an **Executive Order** for AARS for  
12       Kwanzaa of '23; as an apology and gift to all Black people; from America and all the guilty groups!  
13

14       The **Executive Order** should be \$500B from the U.S. Government, and all of the other 28 guilty  
15       groups ASAP, noted to the AARS Hedge Fund and operating U.S. Black Banks. The **Executive**  
16       **Order Directs** the 28 groups to engage AARS, **to atone and profit**, so blacks can get emergency  
17       reparations **relief**, their own **land**, and **police accountability**. When America accepts AARS, they  
18       agree to emergency relief; 40 mi<sup>2</sup> land grants to build safe cities; and ensuring safety for all blacks!

21        **CORPORATE RESTITUTION FOR SLAVERY**  
22        **(Plaintiff and Defendant Information)**

23  
24        This compilation comprises materials on landmark class action lawsuits brought on behalf of 3.5 million  
25        descendants of enslaved Africans for slavery reparations! Plaintiffs in six different states (New York, New  
26        Jersey, Illinois, California, Louisiana, and Texas), filed the actions against a total of seventeen (17)  
27        defendant corporations, who are known to have profited, for hundreds of years from Chattel Slavery,  
28        including the Transatlantic Slave Trade!! The cases have been consolidated in the U.S. District Court,  
29        Northern District of Illinois, Eastern Division before Judge Charles R. Norgle.

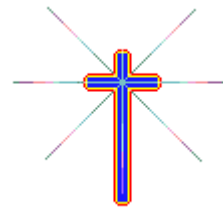
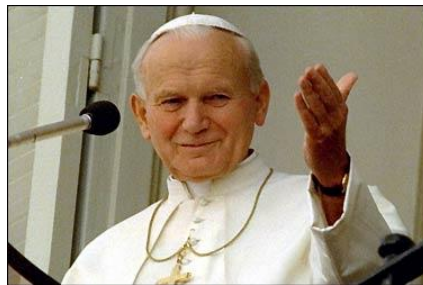
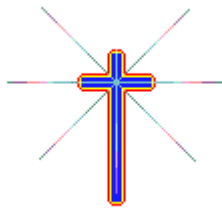
1       **The Pope Apologizes: to Africa and all Black People for their Role in Slavery**  
2       **Apologies should Include \$500B, \$50B & \$5B Cash as Seed Fund Settlements**  
3

4       **We sincerely thank the Pope** for having the courage to admit that the Church should apologize  
5 to Africans/Black people all over the world for their role in slavery! Hopefully other perpetrators  
6 will have leaders with the same guts, to admit their transgressions, because they are liable!! AARS  
7 offers top processes, programs, and services to offer relief for perpetrators and victims of slavery!!!  
8

9       **We also thank the World Council of Churches (WCC)** for telling Europeans, Americans, Arabs,  
10 Jews, and all beneficiaries to pay reparations to African nations; parts of the Diaspora where blacks  
11 were abused, enslaved, and exploited; and in the U.S. and globally, for their role in the Slave Trade.

12       **We honor Mr. Peoples the late Compton Community Activist**, who exposed deeds of the Black  
13 American Slavery Holocaust, by driving a model of a slave ship around LA County for nearly 40  
14 years! He filed a lawsuit against the Church for their role in the Slave Trade, that was, but should  
15 not have been dismissed, without the proper judicial process, in a sworn court of jurisprudence!!  
16  
17

18                               **The Pope Asks Africans to Forgive Christians**  
19                               **for their Role in the Trans-Atlantic Slave Trade**  
20



21  
22  
23       Pope John Paul II recently journeyed along the same route that hundreds of thousands of Africans  
24 passed through on a voyage to the New World as Slaves, and the Pontiff begged Forgiveness for  
25 Christians Involved in the Slave Trade.” How can one forget the enormous suffering inflicted,  
26 ignoring the most elementary rights of man, on the people deported from the African continent?”  
27 he asked.” From this African Sanctuary of Black Pain, we begged the Pardon from Above.” The  
28 Pope made the comments during a visit to Goree Island, which is a 20-minute boat ride from a  
29 French naval base in the capital of Dakar in West African Senegal.  
30

31       Calling the Passage, a “Door of No Return,” the Pontiff toured cells of the “House of Slaves”  
32 where at least 600,000 Africans passed through, during an extended period from the early 15<sup>th</sup>  
33 century to the beginning of the early 19<sup>th</sup> century!! He likened the house where people were held  
34 in chains, awaiting slave ships, to this century’s concentration camps, the “Maison des Enclaves,”  
35 which has been restored as a museum to document the horrors. In a meeting with Muslim leaders,  
36 he appealed for an end to modern-day slavery, citing organized prostitution, and stressed the need  
37 for cooperation and equality for Christian minorities, who he said are discriminated against in  
38 many Muslim countries. The Pope’s week-long pilgrimage was aimed at strengthening the role of  
39 the Catholic Church in the heavily populated Muslim countries of Senegal, Gambia, and Guinea.

## AARS Emergency Cash Payments for all Black People at Home & Abroad

The SEEG identified 3 companies to generate wealth for emergency individual and family relief payments (PM). Many blacks have bank issues or have lost bank accounts. AARS serves them a new bank account as a **1<sup>st</sup> reparations award**, with services for 1 year, to learn good spending and saving habits. All 50M blacks in the U.S. 18 and older, need a **red, black & green, Reparations ID (RID Card)**; by last name A-Z; state; DOB; AGE; SSN; income; photo, fingerprints, and **birth certificate**; for accurate PM. All blacks will be appointed one of the twenty-one operating U.S. Black Banks by last name for PM. All blacks get a bank card from their appointed Black Bank via their **RID**. All reparations PM go to their bank cards. Black settlement for PM is birth by 6-1-23.

We will take these funds and give all blacks 18 and older, in America 100k on 6-19-23, as an initial PM. We will give those U.S. blacks 20 straight 100k payments every 30-90 days, pending how long it takes for those blacks to receive PM. Then we resume payments until we reach the \$2M goal for those blacks in America. This path encourages blacks to use reparations most effectively, and not to squander them selfishly, or with others. And it also gives blacks time to utilize programs to seek top mental and physical health, by engaging in preparation to receive reparations programs; and learning to produce and sell all products, for daily use in America, and in great demand abroad.

AARS delegates the same ID process for all Black Families in Africa, the Diaspora, and Globally, to provide \$2M per family, since the cost of living is much lower, and the number of blacks are much higher. Blacks must be 18 to get these payments. We put these funds for blacks who are not 18 in personal trust funds at their appointed Black Bank. Blacks do not pay taxes on any reparations payments. It should also be stipulated that no government, company, or group should harass blacks for debt, since AARS requires all blacks to be released from all debt, as a **2<sup>nd</sup> reparations award**.

Blacks should take the next 20-month period to fortify a racial hierarchy, their AARS Congress, and studying all parts of AARS to adopt and create healing, repairing, recovering, and transforming programs. We are fortunate to have found funding sources. We apply **Pressure via Planning for National Action**; including (1) the 2<sup>nd</sup> National Black Political Convention, (2) the 2<sup>nd</sup> Million Man March, and (3) the 2<sup>nd</sup> Civil Rights Movement, to demand AARS, by and for Kwanzaa of 23! So, if AARS is not ratified by Kwanzaa, we will lift and activate demands for AARS in all venues!!

Blacks should claim their Injured Indigenous Status, their AARS Plan, and 1 of the 3 reparations models for residence, via their Plebiscite Vote (PV), upon establishing terms. We will keep you informed. The PV indicates blacks are indigenous to this land, as distinct relatives of the Great Ancient Black African Olmecs, who were here first, building civilizations, not Native Indians, or Early Mexicans. **The PV guarantees** blacks land, and other reparative measures. AARS provides **emergency relief** for all blacks, and **initiates dialogue** to improve integration and police and race relations, expand repatriation and to create sovereignty. That signals a spiritual awakening, and a brand-new beginning for all blacks globally. **That is exactly what blacks need for reparations!!**



## THE AARS POWER POINT PRESENTATION

1  
2 Reparations means one group claiming redress, engaging a political process, or filing lawsuits for  
3 crimes, or damages inflicted on them by another group. The U.S. Government was liable for minor  
4 damage done to other groups, so they were right to give them reparations, but they should not have  
5 got them before blacks, yet they did get an apology, land, money, or a mixture. The governments  
6 and the other guilty groups, are liable for vast damage done to Africa and all Black people, so they  
7 owe them prolific reparations. With AARS we go beyond epic proportions to provide reparations.

8 **{{Now, coping with Black people being denied reparations is an insult to the entire black race}}!**  
9 Note it raises frustration, because Black people needed reparations right after slavery! So, **{{blacks**  
10 **at home and abroad should agree to endorse AARS during the KRP, then give a mighty global call,**  
11 **claim, and demand for AARS reparations on 6-1-23, to get AARS ratified by June 15, of 2023}}!**

12 **{{There are some valid pivotal reparations plans with good ideas to offer, but they all rely on**  
13 **lawsuits, elusive reluctant sources, or some aberration of miracles to get trillions. That is highly**  
14 **unlikely and may never happen}}. So, note a great factor of AARS is we generate wealth ourselves.**

15 **{{Thus, there is only 1 reparations plan** that offers processes, programs, and services to {Regain  
16 Control of their Homeland Africa; or at Least to get Most of the Wealth from her Resources;  
17 Reconnect with their Global Black Family, Culture, and Customs; Repair Damages and Injuries;  
18 Solve Problems; Recover Losses; Transform Mentalities to Attain and Secure Unity and Group  
19 Protection, and Progress; Gets Blacks on the Right Path, to Heal and Improve Relations among  
20 Themselves at Home and Abroad; Then with all other Nations and Races}. And, Last but Truly not  
21 Least, yet Most Notably, \* They Generate their Own Reparations Wealth now, and that is AARS}}!

22 No other plan even comes close to offering all these amenities, so we are calling on the masses, to  
23 engage in this peaceful political process, over the next 2 months in the KRP; to study and claim  
24 AARS, and an injured and indigenous status, as we were scheduled for, from Black History Month  
25 to Juneteenth, to Kwanzaa of '22. **{{We inspire reparations advocates and groups, then the masses**  
26 **of blacks at home and abroad, then others with feelings to faithfully endorse and promote AARS}}.**

27 Since blacks are indigenous to this land, they deserve the rights and privileges of indigenous folks.  
28 **{{That includes land, emergency relief on 6-19-23, other reparative measures, and the last part of**  
29 **AARS, which is a National and International Decree, and Treaty, from all Government Agencies,**  
30 **Militaries, and Lobbying Power Groups, for Safety and Security for All Black People Globally}}!**

31 **{{The PV also gives U.S. Blacks a chance to finish the Civil Rights Movement (CRM), when they**  
32 **were forced to integrate. That's when blacks should have been awarded 40 acres and a mule, they**  
33 **were promised, but never received after slavery}}. Since they were maliciously denied freedom,**  
34 **justice, equality, safety, and fair wages, even after the CRM, and experienced even more racial**  
35 **oppression, they should have demanded and gotten options to examine the 3 models of reparations.**

36 The 3 models are (1) to Improve Integration, (2) to Expand Repatriation, and (3) to Create  
37 Sovereignty, then use the PV to claim 1 of the 3 models for residence. **{{It was too early to integrate**  
38 **after the CRM, because the country was still in chaos from avid civil disobedient movement of**  
39 **bussing, freedom rides, protests & sit-ins, then the nation erupted after Dr. King's assassination}}.**

1 So, when blacks take their PV, they claim an injured and indigenous status by name, (Indigenous  
2 African-American or Indigenous Black-American). {{That will stipulate **group status**, to get **land**  
3 **grants of 40 areas, of 40 square miles (40 mi<sup>2</sup>) of prime land at good locations near the oceans.**

4 Blacks should learn they do not have to continue to live in integration, with violence, crime, killing,  
5 and corruption; becoming common, wreaking havoc, escalating out of control. These are the main  
6 reasons why the AAIU believes Black people should demand sovereignty at home and abroad.

7 **(1) Improving Integration:** The AAIU and their Allies are forming the AARS Congress as a  
8 Power Base to implement the AARS Plan. **The AARS Congress will consist of people with a**  
9 **track record of helping Black people;** those who are knowledgeable of reparations; those with  
10 reparations ideas and plans; other reparations activists, and groups; those protesting inequality,  
11 injustice, racism, and police terrorism/killings; those giving input on AARS; and those who are  
12 clear, confident, and savvy on understanding and communicating in serious modes of spirituality,  
13 education, diplomacy, law, politics, reform, and reparations.

14 The AARS Congress will host a 5-year National Dialogue on racism, corruption, and police  
15 terrorism/killings; and hosts 5-year Case Studies on various businesses, entities, institutions, and  
16 systems in America, to improve their performance for, and interaction with Black people. **{{Both**  
17 **processes will improve integration, and police, and race relations, much more than imaginable,**  
18 **and will definitely initiate and sustain national and global healing for racial reconciliation}}**.

19 Everyone in the U.S. should endorse AARS for black reparations, and AARS racism dialogue and  
20 case studies to produce positive changes in all areas in society, because it benefits Black people,  
21 and everyone else in America! AARS also provides financial services for blacks to use reparations  
22 wisely, and not to squander foolishly. Black people have provided many vital contributions, while  
23 enduring racial oppression and profiling, others have not experienced, so Black people need  
24 reparations now! So let the Church and everybody else shout long and loud for AARS reparations!!

25 **(2) Expanding Repatriation:** Repatriation is going back to Africa, down south, or any other place  
26 on earth where Black people were colonized, enslaved, or exploited. We get leaders from global  
27 groups like the TransAfrica Think Tank, and the UNIA to direct repatriation efforts. Blacks go with  
28 invitations from leaders to reunite globally, in places they choose, and learn the customs of their  
29 people, in the places where they choose to go. We request blessings from the leaders, and we make  
30 sure we don't offend our distant relatives on arrival, so, we go with a sense of family and belonging.

31 This will initiate, the **{{Global Black Family Healing, Recovering, Reuniting, and Transforming**  
32 **of their Mentality Process}}**. **They will go with ample resources to build new, beautiful, elite,**  
33 **and safe repatriated cities.** They should also learn their native names, languages, customs, and  
34 culture; to prepare for their, **{{Global Black Family and Culture Restoration Process}}**. **AARS will**  
35 **also Provide Services for all blacks to get Dual Citizenship, to Elevate Both Global Processes.**

36 **(3) Creating Sovereignty:** Best explanation on page 48

37 **\*\*Generating Reparations Wealth: The deciding factor in choosing a reparations plan.** Since  
38 AARS is a comprehensive, thorough, and complete plan to repair, recover, heal, transform, and set  
39 blacks on the right path to good health, peace, and group progress; it is a real blessing for Black

1 people to be able to generate their own wealth, with SEEG programs, from seed funds (SF), to  
2 implement AARS. We are asking everyone to engage in the KRP to endorse AARS. **Most** Black  
3 people are poor folks living in poverty, with poor social conditions, so poor blacks should get  
4 reparations first, then HBCUs, and Black Institutions and Organizations to benefit the masses.

5 In America the SEEG source identified the U.S. Government, the other 28 guilty groups, rich  
6 blacks, and those rich with compassion for blacks as potential clients to engage SEEG programs,  
7 to generate wealth for reparations! Blacks needed redress right after slavery, so AARS is overdue.

8 We go to all potential clients with SEEG programs to generate wealth, instead of acquiescing, or  
9 begging, or filing lawsuits, which we may never win; with the U.S. courts leaning on Standing,  
10 Statute of Limitations, and Sovereign Immunity. **Please Listen and Note Generating Wealth**  
11 **Expedites the Process for all Blacks Reparations Benefits!** **{{Now, it is politically incorrect and**  
12 **socially unacceptable to continue to deny blacks reparations, while offering stimulants and special**  
13 **aid to others! Especially since damage includes losing their homeland, wealth transfer, cultural and**  
14 **family harms and losses, and 600 million people murdered due to racism, cruelty, and brutality}}!**

15 The \$50B-\$500B in SF should go evenly to the AARS Hedge Fund and operating U.S. Black  
16 Banks, for a money trail, and to get real banking power. Then one person becomes a client by  
17 opening a \$5B cash account from the SF, to engage an SEEG program. **{{Rich blacks and the**  
18 **compassionate** start the programs with \$100M up to \$5B, which should inspire the U.S.  
19 Government and the other guilty groups to engage. They will negotiate bank endorsed contracts,  
20 for a huge profit with no risk, and points for AARS}}.

21 **The AAIU 2 Month KRP Campaign Tri-Purpose; (1) To Ask Most Blacks and Others to Read**  
22 **and Endorse AARS, if it meets their approval; (2) To Ask Potential Clients to Engage SEEG**  
23 **programs, ASAP; (3) To communicate and cooperate with the U.S. Government to get AARS**  
24 **Ratified by Kwanzaa, as a Remorse Gift to African-Americans, and the Global Black Family.**

## 26 THE AARS MEMO & BULLET POINTS

### 27 28 **Recruiting Potential Allies to Endorse and Support** 29 **the African-American Reparations/Sovereignty (AARS) Global Black Reparations Plan**

30 AARS Memo:

31 The AARS Plan is a complete and comprehensive plan. It has ideas and suggestions from our great  
32 black scholars of the past and present. It includes processes, programs, and services to get quick  
33 emergency monetary relief, repair colossal damage, solve lingering and mounting problems, and  
34 **will create a new line of thinking in blacks.** To learn and know they have earned, and are entitled  
35 to their own sovereign land, right here in America, as indigenous people, with indigenous rights.

36 That enables blacks to get their own land to build their own new, elite, and safe repatriated and  
37 sovereign cities, form their own governments, write their own laws, and control all affairs,  
38 companies, institutions, and systems within their city limits. In an attempt to diminish and override

1 the sell outs, and unite genuine reparations activists, then the entire Black Family, we will use  
2 AARS as the base reparations plan, then we will add all other good ideas from all good people, as  
3 amendments, to repair damages and injuries, recover losses, and/or to benefit the masses of blacks.

4 AARS Bullet Points:

5 \* 1. First; Giving Honor to God & praying for special help to unite blacks & get justice via AARS.

6 \* 2. The strongest part of AARS is they Generate their own Reparations Wealth from Seed Funds  
7 (SF), from the governments, other guilty groups, those with compassion for blacks, and rich blacks.

8 3. That is why AARS is the best reparations plan by far. All other plans require waiting, begging,  
9 or filing lawsuits, that we may never win. With AARS we get SF and generate wealth right now!

10 4. AARS provides great debt relief for the governments, and all the other guilty groups, who owe  
11 reparations, because they are all guilty of vile and vast crimes against humanity, including mass  
12 murder, disconnecting culture and family, and benefitting from forced enslavement. AARS gives  
13 them great debt relief by **loaning \$500B** in SF, **instead of paying** \$30T up to \$50T they each owe!

14 5. AARS **can** provide great aid and relief for blacks by serving emergency monetary relief ASAP!

15 6. AARS includes spiritual, cultural, family, and social processes, programs, and services, to repair  
16 blacks back to their peaceful and progressive status they were in, prior to colonialism and slavery.

17 7. AARS includes programs and land negotiations to build safe repatriated and sovereign cities  
18 right here in America, rebuild the infrastructure in Africa and globally, and get control of resources.

19 8. AARS has programs and services **to reconnect** blacks with their mother and homeland (Africa),  
20 their spiritual beginnings, their global and extended family, and traditional culture, and customs.

21 9. AARS offers preparation to receive reparations programs to help blacks get in top mental and  
22 physical condition to receive reparations, so that they don't squander them selfishly, or with others,  
23 to make sure they use them most efficiently, to set them on the right path for healing, recovering,  
24 and transforming, and to guarantee their future with provisions for safety and success.

25 10. AARS offers financial services and career-oriented programs to guide blacks, and for stability  
26 in finances, to help them in choosing a career, and to establish high retention in colleges and jobs.

27 11. AARS explains and outlines the **3 Models of Reparations**, to take care of all 50M blacks in  
28 the U.S., then all blacks globally, **(1) Improving Integration**, with AARS Congressional Racism  
29 Dialogue & Case Studies, **(2) Expanding Repatriation**, with approval from our extended family  
30 members where we choose to go, and with ample resources to rebuild the infrastructure, and build  
31 elite and safe repatriated cities, and **(3) Creating Sovereignty, for blacks to develop a new line**  
32 **of thinking**; to know they are entitled to their own land here in America, if they claim an injured  
33 and indigenous status by name, (Indigenous African-American, or Indigenous Black-American).

34 12. **The AAIU Plebiscite Vote (PV)**: serves to let everyone know blacks are indigenous to this  
35 land, as distinct relatives of the Great Ancient Black African Olmecs, who were here first, building  
36 and moving civilizations, not American Indians or Mesopotamian Mexicans. The PV functions to

1 finish the Civil Rights Movement, when blacks were forced to integrate. The PV offers blacks a  
2 chance to choose which model they prefer to reside in, instead of being forced to remain integrated.

3 13. The governments should stipulate that their repatriated and sovereign land can never be taken  
4 away from blacks; for eminent domain, any necessity, or any other reason that they ever conceive!

5 14. The AAIU's KRP, which we are engaging in now, is circulating, reading, and discussing AARS  
6 with all blacks and their allies 18 and older, during the next 2 months of May and June of '23.  
7 Blacks should learn AARS is their best redress plan during that time, because it enables full repair,  
8 and they generate their own reparations wealth. This will prepare them to raise and intensify their  
9 call for reparations by utilizing actions and programs to demand AARS starting on (6-1-23), and  
10 for the next two-week period, to get the U.S. Government to ratify AARS by 6-15-23. If AARS is  
11 not ratified by 6-15-23, they should lift and intensify their demands for AARS, until it is ratified!!

12 15. AARS prevents reparations opponents and their sell outs from trying to set criteria for blacks  
13 to receive reparations. Irrational, all blacks identified as black on their birth certificates qualify.

14 16. Opponents and their sell outs even have the nerve to say blacks can only claim reparations for  
15 the last 400 years. Irrational, Africa was invaded in 332 BC! That is more than 2000 years ago!!

16 17. Opponents and their sell outs are now even saying blacks have to prove they are a descendant  
17 of slaves to qualify for reparations. Irrational, all blacks get reparations based on racial oppression.

18 18. Opponents and their sell outs continue to say blacks sold each other into slavery, repeating the  
19 lie and ignoring the facts! Blacks were brutally beaten, sold, transported, and enslaved by others!!

20 19. When discussing reparations most people are only concerned about the money. AARS provides  
21 emergency monetary relief, along with programs & services to heal, repair, recover, and transform.

22 20. To expose true Black History to prove Africa is the home of humanity, and blacks are the  
23 original people; so, all people, and especially the police and supremacists, can start to give them  
24 respect, or at least tolerate them as human beings, and should stop daily unnecessary harassments.

25 21. The AAIU also list 30 reasons for blacks to claim reparations on section 5 article 5 of their  
26 website; <https://aaiuendracsim.org> Then see [https://www.nairaland.com/2971359/shocking-](https://www.nairaland.com/2971359/shocking-pictures-slavery-never-seen)  
27 [pictures-slavery-never-seen](https://www.nairaland.com/2971359/shocking-pictures-slavery-never-seen) to see evil enslaver tactics causing severe and in-depth emotional  
28 trauma, proving reparations are way past long overdue! After reading reasons, seeing tactics, and  
29 reading this AARS info, you will know why blacks should have got reparations right after slavery!!

30 **{Note the 2 Profound Phrases; “The World’s Economy and America were Built on the Backs of**  
31 **Black Slaves” & “Suppressed Emotional Trauma is causing Blacks to Develop Mental Disorders”}**

32 22. In AARS we demand the government to grant (40), 40 mi<sup>2</sup> land grants, for 40 million blacks,  
33 symbolic to 40 acres and a mule. 10M of 50M blacks may want to remain integrated. They have a  
34 right to choose where they live. They may be rich, satisfied, or a sellout, so they choose model 1.

35 23. **Improving Integration & the AARS Congress:** \*This 7 Power Move Process will be very  
36 effective to get blacks respect instantly, if planned for national and simultaneous action! The AAIU



1 is forming the AARS Congress as a Power Base to implement AARS, and engage (1) - (7) the next  
2 time a black person is unjustly killed by the police, and to demand AARS. (1) initiate an AAIU 5-  
3 year national movement **against** police killings, and **for** reparations; (2) initiate a 5-year-national  
4 dialogue on racism, corruption, and police terrorism; (3) initiate the 5-year-case studies to identify  
5 systematic problems, to produce solutions in all institutions, and in society; (4) initiate 5-year-case  
6 studies to improve interaction with and performance of all companies, institutions, and systems  
7 which blacks depend on for learning, living, and surviving; (5) initiate 5-year-long boycotting  
8 against companies who disrespect blacks; (6) do mass buying from companies who respect blacks;  
9 and (7) transferring 75% of all of their assets from other banks, to the operating U.S. Black Banks.

10 24. \*\* Everyone in the U.S. and globally, should endorse AARS for global black reparations,  
11 because it includes studies to produce positive changes in all businesses, companies, entities,  
12 institutions, and systems in society, therefore AARS benefits blacks, and everyone else nationally!

13 25. **Rev. Tom B. Watson:** Has dedicated more than 25 years to community involvement, and is  
14 a former superintendent of the Milne's Boys Home. He is "Calling the Black Family to Order" as  
15 it pertains to blacks globally. Black men must start standing up for themselves, and their race!!

16  
17 26. AARS requires \$200T for U.S. Blacks, and \$450T for Blacks abroad. The U.S. Government,  
18 and all those guilty of causing acute trauma, and benefitting from colonialism and slavery, should  
19 place \$500B in their new accounts to generate wealth; to bind, settle, and share profits with the  
20 AARS Hedge Fund and the operating U.S. Black Banks. AARS facilitates justice for all blacks,  
21 and reconciling with all nations and races. AARS also asserts the U.S. to recoup war losses, relieve  
22 the national debt, and boost the economy. AARS is an accurate and undeniable solution for quick  
23 relief for victims, and the gathering of culprits to apologize and atone for crimes against humanity.

24 27. **AARS will assist victims and culprits to willingly accept a refined plan for a settlement.**

# **AARS is Fairness Justice & Satisfaction for all Black People and Racial Reconciliation with all Nations & Races**

NOTE: A Strict Call for Reparations to all Blacks for The Last 500 Years of Crimes; Focusing on all the Injustice Before, During, and After Slavery, and Painful Repeated Cycles of Unjust Police Killings; This AARS Position Leads to the AARS Plan in Terms of Equity Restorative Justice (ERJ); In ERJ Victims Settle for Less Than the Debt; but Demand Ample Resources to Repair their Broken Family in America, Africa, and Globally; {In AARS **we Generate Wealth to Relieve Culprits of their Duty to Repair Damage, and Victims of Suffering from Economic Exploitation:**

African-Americans are fortunate to know hundreds of communities and organizations across the country, are considering providing **reparations to blacks for generations of abuse, oppression, racism, and slavery**. Places like California, Massachusetts, Rhode Island, North Carolina, Iowa City Iowa, and Evanston Illinois; along with religious denominations like the Episcopal Church; and prominent colleges like Georgetown University in Washington DC.

We have a problem with the reparations plan that was posed for a few blacks on housing restrictions in Evanston. The civic group that posed the program that landed in 2019, said pro reparations groups offered pro-bono legal aid if the program is challenged. All blacks and everyone else should challenge the program, because it is not a reparations plan, it is only a housing redress program, for a few qualifying blacks, out of thousands. The dissenting voter stated the effort is paternalistic, and assumes that blacks cannot generate or control their own wealth. **African-Americans should claim AARS to generate wealth, and to move towards unity, liberation, and independence.**

Reparations are meant to repair damage done to all Black people, not a few in certain areas, or for certain massacres. There are cases of some blacks being misguided to try to get reparations for a few blacks. The proper way to approach reparations is with a plan that identifies the wide range of damage, using and creating applicable programs to repair that damage, and listing issues and lingering problems we should solve ASAP. We fought the Civil Rights Movement (CRM), to gain rights that would have led blacks to equality. But we were fooled with integration, so now we need a 2<sup>nd</sup> CRM to win those rights, and to slowly dissolve racism and police terrorism. The 2<sup>nd</sup> CRM will be the Reparations Movement, to win our rights in a peaceful and political service called KRP.

In AARS we use all 3 models of reparations for the collective for all 50 million blacks in the U.S., and an emergency settlement, with a priority on poor Blacks, HBCU's, and Black Institutions. The 3 models of reparations are (1) Improving Integration, (2) Expanding Repatriation, and (3) Creating Sovereignty. We need **\$18 Trillion** for programs to improve, expand, and create each model, with **\$8 Trillion** for individual relief, plus **\$5 Trillion** for reserves and unexpected costs, **(that is \$67 Trillion, an ERJ settlement) {{to prepare for sovereignty with service programs}}**.

1 Yes, blacks still get relief if they deny sovereignty, and many options {{to engage various cultural  
2 and social programs to transform, or to remain stable}}, for healing purposes, and for healthy and  
3 productive living. In AARS we also produce and search for programs to create and find jobs.

4 Blacks need reparations now, because others received reparations, for much less damage and/or  
5 loss of lives, yet they were granted their own reservations or territories, so blacks need their own  
6 repatriated and sovereign land. Studies prove they should create, build, form, own, and operate  
7 their own schools, hospitals, corporations, military police; and entire infrastructure with superior  
8 homes, roads, highways, shopping malls, parks, and communication systems; with all the  
9 requirements and luxuries which are essential, to build elite and safe cities, at home and abroad.

10 Blacks are divided, deceived, and in danger, so they should unite around this AARS plan to ask  
11 the government for 40 areas of 40 square miles (40mi<sup>2</sup>) of land, (symbolic to 40 acres and a mule),  
12 to build their own new elite, and safe repatriated and sovereign cities. They deserve sovereignty  
13 after slavery to stipulate group autonomy and collective progress. **Their Internal Black Plebiscite**  
14 **Votes (PV), sometime during 2023, for blacks only 18 and older, to claim an injured and**  
15 **indigenous status, and to improve integration, expand repatriation, and create sovereignty;**  
16 **should be their collective response to institutional racism and police terrorism!**

17 Manhattan, NY is 33.77mi<sup>2</sup> with 1.63 million people. So, 40 mi<sup>2</sup> is a good size for black areas.  
18 Manhattan is one of the world's leading commercial, financial, and cultural centers. Our new  
19 repatriated and sovereign cities will be similar, for our **Black Family Reunion and Cultural**  
20 **Restoration Process**, by being planned for and applying healing, repairing, recovering, and  
21 transforming services. **A priority** should be to reclaim our true homeland, culture, and heritage.

22 This AARS Plan emphasizes leaving corruption in integration, for peace and prosperity in  
23 repatriation and sovereignty. It includes youth programs to decrease foul language and activities  
24 for racial improvement, and adult programs to self-actualize, set goals, and teach good habits and  
25 values to their children. They should also do 5-year case studies on all companies, institutions, and  
26 systems in America, because blacks depend on these sources for socialization into life, and a  
27 democratic nation. **Everyone should endorse AARS for black reparations, and to conduct 5-**  
28 **year studies for positive changes in society, to benefit all blacks and everyone else in America.**

29 There are advantages with (1) sovereignty as an alternative to (2) integration, primarily with  
30 problems which stem from slavery, which have created deep divisions among blacks, which they  
31 must solve among themselves. Basically, they should work towards pride and unity, even if many  
32 of them do remain integrated, as they protest for change to attain peace and collective progress.  
33 Second, they remove themselves from harm and needless fatalities in integration, while they get  
34 the option to learn, and to use their abilities, networks, and skills to build their own elite safe cities.

35 Blacks should live in all (3) models or settings, because they walked and struggled with Whites  
36 and Jews to achieve equality in integration. However, their position also includes embracing (3)  
37 repatriation, because they are deprived of basic civil and human rights, because of the color of

1 their skin, therefore they are mistreated. So, they should protest for 5 years to demand justice, and  
2 work to mend and uplift their extended and global family relationships. They can build their close  
3 southern and distant diaspora relatives, elite safe cities on prime repatriated land. This is an AAIU  
4 based program for the AARS Congress to manage for the Black Family Reunion & Reconciliation.

5 African-Americans and others would appreciate it if athletes, educators, entertainers, and others  
6 who are concerned about justice and equality, would protest and sponsor AAIU Racism Dialogue  
7 for the next 5 years, because the facts show problems are very bad, and getting much worse in  
8 integration; so, blacks need alternatives, when it comes to a permanent residence. Our repatriated  
9 and sovereign city designs will comfortably accommodate 1 million blacks at a time at 40 areas.  
10 We will build more sovereign, repatriated, recovery, and Revival Black Christian and Pro Black  
11 Nationalist Cities, for 2 million blacks at a time, by building 2 cities at a time, by the grace of God.

12 **It takes \$650T to fund AARS**, so it may be best to use the SEEG source to generate wealth, for  
13 the next 50 years, for four terms. If we demand those guilty of enslaving, or exploiting blacks to  
14 donate trillions, or we file lawsuits against them, **as we should**, that could cause resistance. Blacks  
15 already have enough problems to solve, from African Invasions, high death tolls from stress related  
16 illnesses, unjust laws, (drugs, alcohol, and menthol), Tulsa and other Up-Town Attacks, and severe  
17 emotional trauma from police killings, and man-made viruses. After 500-2000 years of stifling  
18 mental anguish and social impositions, **most blacks** really do want and need help via reparations.

19 The AAIU database identifies 17 corporations who surely owe blacks reparations. We also hope  
20 and pray that the U.S. Government, the Roman Catholic Church, and the Bush's and Rothschild's  
21 will cooperate, because AAIU data has proof of them profiting from slavery, and/or exploiting  
22 blacks. {We ask this list of 21 guilty groups, then all others with wealth and compassion, like B of  
23 A, Citi Bank, GM, and Wells Fargo, who committed to economic development for underserved  
24 communities, to consider using the SEEG source to help generate wealth for black reparations}.

25 EXAMPLE: as clients they open a new 5B cash account, with no risk of losing funds, to generate  
26 wealth (100B up to 500B), in 1 year (pending program openings). Since they are invited to such a  
27 lucrative venture, we ask them to keep a huge profit of 25%, to graciously contribute 65% to the  
28 AARS Hedge Fund for our humanitarian cause to build safe cities, and to contemplate emotional  
29 therapy, and 10% for platform, attorneys, bankers, credit facilities, conglomerate businesses,  
30 agents, and fees; then repeat the program 4 times. Now note the profit splits are negotiable.

31 DETAILS: The government ratifies AARS as relief for all U.S blacks 18 and older, to get 100k on  
32 6-19-23, and all other blacks soon after; for engineers and unions to build two safe cities and train  
33 our adults 18-34, \$4000 a month, and ages 35-54 \$8000 a month, to build and maintain our cities;  
34 we ask the military to build a small strong base on our cities perimeters, and train our people to  
35 become the military police. Then, they may agree to leave some strong soldiers behind, **to patrol**  
36 **with our people they train, to keep our cities and residents safe**. It takes a move of this magnitude  
37 to stop the police and white supremacist from unjustly killing innocent and unarmed Black people!!

1 **The priority** should be to leave racism, unjust police killings, and multiple problems in integration,  
2 for freedom, justice, equality, and safety in repatriation and sovereignty via AARS reparations.  
3 Recall, the punishment should fit the crime; so, reparations should materialize to repair the last  
4 500-2000 years of encroaching, exacting, and excruciating abuse, damage, pain, and suffering.

5 Implementing these amenities in quality and quantity are manageable, requires four terms of 50  
6 years for blacks to build safe cities, heal, and they should **replace negative fixtures**, which have  
7 become normalized in their daily interaction, (like offensive foul language, intense vulgar music,  
8 and aggressive lewd behavior), which came from bad experiences with racism and oppression,  
9 **with their classical, identifiable, and noble names, languages, customs, and culture.**

10 Now those in power are using their groups to endorse or produce a black reparations plan. **That**  
11 **could create obstruction** like the H.R. 40 Hearings, the T & R Process in South Africa, and the  
12 trial run for reparations in Evanston Illinois. Everybody should monitor that activity to eliminate  
13 confusion, and corruption, and circulate this AARS Plan, to ask the government, those in power,  
14 various groups, and the entire public for their endorsement. **That is how blacks become proactive**  
15 **in claiming a reparations plan.** They should not wait for or expect others to produce a good plan.  
16 AARS makes it easy for culprits to contribute resources they owe, and the compassionate can also  
17 donate, so that victims get a fair and just AARS reparations settlement, that they need and deserve.

18 **{{A beautiful aspect of AARS reparations is that it can be a healing source for the races. It gives**  
19 **culprits, guilty groups, and perpetrators of the damage a way to apologize, and make amends for**  
20 **stolen wealth, and forced slave labor, and they could opt for a huge profit. The compassionate also**  
21 **get a chance to recognize our collective demise, and place SF to help our cause, to help us build**  
22 **safe cities, in order to live safe and heal emotions, as they could also opt for a huge profit. Victims**  
23 **can opt to undergo programs for therapy for healing, repairing, recovering, and transforming}}.**

24 Black people should want to and have a strong desire to transform, to create new images of  
25 themselves, reflecting the legacy of their great kings, queens, and citizens from Africa; to help  
26 reduce and eventually eliminate bad stereotypes; which causes bad treatment for blacks globally.

27 **{AARS list spirituality and land as key components Black people need in a plan, to facilitate and**  
28 **maintain productive programs for repairing damage, a better life, and prayer to stay the course.**  
29 **We suffer from losses in economics, social status, and properties; cultural assimilation; internal**  
30 **pain; prolific damage and injuries; and preventing group autonomy. AARS operates to find and**  
31 **create solutions, and the AARS Congress will create, identify and implement programs for action}.**

32 **{{The races get along good at musical, political, and sporting events, so reparations should**  
33 **unfold via peaceful promo campaigns, for the races and especially the police, to keep that same**  
34 **level of appreciation and respect for one another, in our daily lives}}.** When blacks get their own  
35 **land, others will give them respect, so that they can build safe cities, and develop programs for**  
36 **emotional therapy, since they are victims of many harmful & long-term eras of damage and trauma.**

1 {{Race relations have been very bad and are getting much worse. A brief parting will help the races  
2 learn to respect one another, like a divorce. People divorce then reconcile after forming a sincere  
3 mutual respect, to keep good relations that last forever. The AAIU presents the sovereign model  
4 of AARS, as an American social service through the AARS Congress, for racial reconciliation}}.

5 Everybody 18 and older should engage in the KRP, because we discuss advantages of sovereignty  
6 over integration, and we discuss great benefits for America, by making her descendants of slaves,  
7 happy and productive residents, instead of unhappy welfare recipients, who are still victims of  
8 racism, oppression, cruelty, and brutality. It also satisfies agitators who prefer segregation. They  
9 openly battled blacks being integrated for decades, yet blacks were still forced into hostile  
10 integration, under fierce opposition, harming both blacks and whites! This AARS strategy is good  
11 for many reasons, mainly in positioning to repair damage, to seek unity among blacks, and just as  
12 important to create ways for genuine and lasting racial harmony with all others at home and abroad.

13 **Brotha Pruitt's Experience:** In Carson our parents taught good family values and we had a strong  
14 support system. That background gave me visions to nurture of helping others. I developed good  
15 habits and a desire to read for long stretches in elementary school, upon engaging the Head Start  
16 Program. I went on to Jr. High and participated in campus activities related to communications. I  
17 enjoyed watching music, sports, and promotional campaigns bring people together, creating the  
18 most festive, fun, and memorable occasions. I grew 10" the summer before High School, so I  
19 learned fundamentals of basketball, and became a Legend at Verbum Dei High in Watts in 1979.

20  
21 I was a gifted 6'8" point guard, trained hard, and became an All American who won a scholarship  
22 to UCLA. I transferred to UAB because coach Larry Brown lied, and did not let me play the point.  
23 After I left UAB I found out coach Gene Bartow was in cahoots with Larry, so he deceived me on  
24 playing the point. Gene let me play the point for the whole year that I sat out. Then when I became  
25 eligible, he switched my position. I tried to appeal but they blackballed me after lying to me, and  
26 telling lies on me! That was cold blooded and it still hurts!! I was a victim of racism in sports by  
27 owners, associations, and coaches abusing their power, as were many athletes like Muhammad  
28 Ali, Curt Flood, Raymond Lewis, and Colin Kaepernick. We should **investigate racism in sports**  
29 to secure equal opportunities for many more blacks to own, manage, recruit for, and coach teams.

30  
31 I had to go overseas to play and retire in Switzerland. I came back to play briefly with Meadow  
32 Lark Lemon and Pistol Pete Maravich on the Shooting Stars. Then I returned to UCLA to get my  
33 degree in sociology. Then I became a group supervisor at a hard detention camp where they filmed  
34 the Gridiron Gang. Since then, I studied big business, became socially active, and aspired to be a  
35 civil rights leader. Now, I am a devoted asset manager, community activist, and problem solver.  
36 These experiences keep visions of helping others in my mind by sharing programs to help slowly  
37 dissolve racism and police terrorism, and posing programs to facilitate true racial reconciliation.

38 I am raising 460B to build two cities. One repatriated and one sovereign. Both will be **ELITE**  
39 **SAFE CITIES** for descendants of slaves, and survivors of disasters, and displacement. Those



1 victims are in great need of help and they need a curriculum, to prepare themselves to compete in  
2 high tech job markets, and other fields projected as being in great demand for future employment.  
3 We also host programs to elevate civil, social, and moral values. **{{The AARS intent is to get  
4 justice and satisfaction for all blacks, to create a path for everyone in America to cope and feel  
5 safe, and to promote positive police and race relations nationally and globally}}**.  
6

7 All places of worship, spiritual leaders and entities, and all concerned citizens should partake in  
8 implementing programs, to raise all expectations and standards for all youth in America, **to  
9 become race sensitive people**. This AAIU program which will be implemented by the AARS  
10 Congress, is key to changing our socialization patterns with all youth in America, on race relations,  
11 from hostile and secluded, to amenable and sociable. Racism is a learned attitude and behavior,  
12 so, if adults teach children to be race sensitive by respecting other races, instead of race haters to  
13 hate other races, all youth will grow up to be friendly to other races. Our youth should become  
14 respectable, tax paying, peaceful members in society, instead of violent gun toting war mongers.  
15

16 We need \$20B for **SSUT Projects** to help protect our nation and our cities; \$10B for an **Oil  
17 Company** (to build small refineries, and later a major plant); and build a **Plastic and Aluminum  
18 Recycling Plant**, all three to create thousands of jobs in processing, assembling, warehousing, and  
19 transportation); \$10B **to buy a Pro Baseball, Basketball, and Football Team, and build an  
20 Exquisite LA Ram like Stadium** for big events, concerts, games, voting, and more jobs; \$7B for  
21 **Agriculture and Energy**; \$6B for **Aero/Med/Tech University**; \$4.2B for **Clothes and  
22 Toiletries**; \$4B for **Hospital/Recovery Center** in our serene area; \$3.5B for **City Workers,  
23 Maintenance, Waste Management, and Water Treatment**; \$3B for **Research and  
24 Development to Improve Family and Social Skills**; \$2.5B for **Parks & Rec**; \$2B for  
25 **Entertainment Productions**; \$1.4B for **High Rise Business Plaza**; \$1B for **WS Blazer Child  
26 Living, Training, and Mentor Facilities**; \$300M for **Gold Project**; and \$100M **Education Plan**.  
27 **Subtotal 225B**  
28

29 I am in direct contact with all principles for all projects named above, and they expect me to get  
30 funding. I am in possession of and have discussed their business plans extensively. They plan to  
31 adhere to environmentally sustainable standards, to limit bad air omissions and poor product  
32 productions. Projects named above are humanitarian in nature via raising funds to create jobs,  
33 expand tax bases for our local and national social services, upgrade K-12 education curriculum in  
34 California, then expand nationally, and implement programs to improve police and race relations.  
35

39 We are complying with national and international guidelines, and are embracing social progress  
40 for those in great need, after enduring extreme and lengthy devastation; like apartheid, slavery,



1 segregation, and natural disasters. We focus on infrastructure, and revival work; building new  
2 cities, keeping hope alive, and uplifting human hearts, minds, bodies, and souls. So, please keep  
3 George Floyd in mind, new cases of terrorism, and similar cases like Rodney King's, and Breonna  
4 Taylor's. Then know blacks need a 70% yes Plebiscite Vote (PV) near the end of '23 at designated  
5 Black Churches, to claim an injured and indigenous status, AARS, and 1 of the 3 reparations  
6 models for residence. We will provide a list of churches as an addendum to this AARS plan, ASAP.  
7

8 This AARS plan includes introducing a class on concealed Black History, (on how racism became  
9 institutionalized, slavery's dominating legacy in the mentalities of Blacks, Whites, and Jews), and  
10 posing AARS reparations as the solution. This will give African-Americans a wide range of  
11 information on these topics, which will prepare them for their internal PV. Blacks should learn that  
12 repatriation is going back to Africa, down south, or any other place where blacks were enslaved or  
13 exploited; with a good understanding of the customs of the places where they choose to go, along  
14 with the promise to improve relations within their Global Black Family, and with ample resources  
15 to build elite safe cities. Blacks should also learn that sovereignty is their salvation in America.  
16 The government grants them their own land, they form their own government, and develop a new  
17 mentality to own, operate, and control all affairs, businesses, institutions and systems on their land.  
18

19 Blacks should have their PV to determine how many of them prefer to remain living in integration,  
20 how many prefer to repatriate, and how many prefer sovereignty. That will show they do have  
21 alternatives to living in integration. Then we will know how many sovereign and repatriated cities,  
22 we need to build for descendants of slaves. {{We also need U.S. Presidential and Congressional  
23 action on U.S. racism, police terrorism, and dangerous, elusive, and mounting systematic and  
24 institutionalized corruption! The AARS Congress will lead them in these 5-year case studies}}.  
25

26 It would help if everyone or most people in America, would study this AARS plan, and take the  
27 class starting on 10-4-22, to study racism, to learn how we can overcome that deadly disease  
28 collectively, as a majority of calm and united people in America. Then give your support in a brief  
29 note stating approval of this AARS plan, and everybody can submit their brief ideas on how to  
30 help repair the Black Family, near the end of 2023; on the bottom of section 10 on the website.  
31

32 The AARS plan like the website will help to educate America on Black History, Racism, and  
33 Reparations, to prepare blacks for their internal PV, and to prepare others to offer their ideas to  
34 help repair the Black Family, during our month to vote in 2023. The PV is a part of the AAIU's  
35 Black History Month - Juneteenth - Kwanzaa Reparations Project (KRP) for '22, which is now the  
36 KRP to help repair, transform, (and go on a mission to secure safety, pride, and unity for all blacks  
37 with AARS). We should rebuild our dear beloved Black Family at home and abroad. Then, we can  
38 also seriously consider working towards true racial harmony with all other peoples in America,  
39 and around the world. Trust in One God, One World, One Family, and One Love.



# AARS Part II

## The African-American Reparations/ Sovereignty (AARS) Business Plan

**AARS is Fairness Justice & Satisfaction for all Black People  
and Racial Reconciliation with all Nations & Races**

America's debt to Black people is to acknowledge they were severely damaged by slavery, lynching, and segregation, and that racism and harassment persist today, so they need a good comprehensive reparations plan, and ample funds to build safe cities, and repair vast damage. The lingering effects of a supremacist mentality in others harms them in all institutions, all areas of life, and mainly with the police. That is systemic racism which has hurt blacks for generations, so they need immediate relief, and a long-term strategy for protection and growth, like AARS.

This AARS plan reveals a way to stop the police and supremacist from killing innocent and unarmed blacks. It reveals a way to generate \$62 Trillion for collective and individual compensation, plus \$5 Trillion for disasters, emergencies and unexpected cost to build elite safe cities, that display the beauty and splendor of noble African cultures, and honors their great Freedom Fighters of the past like Mandela, Fannie Lou Hamer, Callie House, and A. Phillip Randolph. It leads to creating programs for any deficiencies, faults, or vices, like depression, foul language, inebriation, or Post Traumatic Slave Syndrome (PTSS); along with services for blacks who don't have these problems and are stable, to remain stable and to set goals.

We will also conduct 5-year AARS Congressional case studies to improve interaction with and performance of companies, systems, and institutions which African-Americans depend on for learning, working, and survival throughout our nation in integration. It reveals a way to expose hidden and mental barriers creating and sustaining divisions among blacks, so they can overcome those impositions to truly become a united people in America, Africa, and globally. And it also reveals a way to initiate genuine and lasting racial reconciliation with all other nations and races at home and abroad. We can initiate all these programs and services by utilizing the AAIU Truth and Reconciliation Process (T&R Process).

There may be 75-100 groups organized and/or pushing for African-American Reparations. We hope and pray we can bring them all together as leaders with this AARS plan, to provide leadership we need to carry out the working parts of AARS, through the AARS Congress. And all AARS Congress members will be offered a very generous contract for lifetime services.

1 AARS seats are populated after retirement. The AARS Congress will consist of reparations  
2 activists, politicians, and people with a track record of helping blacks. We do have many groups  
3 hosting many programs to help the Black Family. We hope to merge all their efforts with AARS.

4 This is the first step in moving towards reuniting and planning on having a brighter future of  
5 peace and prosperity in repatriated and sovereign cities, for collective peace and progress. It is  
6 important to have a military presence at our cities because history proves through places like  
7 Greenwood, Rosewood, and Atlanta in 1906, that there may be some racial resistance, that may  
8 grow without a military presence. A military presence will quickly dissolve the resistance, so  
9 blacks can live in a civil society in America. Many people have said for many years that blacks  
10 have the resources to build their own repatriated and sovereign cities to provide, protect, and  
11 look out for the best interest of their people, nationally and globally. Now is the perfect time to  
12 put AARS in motion for these reasons. If other reparations plans do not include these amenities,  
13 concessions, processes, programs, and services; everybody should endorse this AARS plan.

#### 14 **The Company**

15 The AAIU is a 40-year-old research and intelligence group, composed of scholars and activists  
16 of different races, looking out for the best interest of Black people, who are victims of historical  
17 oppression, and crimes against humanity! They are a spiritual and political group. The SEEG is  
18 a special group of athletes, educators, entertainers, rich people, and spiritual leaders. We asked  
19 them to consider forming a special advisory board for leadership and guidance, to raise the level  
20 of consciousness and spirituality in America, by asking everyone to study some form of religion,  
21 to talk to and to treat each other with respect, and to reduce then eventually refrain from using  
22 foul language in public, mass communications, and in recordings. They can provide charitable,  
23 for-profit, or refundable seed funding. They are a spiritual, political, and business group.

#### 24 **The Ownership**

25 The company is structured as a sole proprietorship, but there are many allies to help form the  
26 AARS Congress. They will work to produce viable solutions for lingering problems. They will  
27 also produce solutions during honest AAIU Racism Dialogue. We should inform culprits of  
28 racism, invasions, colonialism, slavery; and vile reconstruction, segregation, and integration;  
29 with reflections in their system to maintain control; that they are liable for massive damage.  
30 Consequently, only reparations can repair the colossal damage from those epic assaults, which  
31 bestowed inequality inciting national protest, which ignited the Civil Rights Movement (CRM).

#### 32 **The Management**

33 The company is structured like a school so we can educate America on Black History, to show  
34 their valuable contributions, creations, and inventions. Then we focus on (withheld slave wages  
35 and crop profits), and patriotic sacrifices, to show how much they contributed to making America  
36 the powerhouse she is today. In this process we also have to show how badly racism and slavery's  
37 legacy has harmed them, and still causes problems, in order to reveal AARS as the solution.

## The Goals and Objectives

The goal is to repair damage from deadly European invasions and colonialism in Africa, and throughout the Diaspora, and lethal U.S. racism, slavery, lynching, reconstruction, segregation, and integration. This should be done on a collective basis through the three models of reparations, and an individual monetary settlement.

**THE COMPUTATION FOR THE REPARATIONS DEBT IS ON PART IV - AS THE AARS REVISED PLAN FROM ERJ TO Demanding Full Redress (DFR) - THE DEBT IS SO HIGH AND THE EQUATION IS SO LONG - UNTIL WE LEFT SOME INFO OUT WHICH WE TOOK FOR GRANTED THAT EVERYONE KNEW - (NOW WE ARE GOING TO ADD SOME INFO FOR CLARITY - AND FOR THOSE WHO OPPOSE REPARATIONS) - IN A COMPROMISE WE PRESENT THE COMPUTATION WITH MORE EFFICIENT AND EXPLANATORY TERMINOLOGIES FOR CLARITY - AND TO HELP OPPOSERS UNDERSTAND THE NEED TO REPAIR MASSIVE DAMAGE.**

## The AARS Product

The primary function of the company is five-fold. (1) for Spiritual Guidance, (2) for Emergency Cash Relief, (3) Land to Build Safe Cities, (4) for Healing, Recovering, and Transforming services, and most importantly (5) to Improve Police and Race Relations. AARS is mainly for blacks who are less fortunate, gang related, poorly educated, mentally ill, declining physically, coming out of jail, having visions of •Africans jumping and being thrown overboard of slave ships! • or huge intoxicated crowds gathered to cheer, as they watch a violent lynching! This *social* and *psychological oppression* stems from deeply rooted racism, so Black people need Global Unity, White and Jewish Truth and Reconciliation, and Calm Emotional Therapy.

## The Target Market

The target market is Blacks in America, Africa, and every other place where they were enslaved or exploited. Many people want to blame Black people for the poor condition they are in, but the fact of the matter is many people, and many groups are responsible for in-depth and long-lasting damage. (1) Some offered apologies, which should come with a monetary settlement, while (2) others with compassion committed to economic development. Both should come in the form of seed funds (\$5B), for the SEEG source to generate wealth for reparations immediately. We will illustrate a path including photos of slavery, lynching, beatings, corporations which owe restitution, the enormous adverse effects of the Willie Lynch Letter, Presidents Bush Sr. and Jr., the Rothchild's, and the Pope, to validate **the reparations debt.**

4 **The Faces and Facts of Slavery**

5 **Fountain Hughes, Age 101**  
6 **Circa 1952 Former Slave,**

**Sara Grudger, Age Unknown**  
**Burke County, NC**

7 George Washington owned slaves and he was not the only U.S. President who did, in  
8 contradiction to the freedoms for which the colonists fought to defend. There were even some of  
9 the former presidents who owned slaves, and had babies with our black women, so how could  
10 they treat our people so badly! “My grandfather belonged to Thomas Jefferson.” **Fountain**  
11 **Hughes** told an interviewer in 1949. He was 101 years old. “Wasn’t no schools. When they  
12 started the little school, people that were slaves couldn’t many of them go to school ‘cept they  
13 had a father and a mother. My father was dead. {{My mother was living and she had three or  
14 four other little children. She had to put them all to work to help take care of the others. We  
15 didn’t have no property. We didn’t have no home being slaves all of our lives. My father was a  
16 slave, my mother was a slave, my brother was a slave, and my sisters were slaves. A dire life}}.

17 In their own words, black men and women remember slavery. They put a face on an institution  
18 that is often objectified and dismissed as ancient history, but only by racist and those who  
19 benefitted from abusing, enslaving, and exploiting Black people. They do have a responsibility  
20 to repair the damage they inflicted, so they avoid facing the crimes and violations, because of  
21 the abstract guilt, and the debt is way up in the hundreds of trillions. That is why AARS is so  
22 valuable. It relieves the culprits of their major debt, and provides the victims emergency relief.

23 “These Black Americans make the connection between the past, present, and the future in  
24 “Remembering Slavery”: “African-Americans Talk about Their Personal Experiences of Slavery  
25 and Emancipation.” An audiotape set with a companion book is now available in bookstores. This  
26 is not Black History. This is U.S. History. The Emancipation Proclamation **supposedly** freed  
27 enslaved black men, women, and children only 160 years ago, in January of 1863, but they did not  
28 get the news in Texas until two years later on June 19<sup>th</sup> in 1865. That is why we celebrate  
29 Juneteenth on June 19<sup>th</sup> all across America.

1 {{In the 1930s and 40s workers from the Federal Writers' Project interviewed thousands of former  
2 slaves, and preserved their recollections of bondage and misery; the Civil War, and, finally hopeful  
3 yet elusive freedom via emancipation}}. {{These elderly men and women, some centenarians,  
4 recall childhoods on the plantations, of the brutality, and devastation of the old slave masters;  
5 unbearable conditions working in fields, feeding stock, hunting food, then cooking and preparing  
6 meals they couldn't eat; the unwarranted whippings, and other punishments, family members sold  
7 away without even a goodbye, without any remorse, never to be seen again, and leaving with  
8 absolutely nothing. Some even remember Yankees in blue uniforms and "the Colored Troops"}}.

9 This dramatic documentation is newly accessible in remastered audio recordings and transcripts  
10 from the Works Progress Administration Arts Project. The recording was used in a recently  
11 broadcasted public radio documentary for Smithsonian Productions, giving intimacy to a history  
12 that many right-wing disgruntled Americans would rather forget. {{Our country's history of  
13 slavery is available for those willing to look, listen, and learn; on the movie screen in Oprah  
14 Winfrey's "Beloved", and in Alex Haley's Roots on CD. In the just completed PBS four-part  
15 documentary Africans in America: "America's Journey Through Slavery." A companion book  
16 to the PBS series, traces the saga through the eyes of slaves and enslavers, from the first arrival  
17 of Africans in 1517 in large intentionally separated groups, chained like animals, on awful  
18 smelling multi-level cargo slave ships, to be stripped butt naked and sold off of auction blocks}}.

19 Why remember slavery? It happened so long ago. No living American was either a slave or  
20 slave owner, yet it will never be forgotten and never should be! The remnants of slavery affect  
21 Black people to the point to where they are suffering from debilitating mental disorders without  
22 a clue. That is why some of them say and do things that are self-destructing. If you don't believe  
23 me, ask Arsenio Hall, Kanye West, and Kyrie Irving. They suffer from Temporary Insanity and  
24 Post Traumatic Slave Syndrome (PTSS). They will never forget the lessons learned, so all blacks  
25 should refrain from interviewing controversial figures, and making regrettable remarks forever.

26 The slavery era is a bitter period of our history, which holds answers and insights to an on-going  
27 dilemma: America's unfinished business on African-American race relations, which requires  
28 Black Reparations to facilitate justice and satisfaction for black folks, and positive race relations.

29 Slavery was an institution that took about a hundred years to plot. It lasted for thousands of years,  
30 centuries, and generations; and it caused immense emotional and psychological trauma. Those  
31 who are guilty of abusing and enslaving Black people are the culprits and perpetrators of activity  
32 that caused the destruction of Africa, and the demise of Black people. So, they should feel  
33 obligated to repair those epochs, eras, and regional zones of damage. Just as Black people should  
34 feel like they are obligated to demand AARS, to commemorate their ancestors, and forefathers,  
35 and get emergency monetary relief, land to build safe cities, and programs to repair vast damage.

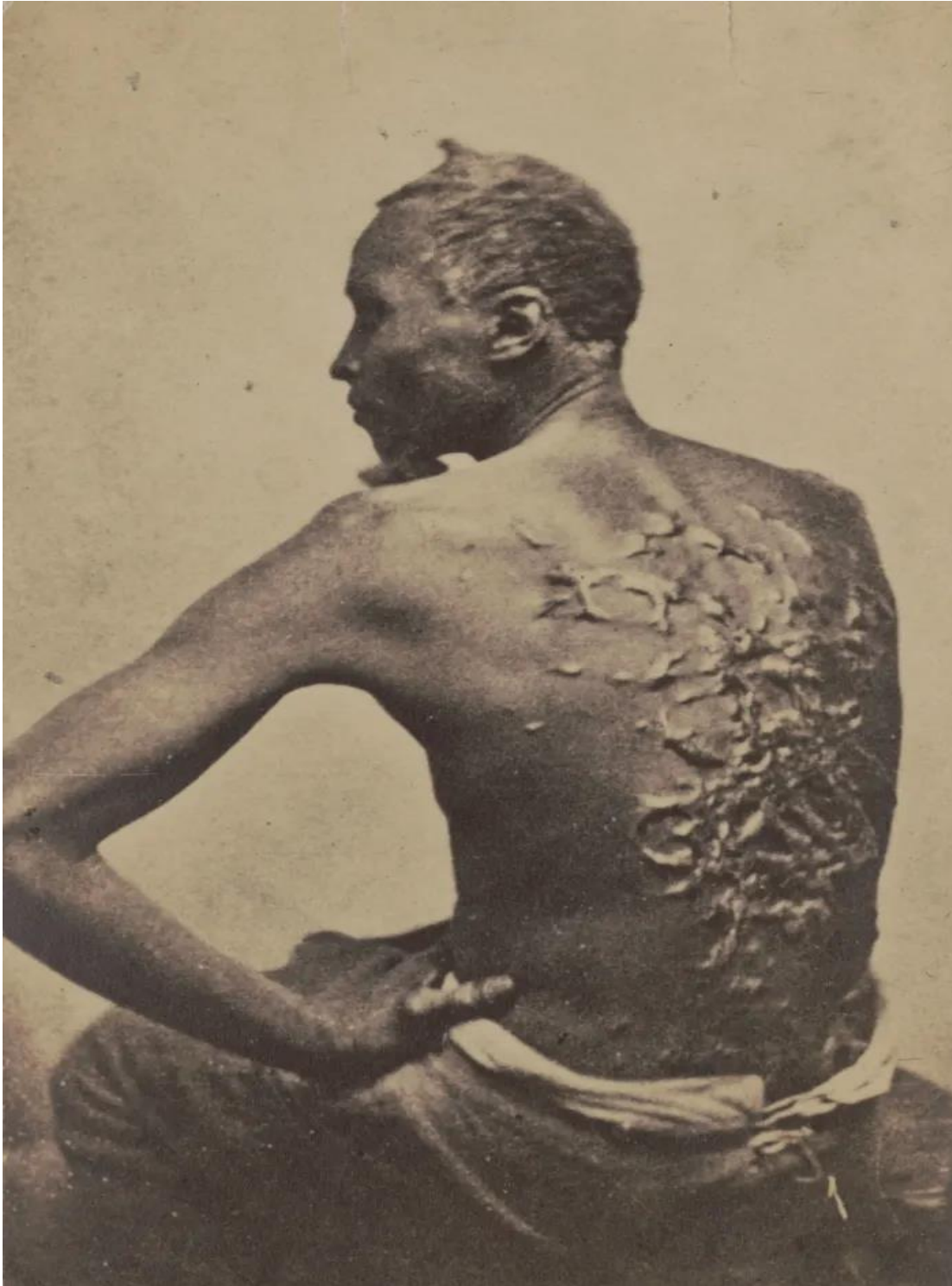

10 **SPEECH BY WILLIE LYNCH IN 1712**

11 This Speech was Delivered by the Infamous British Slave Owner Willie Lynch on the Bank of  
12 the James River in the Colony of Virginia in 1712.

13 Lynch was a Slave Owner as Others were engaged in the Trans-Atlantic, and Slavery in America  
14

15 Gentlemen:

16 I greet you here on the bank of the James River in the year of our lord one thousand seven  
17 hundred and twelve. First, I shall thank you, the gentlemen of the colony of Virginia for bringing  
18 me here. I am here to help you solve some of your problems with your slaves. Your invitation  
19 reached me on my modest plantation in the West Indies, where I have experimented with some  
20 of the newest and still the oldest methods for the control of the slaves' mentality. Ancient Rome  
21 would envy us if my programs were implemented back when they ruled. As our boat sailed south  
22 on the James River, named after our illustrious King, whose version of the bible we cherish, that  
23 they did modify to benefit Whites. **\*\*Therefore, as a Christian, I say all Blacks should Study**  
24 **Black Theology, to Learn how to Use the Bible for Liberation and Independence Purposes.**  
25

26 While Rome used chords of wood crosses for standing human bodies along its old highways in  
27 great numbers, you are here using the tree, and the rope on too many occasions. I caught the  
28 whiff of a dead slave hanging from a tree a couple of miles back, (Lynched in 1712). You are  
29 not only losing valuable stock by hangings, you are having uprisings, slaves are running away,  
30 your crops are sometimes left in the fields too long for maximum profit, you suffer occasional  
31 fires, and your animals are killed too often. So, gentlemen you know what your problems are; I  
32 do not need to elaborate, and I am not here to enumerate your problems. I am here to introduce  
33 you to a method of solving your problem's.  
34

35 In my bag here, I have a foolproof method for controlling the slaves' mentality. I guarantee each  
36 of you, that if instilled correctly; it will control your black slaves for at least 300 years. My

1 method is simple and any member of your family, or any slave master, or any slave overseer  
2 **should apply constantly and rigorously.**

3  
4 **{I have outlined a number of differences among the slaves, and I take those differences and**  
5 **make them bigger}**. I use fear, distrust, and envy for control purposes. These methods have  
6 worked on my modest plantation in the West Indies for decades, and it will work throughout the  
7 South for centuries. **That is why African-Americans deserve repatriated land in the south.**  
8 Take this little list of differences, and think about them. On the top of the list is “Age”, but it is  
9 there only because it starts with the letter “A”, the second is “Color” or “Shade”, there is  
10 intelligence, size, sexual abuse of men, women, and children, size of plantation, status on  
11 plantation, displaying a dominant attitude as slave masters, whether the slaves live in the valley,  
12 on a hill, East, West, North, or South, have fine or coarse hair, or are tall or short. **{Now that you**  
13 **have a list of differences, expand them as an outline of action}**, but before that I shall assure you,  
14 **distrust is stronger than trust, and envy is stronger than adulation, respect, or admiration.**

15  
16 **The Black Slave after receiving this indoctrination shall carry on and will become self-**  
17 **refueling, and encumber a propensity for self-declining and self-destruction for hundreds of**  
18 **years.** Don't forget, you must pitch the old black vs. the young black. You must use the dark  
19 skin slaves against the light skin slaves. You must use females against the males. **You must also**  
20 **have all your white servants, overseers, and masters distrust all blacks. But it is necessary**  
21 **that your slaves trust and depend only on us. They must love, respect, and trust only us.**

22  
23 Gentlemen, these kits are your keys to control, use them, have your wives and children use them,  
24 never miss an opportunity. **My plan is guaranteed, and the good thing about this plan is that**  
25 **if used intensely for one year, the slaves themselves will remain perpetually distrustful.**  
26 **{There is a lot of work to do to dissolve the slave mentality, in Blacks, Whites, and Jews,**  
27 **which is part of the repair process for black reparations}.**

### 28 29 **The Bush's and the Rothschild's**

30  
31 It is good for the government to consider providing reparations for Black people. They're way  
32 past long overdue and greatly needed. The key for blacks to win and control their reparations is  
33 organizing most blacks in America to engage the AARS plan, to carry out national boycotting  
34 against entities who enslaved or exploited blacks, and selective buying from companies who are  
35 fair to blacks. That will force America to talk to blacks about inequality, and reparations focusing  
36 on sovereignty. This will reduce and eventually eliminate police terrorism, discrimination, and  
37 institutional racism. We will conduct similar activities in all businesses, entities, and sectors of  
38 society, primarily with action going towards the three branches of government, and the police.

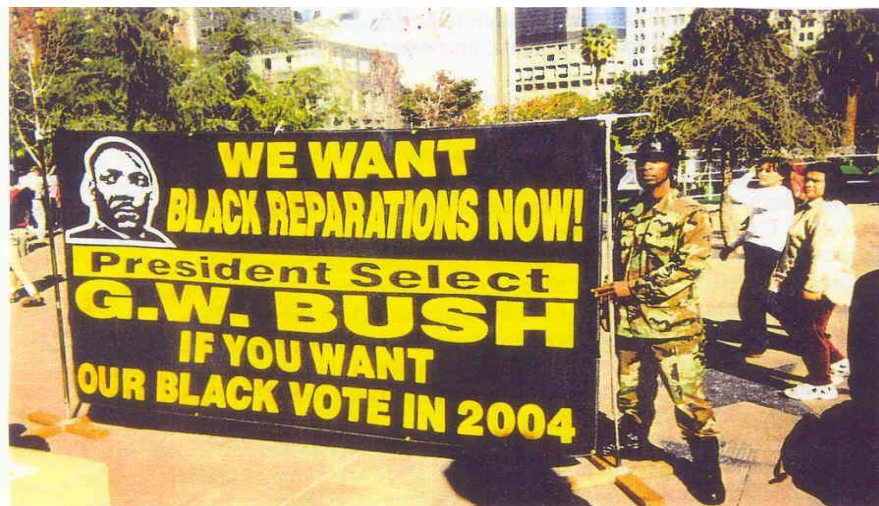
39  
40 Bush Sr. had a large hand in drugs coming into inner-cities in America, by abusing his power as  
41 president. The documented evidence of blacks losing lives, properties, monies, and their minds is  
42 unbelievable! That caused a void in an entire generation of personal growth, family possessions,  
43 and responsibilities. Bush Jr. also used unethical tactics to steal both elections, and acquired more



1 wealth in the oil business, by abusing his power as president, while we paid unbelievably high gas  
2 prices all across the country! The pain and suffering this caused to African-Americans and Black  
3 Communities all across America will never be forgotten!!  
4

5 And it is public knowledge that the Rothschild's had a large hand in the Slave Trade for hundreds  
6 of years!!! So, the Bush's, Rothchild's and all the other peoples and groups who are guilty of  
7 enslaving and/or exploiting blacks, would show a sign of goodwill, if they would accept their duty  
8 to repair the victims of the previous transgressions, by Rothchild's settling for \$1T, and Bush \$1B.  
9

10 With all the damage, the masses should work beside the AAIU and the AARS Congress to have  
11 effective national boycotting programs, and rewarding national selective buying programs. We  
12 have the **collective power** to enrich companies that treat blacks fair, while simultaneously hurting  
13 companies who have benefitted from slavery, and refuse to treat blacks fair, with **national action**.  
14 But we need direction from the AARS Congress, to unite the Black Family in America, to conduct  
15 effective national boycotts and buying programs, because of poor conditions and broken promises.  
16



1 **Pricing Strategy**

2 The pricing approach is to use the companies which the SEEG identified, to generate wealth, hire  
3 the Army Corps of Engineers, and Black and Certified Unions to build elite safe cities. They also  
4 teach our youth to build and maintain elite cities. We ask the military to build small strong bases  
5 at our cities, train our youth to become the military police for our cities, and leave some strong  
6 soldiers behind to patrol with our people they train to protect our cities and our indigenous citizens.  
7 Then we hire experienced professionals to provide job training and financial services, and  
8 individual clinical, emotional, rehabilitative, social, and therapeutical diagnostics and treatments.

9 **The Competitors**

10 There are no competitors. We are simply using this AARS plan as the base plan to unite most  
11 reparations activists and groups, to provide leadership to implement the moving parts we  
12 developed for AARS. We will also create more programs through the AARS Congress, to help  
13 repair, transform, rebuild, and protect blacks for racial stability and uplifting.

14 **The Company - Business Sector**

15 The owner and partners would like to start businesses in the following vocations;  
16 Spirituality Economics Education and Infrastructure:  
17 It is important to note reparations means three fundamental points to repair the Black Family. (1)  
18 To ask all blacks to make and keep God first in their lives. (2) To ask all non-blacks to stop hurting,  
19 and to start treating all blacks fair and just. Then, (3) to ask most blacks to prepare for sovereignty  
20 by learning they are indigenous to this land, and they deserve sovereign land, along with the rights  
21 and privileges of indigenous people. They should start by forming their own government, and  
22 writing their own laws. Emphasizing working towards top mental and physical health starting on  
23 3-1-23, so they hope AARS is ratified by 6-15-23, and are prepared to receive their reparations by  
24 6-19-23. If not, they should lift calls and demands in all venues until AARS is ratified! Then they  
25 will use AARS programs and services most effectively, and spend and save their money wisely.

26 **Company History**

27 The AAIU has held conferences and meetings at various venues including Mt. Tabor Baptist  
28 Church, and the Afiba Center in LA, at Mt. Saini Baptist Church in North Carolina, and at UCLA  
29 in Westwood. Now you can schedule a time with Brotha Pruitt to do a 1–2-hour radio or internet  
30 program to discuss details of AARS, and to endorse and promote AARS until it is ratified. We  
31 always welcome people of all races, and insist that they share info to identify problems created by  
32 racism, along with practical sustainable solutions.

33 **Ownership Background - Brotha Pruitt (owner):**  
34 As a retired pro basketball player, black historian, social scientist, and navy supporter, I have a  
35 wide range of knowledge to produce programs to heal and repair blacks, and to improve all police



1 and race relations. Dissolving racism and improving police and race relations is the change that  
2 will make America a much better place. We look to implement AARS to move in that direction.

3 Company Management Structure  
4 The Company is structured so that we get people from all races and professions, pushing for  
5 reparations to work beside them to help form the AARS Congress, to direct reparations programs,  
6 conduct national boycotts against racist companies, and use selective buying to enrich companies  
7 whom show compassion to African-Americans, and whom respect and treat all Black people fair.

8 Organizational Timeline  
9 The AARS Plan will unfold in 5-year, 50-year, and 200-year programs and services. The amount  
10 of time it will take to build elite safe repatriated and sovereign cities, and provide healing and  
11 recovery services, to vent and transform their slave mentality. Blacks should prepare for  
12 reparations now by self-assessment for self-actualization, to get in top mental and physical shape,  
13 to become the best person possible in preparation to receive reparations, and to gain self-esteem,  
14 and unconditional love and unity for and among all blacks, minus the sambos and sell outs!

15 Company Assets  
16 The company assets are irrelevant because we identified a funding source to generate wealth. The  
17 source needs seed funding from people who can pass a background and entrance process,  
18 including filling out a long 20-30 form for compliance, after opening a new \$100M, \$500M, \$1B,  
19 \$2B, or (\$5B) cash account at a major bank. We are asking a prominent law firm, and financial  
20 wizard Warren Buffet, to be a part of diligence. We may let them appoint two of three signatories  
21 required on the AARS Hedge Fund, to prevent any attempts in illegalities, unethical practices, or  
22 mismanaging funds. The 3<sup>rd</sup> person is also a person everyone can trust. The SEEG can have funds  
23 ready by the end of the year, from the first of four 50-year terms, and many clients to generate the  
24 \$650 Trillion, to fund AARS. The Equity Restorative Justice (ERJ) settlement was at \$67T. New  
25 facts forced us to revise from ERJ to Demanding Full Redress (DFR), of \$650T, which includes  
26 a personal emergency relief payment of \$100k for all blacks 18 and older, in the U.S. on 6-19-23,  
27 if AARS is ratified by 6-15-23. All blacks will receive the payments up to \$2M. We also give  
28 \$2M to all Black Families abroad. Remember if AARS is not ratified by 6-15-23 we lift demands!

29 Product Patents  
30 The company owns the rights to the AARS Global Black Reparations Plan. The AARS KRP  
31 Letter, the AARS Outline, the AARS PowerPoint Presentation, the AARS Memo and Bullet  
32 Points, the AARS Major Parts I, II, III, and IV, and there is an endorsement form for everyone  
33 over 18, and a refusal form for U.S. Blacks 18 and over at the end of the plan.

34 Future Products

1 The programs and services we provide will be unlimited. We have many programs now to help  
2 repair the damage inflicted over the last 500 years in America, and for the last 2000 years globally.  
3 However, it is going to take many more programs to repair all the emotional, family, financial,  
4 and social problems, which we identified. We provide many and various programs, to repair  
5 blacks back to their spiritual, peaceful, safe, and productive status they were in, prior to slavery.

### 6 Marketing Plan

#### 7 Established Customers

8 The customers of our company are easily noticed by the beautiful complexions and tones, of their  
9 **light to dark** colors of their skin. We are pressing for blacks to get reparations and to learn to  
10 produce all products required, needed, and desired for good living in two reparations models,  
11 repatriation and sovereignty; instead of spending it foolishly, or with others. The money should  
12 stay in the Black Family. Blacks should build infrastructures and cities; produce food; design  
13 homes, cars, and clothes; provide light, water and power; and produce appliances (like TVs),  
14 electrical devices (like motors), and electronic devices (like computers). They should get  
15 reparations and become producers of all products to keep the money in their family. Just as  
16 important; we are pressing for blacks to do like Malcolm X said, “Some Serious House Cleaning”.

#### 17 Budget

18 The financial strategy of the company is to utilize the SEEG funding source to raise the \$650  
19 Trillion, and for the AAIU to recruit professionals from all races and professions, to create the  
20 AARS Congress, (the Budget & Program Managers), who will identify problems with 5-year case  
21 studies on all companies, systems, and institutions affecting blacks in America. This should be in  
22 operations to create and identify sound and viable solutions including mental wellness programs.

#### 23 Advertising

24 Many people have debated reparations for blacks in America many times since slavery. The fact  
25 of that matter is blacks never should have been forcefully taken from Africa for slavery, financial,  
26 and deviant reasons, which in the process destroyed their country, culture, race status, and  
27 emotional stability. So, blacks should have received reparations right after slavery. However,  
28 more problems always arise during the debates because the debt is so high, and they lack proper  
29 guidance. The talks usually end prematurely, are intentionally misled, or have people hosting the  
30 debates, who are not knowledgeable of **reparations**, as it relates to generations of **Black Suffrage**,  
31 and they want to diminish the range and depths of damage blacks endured. So, they are not  
32 qualified, and they minimize the harm and trauma of unjustified killings, to the souls of black  
33 folks. They neglect bad social conditions of victims of racism, who have been crying out for help  
34 since emancipation, and who are descendants of slaves. {{Thus, African-Americans need  
35 reparations now to repair generations of damage, and to build trust to improve police and race  
36 relations}}. The advertising consists of endorsing and promoting the KRP doc, and the AARS  
37 summary and plan docs, which are the last 3 docs on the AAIUs website, on their homepage at

1 <https://aaiuendracism.org> along with ad campaigns, broadcasting, emails, local and major  
2 newspapers, pod casts, social media outlets, and zoom calls.

### 3 AARS Congress Analysis - Staffing and Operations

4 The AARS Congress will consist of 200 activists and professionals from reparations groups, and  
5 from all races and professions, and of scholars with a track record of helping Black people. We  
6 invite people from certain entities, institutions, and systems, like housing, education, employment,  
7 and health care, which we know need improvement, to join the AARS Congress. We should create  
8 this group because there are no credentials, rules, or regulations for a reparation's business or  
9 company. **We need those with knowledge of reparations, those who are protesting injustice,  
10 and those who are working in groups to endorse or produce a reparations plan, to stop and  
11 consider helping us to form, and joining the AARS Congress, to implement the AARS Plan.**

12 The AARS Congress will facilitate reparations by creating and offering 5-year programs based on  
13 findings from 5-year case studies, on entities listed above, and the following list of areas to  
14 examine. We also realize there will be a great need for many more programs after providing those  
15 for the same ideals and rights, which we fought for, but failed to gain back in the Civil Rights  
16 Movement. Then we produce programs in the areas of spiritual growth, conflict resolution,  
17 cultural recovery, and social and economic parity, which are reparative measures. We will create  
18 and implement action programs to strive for black pride and unity, an end to black-on-black crime,  
19 and to work towards racial harmony with all others.

20 Racism is still without question the most dominant and powerful social force in America, and the  
21 world. It determines where we are born, how we are raised, how we are treated, where we worship,  
22 where we go to school, where we work, where we play, and where we are buried. This  
23 overwhelming negative social phenomenon called racism, has caused damage for periods of 500-  
24 2000 years, and will not change without 5-year case studies on all the companies, institutions,  
25 systems, and entities, which provide the programs and services, which blacks need to grow up  
26 healthy, proficiently, and safe in integration. That will come automatically and naturally in  
27 repatriated and sovereign cities.

28 I will have top black and white law enforcement officials and politicians on the AARS Congress.  
29 They will direct programs to optimize to stop rampant police killings, and to improve police and  
30 race relations. We will also have a person or group in the AARS Congress representing the best  
31 interest of Africans abroad, to get their agreements from native leaders throughout the Diaspora,  
32 to inform us of their customs, so we arrive without disrespecting them, and having a sense of  
33 belonging. **{{This will boost the will in the Black Family for national and global unity}}**. I will  
34 have some Pastors on the AARS Congress to provide guidance for spiritual awakening, healing,  
35 and rites of passage, via renewal and maintenance programs. In AARS we provide repair and  
36 restore programs; emergency relief; and we improve integration, expand repatriation, and create

1 sovereignty. We also provide social programs to improve police and race relations; which will  
2 work to repair damage, and delegate peace and collective progress for descendants of slaves.

13  
14  
15  
16 It is critical for all blacks to know the government is considering providing reparations, because  
17 they are liable for massive damage including slavery and segregation. Blacks are always kept in  
18 the dark when it comes to political activity that will affect their people. They should not let this  
19 happen with reparations. They should vote on a reparations plan, then have a 2<sup>nd</sup> Civil Rights  
20 Movement (CRM) to let the government, their people, and everyone else know what they want  
21 and demand for reparations. They should want to produce, claim, and work their own redress plan.

22 Reparations are meant to repair damage done to a group or a race of people. The U.S. government  
23 has given others reparations for much less damage than blacks encountered, and we all know that  
24 is not fair. So, all blacks should claim AARS to unite around, then engage the 2<sup>nd</sup> CRM, with that  
25 plan they claim, as their goal in the 2<sup>nd</sup> CRM struggle. This will put pressure on the government

1 and other guilty groups, to make it a priority, and to move with a sense of urgency; to pay  
2 reparations to all blacks by 2023, by generating wealth with SEEG Marshall Plan Programs ASAP.

3 The Black Plebiscite Vote (PV) will ease complexities in claiming a group status, AARS, and 1 of  
4 the 3 reparations models for residence. African-Americans need the money ASAP, but they should  
5 be just as concerned with programs to repair generations of damage, as they are with getting the  
6 cash. Henceforth, note they need the cash, along with a comprehensive plan. Reparations should  
7 unfold to help all 50M blacks in America by utilizing the 3 models of reparations for individual  
8 and collective restitution. AARS will also help all Black Families outside of America.

9 **Improving Integration:** Explained on the next article AARS Part IV

12 **Massive Damage:** “ ”

13 **Self-Destruction and Black on Black Crime:** African-Americans developed a self-destructive  
14 and divisive slave mentality after 200 years of the Willie Lynch Indoctrination. They have a desire  
15 to unite but obvious and hidden barriers prevent all efforts. They should use AARS for another  
16 attempt at true unity, but first make it mandatory to expose all sambos and sell outs. Blacks would  
17 do themselves a world of good if they would put an extra effort into recognizing that the Lynch  
18 Indoctrination taught and molded them to hate and distrust one another, and that is why it is so  
19 hard to unite blacks, in order to solve crucial and lingering problems, and prepare for the 2<sup>nd</sup> CRM.

20 This slave mentality has blacks so twisted and confused until there are even some places in Africa  
21 and throughout the Diaspora, where older blacks are telling younger blacks not to interact with  
22 blacks in America. Young blacks in those areas are coming to realize that that is deepening and  
23 extending divisions among our people. Even worse blacks in America have become accustomed  
24 to hating, distrusting, and deceiving one another, by taking on their slave masters' mentality. Black  
25 people should claim AARS to identify and create programs to slowly dissolve the slave mentality.  
26 That mindset has blacks locked in deadly **black on black crime**, so we must engage **transforming**.

27 **Guilty Parties:** The Roman Catholic Church; the U.S. Government; 7 European Nations; The  
28 Jews; the KKK; 17 U.S. Corporations; Most U.S. Institutions, and Systems, and the Bush's and  
29 Rothschild's. They all are liable for epochs and eras of high rates of murders and thefts. In truth  
30 and reconciliation when combined they all owe blacks trillions of dollars for past and present  
31 transgressions, which were and are described as “In Black Suffrage” and “Crimes Against  
32 Humanity”. Now it will be a big mistake for blacks to take money without a plan, because African-  
33 Americans like others have a tendency to celebrate when they get money, or good news, and on  
34 holidays. However, we know evil people are working in secret right now to try to give blacks  
35 reparations money with no plan. Therefore, we produced the AARS Plan.

1 They want to give blacks reparations with no future plan, because they want to give blacks  
2 reparations with conditions, limitations, and strings attached, which is all bad, and will work to  
3 have blacks in a worse condition in five years, than they are in now. This is a well-known problem  
4 that exists in a pattern, when it comes to representation for Black people. We know the government  
5 has a history of using blacks (sell-outs), and non-blacks (racist) to prevent black unity, and  
6 collective movement. They want to issue orders to downplay and prevent the 2<sup>nd</sup> CRM. We should  
7 offset that demonic activity by claiming and endorsing AARS, that includes emergency relief  
8 ASAP, along with a plan to repair the vast damage via programs and services. {{Guilty groups owe  
9 us money, land, an apology, and a promise that colonialism and slavery will never happen again}}!

10 **Full Restitution:**

11 A profound statement like the World's Economy and America were built on the backs of black  
12 slaves, indicates blacks should own most of both entities, so we keep this in mind to claim AARS.

13 **A Call to Review the Individual Monetary Settlement for Blacks via Reparations Payments  
14 In a Reply to Mexicans Lobbying for 450k for All Family Members Hurt by Trumps Policy**

15 Blacks are victims of extreme and extensive damage, so they need reparations immediately! To  
16 expedite getting reparations they were going to settle for less than the debt owed in Equity  
17 Restorative Justice (ERJ), but they have waited too long, have lingering issues, new problems, and  
18 immense damage to repair. So, if the government continues to disrespect, insult, and denies blacks  
19 justice when it comes to reparations, we must prepare for national action to demand full redress  
20 (DFR) via AARS. AARS is a comprehensive, thorough, and complete plan, with personal payouts.

21 The most recent insult and insane act towards blacks from the government is them just mentioning  
22 reparations to Mexicans, for being temporarily separated from their families, during the Trump  
23 administration. That is a very harsh and very serious insult because the Black Family was  
24 permanently displaced, separated, deculturated, transformed, then indoctrinated for slavery!! Now,  
25 if the government contemplates paying each Mexican 450k for a new crisis, let us review a formula  
26 for all U.S. Blacks 18 and older to receive a monetary settlement of \$2M for historical crimes.

27 First, we must factor in lingering effects to the mentality of blacks from colonialism and  
28 subjugation, and suppressed anxiety from racism, the Middle Passage, slavery, lynching, and  
29 segregation. Then we must factor in severe emotional trauma and acute psychological abuse, from  
30 Post Traumatic Slave Syndrome to Unjust Police and Supremacists Killings. Then we must  
31 decipher variables from exclusion and losses in education, employment, finances, health care,  
32 housing, and loans. Then we reflect on assaults and imagery from the Civil Rights Movement,  
33 including racial attacks at Peaceful Protests, at Freedom Rides, Marches, Protests, and Sit Ins. The  
34 culmination of all of the vicious hate crimes caused blacks to usurp a deadly spiritual decline, and  
35 divisions, so blacks need their own land, free from all the hostility for spiritual recovery and unity.

36 This plane of angles and magnitude of historical crimes, converts to a tabled mathematical equation  
37 utilizing aggregate algorithms. They scaled each black person to receive \$2M; that is  $50M \times 2M =$   
38 \$100T, for individual payouts to blacks in America, which they should receive in 100k increments.  
39 So, blacks should demand \$2M each, for past and present crimes, and for just hearing they want



1 to give Mexicans 450k each for reparations, for a minor family crisis, as they deny blacks  
2 reparations for major family crimes! That is causing **most** blacks to suffer in dire and deep  
3 emotional frustration. Partly for just hearing the government is pondering redress for Mexicans,  
4 but mainly for delaying and denying blacks restitution. The government should help Black people  
5 before any others, because it's a historical debt, that all honest people know should be paid ASAP.

6 **{{If the government wants to continue to insult blacks and delay us from getting our reparations,**  
7 **we should go into **national action by planning** for the 2<sup>nd</sup> Black National Political Convention,**  
8 **then the 2<sup>nd</sup> Million Man March, that propels the 2<sup>nd</sup> Civil Rights Movement, to apply pressure for**  
9 **blacks to get AARS reparations immediately}}**! Our due date for the government to ratify AARS  
10 is 6-15-23, because we wanted payments for 6-19-23, and we should have gotten reparations right  
11 after slavery, so reparations are way past long overdue!! If the government still refuses reparations  
12 by then, we start planning for national action as listed above, because we know reparations are  
13 way past long overdue!!! We start planning for this **5 Consecutive-Year-Long-Serious-National,**  
14 **and Global Civil Rights Movement on 7-1-23, if AARS is not ratified by 6-15-23!!!!**

15 **AARS Reparations Programs and Services:**

16 Spiritual renewal and maintenance services, and land, are key components African-Americans  
17 need in a complete plan, to lament over loss of lives, economics and finances, and properties. They  
18 need to heal internally; restore valuable cultural losses; repair extreme, vast, and severe damage  
19 and injuries; and to declare collective safety and autonomy. The AARS plan covers all these  
20 concessions, and the AARS Congress will identify and produce programs for implementation.

21 Blacks in America should have their PV at the end of 2023 to find how many prefer to live in each  
22 model. We explain the differences in the three models on Part IV. So, blacks needed \$62 Trillion  
23 for the three models and personal relief, plus \$5 Trillion for emergencies and unexpected costs  
24 (\$67T), to design programs to improve integration, and to build elite safe cities. That was an ERJ  
25 settlement. Now we are demanding full redress (DFR) of \$200T for blacks in the U.S. & repatriated  
26 and sovereign land, and \$450T for all blacks outside the U.S., and repatriated and sovereign land.

27 With AARS we ask the government to designate (40 areas); of 40 mi<sup>2</sup> of prime land; symbolic to  
28 40 acres and a mule; as the land part of reparations for blacks in America; so, they can build their  
29 own new, elite, and safe repatriated and sovereign cities. Blacks need their own land because others  
30 received land for much less damage and encroachment, and the police and supremacists kill them  
31 way too often, **so black people definitely need their own sovereign land, at home and abroad!**

32 Now they have the ability, networks, and skills to build their own new elite and safe cities. So, in  
33 the spirit of goodwill let them become sovereign to build their own elite safe cities, and remove  
34 themselves from anger, harms, and fatalities in integration. There are blacks who have proposals  
35 for virtually all ares of building, business, agriculture, products, and repairing damage. They can  
36 plan to fund and utilize all of them with AARS, ASAP. Blacks can also get programs to learn how  
37 to become producers of all products to serve their needs, and producers of products in great  
38 demand, to engage in local, national, and international commerce, to buy and sell top line products.

1 All places of worship, spiritual entities, and concerned citizens should partake in implementing  
2 programs, to raise all expectations and standards for all youth in America, **to become race**  
3 **sensitive people**. The AAIU programs which will be implemented by the AARS Congress, are  
4 key to changing our socialization patterns with all youth in America, on race relations, from hostile  
5 and secluded, to amenable and sociable. Racism is a learned attitude and behavior, so, if adults  
6 start teaching their children to be race sensitive by respecting other races, instead of being race  
7 haters to hate other races, all youth will grow up to be friendly to other races. Our youth should  
8 grow up to become respectable, tax paying, peaceful members in society, instead of violent gun  
9 toting war mongers. That is another great benefit and strong reason to endorse and promote AARS.  
10  
11 The AARS Congress will implement educational programs to facilitate black pride and unity, to  
12 improve police and race relations, and to limit celebrating, in order to utilize reparations wisely. It  
13 is time for everyone to give blacks respect, and stop unjustly harassing & killing them like animals!



## AARS Part IV

### The Complete and Comprehensive AARS Global Black Reparations Plan in Demanding Full Redress (DFR) Terms

AARS can Lead to Justice for Blacks & Global Racial Harmony  
So China & Colonizers should Leave Africa & Stop Racism like  
Stealing Resources & Secret Experiments to Create Viruses

**AARS is Fairness Justice & Satisfaction for all Black People  
and Racial Reconciliation with all Nations & Races**

24  
25 **God's Genesis:** We start and finalize AARS with God to mandate reparations for all Black people.  
26 In 2<sup>nd</sup> Samuel vs. 10, it says, {"Moreover I will appoint a place for my people Israel, and will plant  
27 them, that they may dwell in a place of their own, and move no more; neither shall the children of  
28 wickedness afflict them anymore, as beforetime"}. Black people can relate because they need their  
29 own land to live on in peace, without the wicked long-lasting afflictions of racism, as in pastimes.

1 **Black people need God's guiding light to stay on the course of repair**, to heal, and never divert  
2 back to their poor conditions, as of today, when they get their own prime repatriated and sovereign  
3 land, in America and abroad. The great attorney Alexander J. Pires said, we should tell the story  
4 from antiquity to present, to show America the afflictions and problems caused by racism,  
5 invasions, colonialism, slavery, and segregation. These tragic periods convey major obstacles, and  
6 perpetuate emotional and social problems, so they need reparations to repair that massive damage.

7 {Therefore, we expose true Black History to prove Africa is the Cradle of Civilization, and blacks  
8 are the original people, so that everyone and especially the police, knows they deserve much  
9 respect, and to stop the daily harassment and unjust killings}! Vision invasions and captivity of  
10 Africa, via grand land and resource theft, and enslaving Black people. Then barriers and injuries  
11 caused by subjugation. Then their deeply subdued psychological damage induced by a divisive  
12 Willie Lynch Letter, and historical oppression. Then the desperate need to repair and rebuild Africa  
13 and Black people. We finish with Pastors, for healing and repairing for the next four 50-year terms.

14 **Black History:** Learning the true history of the world would provide a clear understanding of the  
15 many different contributions, that came from various cultures and peoples around the world. A  
16 terrible part of history (racism), that needs adjusting, is why European scholars have elevated their  
17 culture, while belittling and diminishing others. {{Let us reveal the African culture and pay tribute  
18 to their awesome achievements in math and technology, which led to establishing and maintaining  
19 classical African infrastructure}}. Then try to understand the exceptional manner in which they  
20 governed their affairs, and the significance of their impact on the advancement of their civilization,  
21 and most other cultures around the world. {{The great ancient African civilizations consisted of  
22 knowledge and wisdom that was so powerful, that it provided diagrams for most of the wonders  
23 of the world, and also the foundations for society as we know it today}}! These great civilizations  
24 produced great African Kings such as Akhenaton, the world's greatest social reformer of all time.

25 According to Dr. Leaky, the European paleontologist, Africa is the birthplace of all of humanity.  
26 According to Mendel, the European scientist who proved dark genes are dominant, and light genes  
27 are recessive, Africans are the original people, and parents of all human beings. According to the  
28 Honorable Elijah Muhammad, the African prophet who brought self-esteem to millions of blacks  
29 in America, blacks are the original people, and have been here for trillions of years. {{The original  
30 people were created in God's image, and as God's chosen people, he gave them knowledge to  
31 create and advance the arts and sciences, including concepts for language, time, travel, trade, and  
32 royal construction}}. The original people were very dark black folks. They called the land where  
33 they lived the home of the burnt and dark-skinned people. Known as Kemet among the scholars.

34 **Racism & Damage & DFR:** Due to centuries of <sup>1</sup>{lies and deceit}, the myth says damage started  
35 in 1619 when the slave crop production era began, and that the damage took place over the last  
36 400 years. Neither of those myths are true. The damage actually started before the European  
37 Invasions began in 332 B.C., because it takes at least 75 years (407 B.C.) to plot chaos and murders  
38 for resources, slave labor, and deviant sex. They created a supremacist theory that took effect after

1 centuries of building it in terrorism and mass murders, that became racism/white supremacy, to  
2 subjugate native people, and steal their resources. They actually plotted to persuade their peoples  
3 to carry out such evil atrocities. They decided to colonize and deplete Africa after finding its' a  
4 good strategic location, has valuable resources, good weather, and billions of blacks to abuse and  
5 enslave. They stole more than \$600T worth of resources, and still captivate and steal from Africa  
6 today! They murdered more than 600 million Black people, and constantly raped the women, until  
7 they lightened their races color!! So, blacks should claim reparations for more than 2000 years!!!

8 The <sup>2</sup>{truth} is the Pope noticed that 7 European nations were fighting over African land,  
9 resources, and billions of blacks to colonize, vandalize, mistreat, and murder. In order to stop the  
10 fighting, he suggested partitioning Africa into 7 territories where resources flourished on the  
11 superior continent, so each nation could continue dehumanizing and stealing from Black people.  
12 This was plotting the destruction of Africa for the benefit of all of those guilty of crimes of slavery,  
13 profiting from capturing and exploiting Africa, and terrorizing and enslaving Black people. That  
14 occurred in Africa, the Diaspora, and in the Trans-Atlantic Slave Trade. Now abuse still exists and  
15 spreads in America and globally! This plotting era took place from 250 A.D. until 325 A.D., when  
16 they made the partitioning official. Africa and Black people suffered great damage during these  
17 plotting eras. So, blacks encountered massive damage from 407 B.C., until the 1906 massacre in  
18 ATL, up to the 2021 worldwide pandemic, caused by viruses created by man, spreading more  
19 rapidly among blacks; thus, echoing the call blacks should claim reparations for over 2000 years!!

20 In AARS we were going to seek an Equity Restorative Justice (ERJ) settlement of \$67T. In ERJ  
21 victims settle for less than they are owed, but they demand ample resources to repair the damage  
22 done to their people at home and abroad. Since the government is considering benefits for others;  
23 especially 450k as reparations for Mexicans; Blacks are delayed, passed up, and denied again;  
24 extending deep mental frustration; so, they Demand Full Redress (DFR) now! In DFR we should  
25 claim reparations for over 2000 years, but we know that exceeds \$800T, so we defer in terms of  
26 recalculating for the AARS plan, with individual and family payouts, to yield a composite number.

27 The strong part of AARS is we generate the wealth ourselves; so, we really could produce \$800T,  
28 or any amount, though it may take five 50-year terms. Note, we talk about generating wealth later,  
29 so let's talk about a number relevant to the damage over the last 500 years, in terms of DFR, now.

30 Therefore, we will still claim damages in DFR over the last 500 years, but include more areas of  
31 damage, instead of omitting some like we did for ERJ. Since the 1<sup>st</sup> invasions began in 332 BC,  
32 we have to mention guilty parties pillaged Africa for more than 2000 years!! Then we overlap into  
33 the worst era of slavery in America from 1517-1619, when Africans were forced to clear the land  
34 in the south without heavy industrial machinery. The mixture of this explosive era, and the harmful  
35 effects of the Willie Lynch Letter, are the reasons why blacks have earned and deserve repatriated  
36 land in the south. That requires 8 southern states, to set 40 square miles (40 mi<sup>2</sup>) of prime land  
37 aside, for the repatriation model. We are also demanding the government to designate 32 other  
38 states with large black populations, to set areas of 40 mi<sup>2</sup> of prime land aside, for the sovereign

1 model. The government should stipulate that this repatriated and sovereign land can never be taken  
2 away from blacks; for eminent domain, any necessity, or any other reason that they ever conceive!

3 The AAIU says blacks should have been awarded reparations right after slavery! and that there is  
4 no way, that any others should have ever received reparations, before Africa, and all Black people!!  
5 Note: damage, death, and destruction amassed is from 407 B.C. plotting - 2023 viruses created!!!  
6 So, they should not deny blacks reparations any longer. They should ratify AARS immediately!!!!

7 On the AAIU examination, of their 40-year-old study on Africa and Black people they uncovered  
8 cycles of family, financial, and social problems; along with the induction of severe emotional and  
9 psychological trauma; Blacks were hurt tremendously economically and socially by being denied  
10 a proper education; {they suffer from mental anguish because of constant harassment and wrongful  
11 deaths, as others are offered benefits and reparations for much less harm }; they suffer from thinking  
12 debilities because of exclusion and repression; they suffer from a lack of representation because  
13 they are divided in various groups, which perceive theirs is best; they suffer from effects of these  
14 divisions because it prevents solidarity, and collective movement; so blacks should engage  
15 programs to diffuse and transform that divisive slave mentality; {they suffer from medical and  
16 science field corruption creating viruses to engage population control, then selling vaccines prior  
17 to finishing clinical trials, to make billions!! }; they suffer from a racist socialization which has  
18 caused and is mounting immense yet calculatable abstract, concrete, and transitional damage. By  
19 identifying factors and variables of categorical danger in phases of assaults for land, resources,  
20 and forced foul sex for centuries; we adjust an algorithm of corporate seizure, and measure it  
21 through a matrix and matrices of systems, operating in quantitative analysis, quadratic functions,  
22 and linear equations, to ascertain, adjust, and produce the statistical computational figure.

23 **We also include 2 Profound Facts, “The World’s Economy & America were Built on the Backs of**  
24 **Black Slaves”, and Suppressed Emotional Trauma is causing Blacks to Develop Mental Disorders!**

25 We thank the Pope for telling Christians to apologize to Africans for Slavery, and the World  
26 Council of Churches for telling the U.S., Arabs, 7 European Nations, Jews, and all the other guilty  
27 groups to pay Reparations to Africa, and all Black people. Apologies should come with cash to  
28 generate wealth. We suggest (1) \$50T from each of the 28 entities for reparations that they each  
29 owe, or (2) for all 28 groups to note \$500B for the **AARS Hedge Fund**, and operating U.S. Black  
30 Banks, to build safe cities at home and abroad, and provide cash relief! **To expedite the process**  
31 **we don’t need \$30T, or \$50T; just \$500B from each of the 28 guilty groups**, to help serve our  
32 purpose to rebuild our motherland, and provide help for all Black people at home and abroad. Then  
33 we negotiate an ERJ settlement for our Global Black Family in all areas like \$2M per family, since  
34 the cost of living is much lower, and number of blacks are much higher. That is how and why we  
35 calculated and determined **\$450 Trillion** is sufficient for all Black families in Africa and globally.

36 {The \$10Z debt on page four derives from coagulating paradigms, converting social construct and  
37 phenomena, suffusing anomalies and concepts in logics, hypothesis, physics, sciences and theories  
38 which translate from archeology, to paleontology, to hieroglyphics, and are invariably applicable}.

1 **By assessing damage over the last 500 years in the U.S.**, including areas we left out for ERJ  
2 purposes, we verified \$200 Trillion is a DFR settlement. We show **the reparations debt** for being  
3 chained and captured; fueling cruelty and brutality and unjust corporate, entity, family, U.S.,  
4 Arabs, Jews, and 7 nations unjust enrichment for centuries; recalling slaughters on Slave Ports in  
5 Africa like Goree Island; murders in Africa and globally for centuries; lying to, tricking, and  
6 stealing Africans by force for slavery; linked crimes of displacement; deculturalization; horrors of  
7 the middle passage; major negative effects of the Willie Lynch Letter; {centuries of slave breaking  
8 colonies; inhumane chattel slavery, withheld slave labor wealth, and withheld wealth from crops};  
9 deception, deceit, propaganda, and stereotypes; total black town attacks; reckless unjust fatalities;  
10 **stolen** inventions and contributions advancing civilizations; their deposed noble legacy; hundreds  
11 of trillions stolen out of Africa via elements and resources; and historical pain and suffering from  
12 rapes, and assaults to terrorize blacks; was closely vetted and logically computed at **\$200 Trillion!**

13 In AARS we use all 3 models of reparations for the collective for all 50 million blacks in the U.S.,  
14 with an individual settlement, with a priority on Poor Blacks, HBCU's, and Black Institutions. The  
15 three models of reparations are (1) Improving Integration, (2) Expanding Repatriation, and (3)  
16 Creating Sovereignty. We need **\$89 Trillion** for programs to improve, expand, and create each  
17 model, with **\$100 Trillion** for individual relief, plus **\$11 Trillion** for hazards and unexpected costs,  
18 **(that is \$200 Trillion, a DFR settlement)**, as we {prepare for sovereignty with programs}. Yes,  
19 blacks still get emergency individual relief if they deny sovereignty, and the option to study and  
20 {engage various cultural and social programs to transform, or remain stable}, for healing purposes,  
21 and for healthy and productive living. In AARS we produce and seek ways to create and find jobs.

22 In AARS we get the government to designate two areas of 40 mi<sup>2</sup> of land for 2M blacks, symbolic  
23 to 40 acres and a mule. Manhattan is 33.77 mi<sup>2</sup> with 1.63 million people, so 40 mi<sup>2</sup> areas are good  
24 for 40 black land settlements. We ask the Army Engineers, Black Professionals, and Certified  
25 Unions to connect to build, and train our youth to build and maintain our cities. We get the military  
26 to build a small strong base at our cities, and train our people to become the military police for our  
27 cities. We get the military to leave some strong soldiers behind who will help to build the bases, to  
28 **patrol** with our strong Black people they train, to keep our cities and indigenous citizens safe. The  
29 pay is \$4,000.00 a month for blacks 18-34, and \$8,000.00 a month for blacks 35-54. The Army  
30 Engineers, Black Pros, Certified Unions, and Military Workers will get a \$3000.00 a month bonus.  
31 We get experienced professionals for clinical, emotional, rehabilitative, social, therapeutical, and  
32 financial services. That will prepare blacks to heal, limit celebrating, and utilize reparations wisely.  
33 Let's show the repair process for blacks. They get emergency relief, repair the damage, and prepare  
34 for a peaceful, productive, progressive, and safe future via AARS. Blacks should not continue to  
35 be victims of institutional and systematic racism, nor unjustifiable police killings! It is very sad!!  
36 Expressly in others getting reparations, without the deaths, damages, losses, injuries and sacrifices.

37 Recently, President Joe Biden even stated we should have a federal commission to study black  
38 reparations. But his actions seem to avoid, delay, and even deny redress. So, blacks should claim  
39 AARS, by preparing for **(I) national action**. That action is planning for the 2<sup>nd</sup> National Black



1 Political Convention, then the 2<sup>nd</sup> Million Man March, to propel the 2<sup>nd</sup> Civil Rights Movement,  
2 to demand ratifying AARS; ASAP. We put pressure on the U.S. Government and all the guilty  
3 groups with a collective demand for AARS. After Biden’s statement, Senator Steven Bradford was  
4 asked to endorse or produce a Black Reparations Plan. So, we should **(II) blitz him with calls and**  
5 **emails** to let him know blacks want AARS for reparations. We put pressure on him, to make sure  
6 he goes through the process to have AARS ratified ASAP, for our U.S., and Global Black Family.

7 Fortunately, we can save them a lot of time because after 40 years of research we produced this  
8 African-American Reparations/Sovereignty (AARS) Plan. The focus is sovereignty to get blacks  
9 their own land, like others with districts and reservations. AARS shows how reparations should  
10 unfold to get justice for blacks, and as a healing source for the races. **The advantage of claiming**  
11 **AARS is we get a strong plan, and we generate our own wealth**, so we don’t settle for less than  
12 we need, which others will secretly try to negotiate to avoid their debt, and to keep blacks down.

13 **Examining the Plebiscite Vote (PV):** The PV is meant to let everyone know blacks are indigenous  
14 to this land, as relatives of the Great Ancient Black African Olmecs, who were here first, not Native  
15 Americans or Mexicans, and that all blacks deserve the rights and privileges of indigenous people.  
16 The PV says blacks do not have to continue to live in integration as hopeless victims of mounting  
17 corruption, hate crimes, and unjust murders. Yet, we know many blacks will prefer to remain  
18 integrated, but that is only because that is their only way of knowing life in America. In view of  
19 these facts AARS offers programs and services to improve integration, along with SEEG Marshall  
20 Plan like programs to generate wealth, to build new, elite, and safe repatriated and sovereign cities.

21 The PV functions to finish the CRM, when blacks were forced to integrate. **{{Blacks lost many**  
22 **great gains from long periods of struggles, when they were forced to integrate prematurely}}**. They  
23 lost schools, businesses, communities, family structure, and tribal village customs; and they lacked  
24 proper finances, representation, and an agenda. So, they never should have been forced to integrate  
25 without proper preparation. With AARS they fill these voids, and choose where they want to live,  
26 with programs to implement the three models of reparations. **This is a very serious, definitely**  
27 **qualified, and most powerful political move for blacks to make, to get respect and global equality.**

28 The PV will take place after we set criteria by the end of ‘23, to claim an injured indigenous status,  
29 this AARS Plan, and 1 of the 3 models for residence. The PV is a political process for blacks to  
30 engage in to take control of their lives, get their own land, form their own government, write their  
31 own laws, and form their own police force, to stop deadly psychotic unjust police abuse and  
32 killings. They will also form their own entities, companies, corporations, institutions, and systems,  
33 to provide a quality education, gainful and meaningful employment, excellent housing, premiere  
34 health care, and decide their future collectively, especially after having the Civil Rights Movement.

35 **Improving Integration & the AARS Congress:** {The AAIU will form the AARS Congress to  
36 implement the AARS Plan, and follow steps (1) through (7) the next time a black person is unjustly  
37 killed by the police, or to ignite the Reparations Movement. The AARS Congress will (1) initiate  
38 a 5-year national protest **for** reparations, and **against** police killings; (2) initiate a 5-year-national  
39 dialogue on racism, corruption, and police terrorism; (3) initiate 5-year-case studies to identify

1 systematic problems, to produce solutions in all institutions, and in society; (4) initiate 5-year-case  
2 studies to improve interaction with and performance of all companies, institutions, and systems  
3 which blacks depend on for socialization, living, and survival; (5) initiate 5-year-long boycotting  
4 against companies who disrespect blacks; (6) do mass buying from companies who respect blacks;  
5 and (7) transferring 75% of our assets from other banks to the operating Black Banks. This 7 Power  
6 Move Process is effective, if done nationally and simultaneously, to get blacks respect instantly}.  
7

8 The AARS Congress will consist of people with a track record of helping blacks, those who are  
9 knowledgeable of reparations, those with reparations plans, those protesting injustice, those giving  
10 input on the AARS Plan, and those who know diplomacy, law, and politics. {{The AARS Congress  
11 national dialogue with participants who have studied corruption, racism, or police terrorism for at  
12 least 20 years, or produced work on the 3 topics; and the 5-year studies, will improve integration  
13 much more than anyone can imagine. A process to improve corporate, police, and race relations}}.

14 It is our greatest desire to reunite the Black Family at home and abroad with AARS. We all know  
15 there is strength in numbers, so together we stand, but divided we fall. We are hoping and praying  
16 to unite all reparations activists and groups, then the entire Black Family with AARS, to prioritize  
pursuing reparations. We believe an AARS media blitz will get most blacks to vote yes for AARS.

17 {{Everyone in the U.S. should endorse this AARS plan as reparations for blacks, with studies to  
18 produce positive changes in all businesses, companies, entities, institutions, and systems in society,  
19 because it benefits blacks, and everyone else in America}}!! AARS was designed to unify and get  
20 justice for blacks, and to lead to true and lasting racial harmony among all people in America, and  
21 globally. We say 20-25 million blacks may want to remain integrated, we will know after the PV.

22 **Expanding Repatriation:** Blacks should learn that repatriation is going back to Africa, down  
23 south, or any other place on earth where they were enslaved or exploited. We will have leaders  
24 from a global group like the UNIA, on the AARS Congress to direct the repatriation process.  
25 Blacks will go with a good understanding of the customs of their people in the places where they  
26 choose to go, to make sure they don't offend their distant native relatives on arrival, and to go with  
27 a sense of belonging. This will start the Global Black Family Healing, Recovering, Reuniting, and  
28 {Transforming of their Indoctrinated Slave Mind Set Process}. {{They should also go committed  
29 to work to improve relations within their Extended Global Black Family, and with ample resources  
30 to build new, elite, and safe repatriated cities. They should also take time to learn their native  
31 names, languages, customs, and culture; to prepare for their Global Black Family and Culture  
32 Restoration Process}}. AARS offers services for blacks to get dual citizenship for both processes.

33 Captain Paul Cuffee was the first to call for repatriation, but Marcus Garvey was the most famous  
34 advocate. He formed a Black Starline Company complete with a fleet of ships to sail blacks back  
35 to Africa on descent ships, to reenact and vent from being displaced, deculturated, and transported  
36 like animals in chains, on wicked, awful smelling slave ships, leading to **life** in bondage & misery.  
37 Randall Robinson and W.E.B. Du Bois are the two most notable blacks who repatriated. They left  
38 because blacks get no justice, and they need to reunite, so blacks should expand this model for

1 those feeling the pains of injustice, and the need to reunite. Blacks should also get dual citizenship  
2 to Africa, or another area of the Diaspora, to advance their Global Black Family Reuniting Process.

3 **Bishop Henry McNeal Turner (1834-1915):** One of the most influential African-American  
4 leaders in the late-nineteenth-century Macon, Georgia.

5 Henry McNeal Turner was a pioneering church organizer and missionary for  
6 the [African Methodist Episcopal Church](#) (AME) in Georgia, later rising to the  
7 rank of bishop. Turner was also an active politician and [Reconstruction](#)-era state  
8 [legislator](#) from [Macon](#). Later in life, he became an outspoken advocate of the  
9 repatriation model of reparations, which is basically back-to-Africa emigration,  
10 but it includes all other places where blacks were enslaved and/or exploited.



[Bishop Henry

11 Turner was born in 1834 in Newberry Courthouse, South Carolina, to Sarah  
12 Greer and Hardy Turner. Turner was never a slave. His paternal grandmother  
13 was a white plantation owner. His maternal grandfather, David Greer was a  
14 black man, who was taken by force to North America aboard a slave ship in  
15 chains. Yet, according to family legend, was found to have a tattoo with the  
16 Mandingo coat of arms, signifying his royal status in Africa. So, the South  
17 Carolinians decided not to sell Greer into [slavery](#), and sent him to live with a [Quaker](#) family. We  
18 believe 5-10 million blacks may prefer repatriation. We will know after the PV.

19 **Creating Sovereignty:** { Sovereignty is developing a new line of thinking }, for blacks to seek their  
20 own land in America to look out for their own best interest, to declare and pursue their own  
21 political and ideological agenda, and destination. It denotes many of them leaving the shackles of  
22 integration, while gaining control over their lives in sovereignty, stipulating absolute authority,  
23 control and power of a consenting people to form their own government, to manage all activities,  
24 businesses, resources, and entities within their borders. Everybody knows blacks are controlled by  
25 others in integration, and that is their obvious and main problem. Blacks need their own land to  
26 get away from problems and the police in integration, and to provide basic needs for their people.

27 Blacks should also learn that sovereignty is their salvation in America. The government awards  
28 them 40 areas of 40 mi<sup>2</sup> of land, as in 40 acres and a mule, to build their own elite safe cities,  
29 completed with high-tech infrastructure. Their city plans include construction in awe and splendor  
30 to honor their great civilizations, freedom fighters, and political prisoners of the past and present.  
31 Their cities will have **beautiful homes**, parks, schools, highways, roads; and successful businesses,  
32 companies, and corporations; with superior communication, protection, and nutritional services.  
33 Their city residents will **produce products** for sustainability, and for local, state and international  
34 commerce. There are many blacks with good ideas and proposals. We should use the SEEG source  
35 to generate wealth to fund all projects blacks visualize in our own cities, no more begging. So,  
36 blacks become proud multi trillion-dollar producers, instead of injured trillion-dollar consumers.

37 We press for blacks to prioritize utilizing reparations among themselves, instead of spending all  
38 of it with others. The money should stay within the Black Family. Blacks should produce food;

1 design homes, cars, and clothes; provide light, water and power; and produce appliances (like  
2 TVs), electrical devices (like generators), and electronic devices (like computers). Blacks should  
3 get reparations and become producers of all products to keep the money in their family. It is just  
4 as important for us to press for blacks to do like Malcolm X said, “Some Serious House Cleaning”.

5 Sovereignty also refers to the inherent rights of all peoples, to govern themselves without any  
6 interference. When blacks start educating, employing, policing, and providing housing and health  
7 care for their people, their problems will be solved. That cannot be done in integration. That is  
8 why it is imperative, and of the ut-most importance, for most blacks to become a sovereign people  
9 in America. Initially we expect 20-25 million blacks (40%) may prefer sovereignty. We will know  
10 after the PV. However, we believe 90% of all blacks will prefer to become a sovereign people,  
11 after they see we have no racism, solemn peace, and are making collective progress in new cities.  
12 The 10% who may want to remain integrated as they should, are the 5% who are rich or satisfied.  
13 The other 5% are sambos, haters, and sell outs. The masses should want a new start with God, and  
14 a plan. There is no way blacks should want to remain living by a people who enslaved them, then  
15 refuse to make amends for the worst and longest crime in history! but they are quick to help others!!

16 When blacks get their own land to build their own cities; they can establish their own books,  
17 customs, and holidays to observe like Building Bridges over Troubled Waters, Rites of Passage,  
18 and Kwanzaa; and others that offer programs to repair damage; celebrate black awards, triumphs,  
19 and contributions; honor their heroes and sheroes; and offers guidance and stability for the masses.

20 {{Blacks have to learn that they have earned, are entitled to, and should start thinking and knowing  
21 they can live in peace, in their own sovereign and repatriated cities, here in America. They should  
22 claim an injured and indigenous status with the PV, on the land their ancestors built with their  
23 blood, sweat, forced slave labor, contributions, sacrifices, and tears}}. Now is a good time to learn  
24 AARS presents positive alternatives for blacks to living in integration, so let us reunite to  
25 relentlessly pursue reparations with this AARS plan, that will prepare us to initiate national action,  
26 to improve integration, and police and race relations, expand repatriation, create sovereignty.

27 Dissolving racism and improving police and race relations is the “change” that will make America  
28 a much better place. The AARS strategy was written with visions to start a peaceful and political  
29 process, to achieve “both goals”. The AARS strategy is for everyone 18 and older in America, and  
30 the world to observe, as part of an AAIU program to seek pride and unity among blacks, and racial  
31 harmony with all others, so that we can live in a civil society in America, and globally. We  
32 recognize reparations for “crimes against humanity”, “in memory of our ancestors” to reunite,  
33 repair, restore, and uplift our people back to the safe, spiritual, and progressive status we were in,  
34 prior to slavery. In AARS we provide 5, 50, and 200-year programs to bring this to fruition.

35 \* **Generating Wealth:** This is a new, critical, and turning point development in the reparations  
36 arena. Since AARS combines a solid comprehensive plan with generating wealth, if blacks agree  
37 AARS is a good reparations plan to implement, the government should ratify AARS as reparations  
38 for blacks in America and globally, immediately, yet no later than Juneteenth of ‘23. Then all

1 blacks should embrace this AARS plan to secure freedom, justice, equality, and safety, at home  
2 and abroad! Now, everyone knows if the government and the guilty groups offer their deemed  
3 amount in cash, it will be insufficient, and have complications, limitations, and strings attached.

4 However, if we generate the wealth ourselves, we can do what is most important in reparations,  
5 and that is we identify and create programs and services to implement, to repair the colossal  
6 damage inflicted upon our people. We will also generate enough wealth to rebuild Africa, and the  
7 Diaspora with new infrastructure, and elite repatriated cities. {{That says generating wealth helps  
8 blacks to regain black pride and unity, and to attain liberation. So, Generating Wealth becomes  
9 the most valuable tool to provide reparations for blacks now, and no later than Kwanzaa of '23}}!!

10 All the aggression and violence in society has **most** blacks living in caution and fear, with a poor  
11 mental psyche. We should admit racism and lingering effects of slavery have had a major negative  
12 impact on **most** blacks, who live at, and below the poverty line. **Most** blacks are poor folks  
13 experiencing a cycle of racial deprivation perpetuating psychological and social oppression. So,  
14 reparations should go to poor blacks first, then rich blacks may use their reparations, or cash  
15 reserves to make a huge profit, and provide reparations to help poor blacks, with the SEEG source.

16 In America the SEEG source calls for the U.S. Government, all the guilty groups, and those with  
17 compassion to **(A)** form 100 groups, with \$2T each to provide as reparations of (\$200T), over the  
18 next four 50-year terms. We know all 28 guilty groups each owe \$30T up to \$50T, but with AARS  
19 we ask them, and 72 other groups with compassion to set \$2T aside, for reparations; or **(B)** we get  
20 100 groups to place \$500B in SF instead, which is great debt relief for guilty groups, for the SEEG  
21 to generate wealth, \$650T, in four 50 years terms. We also get groups who can afford more than  
22 \$5B, to do a max in SF, for the SEEG. The SEEG sources are experienced with various programs.

23 {We go to the groups with the SEEG programs to generate wealth, instead of begging, or filing  
24 lawsuits, which we may never win with the U.S. courts leaning on Standing, Statue of Limitations,  
25 Sovereign Immunity, and many other laws they will adopt or create, to prevent blacks from getting  
26 reparations}. Generating wealth expedites the process for blacks to get reparations. Now, it is  
27 politically incorrect and socially unacceptable to continue to deny blacks reparations, in the midst  
28 of offering benefits and reparations to others! Especially since blacks can generate wealth now!!

29 Herein AARS offers the government and the other guilty groups a source to make amends, and the  
30 option to make a huge profit, but we may negotiate to let the seed funds be charitable or refunded,  
31 and let the profits go for reparations. Generating wealth should be the strong and turning point for  
32 the government, all guilty groups, those with compassion for blacks, and all blacks, to agree on  
33 utilizing the SEEG source, to generate wealth for reparations now. Then, one client, or one sole  
34 signatory opens a new \$100M, \$500M, \$1B, \$2B, or **\$5B** cash account at a major bank, to engage  
35 the program. So, the \$50B-\$500B cash in SF are noted for the AARS Hedge Fund, the operating  
36 U.S. Black Banks, and the AARS Congress, to implement AARS's short- and long-term strategies.

37 AARS is very strong in providing ample resources for victims, and means for guilty groups to  
38 apologize, provide seed funds, and possibly profit, but definitely make a promise of non-repetition.  
39 Folks say it is absolutely wrong for guilty groups to profit, and I agree, but we offer it as an



1 incentive to secure reparations for blacks ASAP! They have waited way too long, so they want,  
2 need, and deserve their reparations now! Since we have a source to generate the wealth, that should  
3 expedite ratifying AARS ASAP, and no later than June 15 of '23. The source calls for them to  
4 place and note \$50B-\$500B as SF, instead of paying the \$30T-\$50T they each owe. Again its great  
5 debt relief for the governments and all guilty groups. AARS facilitates **racial healing** by providing  
6 emergency relief for victims ASAP, and easing debt for all the guilty groups to generate wealth.

### 7 **Pastors Repair Programs:**

8  
9 Dr. King and others provided a valuable service by conducting the Civil Rights Movement out of  
10 their churches. They thought blacks would reach equality if they were integrated. Since blacks  
11 never reached, or came close to equality in the U.S., they should want repatriation and sovereignty.

12 **ALL CHURCHES AND COMMUNITY ORGANIZATIONS SHOULD BE INVOLVED** – The Pope and  
13 the Church, (**the U.S., Jews & 17 Corps.**), are all guilty of gaining trillions in unjust enrichment,  
14 from slavery and mistreatment in America. All capable Churches should set \$2T aside, and the **19**  
15 **groups** should set \$2T aside for reparations, or place \$500B for SEEG's source to generate wealth.  
16 We can and will generate wealth for all blacks in Africa, America, and globally with the SEEG.

17 All Black, White, and Jewish people who go to worship at their services for spiritual guidance,  
18 should admit blacks cope with lingering issues from racism and slavery, and problems persist, and  
19 find others abuse and mistreat them, because they follow the oppressors and their conspirators. So,  
20 they all should step back to say I'm sorry, and note \$50B-\$500B cash as SF, to generate wealth.

21 Translation: The U.S. government should ratify AARS, ASAP, to inspire the races to form better  
22 opinions of one another, and develop mutual respect for one another. **This is racial healing to**  
23 **make God proud, and America a much better place.** Granting AARS Reparations may avoid  
24 an end time revolutionary event, where the level of destruction is similar in the book of revelations.

25 **Rev. George Brooks:** I will make this very short because I am tired of fighting evil black folks  
26 who do not want to fight evil white folks, if needed, in order to rectify the wrongs done unto our  
27 ancestors. **So, I simply say we do know there are good and bad people in all races.** In knowing  
28 that we can say slavery was a crime that was committed by bad people, who are enemies of  
29 equality, yet they made great monetary gains, in the hundreds of trillions of dollars, and as a result,  
30 created a global system of racism/white supremacy, subjugating black and native peoples, stealing  
31 their resources, and owning and controlling the world, with a built-up star trek like military force.

32 The bad people owe the good people they enslaved reparations for abuse, damages, injuries, losses,  
33 and oppression from racism, slavery, reconstruction, segregation, integration, and now viruses. Is  
34 our ancestors 'abuse, our current injuries, destruction, and cruel treatment, deserving of a fight to  
35 demand the enslavers to pay their debt? I say yes, with a resounding yes!!! In comparison to other  
36 groups who already received reparations, blacks were damaged much much worse, and for a much  
37 much longer period of time. There is no question as to whether or not blacks need, deserve, and  
38 have earned reparations, the answer is in AARS to show what and how reparations should unfold.



1 **Rev. Tom B. Watson:** He has dedicated more than 25 years to community involvement, and is a  
2 former superintendent of the Milne's Boys Home. He is "Calling the Black Family to Order" as it  
3 pertains from boys to men; specifically, violence, drugs, and homicide. There is a great need for a  
4 call to order among Black Men, and among and within the Black Family. Rev. Watson, founder  
5 and pastor of Watson Teaching Ministries, recognizes that there is a void in this nation in terms of  
6 leadership, and fathers in homes. In light of all of the concerns, coupled with other persistent socio-  
7 economic issues threatening to annihilate the male seed, and their families, Rev. Watson will lead  
8 a citywide, town hall forum, to declare with a resonating voice that, The Black Man is Important!

9 "The Call to Order translates into a call for action to strengthen men now to save our boys from  
10 extinction," Pastor Watson explains. "One, we have to stop the assault on black men, including  
11 violence, crime, diseases, the police, viruses, and other hardships meant to destroy them. Two, we  
12 have to make men see their necessary role in bringing our communities to order. And three, we  
13 must continue to empower and develop men, so they can take their rightful place in their families,  
14 communities, states, and our nation. AAIU uses men to form and join organizations for protection.  
15

16 More than just a gathering, the town hall will re-ignite programs that Pastor Watson and his wife  
17 and partner in ministry, the Rev. Pat Watson, have spearheaded for years. Among them is a Male  
18 Mentorship Program, and a Rites of Passage Program, which takes males from boyhood to  
19 manhood, in a strong, nurturing, and career-oriented environment. His wife started the first Family  
20 Preservation Program at Kingsley House long ago. We add these programs to AARS as services.

21 **Rev. Brown:** I am glad to see the good work that the preachers and their associates are doing to  
22 help our people. I am writing you lawyer to lawyer to inform you of the changes in law that do not  
23 require an apology. {{The UN General Assembly in Resolution 60/147 sets out the definitions and  
24 the remedies of reparations, which the U.S., known guilty groups, and other offending entities have  
25 the spiritual and state responsibility to abide by via compensation, restitution, rehabilitation, and a  
26 guarantee of non-repetition}}. We have stipulated this course of action within this AARS plan.

27 The UN law has no statute of limitations, or tracing requirements. **What is required is a consensus**  
28 **for collective representation**, [via the AAIU Plebiscite Vote (PV) near the end of '23, which we  
29 are planning around the country to give us standing, which will give us the injured and indigenous  
30 status (standing), with rights to land and other reparative measures]. We would like you to join us  
31 on this most important and sacred life changing AARS legal and political project, to take blacks  
32 into full equality here in America and globally. We will use the AAIU organization, in order to  
33 hold an electronic ballot box election via Large Black Churches, for the PV, and conduct many  
34 practices, processes, and programs to secure reparations for all blacks at home and abroad.

35 AARS is mainly for blacks who are less fortunate; gang related; poorly educated; mentally ill;  
36 declining physically; (in jail, or out of jail and on probation or parole); having visions of • Africans  
37 being harshly thrown overboard, and jumping out of fear, off of slave ships! • or visioning huge

1 intoxicated crowds gathered to cheer a brutal and violent lynching!! These social & psychological  
2 impositions cause emotional torture, and dire depression. It is deeply rooted racism, so black folks  
3 need Black Unity, White and Jewish Truth and Reconciliation, and Calm Emotional Therapy.

4 We believe everyone will endorse AARS because it benefits everyone, as it offers great relief for  
5 the victims, and for the perpetrators. After blacks accept AARS, and the U.S. Government ratifies  
6 AARS, the seed funds go evenly to the AARS Hedge Fund and operating U.S. Black Banks. We  
7 keep data to guarantee transparency, and reparations for African-Americans, and all Black people.

8 The groups and organizations **who already gave money for reparations** made a serious mistake.  
9 They have given from \$100M to \$1B, for reasons we don't know. If they would have engaged the  
10 SEEG, with those funds to be used as SF, the SEEG would have their money blocked in their bank  
11 accounts, for the duration of the 10 days to 1-year company programs, to generate wealth. They  
12 split the profit, then SF are unblocked after the programs' completion, so clients cannot lose their  
13 money. They split profits. In this case we would give 25% to clients, 65% to AARS, and 10% fees.

14 We access rules like mergers and acquisitions to create the Global Bank of Africa (GBA), as the  
15 parent bank for the AARS Hedge Fund and the operating U.S. Black Banks. The profits from the  
16 SEEG programs go to the Hedge Fund, then to the Black Banks, until we certify the GBA. The  
17 AARS account will be moved to the GBA, to look out for blacks globally. We do have funds in  
18 the AARS account now. We will have a sector for each bank with their normal business practices.

19 The sectors will perform studies on gentrification, the police, institutions, and systems the AARS  
20 Congress list for improvement and stability. We will **improve** integration via dialogue and studies.

21 With AARS blacks get relief, justice, satisfaction, and a good plan. Then race relations improve  
22 because victims get fairness, guilty groups pay less, and all others treat blacks with mutual respect.

1 Our blog is based to demand AARS via the KRP. The AARS Congress will host racism dialogue  
2 to help slowly dissolve and end racism and police terrorism in America, and monitor others who  
3 are working to select or produce an African-American Reparations Package, or a Global Black  
4 Reparations Plan. The SEEG will reserve several holdings to assign \$100M - \$5B cash accounts,  
5 to help us build our own new beautiful, elite, and safe repatriated and sovereign cities. We form  
6 the AARS Congress as an institution to last forever, and focus on using platforms, and protesting  
7 to keep constant contact with the U.S. Government, to **advocate** and **enforce** policies we produce  
8 in dialogue to **end racism**, and **police terrorism**, and to **endorse equality**. Everybody should use  
9 their platforms to identify and solve problems blacks have encountered and endured since slavery.

10  
11 We will also use programs and platforms, to discuss the need for **most** African-Americans and  
12 blacks in the U.S. to **leave** racism/police terrorism, and corruption in integration, to become a **truly**  
13 **free and independent people**. They will build safe repatriated and sovereign cities for peace and  
14 progress. Blacks have waited too long for peace in integration, with racism and aggression rapidly  
15 spreading and intensifying! **AARS issues demands for all blacks to live in peace in safe cities!!**

16 The AAIU is **positioning the military** to encourage and train young crips and bloods, young  
17 tough brothas and sistas, and our brothas and sistas coming home from jail; to build, maintain,  
18 and become the military police force, for our repatriated and sovereign cities. The pay scale is  
19 \$4000 a month for blacks 18-34, and \$8000 a month for blacks 35-55. With AARS **all blacks in**  
20 **the U.S. 18 & older** can start getting paid (\$100k), later this year or ASAP. We also need our  
21 government to grant us 40 areas of 40 square miles (40mi<sup>2</sup>) of prime land; (symbolic to 40 acres  
22 and a mule); for 40 million blacks in the U.S. We know Manhattan is 33.77mi<sup>2</sup> with 1.63 million  
23 people and considered one of the world's leading commercial, financial, and cultural centers. So,  
24 40 areas of 40mi<sup>2</sup> are good for 40 U.S. Black Repatriated & Sovereign Land Settlements. Our  
25 first two cities will be formed as spiritual repatriated and sovereign cities, for the **Global Black**  
26 **Family Reunion and Recovery Process**, and will be designed and function similar to Manhattan.  
27 One city for Black Christians, and One for Black Nationalist. We should build four cities at a time  
28 to include more groups of blacks, until we help all 50M blacks in the U.S., then all blacks abroad.

29 The military will build a strong small base in each reparation's city. Army on the north, air force  
30 on the south, navy on the west, and marines on the east. These small bases will be top flight with  
31 top flight strong soldiers, and we will pay them an **extra stipend** with their military benefits,  
32 because **blacks being unjustly harassed and killed** is a **matter of national security!** They can  
33 leave some of their strong soldiers behind to **patrol** with our soldiers they train, **to keep our cities**  
34 **and citizens safe**. The AAIU mainly reveals AARS to stop white supremacist, and the police  
35 terrorist from repeatedly killing innocent and unarmed blacks!! **Blacks are not safe** in integration  
36 as victims of racism and police terrorism, even though they are **descendants** of slaves, who were  
37 **victims of extreme abuse and terrorism**, for generations!!! **Now**, that is a dog gone shame,  
38 especially in knowing all the contributions, sacrifices, and suffering blacks endured. Black people  
39 need **reparations, honesty, and accountability** for redress, reconciliation, and a new beginning.

2 **The AAIU AARS Reparations Endorsement Form**

3 After reading the AARS Global Black Reparations Plan, I acknowledge that Black people have  
4 been damaged by individuals and groups, and that it is their duty to repair that damage they  
5 inflicted. From that point of view, it makes sense to offer AARS for rapid relief for the culprits,  
6 their cohorts, and the victims. AARS is a good formula for atonement and compensation.


7 Reparations for Black people are so controversial because the debt is so high, and the guilt among  
8 the culprits is a burden, yet subdued, but is just as high. Now, the victims have been crying out for  
9 help since slavery, but have been intentionally denied or misled. AARS presents a scenario where  
10 culprits and victims will benefit tremendously, and that will lead to genuine reconciliation.

11 Therefore, as a person who is at least 18 years old, and have read and understand the AARS Plan,  
12 I endorse and will promote the KRP, for everyone 18 and older at home and abroad, to get a chance  
13 to evaluate AARS. It is my firm belief that African-Americans, and all Black people should claim  
14 AARS for Global Black Reparations, then seek reconciliation with all other nations and races.



8 reparations for violations which were much less harmful, then damage encountered by blacks at  
9 home and abroad, so they can realize blacks need the U.S. Government to ratify AARS, ASAP!!

10 Others were granted reparations for violations that did little harm to their people, but no people  
11 have been abused, damaged, harmed, lynched, relocated, slavery indoctrinated, and tortured like  
12 Black people! There is absolutely no comparison! Black people have been enslaved and oppressed  
13 for the last 500 years nationally, and over 2000 years globally! So, they need a global redress plan;  
14 **This African-American Reparations/Sovereignty (AARS) Global Black Reparations Plan.**
