It is insulting, painful, politically incorrect, and socially unacceptable to continue to offer others benefits and reparations, while denying blacks their long overdue reparations. Blacks contributed more, sacrificed more, and suffer more from economic, emotional, and social depression, which others don't, because they can assimilate. **The Black Experience** is centuries of abuse, daily disrespect and harassment, and unjust police killings, because of the color of their skin. Their country, culture, and status were compromised, and they do not even have their own names, languages, or customs. That Willie Lynch Brainwashing permeated 200 years, so they need to transform their thinking from that divisive slave mentality, into solidarity for collective movement.

It is very frustrating to Black people knowing their ancestors endured slavery to build this country, and defend its borders, but they are denied reparations today for vile and vast crimes! **Blacks** built this **world economy** that this country and most other nations enjoy, producing products for sale here and abroad. **They built this country** with the hard-core slave labor of their **bare hands**, and the blood, sweat, and tears from generations of life in bondage and misery. They provided special gifts for reasons of necessity and subsistence, which led to inventions and contributions; which citizens, visitors, and immigrants enjoy today. **Blacks developed those gifts** during **oppression and being stigmatized!** The kidnapping, carnage, and destruction of black lives began more than 2000 years ago and caused tremendous pain and suffering, and the effects continue today! So yes, Black Lives do Matter!

The African-American Independent Union (AAIU) worked in conjunction with several reparations activists and groups, **for more than 40 years**, in an intense research period, to gather data to produce the AARS Global Black Reparations Plan, to provide a platform to solve all problems via reparations, and to slowly dissolve and end racism and police terrorism in America. We are calling for the **collective movement** of all activist 18 and older, and all groups whom have produced reparations work, have reparations groups, or have written a reparations plan, to engage in the **KRP**, to read the African-American Reparations/Sovereignty (AARS) Global Black Reparations Summary Docs and the AARS Plan. If you approve, we use the plan to unite reparations activists and groups, then the entire Global Black Family and their allies, to demand AARS, ASAP!

We have identified the names and ranks of countries, corporations, entities, families, and groups who were complicit, and are guilty of enacting slavery and benefiting from committing crimes against humanity, which have caused massive damage and extensive suffrage. We offer those groups an incentive to repair the damage with programs via the SEEG to generate wealth from seed funds (SF), for much less than they owe. Generating wealth will also help to create more reparative amenities and measures, to repair the damage done to Black people at home and abroad.

AARS reparations provides what they have been denied, in the form of basic civil and human rights, for safety and civil opportunities to <u>improve integration</u>, <u>expand repatriation</u>, and <u>create sovereignty</u>; with an emphasis on improving integration and police and race relations. The AARS Plan has victims engage programs to prepare to receive reparations in top mental and physical shape, to lead good, clean, peaceful, and productive lives in all 3 <u>settings</u>, utilize reparations wisely, and to plan for the future.

We expect this process to begin and grow during the KRP, so when the Plebiscite Vote (PV), occurs at large Black Churches to 1) claim their injured and indigenous status, 2) to claim their AARS Global Black Reparations Plan, and 3) for each black person 18 and older, in the U.S. to claim 1 of the 3 reparations models, where they prefer to live. The PV stipulates Ancient Black African Olmecs were here first, so Black people are indigenous to this land, not Indians or Mexicans. Therefore, Black people deserve the rights and privileges of indigenous people via AARS redress. {{The PV is a serious move towards liberation and independence for all Black people, and represents immediate action in a collective response to end racism and police terrorism, via repatriation and sovereignty}}.

Now, the question is what do blacks need **to repair** the excessive damage they endured. The answer is improving integration, expanding repatriation, creating sovereignty, and providing processes, programs, and services for healing, repairing, reconnecting, and transforming. These remedies are requirements because slavery, damaged Black people in all aspects of life. Therefore, blacks need reparations to stipulate group autonomy, protection, and progress. Blacks are divided, deceived, and in danger, so they should unite around AARS to ask the government for 40 areas of 40 square miles of prime land, in 8 southern states, and in 12 other states with large black populations, to build their own new elite and safe repatriated and sovereign cities, at home and abroad. They never reached equality in America, and the police and supremacist kill them way too often, so they need their own land! **The goals**; spiritual guidance, emergency relief, land for two of the reparations models, and reparative concessions.

Now that we have the ability to generate wealth the government and all the other guilty groups should be quick to endorse and ratify AARS, as reparations for Black people at home and abroad. The strong points are it is a comprehensive plan, victims get justice and satisfaction, and their pride and dignity are restored, by generating their own wealth, and starting to repair damage. It is also motivation to secure genuine and lasting unity among Black people at home and abroad. The U.S. Government and the all the other guilty groups who benefited from slavery in America are offered great relief because they loan \$500B in SF, instead of paying the \$30T up to \$50T that they each owe. Then culprits causing damage abroad should also loan \$500B in SF, instead of paying the \$30T up to \$50T that they each owe! Then people will begin to treat Black people with the due respect that they have earned and deserve. This scenario presents relief for the U.S. Government and all the other guilty groups. Then feelings of joy and happiness will spread within the victims, and among the kind and compassionate.

Rich Black people can open or block \$100M - \$5B cash accounts. The principles are the same, so the programs are safe with compounding returns. We are utilizing this source to generate wealth

- for reparations, because blacks have not reached equality since they were integrated back in the
- 2 60s, and that is a dog gone shame, especially in knowing all that blacks have produced, and
- sacrificed, to benefit America! They thought blacks would reach equality because they would have
- 4 the same education, social status, and equal protection under the law, which whites possess. But
- 5 unfortunately, videos, and studies prove that is not true, so we need action for AARS now!! This
- 6 scenario will lead to justice and satisfaction for all Black people, and racial harmony among all
- 7 nations and races!!!
- 8 I have taught a class to provide a good education on and understanding of Black History, Racism,
- 9 and Reparations. The agenda is on the AAIU and SEEG Service doc on the homepage. Now we
- are focusing on circulating the AARS Executive Summary to get people to read the last 3 docs on
- the homepage, for the KRP, which are the KRP doc, and the AARS Summary and Plan. We plan
- on initiating a Global Civil Rights Movement via the media in the KRP. We hope everybody 18
- and older endorses and promotes AARS, because it includes input from many scholars who studied
- the issue for more than 40 years. They suggest blacks should limit celebrating, prioritize utilizing
- 15 reparations wisely, and planning for the future. They are getting reparations for "crimes against
- humanity, in memory of their ancestors" to reunite, repair, restore, and uplift their people back to
- the safe, spiritual, and progressive status they were in, **prior to colonialism and slavery**. In AARS
- we offer 5-, 50-, and 200-year processes, programs and services to bring this to fruition.
