## ::: AAIU Racism Dialogue and T&R Process

We are forming and registering the African-American Independent Union (AAIU) to unite and organize Black People in America first; and then others should affiliate, to struggle for liberation as we talk to reduce and eventually end racism, and police terrorism. We will have honest AAIU Racism Dialogue until we produce solutions for problems now, and lingering problems that will take time, in the AAIU United States of America Truth and Reconciliation Process (T&R Process).

In order to solve problems created by racism one must recognize it is a social phenomenon that emanates from the host group having power to abuse, exploit, and dominate mainly blacks, in all social and legal practices. That is institutional racism that must be dealt with in the T&R Process.

Racism must be dissected by people who have studied the issue for at least 20 years. It will take a person 10 years to study racism to discover the millions of lies and thousands of tricks that the enemies of equality (EE) have used and perfected for hundreds of years, to subjugate and suppress African-Americans during that time, and until this day. That is racism deeply rooted in their minds.

The terms racism and civil rights should be reserved for blacks in their fight against 500 years of racial oppression, and for 500 years of struggle for racial equality, and for others to acknowledge centuries of Black Suffrage. Others are victims of minor discrimination when comparing Black Suffrage to their groups harm, and for a much shorter period of time. Major assaults and the time period are the facts of racism, that must be dealt with in the AAIU National Dialogue on Racism.

People should know this information to participate in the dialogue. It should be a priority for most people in America to seriously consider joining the AAIU, to utilize and implement the AAIU plan and agenda to reduce and eventually end racism and police brutality.

We have information from professionals and activists who have studied the issues for at least 20 years, and they are ready to help solve these critical problems. We will use the AAIU/SEEG to assess, monitor, and impart means for accountability through rewards for good acts towards humanity, and legal means to guarantee severe and swift punishment for deadly acts against humanity. We are forming both groups for spiritual, political, and legal guidance and action.

It is a blessing to see pro athletes standing for justice and kneeling against injustice. They are using their platforms to bring light to the racism and police brutality issues, and that is a great benefit for all of America. We need them to continue using their platforms for shedding light on the issues, and to support protesting, and we need their help in focusing on forming both groups, to produce our own AAIU Racism Dialogue, with a qualified, rich, and diverse group of those of us who are prepared for this endeavor, to make sure we solve problems, and create a reward and punishment system, that we control. In doing this work we ensure people will be held accountable for their actions. We cannot let the system continue to allow blacks to be killed by the police, and our reactions are limited to crying and protesting. By forming both groups for this purpose, we are

announcing the beginning of monitoring uncivil activity in society, that contributes to the decline of spirituality, or that leads to the police unjustly killing blacks, and to assume accountability.

If an African-American is rich, middle class, has a good job, or is satisfied with living in integration they should remain living as they are in integration. Black People fought the Civil Rights Movement for the right to vote, get equal opportunities, and to stop being brutally killed by the police in integration. So, in essence AAIU Racism Dialogue will lead to peace in America.

{If a black person is poor, and feel emotional torture from not having basic necessities for life, and they feel racism from daily police terrorism in integration, they have a **right** to build and live in safe sovereign cities, because they will own and control all systems and institutions on their own land. Therefore, the police will not have any contact with them, so they won't be able to kill them}.

{If a black person is rich, or well off, but not satisfied living in integration they are more than welcome to live with us in our safe sovereign cities. When we conduct our AAIU Racism Dialogue we will solve problems in integration, and create the **option** for sovereignty for all Black People}.

Enemies of equality will continue to **use** rich, famous, and publicity seeking people, to participate in their racism dialogue **to pacify the people**. The AAIU has guidelines to make sure people are qualified to participate in our AAIU Racism Dialogue, **so we can produce solutions**. A very special thanks to the athletes and all those using their platforms to address racism and police brutality. Now let's start our solution oriented AAIU Racism Dialogue to solve problems caused by racism, discuss sovereignty, and work to implement programs for racial healing.
