::: Overcoming Damage and Divisions by Reuniting and Organizing Blacks then Others for Action

Blacks should take this time to organize their masses with the AAIU and their allies, to get highly educated and qualified people, along with rich and famous people, to agree to or produce the best reparations plan, to solve problems, that were and are created by racism and lingering effects of slavery. African-Americans need a comprehensive plan like the AAIU's AARS Plan of 12 forces and 7 power moves. It will take 50 years to implement to repair the last 500 years of damage.

The worst effects of racism and slavery on African-Americans was how successful its plans were to divide and conquer Blacks; including the Willie Lynch Indoctrination to create small and large divisions, which stem from pitting young Blacks against old Blacks; light Blacks against dark Blacks; field negroes against house negroes; and Black groups against other Black groups. These divisions are a result of racism, lasted for generations, caused great damage, and we never reunited.

Our internal family conflicts and external racist forces which worked to divide and conquer Blacks, took thousands of years to ingrain, and was the oppressors master time piece. They set up rules for ceremonies, inductions, initiations, tattoos, and crossing lines and burning sands for Blacks to join certain groups, which other Blacks could not join, if they did not submit to that Black groups' bylaws. Big group divisions caused much more damage than small personal divisions, even though they both worked, and still work very effectively to serve the same purpose, (Divide and Conquer).

Whether they are Black Christians, Muslims, Jews, Hebrews, Moors, Masons, Eastern Stars, Fraternities, Sororities, Crips, Bloods, Rich, Poor, Democrat, Republican, Leagues, Networks, or Associations; the time has come for all Africans and Black People to say we recognize the divisions we started and/or you tricked us into, have caused great damage to our people, but now we are using those divisions for our benefit, because we will remain in our groups to show we respect our groups, and as a possible way to receive reparations, but most importantly all Blacks should unite around the AARS plan to help overcome the deadly destructive divisions, for the good of our race.

African-Americans/Black People should have organized in a union right after slavery, to prevent and/or deal with sudden yet overwhelming damage they incurred individually and collectively, and to become politically proactive in decisions that would affect their race locally, nationally, and globally. Now Blacks have an opportunity to unite with the AAIU Congress, to overcome that destructive damage they incurred as a divided people, because they were forced into integration, without adequate social standing, or legal or political representation. In reuniting let us mimic Civil Rights Movement (CRM) work, **but** make sure all decisions are made for the benefit of our race.

People should recognize there were and are criminal, population control, and suppressive intentions directed at the Black Family before, during, and ever since slavery. That is racism and that is why it is imperative for Blacks to reunite first around the AARS plan; before inviting others. Black People suffered unimaginable psychological damage on slave ships, of which they must recover from, without interference from others. They were forced to endure displacement, could never as-

similate because of the color of their skin, (which is a big part of the American Dream), and they endured damage that can only be classified as crimes against humanity in slavery, reconstruction, segregation, and now in integration. The AARS Congress will be a nucleus group to gather information and ideas from all people, to repair damage Blacks incurred over the last 500 years.

The Congress is mainly to help Blacks, because they are in the greatest need of help and protection, but they believe allies and others will affiliate with them, after they organize themselves, for the same purpose as the CRM, to address social issues, institutions, mechanisms, and systems, which are preventing Blacks from reaching equality, and allowing the police to continue to kill Blacks, with no accountability. People should realize this is a critical time in history for African-Americans to reunite in order to recover and recuperate from centuries of oppression, and to overcome destructive family divisions by forming the AARS Congress, to prepare for action.

Blacks should create their own curriculum for themselves and everybody else to learn their true history in Americas' Education System, and demand reparations to repair damage and heal slowly.
