- 2 to Repair the Damage Done to Their People:
- 3 {I} Learning about Africa and true Black History before the Roman-European led invasions in

- (2) The Europeans invasions were inspired by economics, environment and the potential of free labor, which resulted in Black Suffrage. A Jewish scholar said epithets and accounts that were not true were written into the ideology of religion by Jews, as Negro phobic language in religious works. - These criminal groups of black people have been used for hundreds of years to mislead and
- 3 perpetuate divisions among the masses of Negroes. It goes all the way back to slavery. African-
- 4 Americans have developed a process to address this level of black-on-black crime in the RULA.
- 5 Any person or group suspected of prolonging or preventing progress in the Reparations Movement
- 6 must be exposed and fed with a long handle spoon. Black people in America, Africa and the
- 7 Diaspora should participate in a similar process to bring justice to blacks wherever they were
- 8 colonized, enslaved and/or exploited. This process shall include self-evaluation because it is time
 - out for white racism and black on black crime in all nations and at any and every level.

African-Americans can utilize the Five Phase Plan to address these three major criminal groups among their people, while focusing on producing a Reparations Package, which should contain solutions for every concern, issue and problem facing their people. They cannot let any attorney, educator, leader or group hold them back. They know they need resources to repair the damages done to their people, and they know those resources should materialize in a collective and individual compensatory manner. This would provide an abundance of resources to improve Integration, create Repatriation and establish Sovereignty as collective compensation, which would be coupled with individual compensation for blacks between 18-34 to receive \$2500 a month and between 35-54 to receive \$5000 a month. Blacks have also began the process of creating culturally reforming and reaffirming programs as they ask for elders of 55 and above to receive a negotiated amount between \$200,000 and \$2,000,000 each. This action represents working towards completing the struggle we left behind in the Civil Rights Movement, which was a national will that began with African-Americans expressing their desire to gain equality. Then the intensity grew as whites, jews and others who admitted blacks were victims of the system joined the movement. The Reparations movement will take the same direction.

1. Explain the spiritual component? It is the most important aspect of Reparations

- a. For Blacks to willingly participate in a personal, family and collective healing process (unity)
- b. For a healing between the races (other races understanding the condition of Black people)

2. Explain the 3 models of Reparations? Blacks choose a model to reside in to find equality (I-R-S)

- c. **Integration** (To improve the integrated communities African-Americans live in today)
- d. **Repatriation** (To build new black communities and relationships in Africa and the Diaspora)
- e. **Sovereignty** (To build new black communities in America and better relations among Blacks)

3. How will Reparations Materialize? To Repair Renew and Revive the Black Family

- f. In a Reparations Package: (Consisting of immediate compromises and long-term goals)
- g. Creating the Reparations Fund: plenty of amenities for the 3 models (Creating 8 regional funds)
- h. Emergency jobs and housing for Blacks from 18-54 (and a settlement for Blacks 55 and older)

4. How can Blacks win Reparations? By learning about and participating in the Five Phase Plan!

- i. Learning the scope of repair should fit the magnitude of the crime. Since we know the damages and injuries were of great proportions and long lasting the compensation must equal that range.
- j. African-Americans have claims as victims of gross civil and human rights violations that include displacement, deculturation, enslavement, segregation and discrimination.
- k. The resources blacks can gain from filing a collective lawsuit and/or pursuing political action for past and present crimes will enable them to heal and prepare themselves to receive reparations with the intent of making the best use of the amenities as described above.
