:: The Reparations Explanation Reparations is a Necessity for African-Americans to Repair Damages by

- (I) Learning about Africa and true Black History before Europeans invasions in 332 BC. Prior to that time Africans advanced the sciences, built the pyramids, and ruled the earth in a Godly manner. Africa and Black people suffered mass devastation and exploitation following 332 BC, which led to many oppressive acts, including the Pope's 325 Partitioning. He asked 7 European nations to stop fighting over resources in Africa, and suggested they partition Africa into 7 parts, for colonial and slavery purposes. Restoring Blacks back to their peaceful status and state of mind, environment, and conditions they were in, prior to invasions requires learning the truth.
- (II) The European invasions were inspired by economics, environment, and the potential of free labor, which resulted in Black Suffrage. A Jewish scholar said epithets and accounts that were not true (pure propaganda), were written into the ideology of religion by Jews, as Negro phobic language in religious works. Though the language was lies, it designated Africans as slaves to Europeans and Jews for thousands of years, yes thousands of years! This caused Black people to endure the worst experience ever perpetrated on any race of people (racism). This was a vicious set of lies and actions that both parties like to refer to as civilizing African people, when they were actually covering up their dirty deeds of slavery, colonialism, and mass murder and rape.

Research proves there were many lies written. According to the honorable Elijah Muhammad's, "Message to the Black Man", African civilizations were on this planet trillions of years before the grafted Europeans, so Europeans could not have civilized Africans. Blacks, Whites, and Jews need to work towards a true understanding of the past, so we can develop open and honest relationships for the future. Black people cannot remain victims of the current capitalist system in their consumer role. They must become producers by fighting hard for their reparations, so that they can establish billion-dollar corporations and institutions featuring the latest technology, for the dual purpose of looking out for the best interest of their people, and participating in local, national, and international commerce. African-Americans can institutionalize that course of action by implementing the African-American Reparations/Sovereignty (AARS) Plan..

(III) Centuries of slavery, colonialism, and suffering caused by the oppressors, created major criminals in the form of agent provocateurs and paid informants among Black people. This is where the mentality of a sellout begins, and you can witness this madness in Black Leadership all over the world, especially in Africa. The Black experience became so depressing and degrading that a criminal group of Black people developed within their race. They had desires to live free of this legacy of bigotry and hatred, with no regard for the consequences. This group includes Blacks who tried to pass as Whites if they were light enough, over to the most dangerous Blacks who use their political positions to get money, instead of helping their people, and they still exist today. They are those who are (brainwashed), who think Whites and Jews or others should rule them. They are those (sellouts), who let others dictate their voice and votes on issues and laws, and they also include those (conspirators), who are in cahoots with others to

subvert black progress, and worst of all to water the Reparations Movement down to more lies, delays, and denial. These Black criminals are the House Negroes who are working in sin with opponents of Black Progress and Reparations, to determine if Blacks should get reparations. It is going on right now but Blacks should not let this happen. They should expose all of those individuals and groups participating in that nonsense in the AAIU Reparations Tribunal. They should deal with Black race traitors and sell outs just like America deals with those found guilty of high treason, technical espionage, or breaching national security.

These criminal groups of Black people have been used for hundreds of years to mislead, and perpetuate divisions among the masses of negroes. It goes all the way back to the invasions. African-Americans should use the Tribunal to address this level of black-on-black crime. Any Black person or group suspected of prolonging or preventing progress in the Reparations Movement must be exposed and dealt with accordingly. Black people in America, Africa and in the Diaspora should participate in a similar process to bring justice to Blacks, wherever they were colonized, enslaved, and/or exploited. This process shall include self-evaluation because it is time out for white racism, and black on black crime, in all nations, and at any and all levels.

African-Americans can utilize the AARS Plan to address these three major criminal groups among Black people, while focusing on getting supporters for the AARS Plan, which should contain solutions for all concerns, issues, and problems. They cannot let any attorney, educator, leader, or group hold them back. All Black people should know they need resources to repair the wide range of damages done to their people, and they know those resources should materialize with collective and individual compensation. This would provide an abundance of resources to improve integration, expand repatriation, and create sovereignty as collective compensation, which would be coupled with individual compensation. Blacks should also get military training to help build, maintain, and protect their own new elite, and safe repatriated and sovereign cities.

(IV) Blacks have also programmed the process of creating cultural and family transforming and reaffirming programs, as they ask for all Blacks to receive 2M each on 12-1-22. This action is working to complete the struggle they left behind in the Civil Rights Movement, which was a national effort that began with African-Americans acting in their desire to confront and slowly diminish racism and police terrorism, and to gain full equality. Then the movement intensity grew when Whites, Jews, and others who admitted Blacks were victims of racism and constant harassment, joined the movement. The Reparations Movement will rise up in the same manner.

- a. For Blacks to willingly participate in a personal, family, or collective healing process with religious and/or spiritual materials of black theology to admit they have, and need to release built up anxiety & trauma from over 2000 years of abuse, (psychological damage).
- b. For a healing process with other races, (for other races to admit/agree Blacks need help).

2. Explain the 3 Models of Reparations so Blacks can Choose where they prefer to Live

- c. **Integration**: To improve the integrated communities African-Americans live in today, with case studies and dialogue, and strive for better relations with Whites, Jews, and all others.
- d. **Repatriation**: To build new elite, beautiful, and safe repatriated cities, and better relations within our extended family in Africa, and the Diaspora where Blacks were enslaved or exploited.
- e. **Sovereignty**: For Blacks to get their own land and form their own government, to build their own new, elite, beautiful, and safe all black sovereign cities in America, get emotional therapy, improve relations within the Black Family & expose all race traitors and sell out groups.

3. How will Reparations Materialize? Repairing and Rebuilding the Black Family

- f. With AARS posing immediate individual emergency relief payouts (\$2M on 12-1-22), and long-term goals for collective compensation, to build safe repatriated and sovereign cities.
- g. Building the AARS account to amass wealth and prescribe plenty of amenities for all 3 models, and creating 10 regional governing bodies, 2 for repatriation and 8 for sovereignty.
- h. Emergency jobs and housing for Blacks from 18-54 for personal relief, in the process to start training to learn how to build, maintain, and protect their new, elite and beautiful safe cities.

4. How can Blacks demand Reparations? By Learning about and Utilizing the AARS Plan!

- i. Learning the scope of repair should fit the magnitude of the crime. Since we know the damages and injuries encountered were of great proportions, and long-lasting suffrage, the compensation must equal that range, just like the punishment should fit the crime.
- j. African-Americans have reparations claims as victims of long term gross civil and human rights violations, which include but are not limited to racism, oppression, abuse, displacement, deculturation, colonialism, enslavement, reconstruction, segregation, integration, discrimination, and now viruses. These crimes have occurred since the 332 invasions, so yes reparations are way past long overdue, and is a \$200T debt. Blacks in Africa, America, and the Diaspora have been abused via invasions, colonialism, imperialism, and slavery, so they need AARS now.
- k. The resources Blacks will gain from filing a collective lawsuit and/or pursuing AARS legal and political action for past and present crimes, will enable them to heal among themselves, and with others, and prepare them to receive reparations with the intent of limiting celebrating, and making the best use of the resources.

Reparations History:

MAAFA or MAAGAMIZI – Are terms coined by Black scholars to expose and document the intentional crimes and devastation committed against Africa and Black people, in Africa, throughout the Diaspora, and in America for over 2000 years!

Biblical Perspective - Discussing principles of restitution throughout the bible, and studying religion and spirituality as a means for therapy in venting, releasing, and healing.

Early Slavery – Many unearned and multiple unjust benefits, gains, and wealth for enslavers, and perpetual overwhelming psychological, economic, and social damage inflicted upon slaves.

Israel and Jews - Israel gets billions of dollars annually because everyone feels sorry for Jews as victims of the holocaust, and rightfully so, but research reveals they enslaved Blacks, made huge unjust gains in wealth, and subjected them to inhumane treatment. They owe Blacks \$55T for starting, institutionalizing, and expanding slavery. Tell them to send it to the AARS account.

Emancipation Proclamation - Supposedly meant to free the slaves, but in reality it was submitted to save the union, and all U.S. slaves were not freed until the 13th amendment in 1865.

Reconstruction – The time following slavery meant to rebuild the war torn south, and provide opportunities for x-slaves to get land, along with freedom, and the rights of all citizens. **LOL**

Captain Paul Cuffee - A businessman, merchant, and political activist who was the first African-American to call for repatriation. He worked to repatriate Blacks back to Africa for good reasons, and in a civilized manner.

Sista Callie House - Formed the first national organization for reparations. It was called the Ex-Slave Mutual Bounty and Pension Association, whose purpose was to see that those who had worked into old age in slavery, would receive some type of compensation for their work.

Queen Mother Moore - Her family experienced severe racism inspiring her to live a life of 77 years in the struggle. The state of New York submitted a Reparations Bill in her honor acknowledging her contributions to the Reparations Movement.

Segregation - Jim Crow laws that legalized separate but equal on the surface, but in reality it was even worse, it was used as a means to further subjugate and oppress Blacks via institutional racism.

The Kerner Commission Report - President Lyndon B. Johnson formed a group to investigate causes for civil unrest spreading across the nation, after Dr. King's assassination, that effectively. violently, and abruptly ended the Civil Rights Movement, to recommend solutions. <u>It determined racism and discrimination persisted</u>, and that there was a great need for national reform in housing, employment, health care, and education, which were ignored, but are desperately and still needed for Blacks to reach equality in integration!

The Black Manifesto - A document that declared various religious institutions played a role in the enslavement of Blacks, and received great benefits, and that it was their responsibility to repair the damage through reparations. That should and definitely still applies today.

Lawsuits and Legal Strategies - It is important for African-Americans to know forming a <u>legal strategy</u> to file a reparations lawsuit is a critical part of winning the case. A lawsuit would work well with support of the masses, but we will include selective buying and national boycotts, along with political and national action via AARS, in addition to hosting congressional and

townhall debates, to apply serious pressure. These are the factors that would constitute a massive campaign to win reparations. Let's get busy in memory of our ancestors!!

Reparations Action - Noted events and people who contributed to and promoted reparations activity, education service, programs, and movement.
