

1 **REPARATIONS** - We know some culprits profited much more than others, but we
2 expect all culprits to pay their debt from their economy and reserves, and by
3 participating in programs, to generate wealth to provide AARS reparations for Africa,
4 African-Americans, and all Black People. AARS also offers an incentive for culprits
5 to share the profits, in order to facilitate truth and reconciliation with all nations and
6 races, who endorse, support, and promote AARS. **African-Americans and all**
7 **Blacks in the U.S. 18 and Older should take the AAIU BPV**; electronically on this
8 website; then all Black People abroad. {{The AAIU teaches people
9 that land, liberation, freedom, improving integration, expanding repatriation,
10 and creating sovereignty; are the only fair and just solutions for problems caused
11 by invasions, colonialism, the middle passage, slavery, lynching, and segregation}}.

13 {{African-Americans and all Black People need spiritual guidance to self-actualize,
14 by coping with ailments and vices which prevent reaching top mental and physical
15 shape, to become the best person possible. We also use AARS to promote spiritual
16 guidance to strive for unity at home and abroad; to use and create economic programs
17 to generate wealth to close the wealth disparity gap; and to get government land
18 grants to build new, elite, and safe cities at home and abroad}}.

20 **People should learn and realize that Africans were severely impacted**
21 **physiologically, emotionally, mentally, and psychologically**, which was caused by
22 losing their homeland, families, culture, heritage, identity, values and traditions. No
23 other groups had to face and withstand so much evil, hurt, intent, malice, and pain
24 and suffering, over such a long period of time. So, **Africans encountered a series of**
25 **serious disasters** causing them to experience and endure many major losses,
26 including displacement; so, recovery, repair, reforming, and transforming programs,
27 are critical and crucial which AARS offers.

29 **The AAIU and Their Allies Will Form the AARS CONGRESS as a POWER**
30 **BASE to IMPLEMENT AARS.** The AARS Congress will host **5-year case**
31 **studies** on institutional racism, and also host **5-year programs for racism**
32 **dialogue** focusing on police terrorism, to help slowly dissolve and eventually end
33 racism and police terrorism. AARS will help Black People to improve integration,
34 expand repatriation, and create sovereignty, so AARS is a reparations solution that
35 should be accepted and appreciated by all culprits and victims of colonialism and
36 slavery. Now, it is futile, redundant, and **government corruption**, to continue to try

1 to produce or write any more reparations plans, because there are already too many
2 to choose from. {{Trying to produce or write more reparations plans will only **cause**
3 **confusion, delay justice, and may even diminish aid, amenities, and other vital**
4 **resources, which were earned, well deserved, much needed, and long**
5 **overdue, to repair all the damage and ensure justice and satisfaction for the victims}}**.

7 **SO PLEASE DO NOT WRITE ANY MORE REPARATIONS PLANS - USE**
8 **THE AAIU BPV TO CLAIM AARS or TO WRITE THE NAME OF THE**
9 **REPARATIONS PLAN YOU PREFER - ON AND AT THE END OF THE**
10 **BPV}}**. African-Americans and all Black People should get therapy and treatments
11 for mental illness, emotional trauma, and/or psychological injuries because of racism.
12 So, most of them have **Subdued Emotional Trauma and/or Latent Psychological**
13 **Damage**, due to experiencing major losses, and excessive cruelty and brutality from
14 racism. That led to a life of misery, pain, and suffering for Africans, African-
15 Americans, and all Black People, right here in America and globally!

17 So, Africa, African-Americans, and all Black People should get AARS reparations
18 ASAP! for **enduring crimes against humanity!!** It is very important for everyone
19 to learn and understand, **that no African-American or any black person, should**
20 **have to prove anything to get reparations.** The damage done to Africa and Black
21 People is too great for any proof to be required to receive reparations. {{The AARS
22 Congress will eliminate all that irrational thinking, and **establish easy and**
23 **reasonable ways for all blacks to qualify,** and be sure to provide reparations for
24 Africa, African-Americans, and all Black People, and promote truth and
25 reconciliation with all others who endorse and promote AARS}}.

27 **THE AARS CONGRESS Will BECOME an INSTITUTION to LAST**
28 **FOREVER.** AARS will work to guarantee transparency, so that all of Africa, all
29 African-Americans, and all Black People will benefit from AARS reparations. ***}}***
30 ***The Mass Media Should use Their Platforms, to Host AARS Dialogue via the KRP as***
31 ***a Public Service Announcement and Commitment}}***. {{There is no way people
32 should discuss reparations in secret behind closed doors, then claim success with no
33 written account or report for proof! But that is the kind of **Corruption** that is Going
34 on **In the Reparations Arena}}**!! That is wrong, repugnant, and repulsive, so we
35 should demand an end to those secret meetings and discuss reparations in public via
