TERMS AND CONDITIONS

Warranty

Rapid Business Services undertakes to pass on to the Customer any transferable warranties received from the manufacturer of the products sold. Apart from these, Rapid Business Services makes no other warranties, whether express or implied, regarding the Products. Specifically, Rapid Business Services does not warrant the merchantability of the Products, their suitability for any particular purpose or use, or their non-infringement.

In the event of any liability arising from the sale of products to the Customer, Rapid Business Services' liability is expressly limited to either: (1) Refunding the purchase price paid by the Customer for such products (without interest), or (2) Repairing and/or replacing such products, at Rapid Business Services' discretion. These remedies are exclusive and replace all others. The Customer must notify Rapid Business Services of any defective product within 30 days from the date of shipment. This warranty supersedes all other warranties, whether oral, written, express, implied, or statutory. Implied warranties of fitness for a particular purpose and merchantability are specifically excluded and do not apply. Customer's obligations and Rapid Business Services' remedies regarding defective or nonconforming products are solely as stated herein. Furthermore, no warranty shall apply if the Product has been subject to misuse, static discharge, neglect, accident, modification, or alteration in any way.

Limitation of Liability

Rapid Business Services shall not be liable for any special, incidental, or consequential damages of any kind, including but not limited to damages resulting from loss of profit or revenue, recall costs, claims for service interruptions, failure to supply downtime, testing, installations, or removal costs, costs of substitute products, property damage, personal injury, death, or legal expenses.
