Seller Representations and Limited Warranty
The seller represents that:
(a) The puppy has been examined by a licensed Veterinarian and was found to be in good health; the puppy will/was wormed, given first set of puppy vaccinations, on a 30 day heart worm preventative, and puppy is guaranteed to be in excellent health when the puppy leaves seller's premises.
(b) This puppy is being sold as a pet
and companion animal.  (c) Reasonable precautions have been taken to prevent this puppy from acquiring hereditary defects of the hips, elbows, eyes, and heart.  However due to hereditary and environmental causes of such defects no guarantee will be given against them.
Sellers Limited Warranty
Seller hereby warrants only the following:
Should the puppy being purchased under this
agreement be diagnosed by a board certified

specialist as being affected by hereditary defects

of the hips, elbows, eyes, and/or the heart, the Seller at the Seller's sole discretion will take the puppy back and replace it with a puppy from another breeding, so long as said diagnoses and request for replacement happens on or before the puppies 1st birthday. The original puppy must be returned to me (at Buyer's expense) before a new puppy can be delivered. The Buyer is responsible for any shipping fees for the replacement puppy. In the event of death, an autopsy must be performed at Buyer's expense by a licensed veterinarian to determine the exact cause of death. The report from the autopsy must be sent to Seller's attending veterinarian for review.

Validation of this guarantee requires examination of the puppy by the veterinarian of Buyer's choice within 72 hours of the day the Buyer takes possession of the puppy. If the puppy is returned due to illness a verified letter from the veterinarian is required. This includes death or illness from any health condition deemed present prior to removal from Seller's premisses. This does not cover coccídía, giardía, or hypoglycemía. These conditions are common in puppies and can be easily treated. Please make sure to use caution and DO NOT take your puppy into yards, pet stores, or other areas where unknown dogs are present until your puppy has completed their puppy vaccinations. Exposing your puppy to unknown dogs who may be sick or not fully vaccinated can jeopardize the health of your puppy until vaccinations are completed. (usually 16 weeks)

You the buyer agree that said dog will be given proper medical care including, but not limited to vaccinations, annual boosters, regular deworming, adequate and high standard of shade and housing in a fenced yard of kennel. That Buyer will groom, train, and care for this puppy in a manner consistent with high quality husbandry practices.

You agree this dog will NEVER be surrendered to any humane society, animal rescue group, animal shelter, or re homed in any way. Seller will accept any dog that is unable to be cared for and Seller will take ownership of possession of, and responsibility for any such puppy/dog previously purchased from Cowboys § Angels.
This limited warranty is given only to the original purchaser of the puppy sold under this agreement. This limited warranty is only given on the puppy/dog purchased under this agreement.
This contract contains the entire agreement between parties and no statement, promises, or inducements made by either party that is not contained in the written contract shall be valid or binding. This contract may not be modified or altered except in writing signed by both parties and endorsed herein.
