1 DESCRIPTION OF ACTIVITIES

1.1 Introduction

FI Joint Venture Pty Ltd (FIJV) were granted approval under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) (EPBC 2017/8124) to develop the Yogi Magnetite Project (the Project), which is located approximately 225 km east-northeast of Geraldton and 15 km northeast of Yalgoo in the Mid-West region of Western Australia (WA). The approved Action details are presented in Table 1-1 below.

This Annual Compliance Report (ACR) has been prepared in accordance with the Department of Climate Change, Energy, the Environment and Water (DCCEEW) Annual Compliance Report Guidelines (Commonwealth of Australia, 2023) and aligns with the requirements of EPBC 2017/8124.

This ACR covers the reporting period from 23 December 2024 to 23 December 2025 (reporting period) and will be published on the FIJV website within 20 business days after the end of the reporting period.

This ACR demonstrates compliance with the conditions of approval EPBC 2017/8124 under the *Environment Protection and Biodiversity Conservation Act 1999* (EPBC Act) for the Project.

The person accepting responsibility for the report is Mr. Seyed Reza Azimi (Managing Director), with the signed declaration provided above.

1.2 Current Status

Commencement of the action has yet to occur as the Project remained in the pre-construction phase during the reporting period. No mining-related disturbance, operational activities, or rehabilitation have occurred during the reporting period.

No major issues arose during the reporting period. Key milestones included:

- Submission and approval of the Project Environmental Management Plan (EMP).
- Continued with baseline groundwater monitoring.
- Additional environmental assessments finalised over the broader mine area, including Flora and Vegetation and a Level 1 and Targeted Fauna Assessment.

A Section 46 of the *Environmental Protection Act 1986* request from the Minister for Environment to undertake inquiries into changing implementation conditions was initiated during the reporting period which is currently under assessment. The Amendment requested is to: *change the implementation conditions relating to greenhouse gas emissions in the Ministerial Statements that apply to the 20 approved proposals identified by the Minister for Environment.*

2 COMPLIANCE

2.1 Compliance With Approval Conditions

All conditions of EPBC 2017/8124 have been considered and complied with during the reporting period, as outlined in the EPBC Approval Conditions Compliance Table provided as Appendix A. No non compliances have been reported for the Western Australian Approval.

2.2 Non-compliances and Corrective Actions

No non-compliances or potential non-compliances were identified during the reporting period, therefore no corrective or preventative actions were required. Any future non-compliances will be reported in accordance with the EPBC 2017/8124 conditions and FIJV will notify DCCEEW electronically within 2 business days of becoming aware of the incident and provide details of the incident in writing within 12 business days of becoming aware of the incident.

3 NEW ENVIRONMENTAL RISKS

No new environmental risks became apparent during the reporting period.

4 OTHER INFORMATION

4.1 Monitoring

Monitoring will align with the commitments outlined in the approved Project Environmental Management Plan (EMP). Monitoring will focus on key environmental factors, including flora and vegetation and terrestrial fauna, using tools such as GIS databases, inspection records, and registers to track baseline trends and detect changes. Planned monitoring activities are detailed in the following sections.

4.1.1 Flora and Vegetation

Post-clearing surveys will be conducted as required following the completion of scheduled clearing works. This will be supported by quarterly internal reviews of ground disturbance records and GIS disturbance databases, along with annual vegetation health assessments conducted during Spring (September–November). In addition, weed monitoring and control programs will be implemented biannually, with at least one session during the growing season to evaluate diversity and abundance. Vehicle and plant hygiene records will also be reviewed prior to any equipment arriving on site.

4.1.2 Terrestrial Fauna

Fauna sightings and deaths will be documented in the fauna register as they occur during construction and operations. These records will be supplemented by quarterly reviews of ground disturbance records and GIS databases, as well as monthly environmental compliance inspections. Feral pest control programs will be carried out at least annually, while trench inspections will take place twice daily during construction to identify and safely remove any trapped fauna.

4.2 Research

No research or trials were planned or implemented during the reporting period.
