
Can Ferguson Hide his Record on Crime and Become Governor of Washington?



Why Bob Ferguson's Record on Crime Shows a Lack of Concern for Washington State

Washington State has faced a growing crisis of crime, particularly in retail theft, under the leadership of Attorney General Bob Ferguson. Late and Ineffective Action: It wasn't until 2023—after nearly a decade in office—that Ferguson established the Organized Retail Crime Unit. This move, though necessary, came far too late and has yielded minimal results. The most notable prosecution during his tenure was the conviction of Shawn Nanez, who stole \$145,000 worth of merchandise. This single case is insignificant compared to the billions lost during Ferguson's time in office.

Kept Secret the attempt to invalidate all the initiatives: Go Washington has been the group to collect the required signatures for the initiatives. Bob Ferguson was the only top five Gubernatorial candidate who was against the capital gains tax initiative. On August 9th, Go Washington received a call that the group headed by Bill Gates and Steve Ballmer had filed to invalidate all the initiatives. They were not notified that this suit existed until it was in front of a judge. This deceitful move to invalidate several hundred thousand citizen signatures, and to not notify the main stakeholders that they were being challenged, was an example of political foul play. The Attorney General knew about the lawsuit and chose not to inform Go Washington. This was a very sneaky underhanded non-action on his part. Thankfully the judge ruled that the signatures were legal, and the initiatives will proceed to the ballot. It is scary to think that we live in a state where two billionaires can use legal trickery to try to invalidate the will of the citizens. They get an assist Bob Ferguson, by hiding the suit from the stakeholders.

While serving in Congress, Reichert voted to allow abortions up to 20 weeks and beyond in cases of rape, incest, or when the mother's life is at risk. This is similar to Washington law, except Washington allows abortion up to 24 weeks.

Some recent advertisements by the Ferguson campaign have inaccurately addressed the facts suggesting that Reichert's voting record is an attack on women's reproductive rights. However, this misrepresentation of the facts is an attempt to divert attention from the pressing issues facing Washington today, including the challenges that have arisen during Attorney General Bob Ferguson's 12 year tenure as Attorney General.
