## LEASING GUIDELINES GULFVIEW POINTE HOMEOWNERS ASSOCIATION, INC.

The purpose of these Leasing Guidelines and the Unit Use Notification Form is to ensure that every prospective tenant is aware of our community goals before signing a lease and to ensure that all tenants understand their responsibilities as set forth in the Homeowner Association governing documents and rules and regulations of the community. No lease can be approved prior to these forms being signed by the owners or the owner's agent and the prospective tenant. The HOA or its representative will review the forms for accuracy and for any potential conflict with the HOA governing documents and rules and regulations. The HOA or its representative will approve the forms and return it to the owner or owner's agent. Only upon completion of this process can the owner or owner's agent be permitted to provide the prospective tenant access to the community.

#### Occupancy Limits:

- 2 bedrooms may be approved for up to 6 persons
- 3 or 4 bedroom units may be approved for up to 8 persons
- Occupancy over these limits will result in termination of lease.

#### Pets:

- Pet registration Form must be submitted with lease approval form.
- No more than 2 pets per unit without special HOA permission.

#### Noise:

- Loud disruptive noise cannot be tolerated at any time. The privacy, peace and enjoyment of all of our residents are protected by the HOA.
- Loud amplified music is not allowed on outside deck of the house. Music
  must be kept at a volume that does not interfere with your neighbor's right
  to tranquility.
- Profanity or offensive behavior on common grounds or deck area is not tolerated.

#### Rules and Regulations:

The Unit Use Notification is not a substitute for the owner/landlord's independent responsibility to provide the tenant with a full set of rules and regulations of the HOA. By signing this form the owner or agent and the tenant acknowledge that the tenant has received and read a full set of the rules and regulations and agrees to be bound by them and to cause all of their guests and invitees to equally observe them.

Additionally, each owner or agent is required to keep posted in plain view within the unit a summary of operating procedures (Operations Notice) provided by the HOA. The Operations Notice provides the owner or owner's agent name and phone number to be contacted in an emergency or for any other problem.

The owner or owner's agent agree that a tenant may be evicted by the HOA after two notices in writing to the owner or their agent of violations of the rules and regulations or after one instance of excessively disruptive or abusive behavior as determined by the

HOA in its sole and good faith discretion. The owner or owner's agent additionally acknowledge that the owner can be subject to fines and/or damage assessments which may be caused by owner's tenant for violation of the HOA governing documents or rules and regulations. The owner may additionally be charged for any damage to property owned by the Association or for reimbursement for expenditures made on behalf of the Association for enforcement of the governing documents or rules and regulations of the HOA.

The owner or owner's agent acknowledge and agree by either of their signatures below that the HOA has the right of eviction of owner's tenant.
