#### What you are purchasing:

This is an AUTOMATICALLY RENEWING HOUSEHOLD-BASED MEMBERSHIP. It allows your household and if applicable a guardian/nanny pass to use the pool during swim season, use of the tennis courts & clubhouse rental throughout the year. For the rentals you will need to go through the clubhouse manager to arrange dates, times, and payments.

### To purchase a Hunters Creek Swim & Racquet Club Membership:

You need to read and be familiar with the By-Laws which have the rules and regulations for your membership, the Pool & Tennis Court Rules, and the Guest Pass Policy. These files are located on our website under the membership tab.

Complete this purchase form and email it to the Membership Manager (MM) for the fastest results. Once the form is received by the MM you will receive a confirmation email with a copy of the completed form for your records that has your newly issued Membership Number. Please keep this somewhere for later reference.

Additionally you will need to make a purchase payment of \$200 along with the current years annual dues. This payment can also be completed Online on the HCSRC website under Online payments tab. Once payment is received the MM will send a separate confirmation email about your membership status.

You will need to set-up a date & time to pick up your passes and if requested, tennis court key from the Membership Manager. This too will be handled by email.

Annual Dues are required to be paid every year by 5/1.

**To surrender/cancel or sell your Hunters Creek Swim & Racquet Club Membership:** If you wish to surrender/cancel your membership, it can *only be done between 8/30 and 11/30 of the fiscal year and only if you are a member in good standing*. Otherwise it is <u>your responsibility to find a buyer</u> of your membership. Further details about the sale and surrender process can be found in the By-Laws. Please bear this in mind when moving out of the area.
