

CAMPGROUND RULES

To ensure a good camping experience and the safety of all guests please adhere to the following:

- Speed limit in the campground is 5 mph and strictly enforced! Only one warning will be given without consequence. Please watch out for children and pets!
- Quiet time is from 10 pm to 8 am. No excessive noise during these hours. All radios and outdoor TV's must be turned off. Refrain from loud activities including loud conversations. Noise at anytime must not be bothersome to your neighboring campers. If you must be asked to be quiet after 10 pm more than once you will be asked to leave without a refund.
- All ATV's must be back in camp and at your site with engines off by 10pm
- ATV's must be kept on site and only used for trail riding or going to the store for purchases. Please do not ride ATV's to the pool. No riding out of camp before 8 am.
- Drunk or disorderly conduct may be grounds for immediate expulsion from the campground without a refund. Law enforcement will be called as necessary.
- The trash dumpster is located across from site 30. The dumpster is to be used for daily household trash only! Do not throw lawn chairs, tents, tires, or other large items in the dumpster. Please take them home with you for disposal.
- Do not litter in the campground. Do not throw cigarette butts on the ground! Do not litter on the ATV trails. 90% of the ATV trails are on private property. Please respect the landowners who grant you permission to ride on their property! Leave the campground and trails as clean as you find them.
- For safety reasons do not leave food or trash outside of your RV. Leaving trash or food outside can attract wild animals including bears!
- Swimming is at your own risk. There is no lifeguard on duty. Children 13 and younger must be accompanied by a parent or an adult 21 years of age or older while in the pool area. Swim diapers are required for children who are not toilet trained. Food is not allowed in the pool area. Drinks in plastic or aluminum cans are allowed. Pool hours are 9 am to dusk. Only registered Big Rock Campers and their paying guests may use the pool. No smoking in or near the pool area.
- Pets: All campers must provide a current rabies certificate at time of check in. Pets MUST be kept on a leash or tie out not longer than 6 feet at all times. Pets are never to be left unattended when outside. All pet waste is to be picked up immediately and disposed of in the trash. Pet waste is not to be flushed in toilets or buried. Owners are responsible for any personal injury or property damage caused by their pets. Any pet deemed a nuisance will not be allowed to remain in the campground. No refunds will be given.
- Bathrooms are to be used for their intended purpose only. Do not flush anything besides toilet paper in the toilets; this includes baby and adult wet wipes! Sanitary pads and tampons should be wrapped and disposed of in the trash can. Please do not enter showers with muddy clothes on. Do not use sinks or showers to wash excess mud off clothing.

- Laundry room is located in the back side of the store. Coin operated. Rinse heavy mud off clothing before using the washing machine. The dryer is for clean, washed clothing only. There is a sink located in the laundry room area for our cabin guests to wash dishes. Please do not dump grease down the sink drain.

- NH state law prohibits the use of reverse flush valves at camp site sewer connections. If you need to use this type of flush valve you may do so at the dump station near the store. Examples of a reverse flush valve is Hydro-flush, Flush King, and RV Dual Flush. Using these types of valves at sites can result in back flow of contaminated water into the campground freshwater system.

- Firewood cannot be brought to the campground from out of state per NH state law. Firewood must be purchased at the campground unless you have purchased packaged kiln dried firewood and have a receipt to show at check in. No pallets or pressure treated wood is to be used in the fire rings. Do not cut trees or limbs for firewood.

- Campfires must never be left unattended. Campfires should be kept at a height of about 2 feet or less. Do not burn trash in the fire pits. Store firewood at least 3 feet away from the fire. Do not use gasoline or lighter fluid on fires. Do not move the fire rings. Fires must be extinguished by midnight.

- Please turn off your vehicle engine while parked outside of the office

- No use of Firearms in the campground. This includes BB guns, pellet, guns, or paintball guns.

- No fireworks of any kind are allowed to be used in the campground. If you are found lighting off fireworks you will be asked to leave the campground immediately without a refund.

- Check out time is 11 am unless you have arranged a late check out with the office.

- Children 17 and younger are not allowed to ride their ATVs in the campground except to access the ATV trail. Children 17 and younger MUST have a helmet on ANYTIME they are on an ATV and be accompanied by a licensed adult.

- The playground closes at dark. Please make sure your children are back at your site by dark. After dark children 12 and younger must be escorted by an adult when they are off of your site.

- For insurance purposes ALL guests and visitors MUST register in the campground office prior to proceeding to any site. Guests and visitors need to have a vehicle pass to enter the campground and are subject to daily use or overnight fees. Guests visiting for the day are NOT allowed to bring their ATVs to the campground or use the campground trail access without prior permission from the office. There is a free parking area 5 miles north of the campground (Burn's Field) where you can meet your guests to ride for the day. Visitors who ride their ATVs to Big Rock from other campgrounds or lodges still must register in the office.
