**Guest Speakers:** Sgt. Gregg Johnson, Captain Lissette Quintero Captain Lissette Quintero: Traffic unit was dispatched, and he was not received with welcome. Encountered resistance and bullied. Strive to keep the community safe. Will not share the actual party involved.

Gregg Johnson: Stop sign violations, Children driving golf carts recklessly, Speeding, alcohol being used by children. Perception is that it is a "free for all," particularly on holiday weekends.

Child was given car keys by parent, speeding and crashing into a golf cart. If juveniles are found in possession of alcohol, they will be issued juvenile citations, be seen by a Judge, the parents will have to sign or take them there. The laws apply everywhere. Parents need to ensure their children are safe and abiding by the law. Tickets, arrests, juvenile citations, notice to appear will be issued. The laws will be enforced. Driving a Golf Cart under the age of 18 you must have a driver's license. Eighteen and over you just need some type of identification. Hours of operation are sunrise to sunset. On the fourth of July will be one Officer roaming, the others will be at the beach checking for trespassers, underage drinking, violation of the 300 foot no boating rule. If you see a violation, call the non-emergency number and if available dispatch will send additional officer.

Is a no Trespassing sign needed? Not necessary, call and report. Must be in the presence of the officer for an arrest. Consult your insurance company regarding your liability for an accident under these circumstances. Posting a lighted sign stating climb at your own risk might limit activity.

President Oscar: Lack of Parental control. Repeat juvenile offenders. Keep giving breaks to these kids needs to stop. They cannot be drinking beer, stealing fruit from trees, trespassing on private property, checking for locked doors and car doors. Architectural Control Committee: Martin Pico, Chair Any new business of the ACC.

ACC Meeting - a meeting will be scheduled next week.

Legal and Communications: Martin Pico, Chair: none.

Recreation Committee: Ricky Lopez: Chair. No report. Maintenance:

- Beach gate hinges have been received and are to be installed asap. Magnet not working, replace also.
- JC Pernas comments that there are BBQ grills that need to be replaced. Mari Joiner, CAM will get a count and order them.
- Replace the breaker box entirely for cameras and gate software. A temporary fix
  of 2 new breakers will just keep us running but the rust and corrosion in the box
  is extensive. It is just a matter of time until we lose power to the system. We
  both recommend that this be done by a licensed electrician because of the
  liability. The probable cost will be at least \$2,000, maybe more. Board approval
  requested by Richard and Rita, after the fiberoptic line was added to the box.
  - Oscar Callejas made a motion to approve the replacement of the electrical box housing the internet hardware. Richard Wielandt seconded the motion, all in favor, none opposed, the motion carried. Rita will obtain estimates by licensed insured contractors.
- Another camera facing the gate from inside the beach access. This will not only need an additional camera, but pvc piping as well. We were unable to get a good shot of the faces of the kids that have damaged the gate, this camera will allow us to capture the images clearly of anyone creating damage. The cost will be less than \$300.00.
  - Oscar Callejas made a motion to add an additional camera at the beach entrance to capture anyone doing damage to the gate. Martin Pico seconded the motion, all in favor, none opposed, motion carried.
  - Rita Klopf and Oscar Callejas thank Richard Wielandt for all his work on the camera system and working with Mari Joiner, CAM to maintain the computer connection to the box.

- Ricky Lopez addresses the erosion situation on the beach. He will volunteer his bobcat equipment to spread the already existing piles of sand to fill the areas. Oscar Callejas and Larry Coraggio will check with the Village to let them know that this is not a new sand delivery to ensure it will be covered by the already existing permit.
- Richard Wielandt suggested that the addition of more tables on the beach before the 4<sup>th</sup> of July holiday would be advantageous. He suggested concrete, but that might involve permitting. Oscar Callejas suggests additional wooden ones. Oscar Callejas will contact the vendor that delivered the last tables.
