ORDINANCE NO. 12/3/8

AN ORDINANCE CREATING THE OFFICE OF TOWN MARSHAL

WHEREAS, the Town Council of the Town of Lewisville, Indiana, desires to retain the service of a Town Marshal on a part-time basis in order to provide security to the citizens of the Town; and

WHEREAS, Indiana Code 36-5-7-1 provides that all towns that have not abolished the office of Town Marshal may proceed to appoint an individual to perform the services of Town Marshal, fix his compensation and his duties; and

WHEREAS, the Town of Lewisville, Indiana, has never abolished the office of Town Marshal; and

WHEREAS, the Town Council of the Town of Lewisville, Indiana, believes that the appointment of a Town Marshal to be in the best interest of the health, safety, and welfare of the citizens of Lewisville, Indiana.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council of the Town of Lewisville, Indiana, as follows:

SECTION I

The office of Town Marshal of Lewisville, Indiana, is hereby created and established pursuant to Indiana Code 36-5-7-1 et seq.

SECTION II

The Town Marshal of Lewisville, Indiana, shall have the powers and duties as set forth in Indiana Code 36-5-7-4.

SECTION III

The Town Council of the Town of Lewisville, Indiana, shall establish the compensation for services rendered by the Town Marshal annually by way of contract and/or inclusion within the Lewisville salary ordinance for the year in question.

SECTION IV

This Ordinance shall be in full force and effect from and after its passage and due publication.

SECTION V

Introduced and filed on the 13th day of December, 2018. A motion to consider on first reading on the day of introduction was offered and sustained by a vote of _____ in favor and _____ opposed pursuant to I.C. 36-5-2-9.8.
