Richard Craig made a motion to approve the fence permit on the property at 201 N First, owned by Joseph Zita. Motion passed 3-0.

Richard Craig made a motion to approve the purchase of a John Deere Z907R, 72" deck mower not to exceed \$13,000.00, only after the Clerk Treasurer has a secure means to pay for mower. (either through a loan with Citizen State Bank or Town funding) This motion passed 3-0.

Monica Altman made a motion to approve Indiana Floor Store to replace the damaged floor in the Clerk Treasurer's office at a cost of \$1049.48. Motion passed 3-0.

Richard Craig made a motion to approve the 2022 Spring Clean, on April 29th through May 9th, to have the dumpster placed behind the Fire Station on N Market Street. Henry Co. Community Foundation will be donating \$220.00 towards the rental of the dumpster. Motion passed 3-0.

There was discussion on the plants at Freeman Square. The CCM Grant will begin work on the square in the next month and the Town Council is wanting to keep as many of the plants as possible. Many of the bulbs were donated and they would like to put some back into the square after the new landscaping is finished. It was decided to meet on April 16th to take as many out as we can.

There was discussion on large trucks parking on Main St (US 40), between Vine St and Cherry St. This makes it hard to see on coming traffic if you are wanting to go onto Main St from these side streets. Monica Altman will get in touch with the Driver of the semi and ask them not to park on Main St. before the council takes any other action on this matter.

Public comments:

Mr. Thomas Corman commented on Ron Walker stopping his friend and the comments made to her. There was no formal complaint at this time but the Council heard his concerns.

Mr. Justin Thompson informed the Council that the Lewisville Masonic Lodge 72 will be hosting a blood draw along with the Red Cross on June 7^{th} , 2022 at the Lewisville Shelter House in the park from 12:30 to 5:30.

Resident from 307 E Main St. informed the Council that Big B refused to pick up the recycling at this address. The Clerk will check into why Big B didn't pick up, and report back to the council.
