There was discussion on the replacement for the SHRWD representative for the Town of Lewisville. Which was tabled until Oct. 8th meeting.

Discussion on the rock's owned by Jerry Lilly's that are on the Town's easement. Waylon Thompson made a motion to have Jerry Lilly remove the rock off the Town's easement within 30 days from this the 10th of Sept. Sue Saunders seconded the motion, passed 3-0.

Discussion on David Deal's pool which is on the Town's easement. David is going to have Henry County Building inspector come and check the safety of the pool (Sue Saunders said she would help him with this). It was decided to table this until the Oct. meeting to give David time to get with the Building inspector.

Sue Saunders made a motion to except the service agreement with AMI for new Electric and Water meter for the Town of Lewisville. Waylon Thompson seconded the motion, passed 3-0.

Waylon Thompson made a motion to approve Ord. 091020 on first reading for an Electric rate increase that will be effective as of Jan. 1, 2021. Sue Saunders seconded the motion, it passed 3-0.

There will be a public hearing on Oct. 8th, 2020 for final reading and approval of Ord. 091020.

Waylon Thompson made a motion to approve Ord. 091020 on the second reading, Sue Saunders seconded the motion, it passed 3-0.

Waylon Thompson made a motion to approve Monica Altman, as President, to sign legal documents for the Town of Lewisville. Sue Saunders seconded the motion, it passed 3-0.

Waylon Thompson made a motion to have Halloween on Oct. 31 from 5:00 pm to 8:00 pm. Sue Saunders seconded the motion, passed 3-0. (it was noted due to Covid-19 that people are to use there own judgement on Halloween)

There was discussion on Chad and Heather Hoopingarner's water bill. Waylon Thompson removed himself from any discussion on this matter due to being related to Heather. No one was there to speak for Hoopingarner. This was tabled.

Sue Saunders made a motion to have Nathaniel Neal purchase speed bumps for Helen Blvd, Waylon seconded the motion, it passed 3-0.

There was discussion on the properties in Town that need to be mowed, Sue Saunders said she would get letters out to the home owners.

Nancy McCullers, from the Park Comm. Asked about the Pine trees that had been removed. She requested that no more be cut down. The Board approved not to cut any trees down before consulting the Park Comm.

Nancy McCullers informed the board that HCC Grant was approved for Football Frisbee in the park.

There was no further business, Sue Saunders made a motion to adjourn the meeting, Waylon Thompson seconded the motion, it passed 3-0.
