

**ORDINANCE NO. 041119 -2-**

**AN ORDINANCE REGARDING PARKING WITHIN THE  
TOWN OF LEWISVILLE, INDIANA**

**WHEREAS**, the Town Council of the Town of Lewisville, Indiana, has become aware of a potential safety issue by vehicles parking on the north and south side of U.S.40 within the incorporated limits of Lewisville, Indiana; and

**WHEREAS**, the Town of Lewisville, Indiana, has received authorization from the appropriate representative of the Indiana Department of Transportation to enact parking restrictions on U.S. 40 within the incorporated limits of Lewisville, Indiana, by means of an ordinance; and

**WHEREAS**, the Town Council of the Town of Lewisville, Indiana, believes it is in the best interest of the health, safety, and welfare of the citizens of Lewisville, Indiana, to adopt the following restrictions as to parking on the north and south side of U.S. 40 within the incorporated limits of Lewisville, Indiana.

**NOW, THEREFORE, BE IT ORDAINED**, by the Town Council of the Town of Lewisville, Indiana, as follows:

**SECTION I**

It shall be unlawful for any motor vehicle, boat, trailer, motorcycle, or truck of any size and description, to park on either the north or south side of U.S. 40 from Market Street to 1<sup>st</sup> Street for a period of more than two (2) hours between the hours of 6:00 a.m. and 7:00 p.m. local time.

**SECTION II**

It shall be unlawful for any motor vehicle, boat, trailer, motorcycle, or truck of any size and description, to park at any time on the south side of U.S. 40 within 75 feet either way from its intersection with Williams Street in Lewisville, Indiana.

**SECTION III**

Any person or entity violating this Ordinance will be fined in the amount of \$25.00 for the first violation, \$50.00 for the second violation, \$100.00 for the third violation, and \$250.00 for the fourth violation occurring within any twelve (12) month period.

**SECTION IV**

Should the Town of Lewisville, Indiana, be required to enforce the terms and provisions of this ordinance through the Henry County court system, any such defendant, upon a finding that they violated this ordinance, shall, in addition to any fine imposed, be required to pay all attorneys' fees incurred by the Town of Lewisville, Indiana, as a result of said enforcement action.

**SECTION V**

This Ordinance shall be in full force and effect from and after its passage and due publication.

**SECTION VI**


