



VOLUNTEER LIABILITY RELEASE

In consideration of the services rendered by The Service Dog Connection LLC (the "Company" and sometimes referred to herein as "The Service Dog Connection Training Program"), I have read, understand, acknowledge and agree as follows:

I hereby release The Service Dog Connection LLC, its employees, owners, directors, representatives, subcontractors, agents, animal owners, customers and potential customers from any and all liabilities, financial and otherwise, for injuries to myself, my dog, or any other property of mine, which arise in any way at any time directly or indirectly from services, activities and/or products provided by or as consequence of my association with The Service Dog Connection LLC.

I hereby agree to indemnify, defend and hold harmless the Releasees from and against any and all claims, damages, injuries, losses, liabilities, expenses, or injuries arising directly or indirectly as a result of any action by my dog or any other dog or service dog in training including any claims by myself, my family members or any other person accompanying me to or present with me at any function, program, event or activity of The Service Dog Connection LLC.

THIS IS A COMPREHENSIVE LIMITATION OF LIABILITY AND IN NO EVENT SHALL THE SERVICE DOG CONNECTION LLC OR ANY OF THE RELEASEES BE LIABLE, JOINTLY OR SEVERALLY, TO ME OR ANY OTHER PERSON AS A RESULT OF OR IN CONNECTION WITH THE SERVICES OFFERED TO ME BY THE SERVICE DOG CONNECTION TRAINING PROGRAM, INCLUDING, WITHOUT LIMITATION, FOR INDIRECT, CONSEQUENTIAL, SPECIAL, INCIDENTAL, PUNITIVE, OR EXEMPLARY DAMAGES, LOST PROFITS, LOST SAVINGS, AND LOST REVENUES, OR OTHER PECUNIARY LOSS (COLLECTIVELY, THE "EXCLUDED DAMAGES"), WHETHER OR NOT CHARACTERIZED IN NEGLIGENCE, TORT, CONTRACT, OR ANY OTHER THEORY OF LIABILITY, EVEN IF THE SERVICE DOG CONNECTION LLC OR THE RELEASEES HAVE BEEN ADVISED OF THE POSSIBILITY OF OR COULD HAVE FORESEEN ANY OF THE EXCLUDED DAMAGES, AND IRRESPECTIVE OF ANY FAILURE OF AN ESSENTIAL PURPOSE OF A LIMITED REMEDY. IF ANY APPLICABLE AUTHORITY HOLDS ANY PORTION OF THIS SECTION TO BE UNENFORCEABLE, THEN THE LIABILITY OF THE SERVICE DOG CONNECTION LLC WILL BE LIMITED TO THE FULLEST POSSIBLE EXTENT PERMITTED BY APPLICABLE LAW. WITHOUT LIMITING THE FOREGOING, UNDER NO CIRCUMSTANCES SHALL THE SERVICE DOG CONNECTION LLC BE LIABLE FOR ANY CLAIM, LOSS, COST, EXPENSE, OR DAMAGE WHATSOEVER TO ME OR ANY THIRD PARTY IN AN AMOUNT EXCEEDING THE SUM ACTUALLY PAID BY ME TO THE SERVICE DOG CONNECTION LLC DURING THE TWELVE-MONTH PERIOD IMMEDIATELY PRECEDING THE DATE ON WHICH THE SERVICE DOG CONNECTION LLC IS NOTIFIED OF SUCH CLAIM IN WRITING.

I understand that The Service Dog Connection Training Program has the right to refuse service to me and/or my dog at any time for any reason. I hereby declare to The Service Dog Connection LLC that I am the legal owner of my dog; that my dog has not been exposed to distemper, rabies or parvovirus within the past thirty (30) days, that my dog has been inoculated as indicated by records presented.

I understand that I am not the owner of any service dog in training that I am training, raising, housing, or providing care for The Service Dog Connection Training Program and am required to uphold training standards and guidelines from The Service Dog Connection staff.

I understand that The Service Dog Connection may take the service dog in training out of my care at any time for any reason, and that I do not have any say in decisions made about the service dog in training's care, placement or training plan.

I understand that I am held liable for any damages or injury caused by a service dog in training under my care.
